REVIEW OF OVERSEAS TRADE

During the month of April 2013, imports to Barbados were valued at \$316.6 million whilst total exports from Barbados were valued at \$90.1 million. This resulted in a visible trade deficit of \$226.5 million, compared with a visible trade deficit of \$184.6 million for April 2012.

Imports for April 2013 were \$23.4 million more than imports recorded for April 2012, an increase of 8.0%. Total exports decreased in value by some \$18.6 million, or 17.1% of the April 2012 figure. This was as a result of declines recorded in domestic exports of \$14.3 million, or 22.7%, and in the value of re-exports of \$4.2 million, or 9.3%, in comparison with the corresponding month in 2012.

CARICOM TRADE

During the month of April 2013, imports from CARICOM countries were valued at \$127.8 million whilst total exports to CARICOM countries were valued at \$35.4 million. This resulted in a visible trade deficit of \$92.4 million, compared with a visible trade deficit of \$80.6 million for April 2012.

CARICOM imports for April 2013 were \$14.5 million more than CARICOM imports for April 2012, an increase of 12.8%. Total exports to CARICOM countries for April 2013 also increased in value by \$2.8 million, or 8.5%, of the total exports figure for April 2012. This increase in exports came as a result of increases recorded in domestic exports of \$1.1 million, or 3.5%, and in the value of re-exports of \$1.7 million, or 75.0%, in comparison with the corresponding month in 2012.





Principal Domestic Exports - June 2007





Principal Domestic Exports January- June 2007





JUNE 2007 WITH THE CORRESPONDING MONTH OF 2006









JUNE 2007 WITH THE CORRESPONDING MONTH OF 2006






