REVIEW OF OVERSEAS TRADE

During the month of August 2018, total imports to Barbados were valued at \$254 million, whilst total exports from Barbados were valued at \$69 million. This resulted in a visible trade deficit of \$185.0 million, as compared with a visible trade deficit of \$186.4 or August 2017.

Imports for August 2018 were \$7.8 million less than imports for August 2017, a decrease of 3.0%. Total exports decreased by \$6.4 million or 8.5% of the August 2017 figure. Domestic exports increased by \$2.9 million or 7.4% over August 2017, while the value of re-exports decreased by \$9.3 million or 26.2% over the corresponding period 2017.

For the period January – August 2018, the value of imports to Barbados was \$2.10 billion, whilst the value of total exports was \$611.8 million representing an accumulated visible trade deficit of \$1.48 billion as compared to a similar deficit of \$1.44 billion for January – August 2017.

Imports for January – August 2018 were \$34.7 million more than imports for the same period 2017, an increase of 1.7%. Total exports showed a decrease of some \$4.6 million or 0.7% over the January - August 2017 figure. Domestic exports increased by \$17.9 million or 5.4% over January – August 2017. The value of re-exports decreased by \$22.4 million or 7.9% over the corresponding period 2017.

CARICOM TRADE

During the month of August 2018, total imports from CARICOM countries were valued at \$41 million, whilst total exports to CARICOM were valued at \$26 million, resulting in a trade deficit of \$14.6 million as compared with a visible trade deficit of \$29.8 million for August 2017.

Total CARICOM imports for August 2018 were \$12.5 million less than CARICOM imports for April 2017, a decrease of 23.6%. Total exports to CARICOM for August 2018 were \$2.7 million more than total exports for August 2017, an increase of 11.4%. Domestic exports increased by \$4.0 million or 21.3% over August 2017. The value of reexports decreased by some \$1.3 million, or 27.1% over the August 2017 figure.


For the period January – August 2018, total imports from CARICOM were valued at \$432 million, whilst total exports were \$232 million resulting in an accumulated visible trade deficit of \$200.2 million as compared with a deficit of \$199.9 million for the same period of 2017.


During this period, CARICOM imports were approximately \$22.9 million more than those over the same period in 2017, an increase of 5.6%. Total exports to CARICOM for January – August 2018 were \$22.6 million more than total exports for the corresponding period 2017, an increase of 10.8%. Domestic exports increased by approximately \$35.8 million or 21.2% over the same period 2017. The value of re-exports decreased by \$13.2 million or 31.9% over the January – August 2017 figure.
