## **REVIEW OF OVERSEAS TRADE**

During the month of July 2019, total imports to Barbados were valued at \$259.5 million, whilst total exports from Barbados were valued at \$71.7 million. This resulted in a visible trade deficit of \$187.8 million, as compared with a visible trade deficit of \$211.3 for July 2018.

Imports for July 2019 were \$29 million less than imports for July 2018, a decrease of 10.1%. Total exports decreased by \$5.6 million or 7.2% of the July 2018 figure. Domestic exports decreased by \$10.0 million or 18.6% over July 2018, while the value of re-exports increased by \$4.5 million or 19.1% over the corresponding period 2018.

For the period January – July 2019, the value of imports to Barbados was \$1.8 billion, whilst the value of total exports was \$551.1 million representing an accumulated visible trade deficit of \$1.29 billion as compared to a similar deficit of \$1.3 billion for January – July 2018.

Imports for January – July 2019 were \$2.2 million less than imports for the same period 2018, a decrease of 0.1%. Total exports showed an increase of some \$8.2 million or 1.5% over the January - July 2018 figure. Domestic exports increased by \$6.7 million or 2.2% over January – July 2018. The value of re-exports increased by \$1.5 million or 0.6% over the corresponding period 2018.

## **CARICOM TRADE**

During the month of July 2019, total imports from CARICOM countries were valued at \$45.0 million, whilst total exports to CARICOM were valued at \$27.9 million, resulting in a trade deficit of \$17.1 million as compared with a visible trade deficit of \$15.1 million for July 2018.

Total CARICOM imports for July 2019 were \$9.2 million less than CARICOM imports for July 2018, a decrease of 16.9%. Total exports to CARICOM for July 2019 were \$10.6 million less than total exports for July 2018, a decrease of 27.4%. Domestic exports decreased by \$8.3 million or 24.5% over July 2018. The value of re-exports decreased by some \$2.2 million, or 49.6%, over the July 2018 figure.

For the period January – July 2019, total imports from CARICOM were valued at \$340.2 million, whilst total exports were \$204.2 million resulting in an accumulated visible trade deficit of \$136 million as compared with a deficit of \$185.7 million for the same period of 2018.

During this period, CARICOM imports were approximately \$51.7 million less than those over the same period in 2018, a decrease of 13.2%. Total exports to CARICOM for January – July 2019 were \$2.1 million less than total exports for the corresponding period 2018, a decrease of 1.0%. Domestic exports increased by approximately \$0.9 million or 0.5% over the same period 2018. The value of re-exports decreased by \$3.0 million or 12.1% over the January – July 2018 figure.

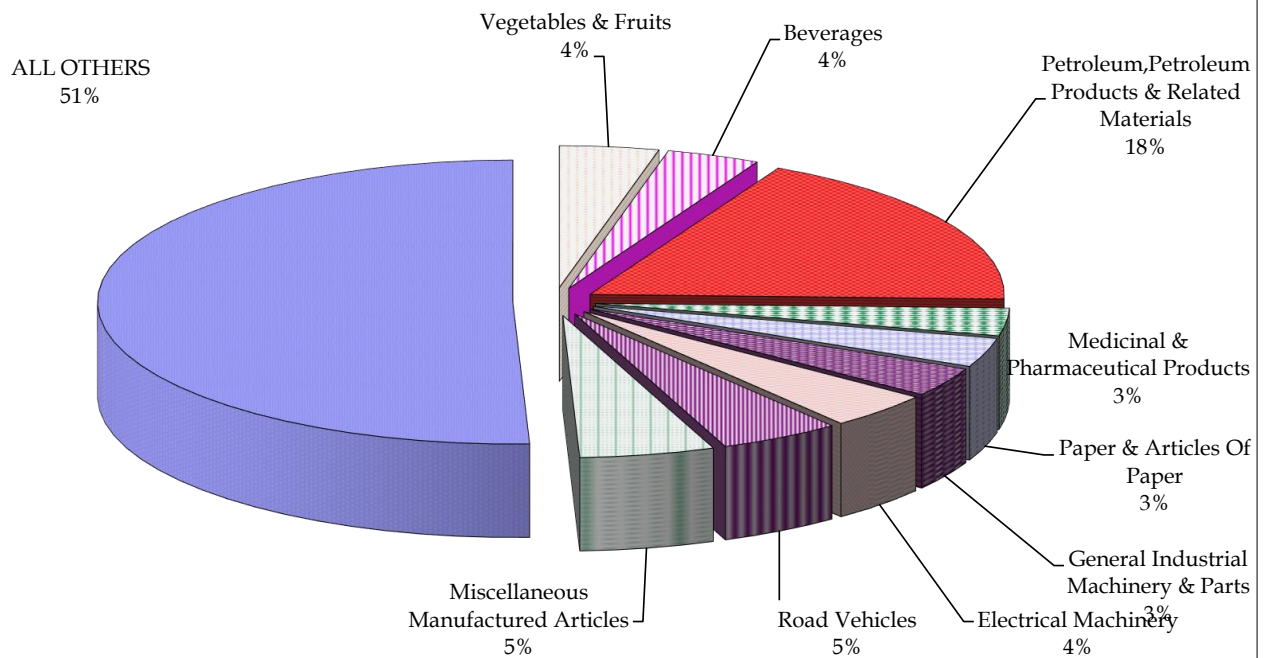

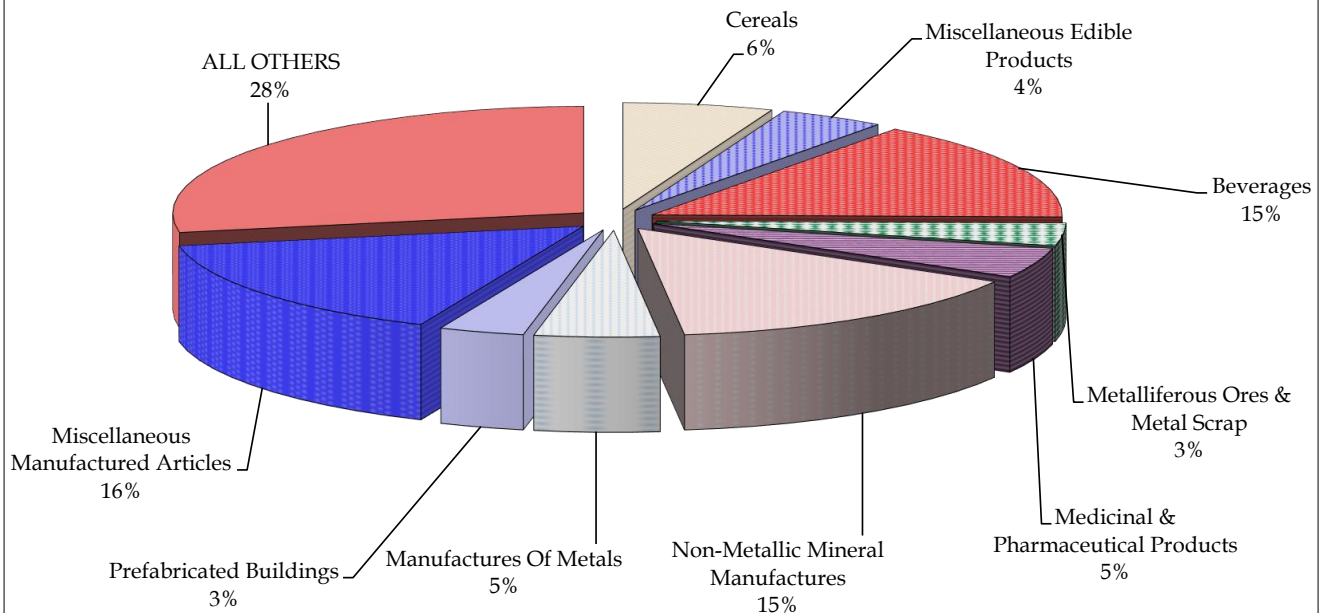

## Principal Domestic Exports - July 2019

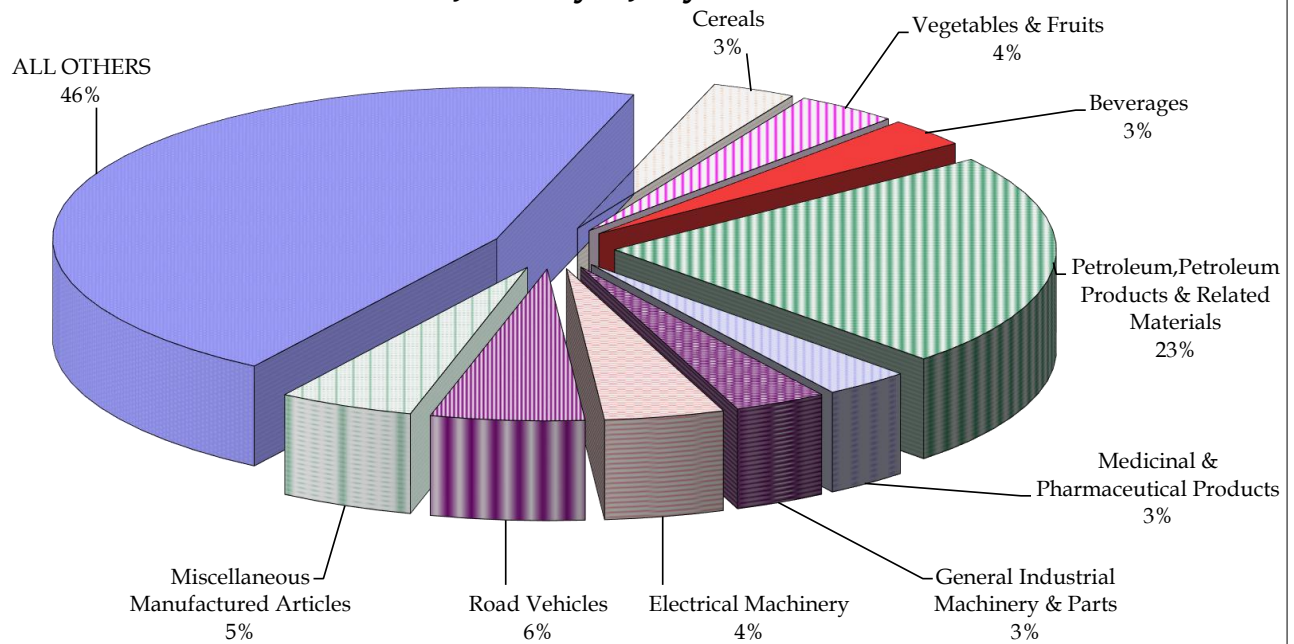

## Principal Domestic Exports January - July 2019

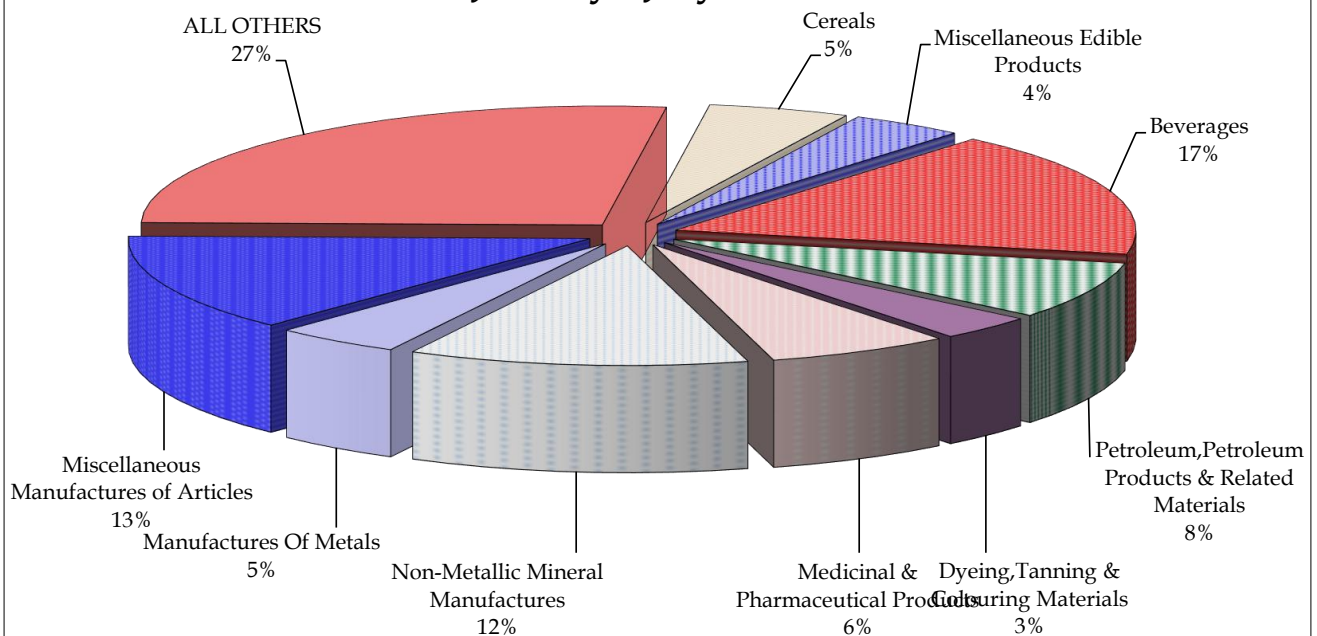

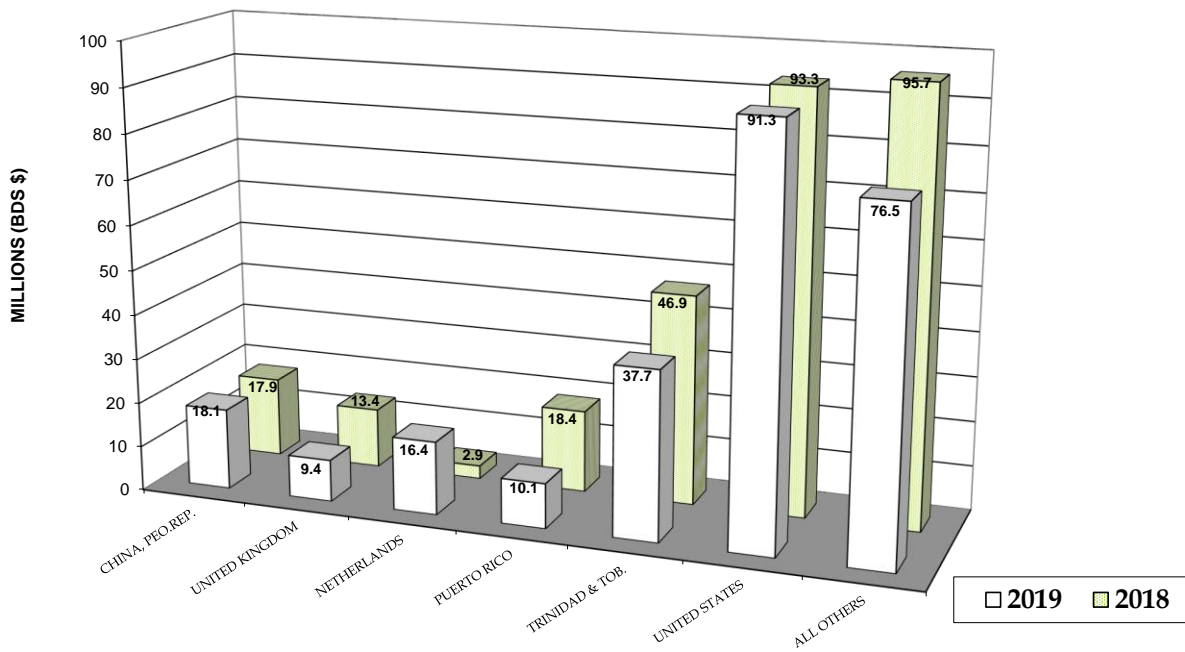

JULY 2019 WITH THE CORRESPONDING MONTH OF 2018

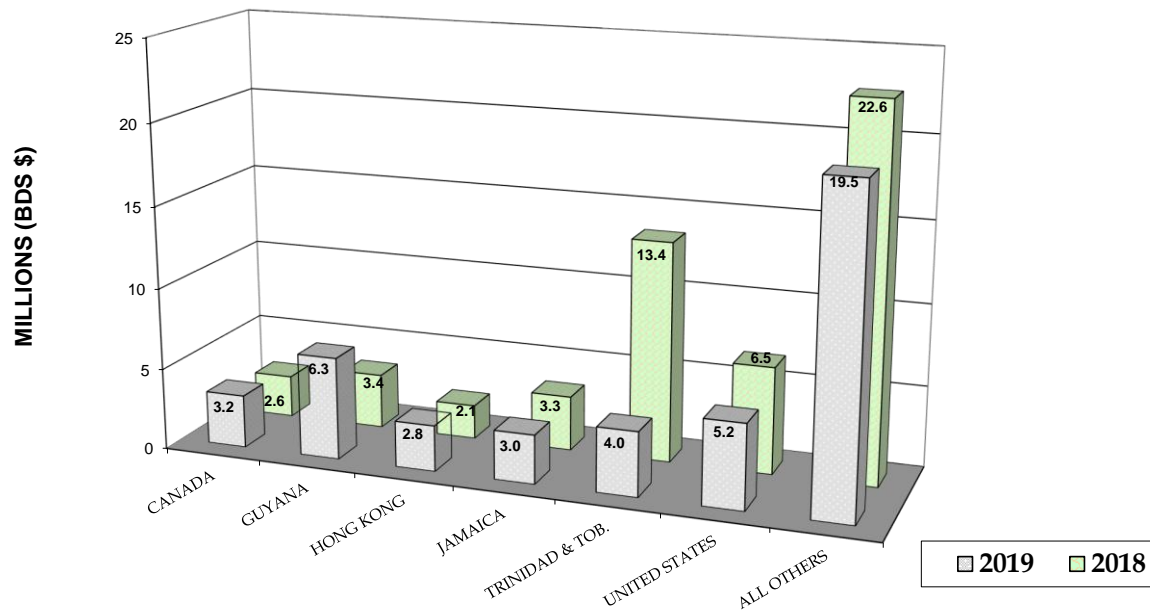


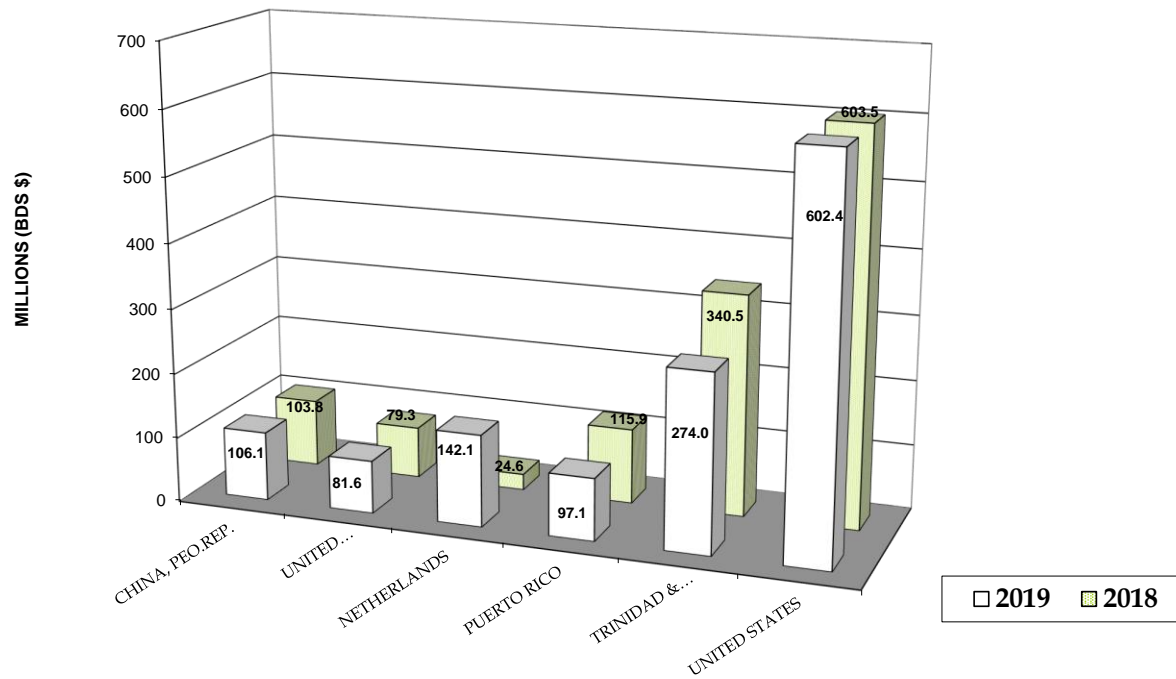

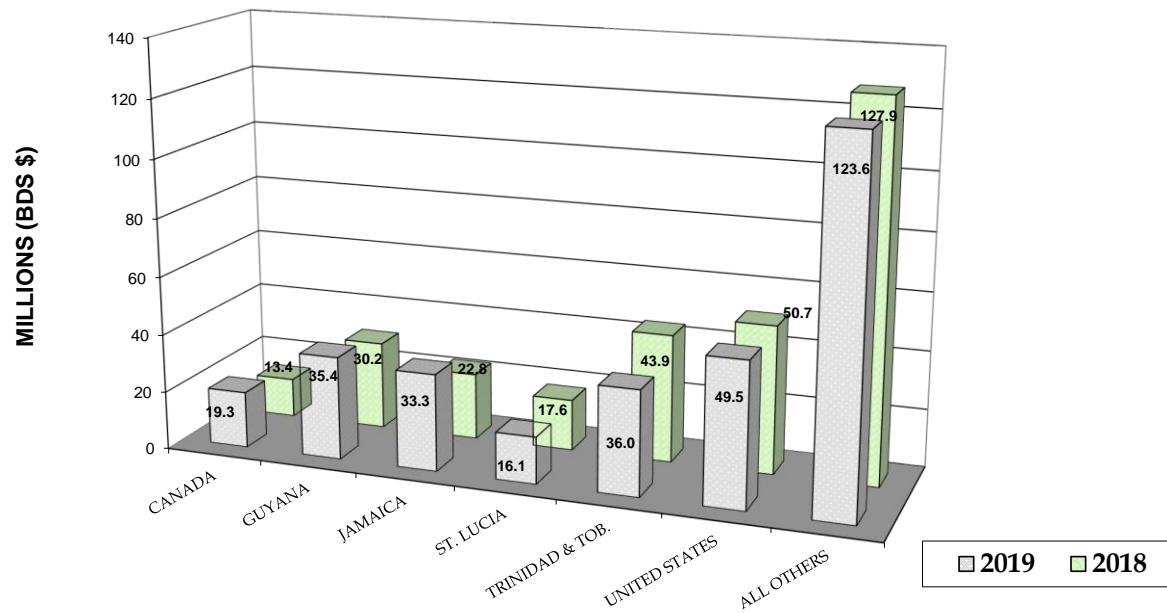

JULY 2019 WITH THE CORRESPONDING MONTH OF 2018

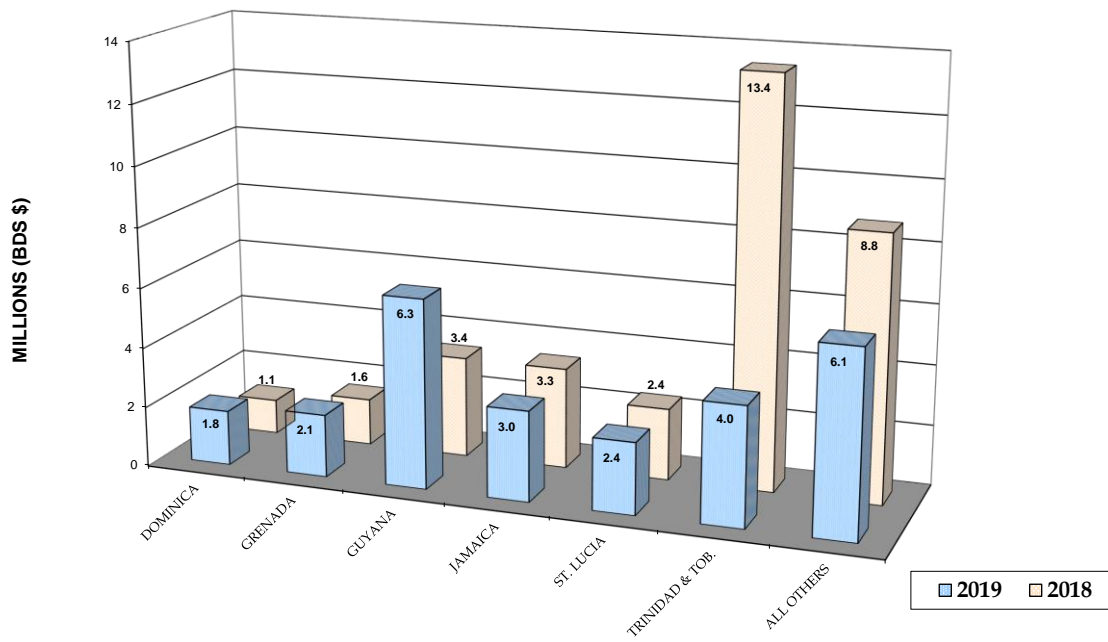


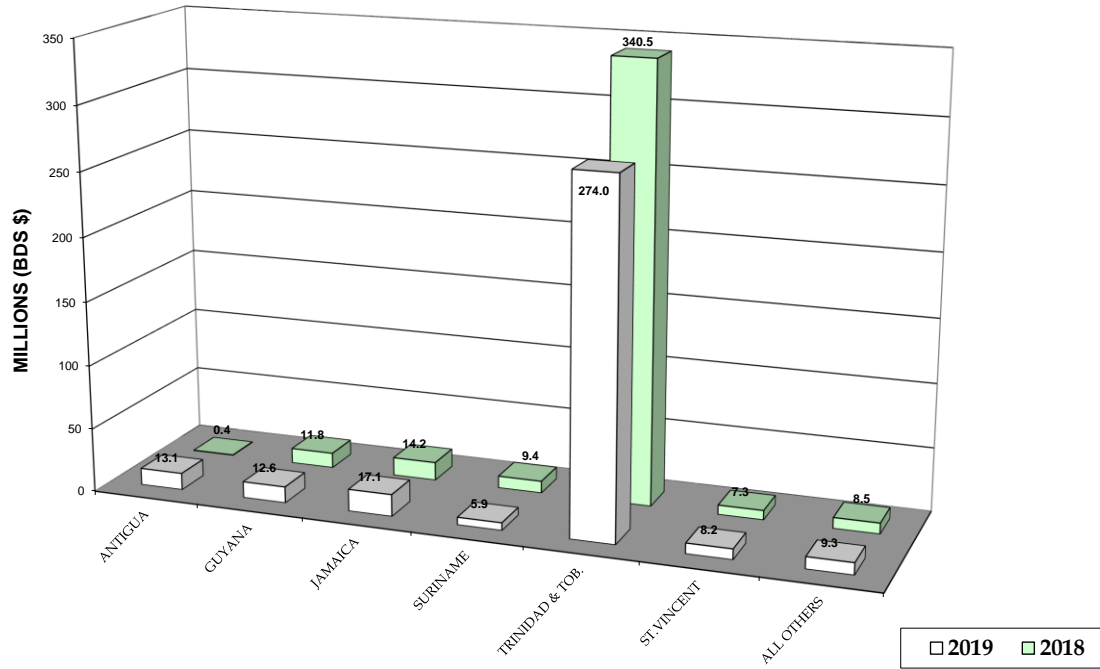

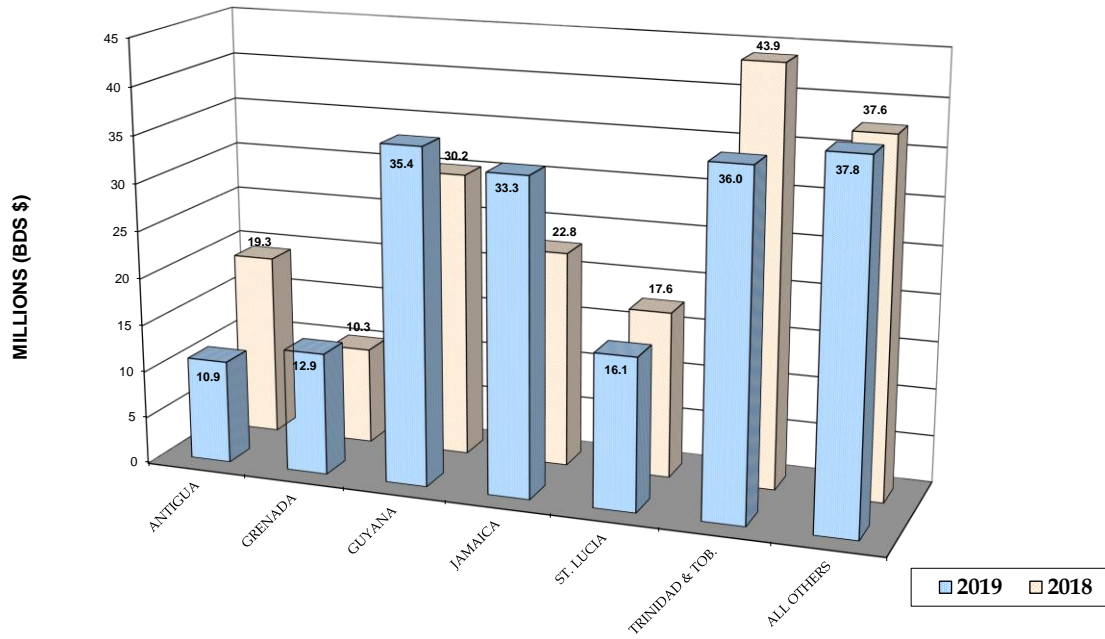
