REVIEW OF OVERSEAS TRADE

During the month of June 2012, imports to Barbados were valued at \$268.1 million whilst total exports from Barbados were valued at \$175.8 million. This resulted in a visible trade deficit of \$92.4 million, compared with a visible trade deficit of \$204.1 million for June 2011.

Imports for June 2012 were \$11.7 million less than imports recorded for June 2011, a decline of 4.2%. Total exports increased in value by some \$100.1 million, or 132.2% of the June 2011 figure. This was as a result of increases recorded in domestic exports of \$12.5 million, or 24.5%, and in the value of re-exports of \$87.6 million, or 351.2%, in comparison with the corresponding month in 2011.

For the period January – June 2012, the value of imports to Barbados was \$1,722.1 million, whilst the value of total exports was \$690.4 million. This resulted in an accumulated visible trade deficit of \$1,031.7 million as compared to a similar deficit of \$1,273.7 million for January - June 2011.

Imports for January - June 2012 were \$33.9 million less than imports for the corresponding period in 2011, a decline of 1.9%. Total exports increased in value by some \$208.1 million, or 43.1%, over the January - June 2011 figure. This was as a result of increases recorded in domestic exports of \$66.9 million, or 25.1%, and in the value of re-exports of \$141.3 million, or 65.3%, in comparison with the corresponding period in 2011.

CARICOM TRADE

During the month of June 2012, imports from CARICOM countries were valued at \$84.1 million whilst total exports to CARICOM countries were valued at \$19.8 million. This resulted in a visible trade deficit of \$64.3 million, compared with a visible trade deficit of \$72.2 million for June 2011.

CARICOM imports for June 2012 were \$7.8 million less than CARICOM imports for June 2011, a decline of 8.5%. Total exports to CARICOM countries for June 2012 increased in value by \$0.04 million, or 0.2%, of the total exports figure for June 2011. This increase in exports came as a result of an increase recorded in re-exports of \$0.6 million, or 18.4%, while the value of domestic exports declined by \$0.5 million, or 3.3%, in comparison with the corresponding month in 2011.

For the period January – June 2012, total imports from CARICOM countries were valued at \$660.2 million whilst total exports to CARICOM countries were valued at \$159.1 million. This resulted in an accumulated visible trade deficit of \$501.1 million, compared with a deficit of \$534.2 million for the period January – June 2011.

During this period, CARICOM imports were approximately \$5.8 million less than those recorded over the same period in 2011, a decline of 0.9%. Total exports to CARICOM countries for the period January – June 2012 increased in value by \$27.4 million, or 20.8%, of the total exports figure for the corresponding period in 2011. This increase in exports came as a result of increases recorded in domestic exports of \$27.2 million, or 24.9%, and in the value of re-exports of \$0.2 million, or 0.7%, in comparison with the corresponding period in 2011.

JUNE 2012 WITH THE CORRESPONDING MONTH OF 2011**

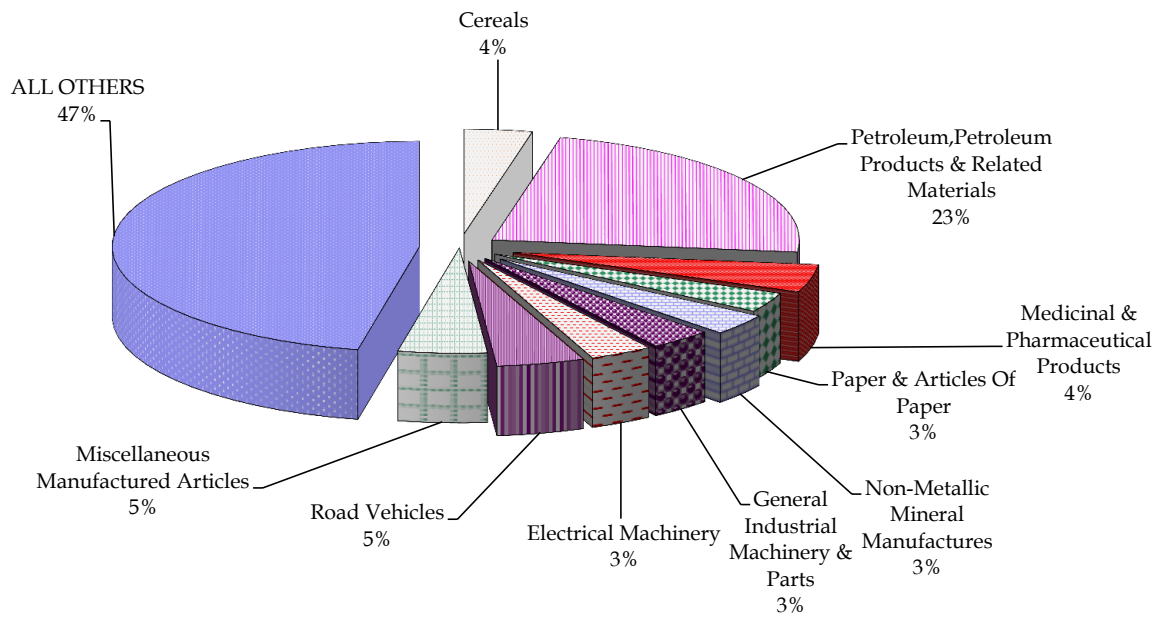

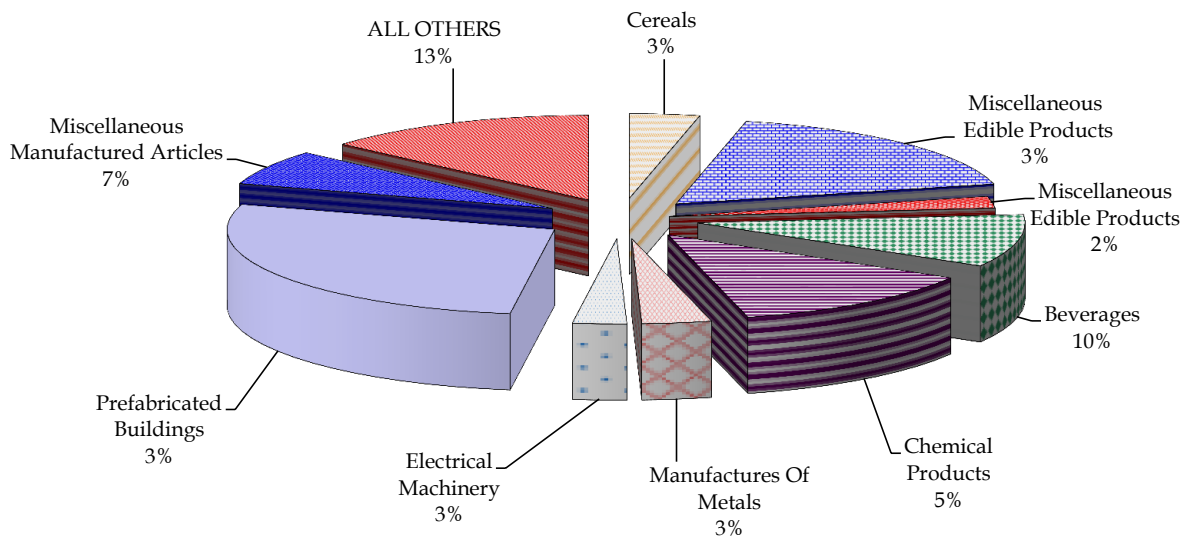

Principal Domestic Exports - June 2012



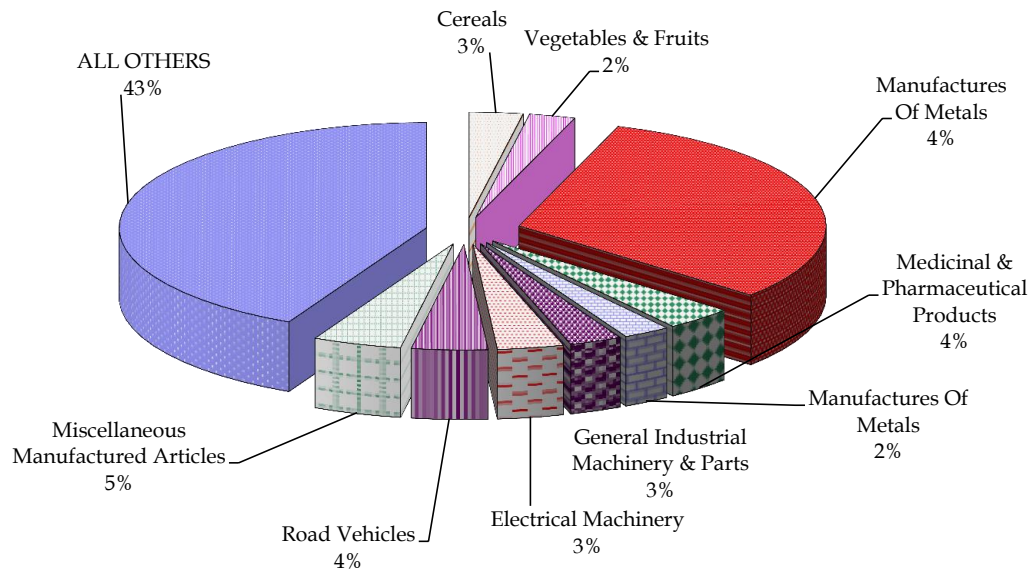

Principal Domestic Exports January- June 2012

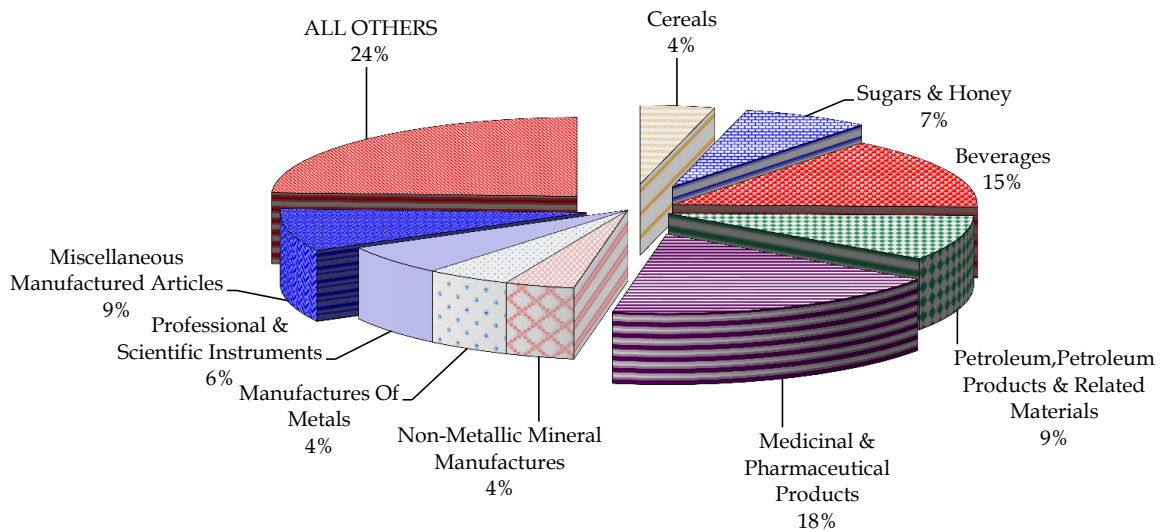

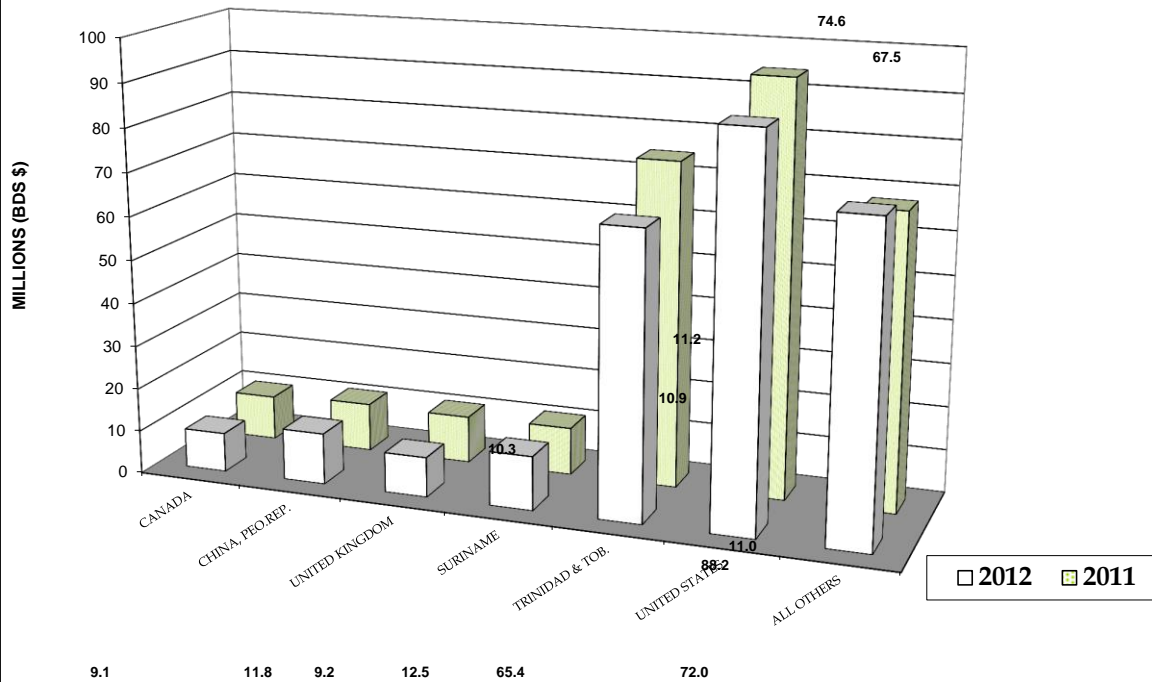

JUNE 2007 WITH THE CORRESPONDING MONTH OF 2006

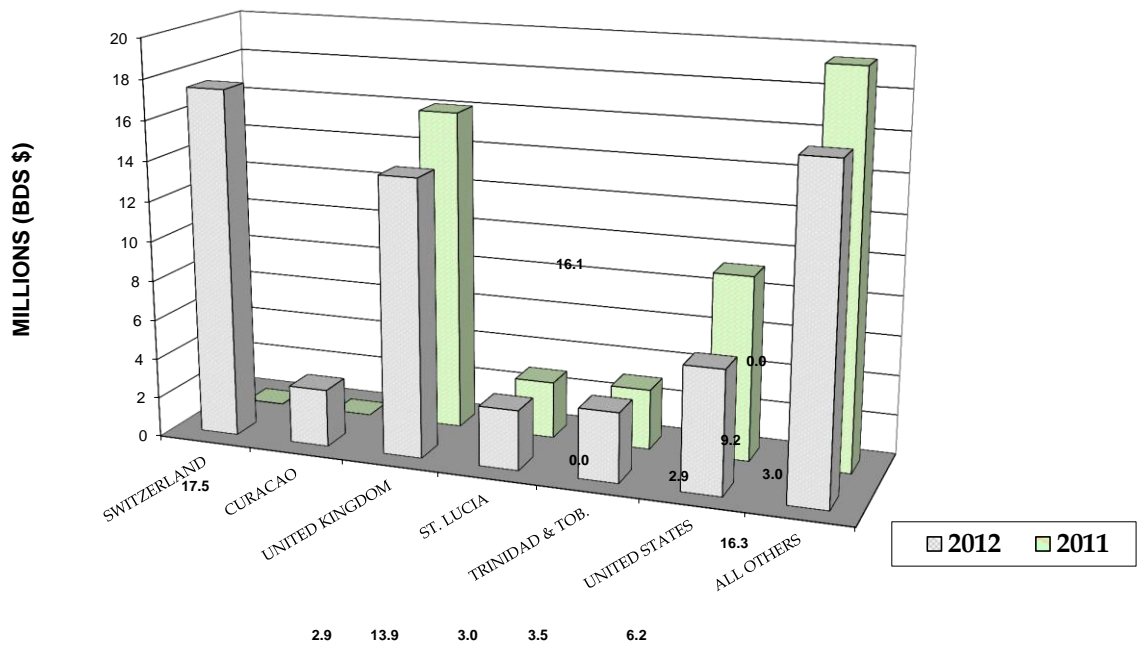

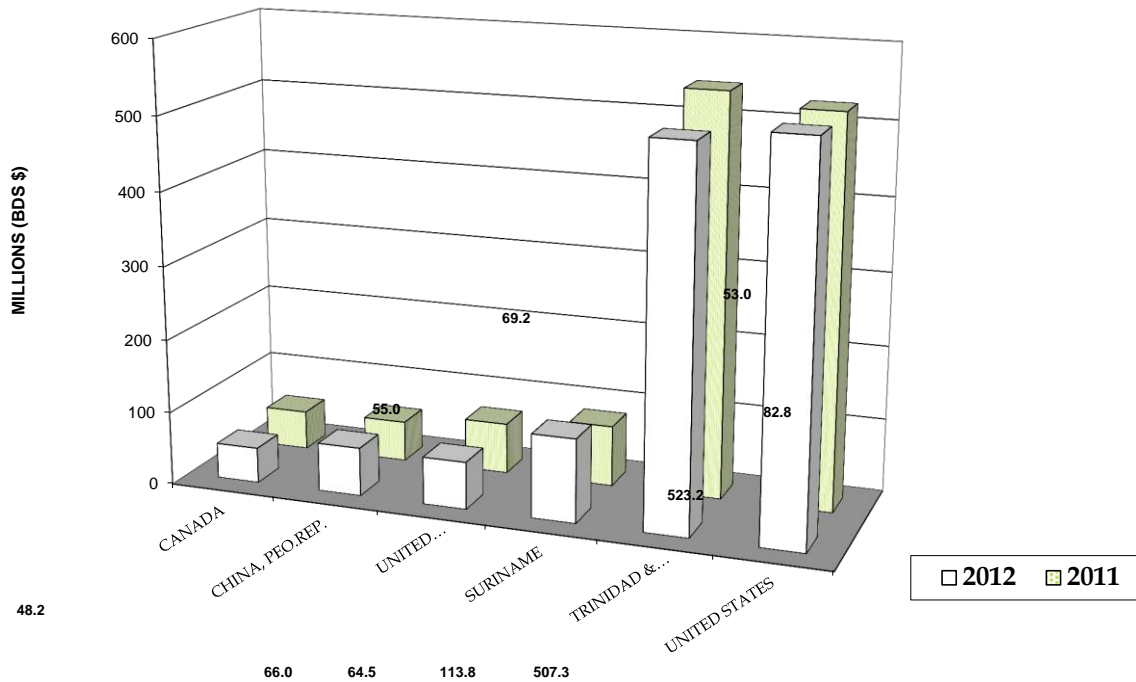

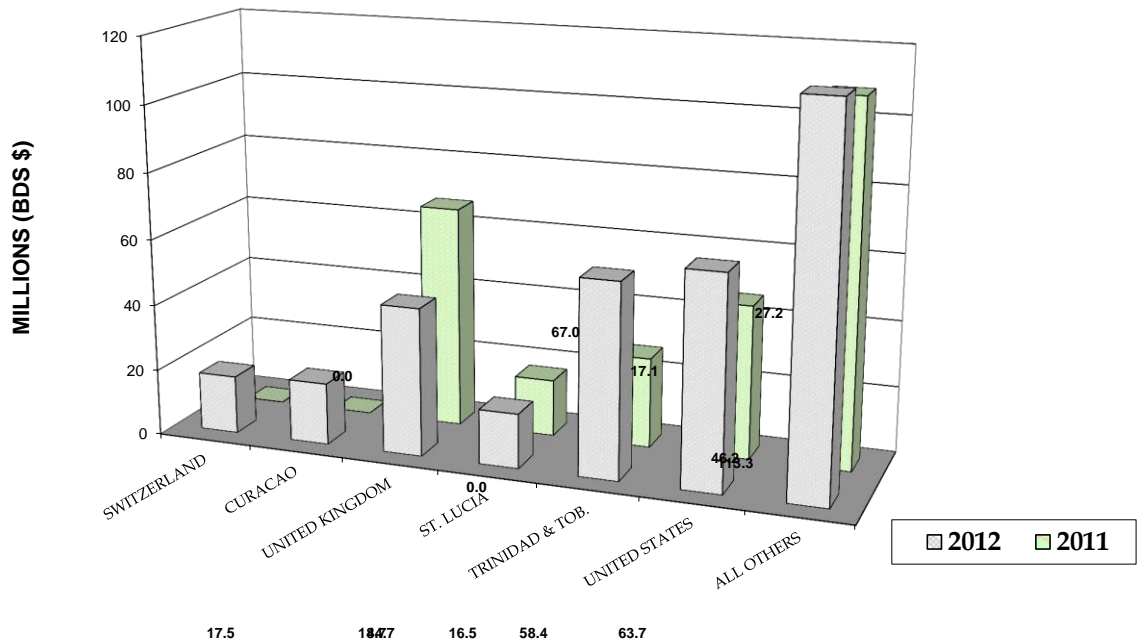

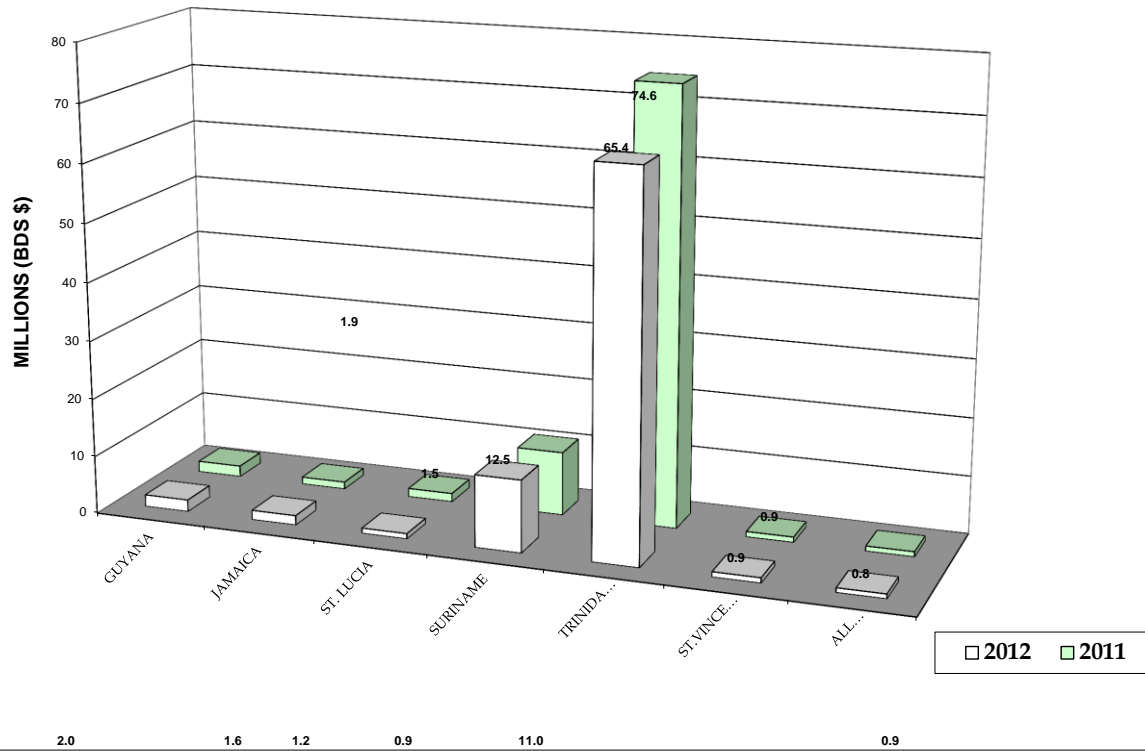

JUNE 2007 WITH THE CORRESPONDING MONTH OF 2006

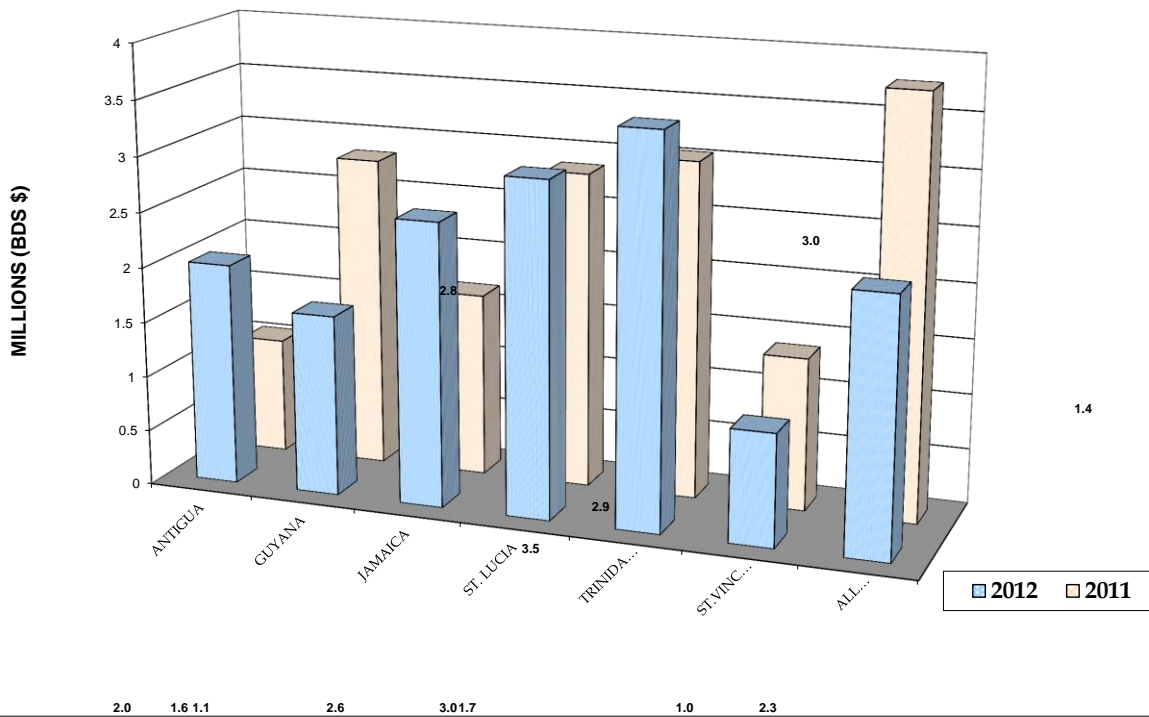

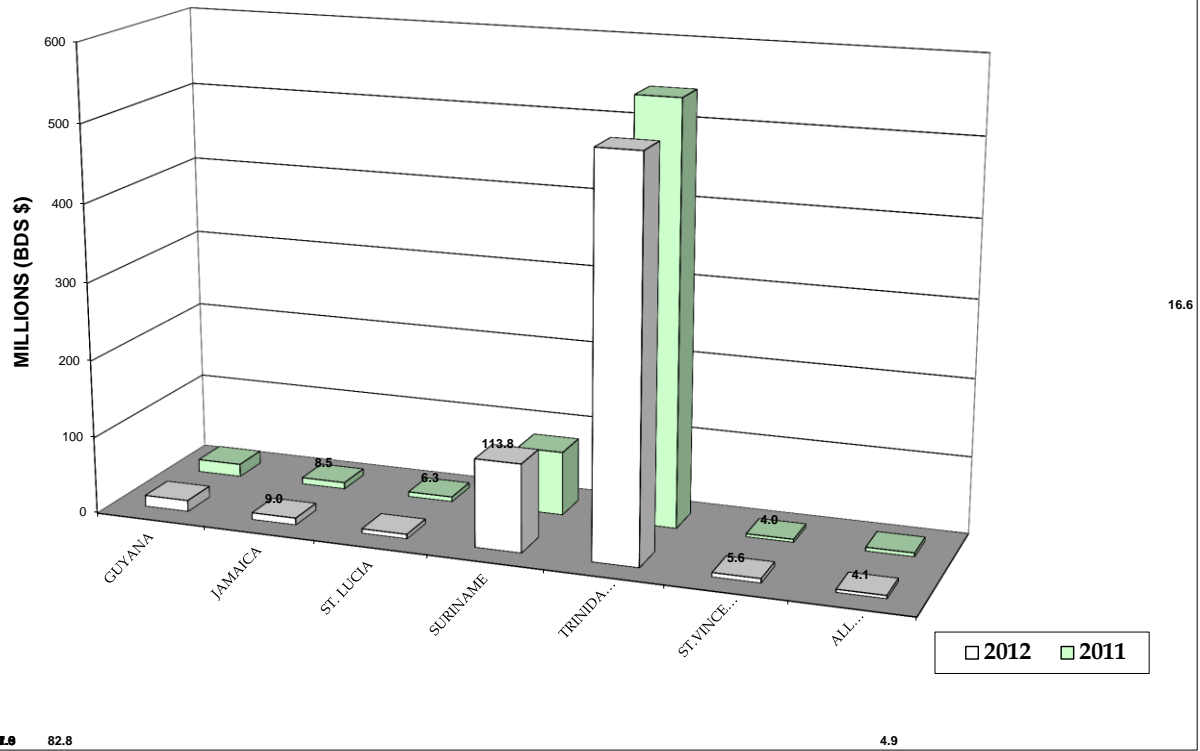

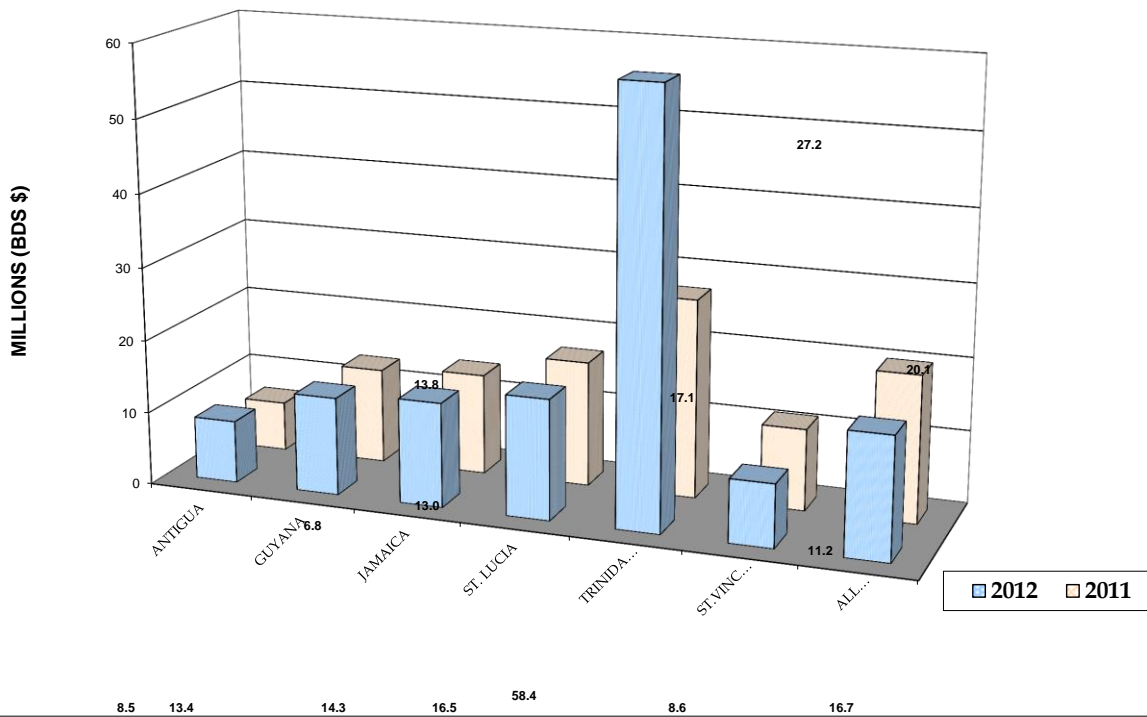
