REVIEW OF OVERSEAS TRADE

During the month of May 2018, total imports to Barbados were valued at \$244 million, whilst total exports from Barbados were valued at \$65 million. This resulted in a visible trade deficit of \$179.8 million, as compared with a visible trade deficit of \$193.8 for June 2017.

Imports for June 2018 were \$25.3 million less than imports for June 2017, a decrease of 9.4%. Total exports decreased by \$11.3 million or 14.9% of the June 2017 figure. Domestic exports decreased by \$5.4 million or 11.0% over June 2017, while the value of re-exports decreased by \$6.0 million or 21.8% over the corresponding period 2017.

For the period January – June 2018, the value of imports to Barbados was \$1.55 billion, whilst the value of total exports was \$465 million representing an accumulated visible trade deficit of \$1.09 billion as compared to a similar deficit of \$1.10 billion for January – June 2017.

Imports for January – May 2018 were \$15.5 million less than imports for the same period 2017, a decrease of 1.0%. Total exports showed a decrease of some \$2.2 million or 0.5% over the January - June 2017 figure. Domestic exports increased by \$4.8 million or 2.0% over January – June 2017. The value of re-exports decreased by \$7.0 million or 3.2% over the corresponding period 2017.

CARICOM TRADE

During the month of June 2018, total imports from CARICOM countries were valued at \$63 million, whilst total exports to CARICOM were valued at \$26 million, resulting in a trade deficit of \$36.8 million as compared with a visible trade deficit of \$17.7 million for June 2017.

Total CARICOM imports for June 2018 were \$20.0 million more than CARICOM imports for June 2017, an increase of 46.1%. Total exports to CARICOM for June 2018 were \$0.9 million more than total exports for June 2017, an increase of 3.6%. Domestic exports increased by \$2.9 million or 13.6% over June 2017. The value of re-exports decreased by some \$2.0 million, or 43.7%, over the June 2017 figure.


For the period January – June 2018, total imports from CARICOM were valued at \$337 million, whilst total exports were \$167 million resulting in an accumulated visible trade deficit of \$170.0 million as compared with a deficit of \$157.4 million for the same period of 2017.


During this period, CARICOM imports were approximately \$27.1 million more than those over the same period in 2017, an increase of 8.7%. Total exports to CARICOM for January – June 2018 were \$14.5 million more than total exports for the corresponding period 2017, an increase of 9.5%. Domestic exports increased by approximately \$24.6 million or 20.0% over the same period 2017. The value of re-exports decreased by \$10.1million or 33.4% over the January – June 2017 figure.
