## **REVIEW OF OVERSEAS TRADE**

During the month of June 2019, total imports to Barbados were valued at \$269.7 million, whilst total exports from Barbados were valued at \$71 million. This resulted in a visible trade deficit of \$198.6 million, as compared with a visible trade deficit of \$179.8 for June 2018.

Imports for June 2019 were \$25.3 million more than imports for June 2018, an increase of 10.3%. Total exports increased by \$6.4 million or 9.9% of the June 2018 figure. Domestic exports increased by \$3.8 million or 8.8% over June 2018, while the value of re-exports increased by \$2.6 million or 12.2% over the corresponding period 2018.

For the period April - June 2019, the value of imports to Barbados was \$1.58 billion, whilst the value of total exports was \$479.3 million representing an accumulated visible trade deficit of \$1.10 billion as compared to a similar deficit of \$1.09 billion for April – June 2018.

Imports for April - June 2019 were \$26.8 million more than imports for the same period 2018, an increase of 1.7%. Total exports showed an increase of some \$13.8 million or 3.0% over the April - June 2018 figure. Domestic exports increased by \$16.7 million or 6.6% over April - June 2018. The value of re-exports decreased by \$2.9 million or 1.4% over the corresponding period 2018.

## **CARICOM TRADE**

During the month of June 2019, total imports from CARICOM countries were valued at \$62 million, whilst total exports to CARICOM were valued at \$31 million, resulting in a trade deficit of \$31 million as compared with a visible trade deficit of \$36.8 million for June 2018.

Total CARICOM imports for June 2019 were \$1.2 million less than CARICOM imports for June 2018, a decrease of 2.0%. Total exports to CARICOM for June 2019 were \$4.3 million more than total exports for June 2018, an increase of 16.1%. Domestic exports increased by \$4.1 million or 17.0% over June 2018. The value of re-exports increased by some \$0.2 million, or 8.1%, over the June 2018 figure.

For the period April - June 2019, total imports from CARICOM were valued at \$295.2 million, whilst total exports were \$176 million resulting in an accumulated visible trade deficit of \$118.9 million as compared with a deficit of \$170 million for the same period of 2018.

During this period, CARICOM imports were approximately \$42.6 million less than those over the same period in 2018, a decrease of 12.6%. Total exports to CARICOM for April - June 2019 were \$8.5 million more than total exports for the corresponding period 2018, an increase of 5.0%. Domestic exports increased by approximately \$9.2 million or 6.2% over the same period 2018. The value of re-exports decreased by \$0.8 million or 3.7% over the April - June 2018 figure.

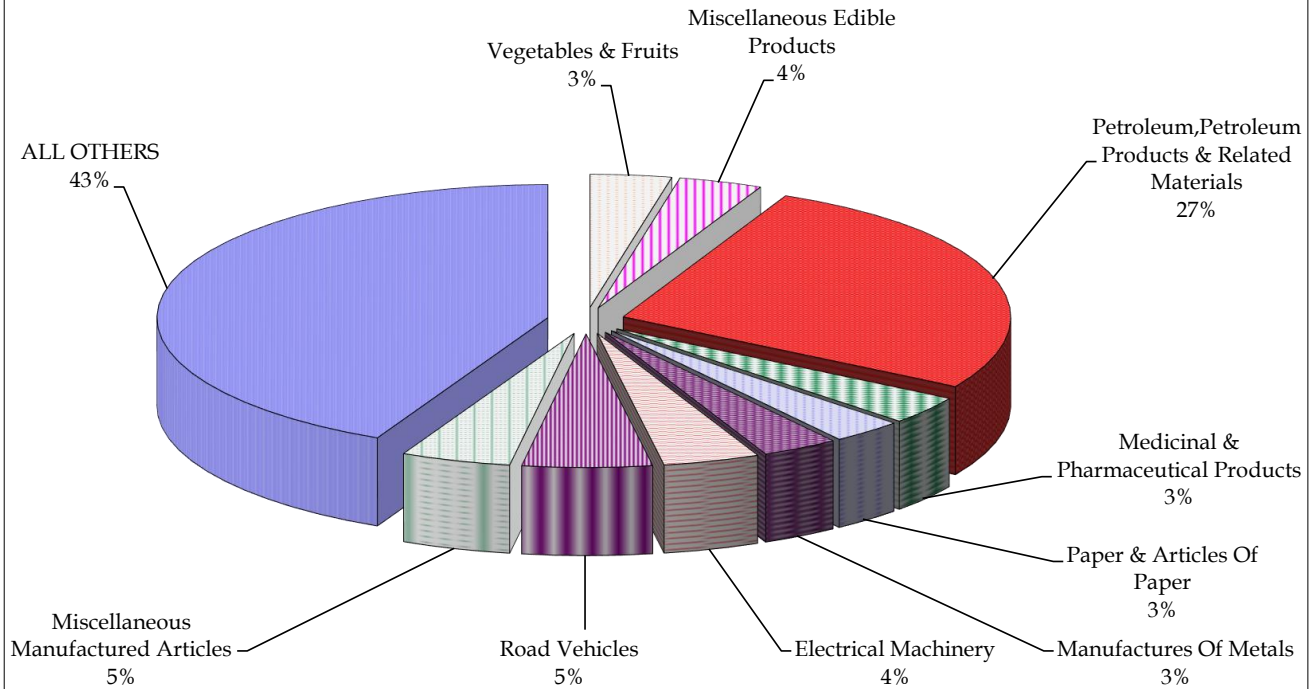

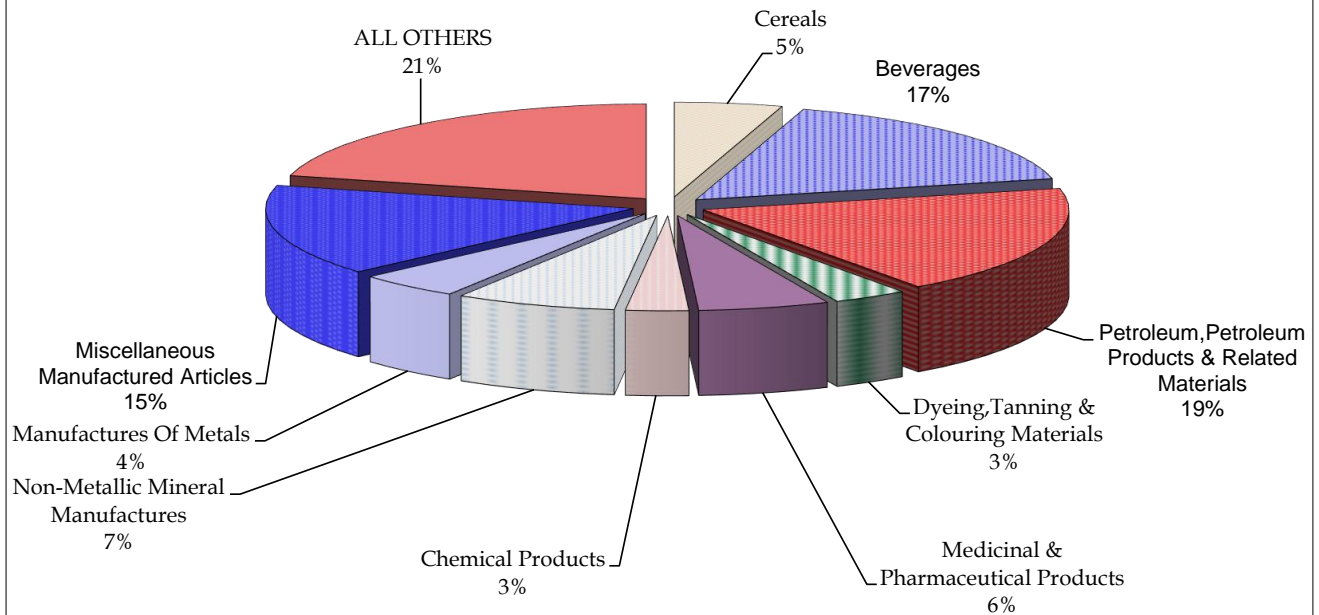

## Principal Domestic Exports - June 2019



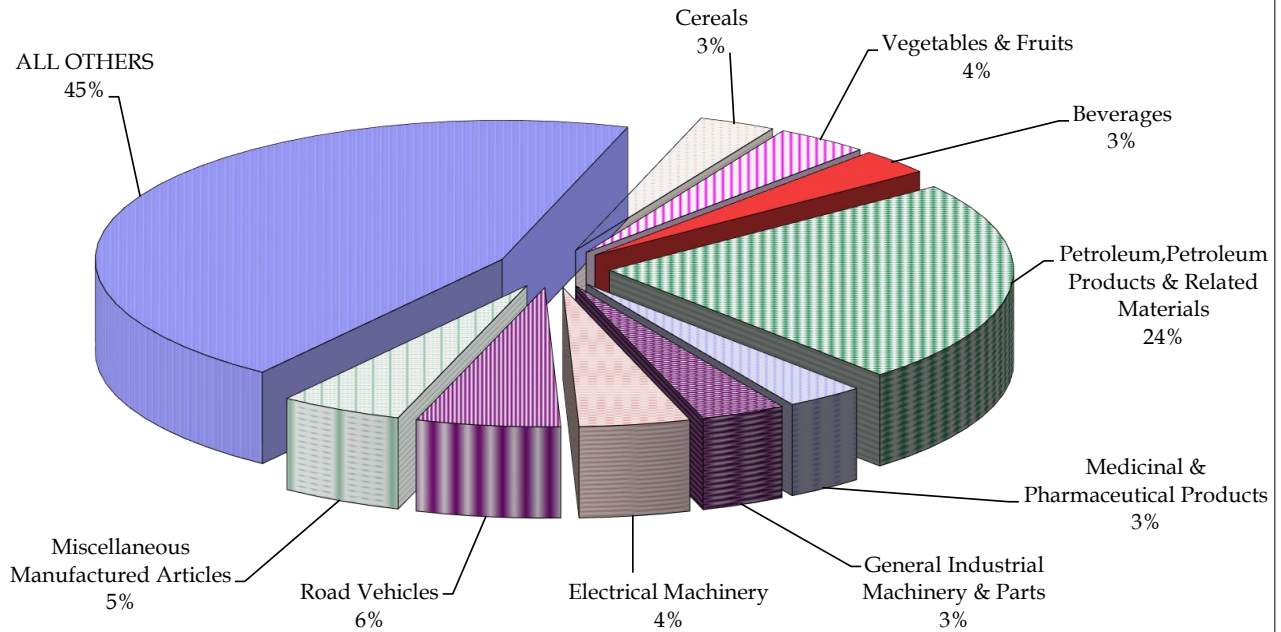

## Principal Domestic Exports January - June 2019

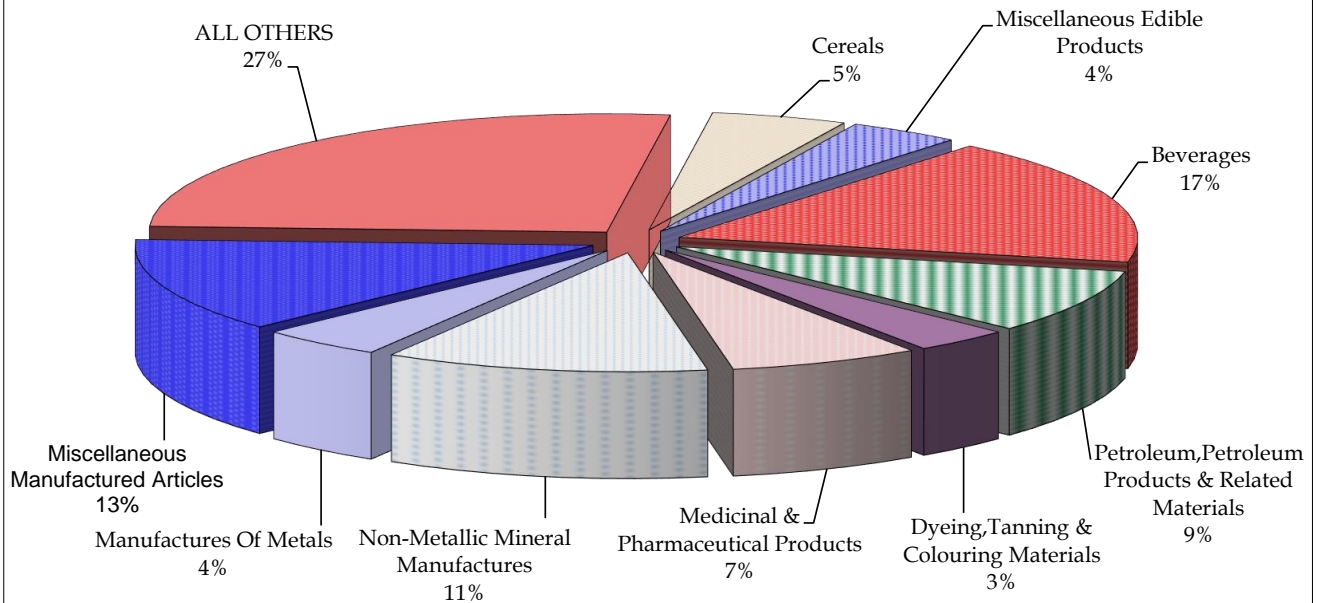

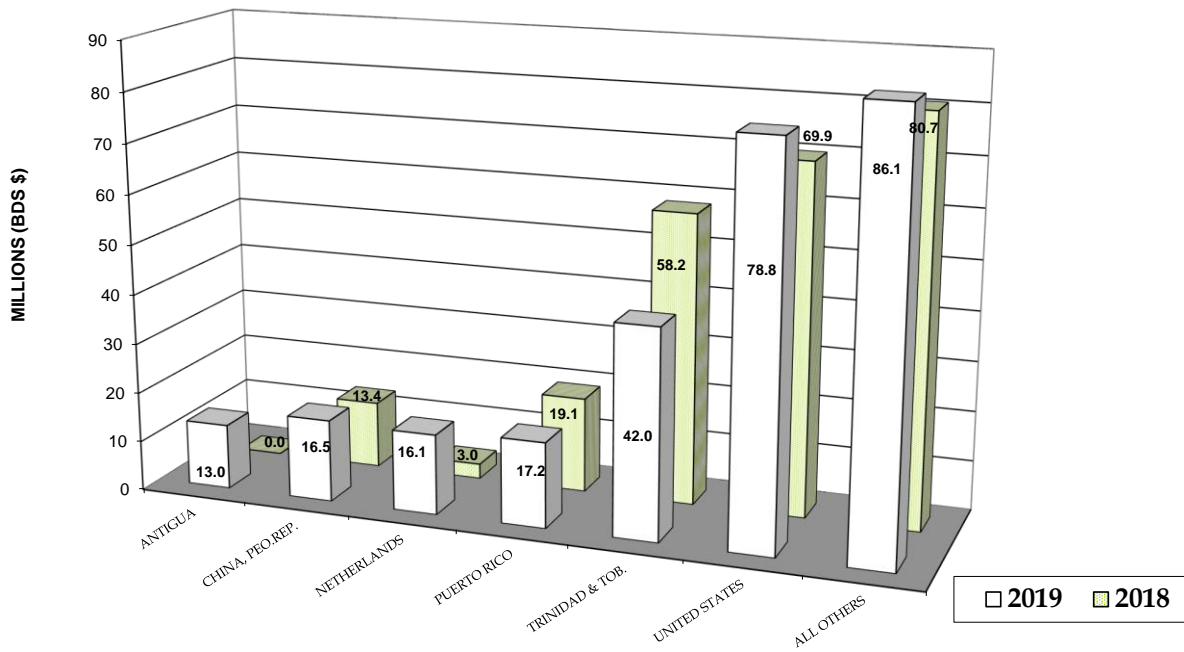

JUNE 2019 WITH THE CORRESPONDING MONTH OF 2018

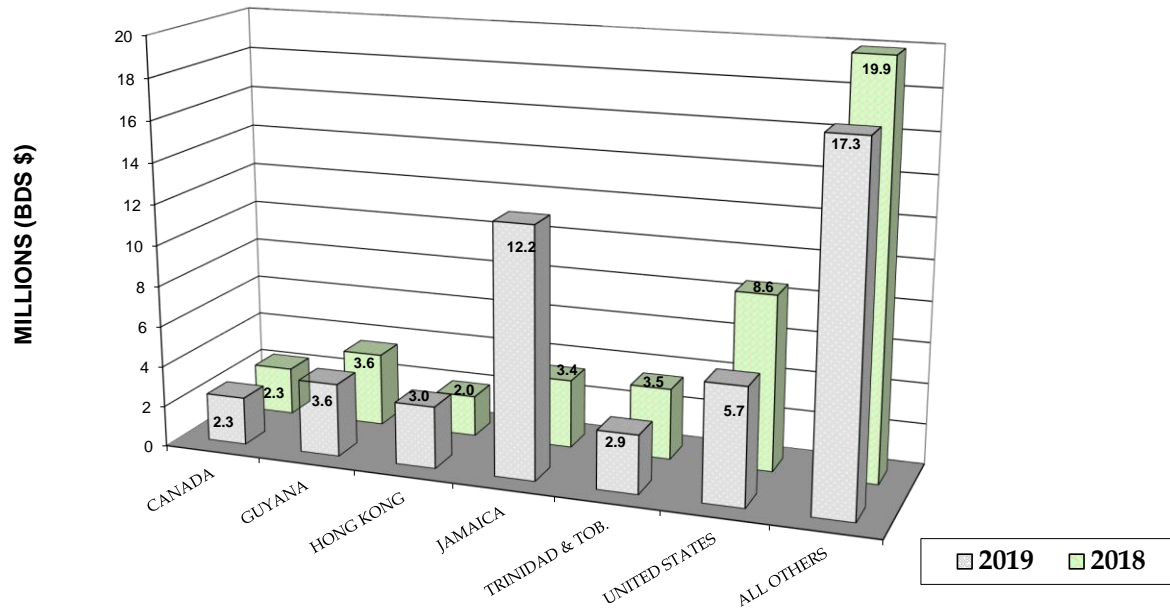


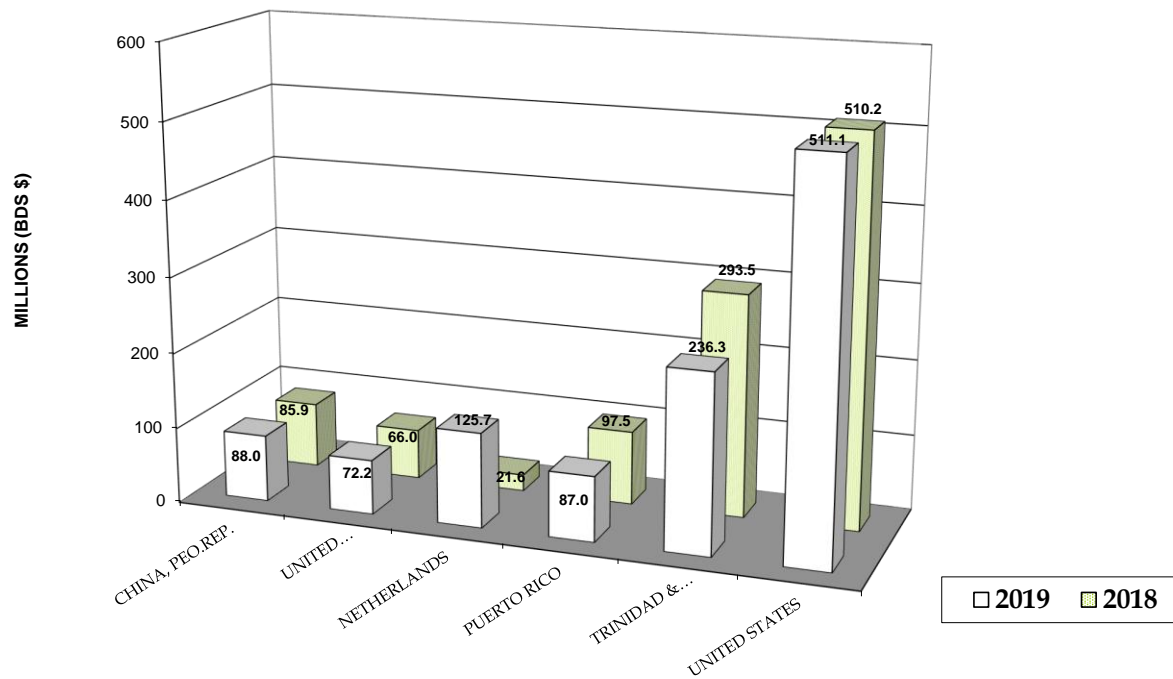

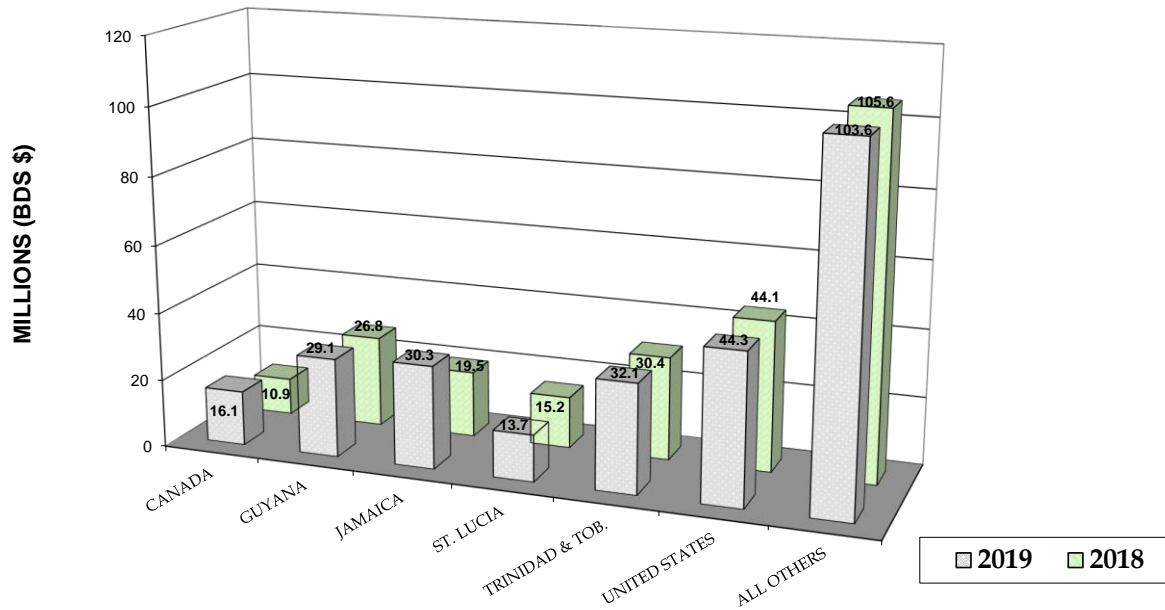

JUNE 2019 WITH THE CORRESPONDING MONTH OF 2018

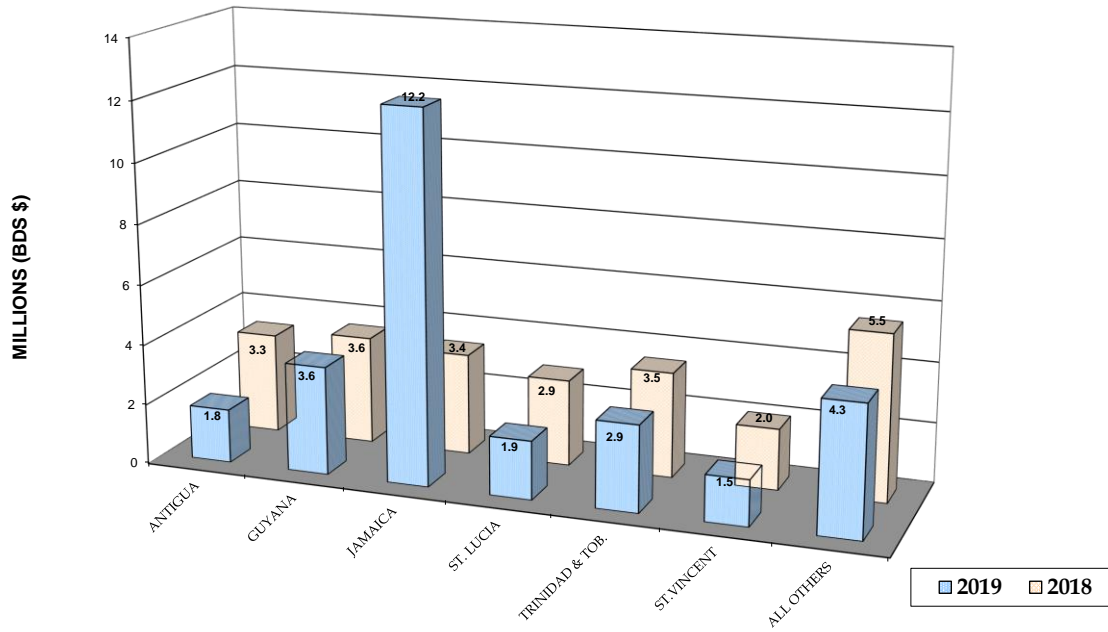


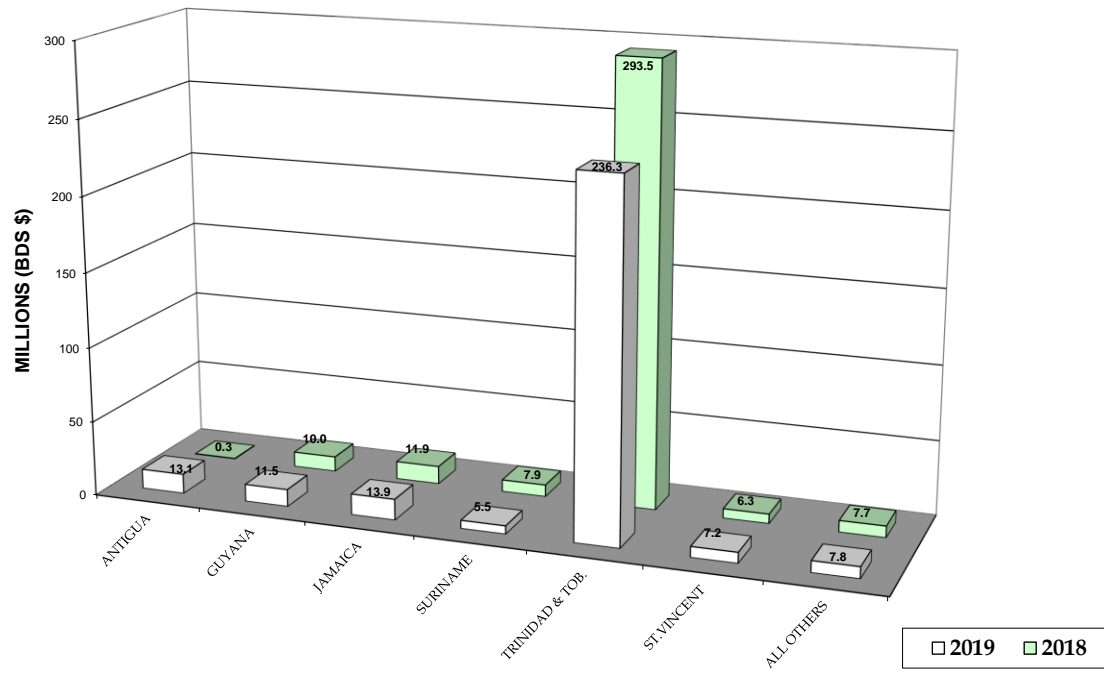

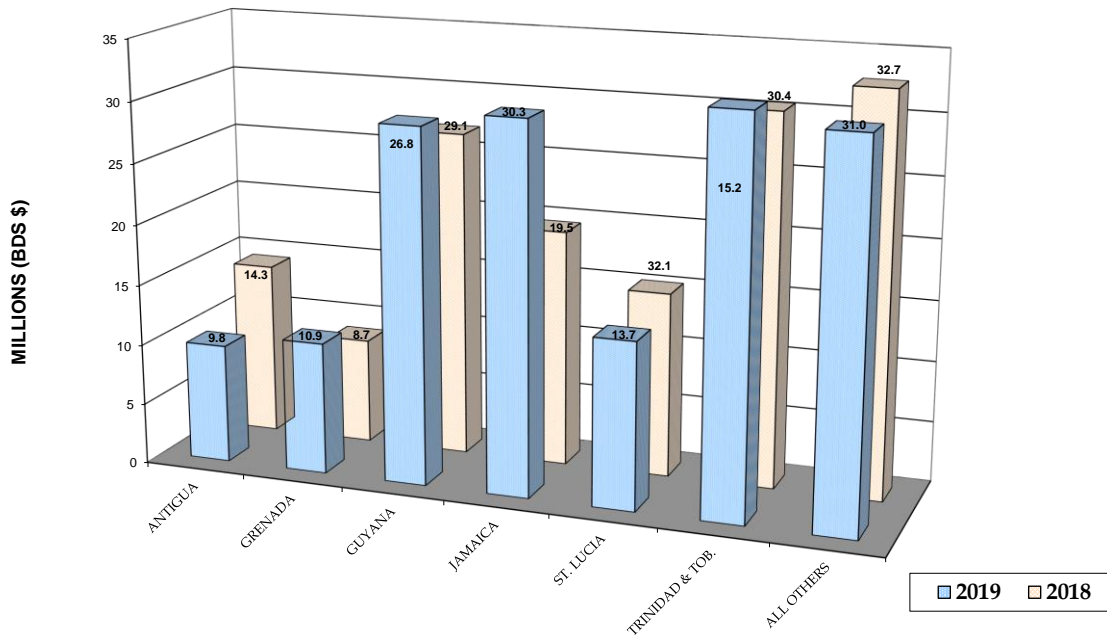
