## **REVIEW OF OVERSEAS TRADE**

During the month of March 2018, total imports to Barbados were valued at \$261.8 million, whilst total exports from Barbados were valued at \$78.5 million. This resulted in a visible trade deficit of \$183.3 million, as compared with a visible trade deficit of \$185.2 for March 2017.

Imports for March 2018 were \$4.7 million less than imports for March 2017, a decrease of 1.7%. Total exports decreased by \$2.7 million or 3.4% of the March 2017 figure. Domestic exports decreased by \$0.0 million or 0.0% over March 2017, while the value of re-exports decreased by \$2.7million or 6.4% over the corresponding period 2017.

For the period January – March 2018, the value of imports to Barbados was \$766.6 million, whilst the value of total exports was \$250.8 million representing an accumulated visible trade deficit of \$515.8 million as compared to a similar deficit of \$531.4 million for January – March 2017.

Imports for January – March 2018 were \$24.9 million less than imports for the same period 2017, a decrease of 3.1%. Total exports showed a decrease of some \$9.3 million or 3.6% over the January - March 2017 figure. Domestic exports increased by \$8.8 million or 7.7% over January – March 2017. The value of re-exports decreased by \$18.1 million or 12.4% over the corresponding period 2017.

## **CARICOM TRADE**

During the month of March 2018, total imports from CARICOM countries were valued at \$61.4 million, whilst total exports to CARICOM were valued at \$26.8 million, resulting in a trade deficit of \$34.6 million as compared with a visible trade deficit of \$20.8 million for March 2017.

Total CARICOM imports for March 2018 were \$14.5 million more than CARICOM imports for March 2017, an increase of 30.8%. Total exports to CARICOM for March 2018 were \$0.6 million more than total exports for March 2017, an increase of 2.5%. Domestic exports increased by \$2.5 million or 11.9 % over March 2017. The value of re-exports decreased by some \$1.9 million, or 36.4%, over the March 2017 figure.

For the period January – March 2018, total imports from CARICOM were valued at \$158.4million, whilst total exports were \$82.8 million resulting in an accumulated visible trade deficit of \$75.6 million as compared with a deficit of \$85.5 million for the same period of 2017.

During this period, CARICOM imports were approximately \$7.8 million less than those over the same period in 2017, a decrease of 4.7%. Total exports to CARICOM for January – March 2018 were \$2.2 million more than total exports for the corresponding period 2017, an increase of 2.7%. Domestic exports increase by approximately \$10.7 million or 17.1% over the same period 2017. The value of re-exports decreased by \$8.5 million or 46.5% over the January – March 2017 figure.

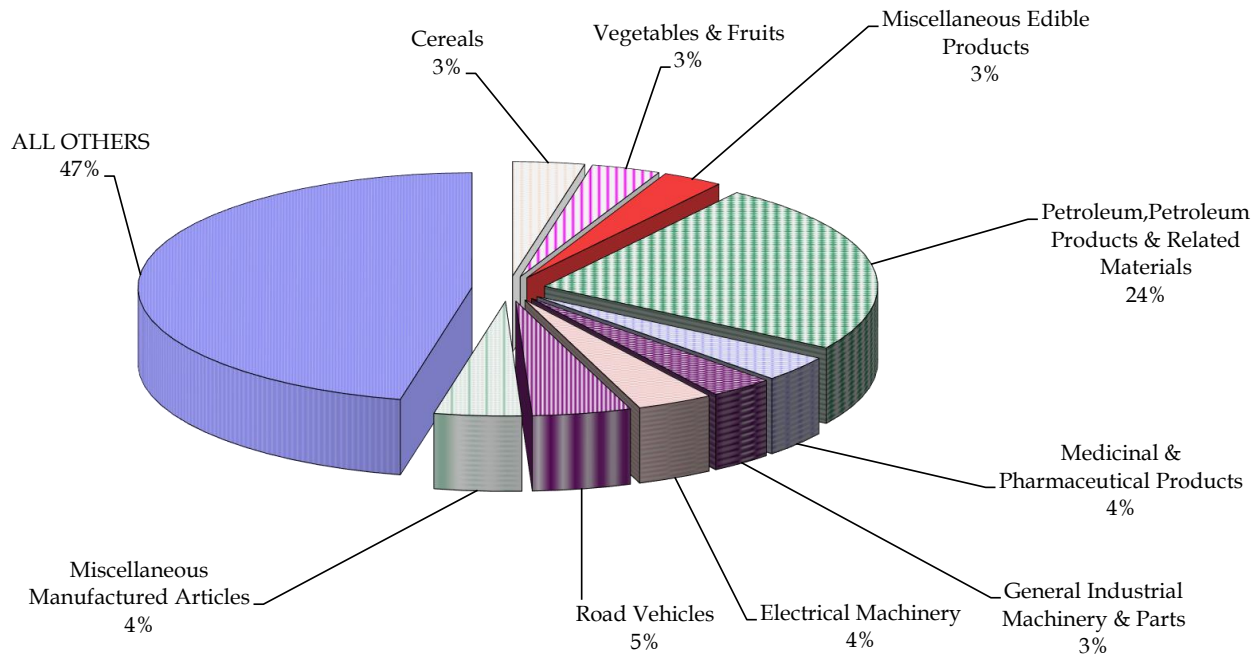

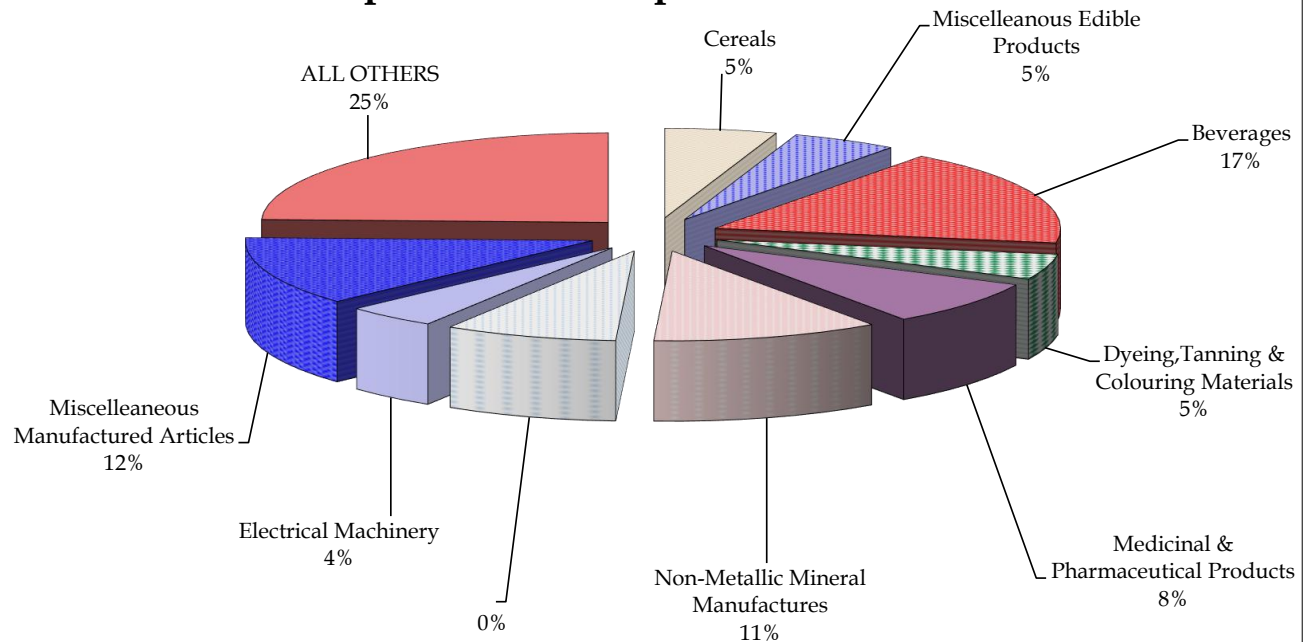

### Principal Domestic Exports - March 2018



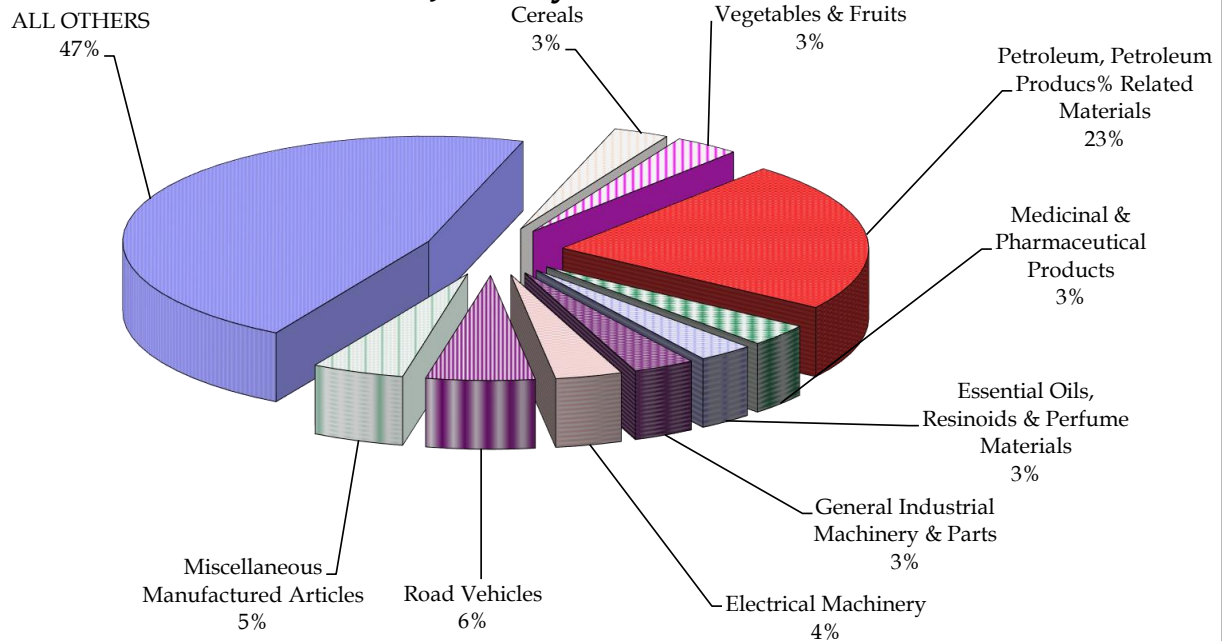

## Principal Domestic Exports January - March 2018

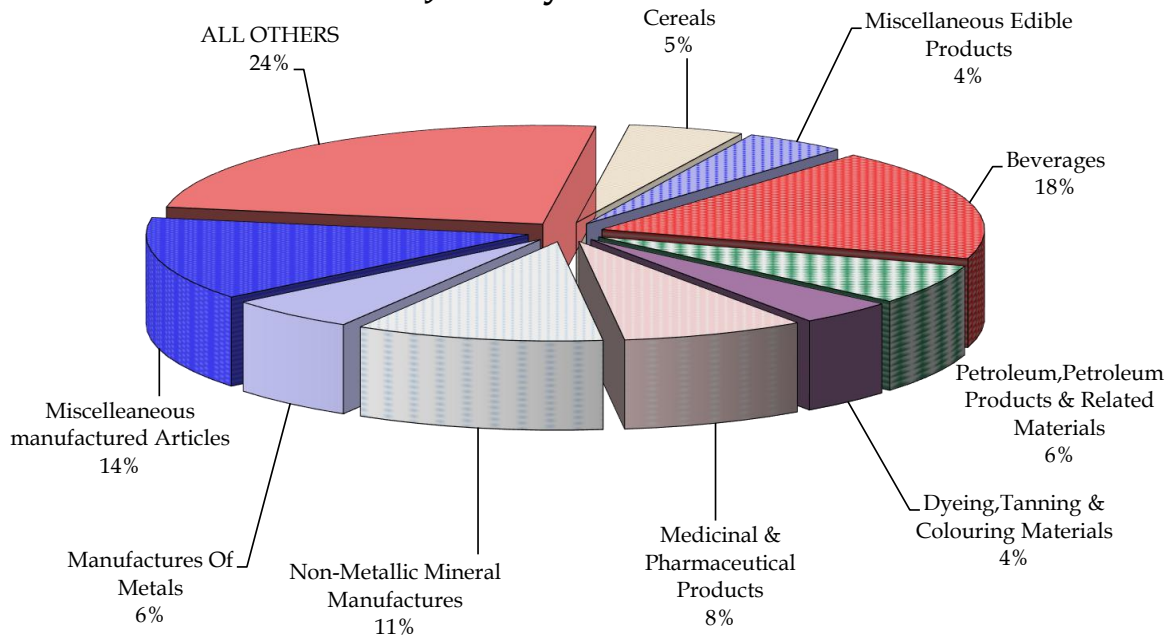

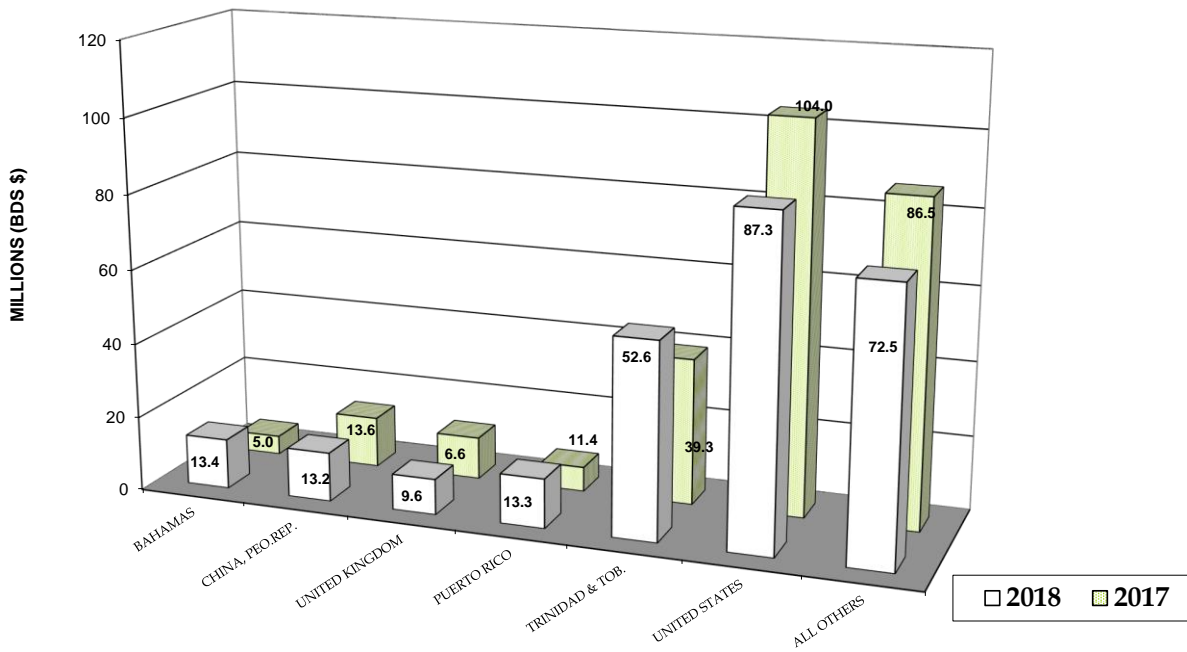

MARCH 2018 WITH THE CORRESPONDING MONTH OF 2017

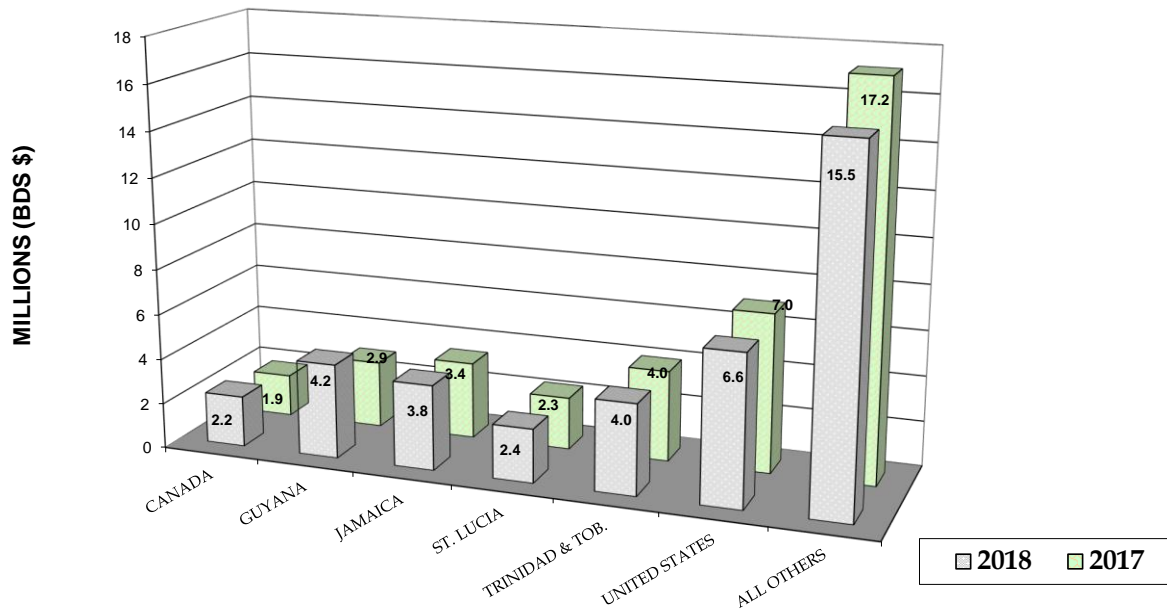


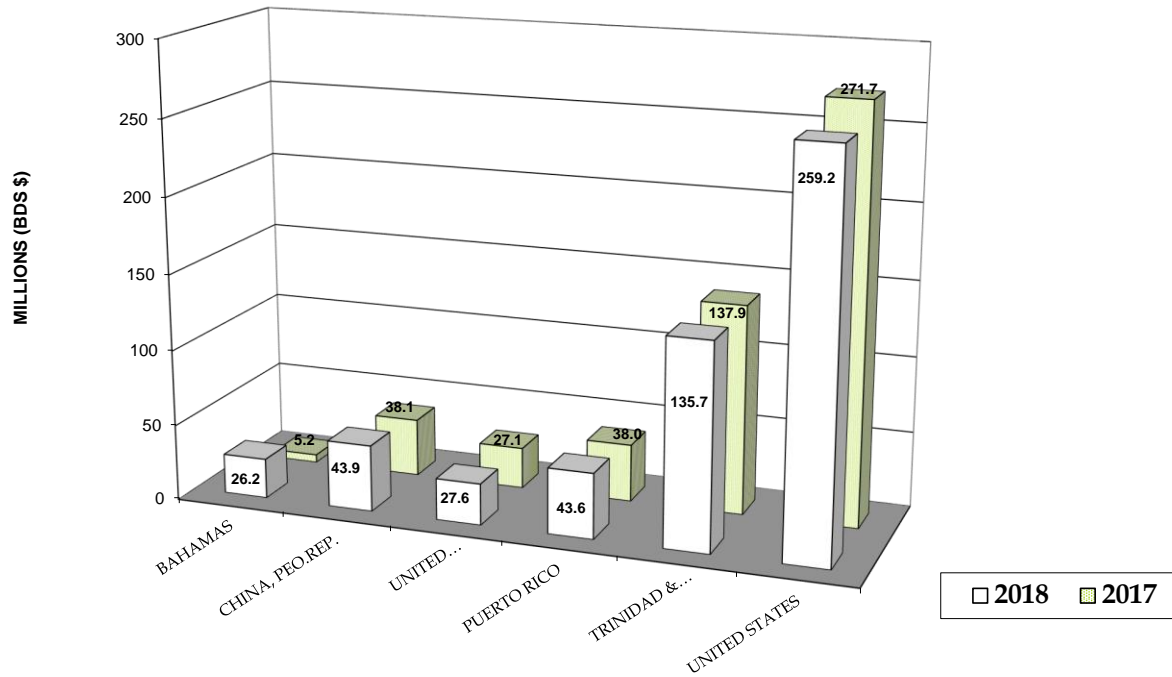

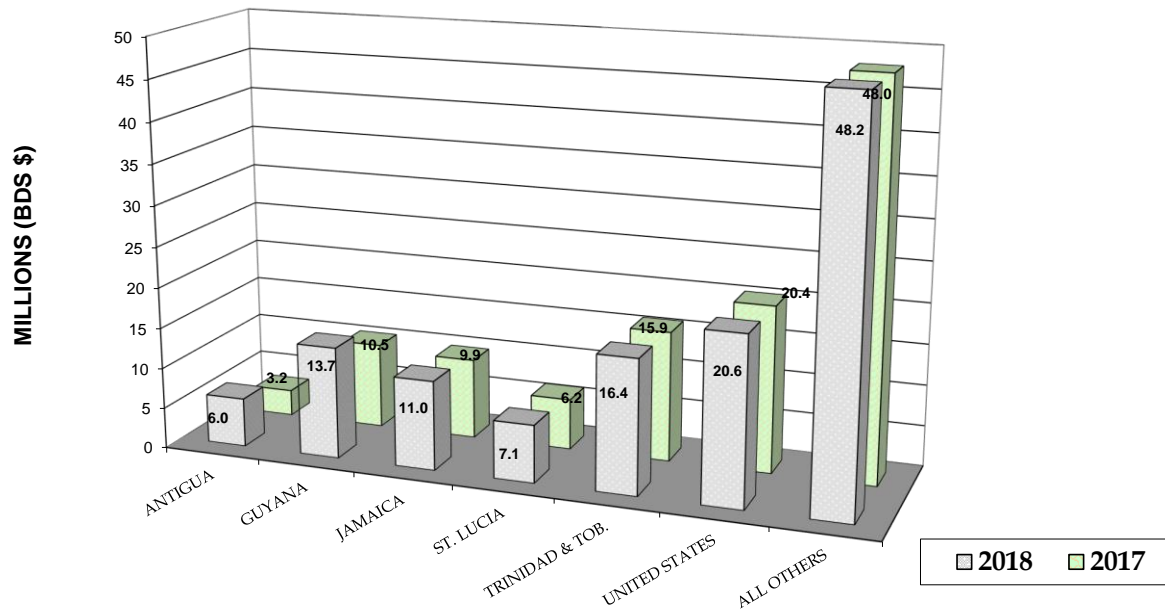

MARCH 2018 WITH THE CORRESPONDING MONTH OF 2017

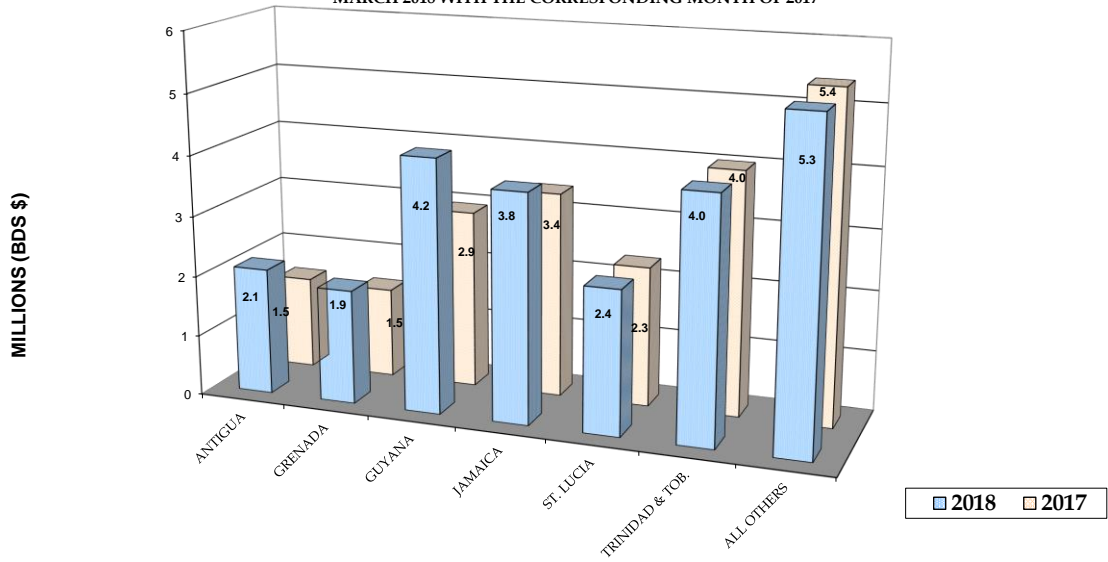


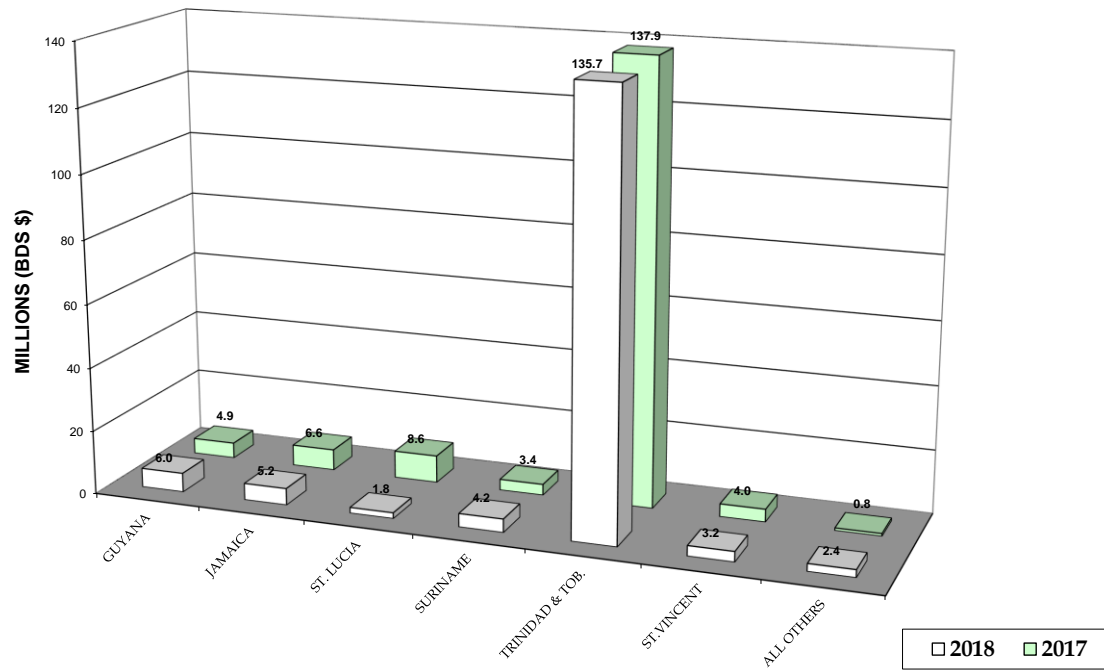

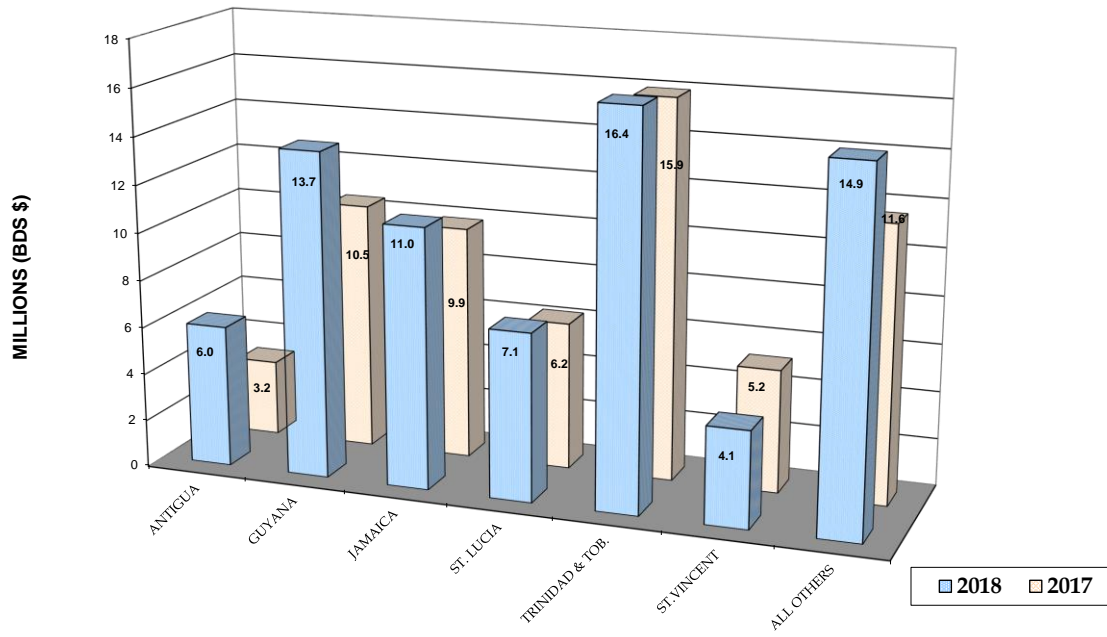
