OCTOBER 2012

REVIEW OF OVERSEAS TRADE

During the month of October 2012, imports to Barbados were valued at \$348.3 million whilst total exports from Barbados were valued at \$76.2 million. This resulted in a visible trade deficit of \$272.2 million, compared with a visible trade deficit of \$88.6 million for October 2011.

Imports for October 2012 were \$95.8 million more than imports recorded for October 2011, an increase of 37.9%. Total exports decreased in value by some \$87.8 million, or 53.6% of the October 2011 figure. This was as a result of a decrease recorded in re-exports of \$97.5 million, or 78.3%, while the value of domestic exports increased by \$9.6 million, or 24.4%, in comparison with the corresponding month in 2011.

For the period January – October 2012, the value of imports to Barbados was \$2,882.9 million, whilst the value of total exports was \$983.3 million. This resulted in an accumulated visible trade deficit of \$1,899.6 million as compared to a similar deficit of \$2,060.9 million for January - October 2011.

Imports for January - October 2012 were \$26.9 million less than imports for the corresponding period in 2011, a decline of 0.9%. Total exports increased in value by some \$134.4 million, or 15.8%, over the January - October 2011 figure. This was as a result of increases recorded in domestic exports of \$72.3 million, or 16.6%, and in the value of re-exports of \$62.1 million, or 15.0%, in comparison with the corresponding period in 2011.

CARICOM TRADE

During the month of October 2012, imports from CARICOM countries were valued at \$118.2 million whilst total exports to CARICOM countries were valued at \$33.4 million. This resulted in a visible trade deficit of \$84.8 million, compared with a visible trade surplus of \$95.6 million for October 2011.

CARICOM imports for October 2012 were \$92.8 million more than CARICOM imports for October 2011, an increase of 365.4%. Total exports to CARICOM countries for October 2012 decreased in value by \$87.6 million, or 72.4%, of the total exports figure for October 2011. This decrease in exports came as a result of a decline recorded in re-exports of \$100.8 million, or 96.2%, while the value of domestic exports increased by \$13.2 million, or 81.4%, in comparison with the corresponding month in 2011.

For the period January – October 2012, total imports from CARICOM countries were valued at \$1,064.3 million whilst total exports to CARICOM countries were valued at \$265.5 million. This resulted in an accumulated visible trade deficit of \$798.8 million, compared with a deficit of \$682.5 million for the period January – October 2011.

During this period, CARICOM imports were approximately \$55.8 million more than those recorded over the same period in 2011, an increase of 5.5%. Total exports to CARICOM countries for the period January – October 2012 decreased in value by \$60.5 million, or 18.6%, of the total exports figure for the corresponding period in 2011. This decrease in exports came as a result of a decline recorded in re-exports of \$101.3 million, or 72.2%, while the value of domestic exports increased by \$40.8 million, or 21.9%, in comparison with the corresponding period in 2011.

OCTOBER 2012 WITH THE CORRESPONDING MONTH OF 2011

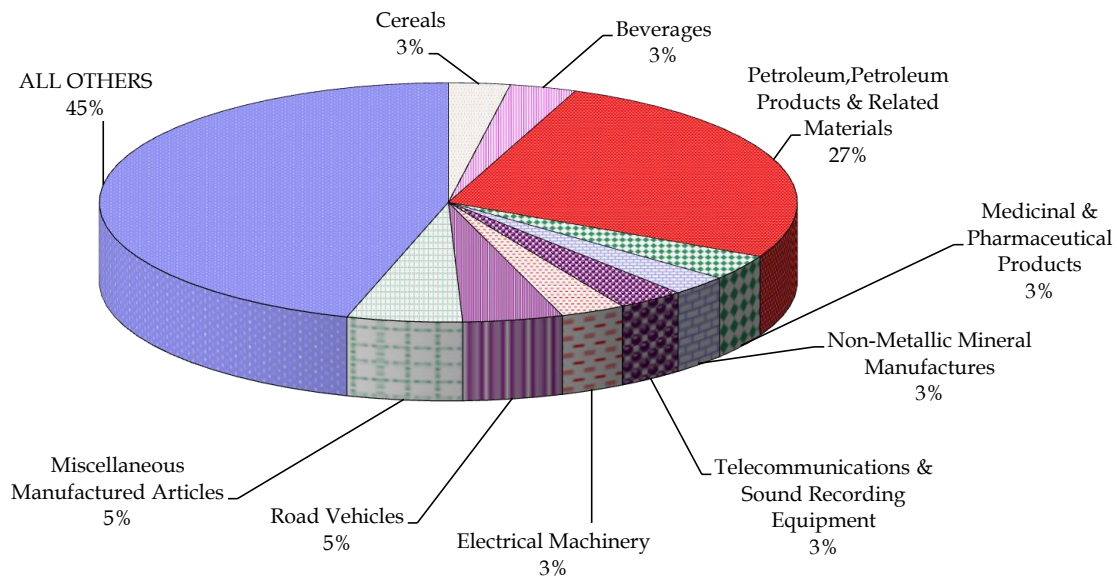

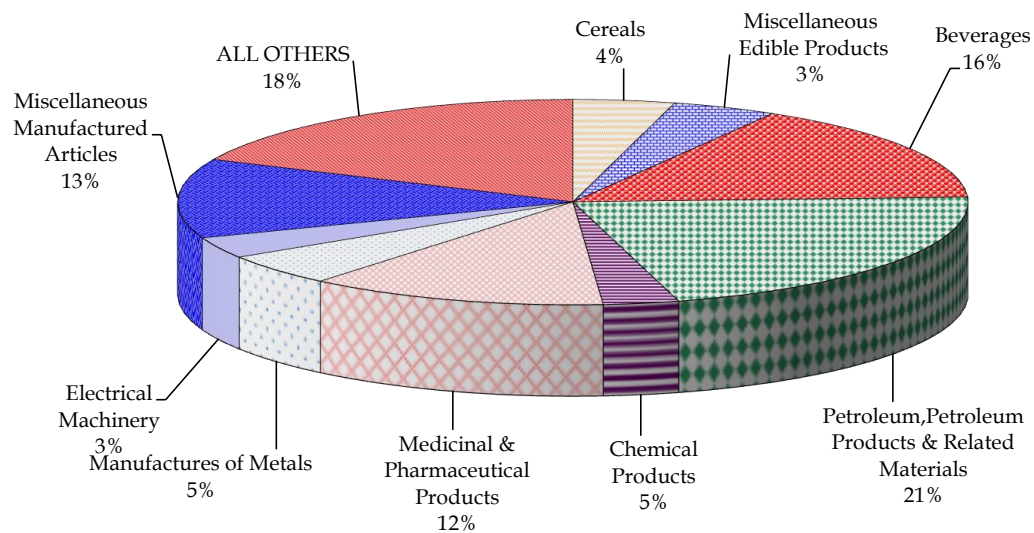

Principal Domestic Exports - October 2012



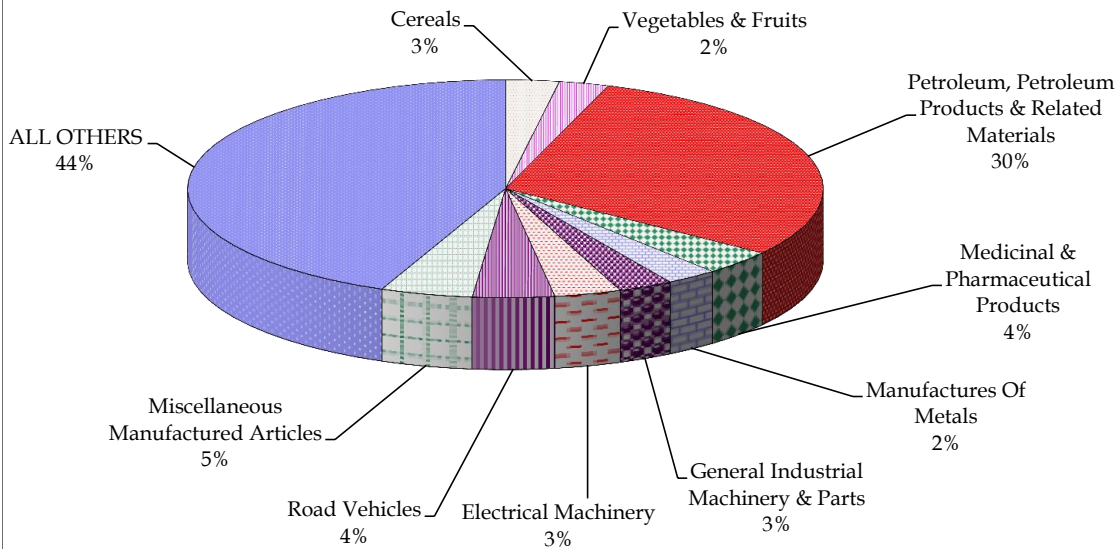

Principal Domestic Exports January - October 2012

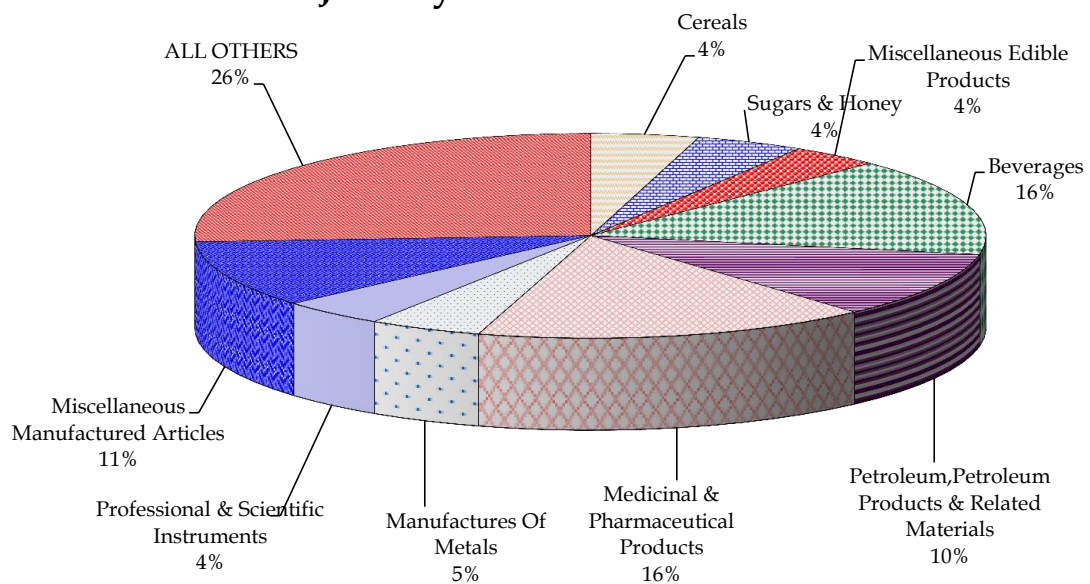

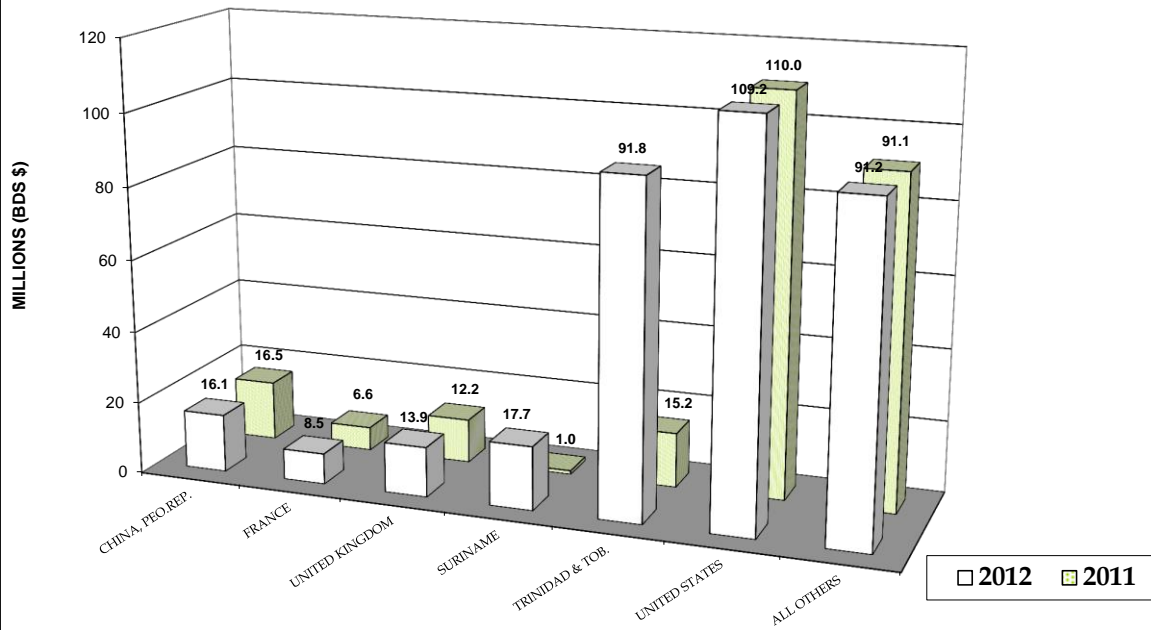

OCTOBER 2012 WITH THE CORRESPONDING MONTH OF 2011

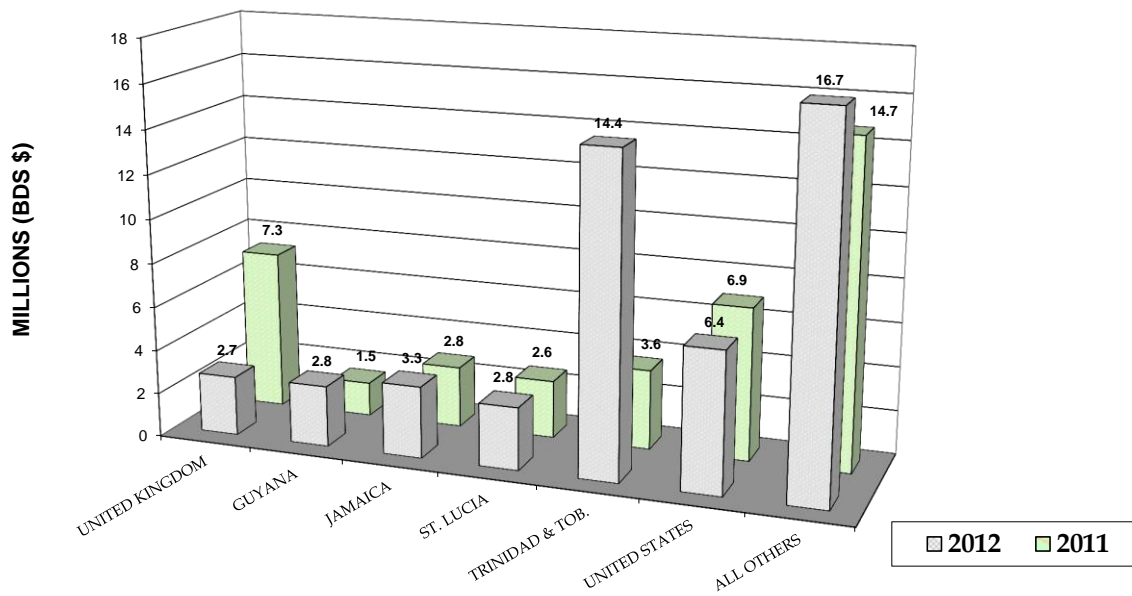

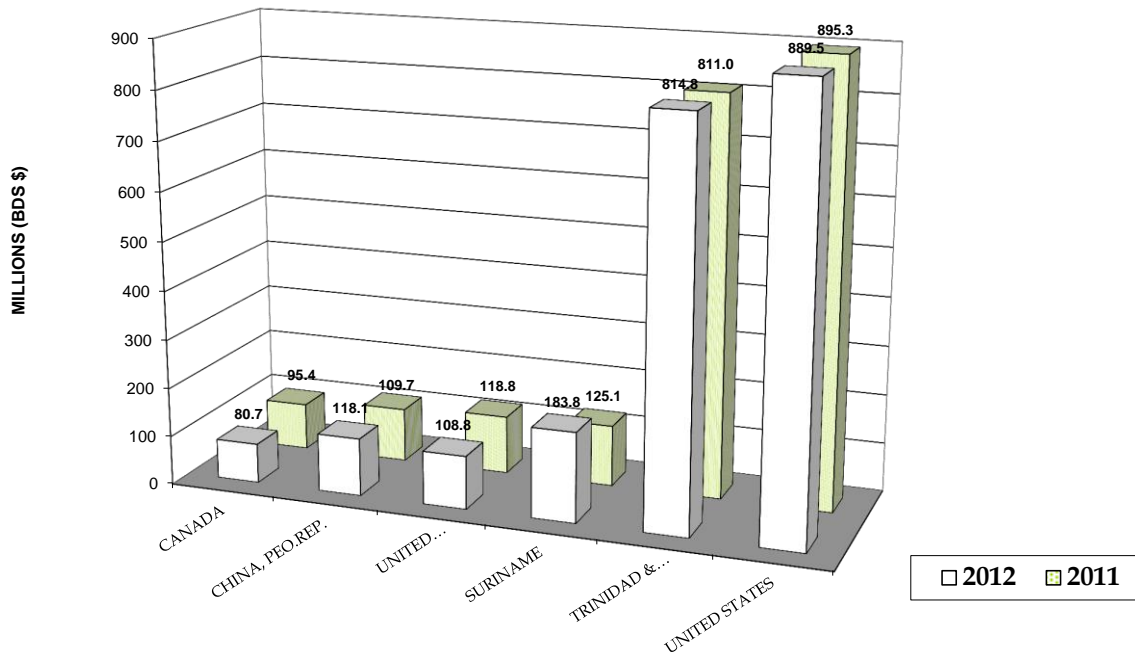

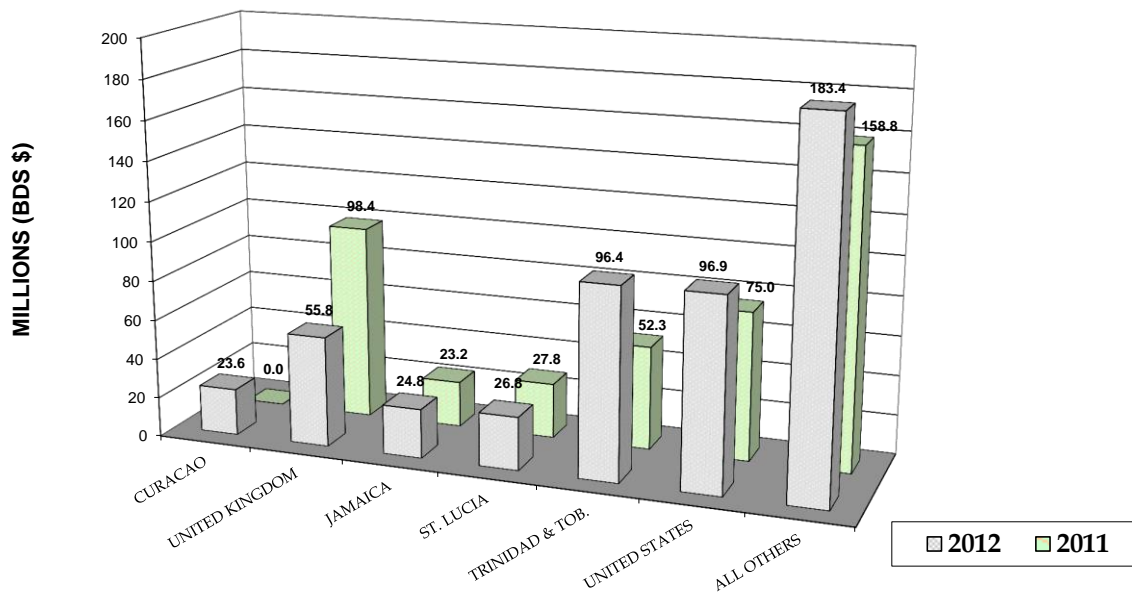

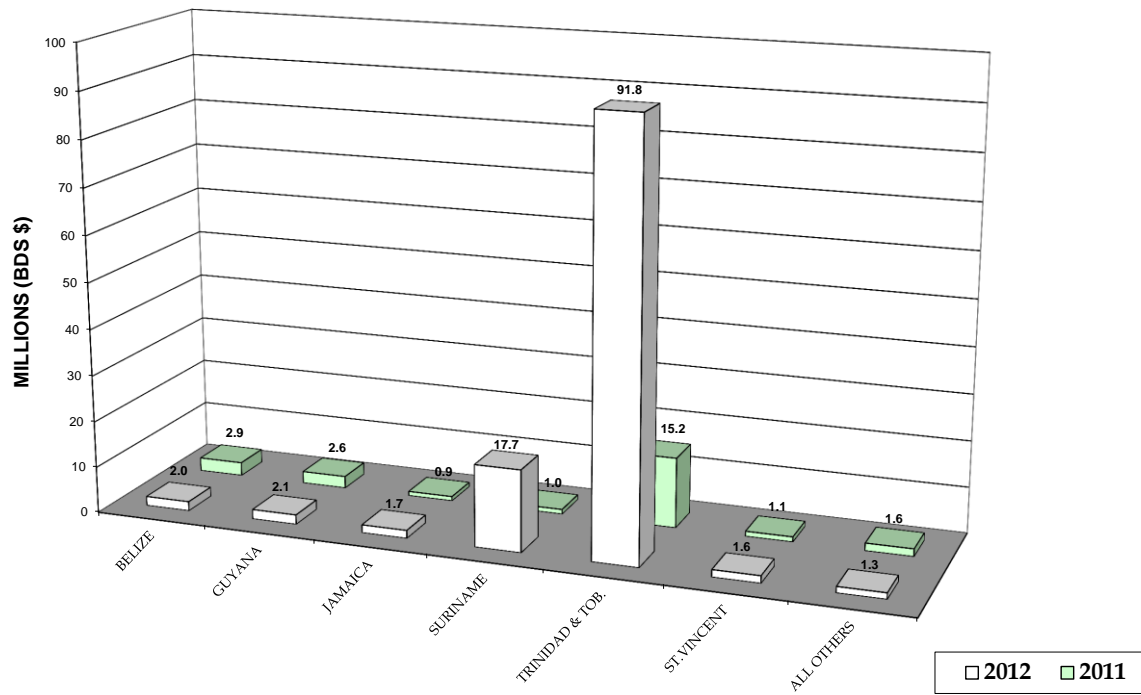

OCTOBER 2012 WITH THE CORRESPONDING MONTH OF 2011

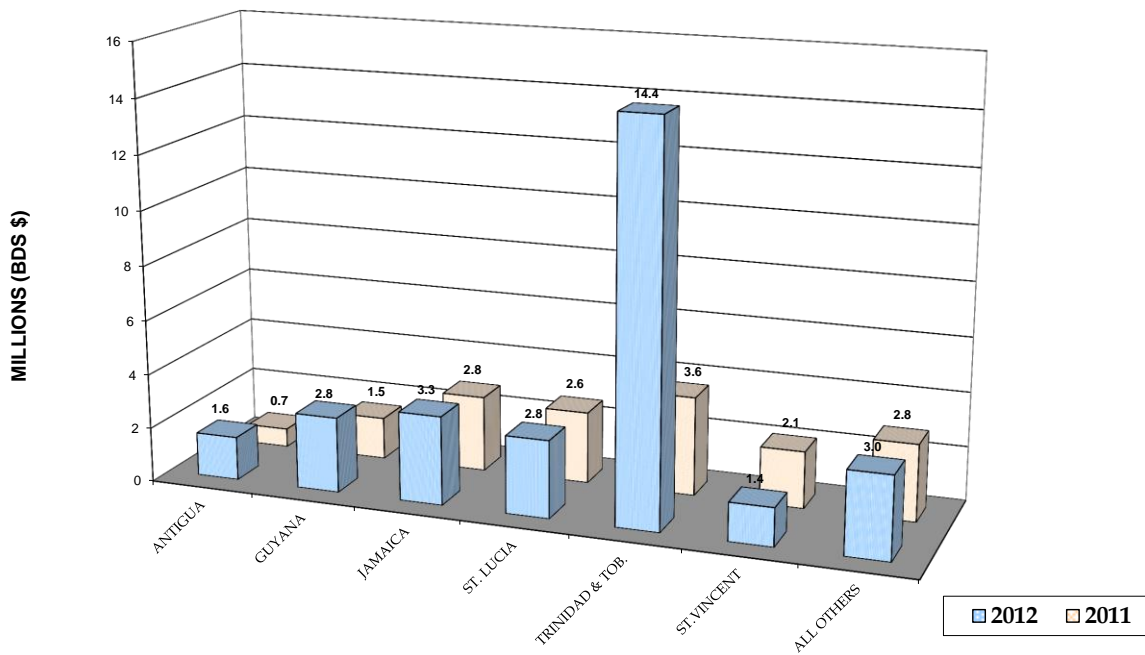

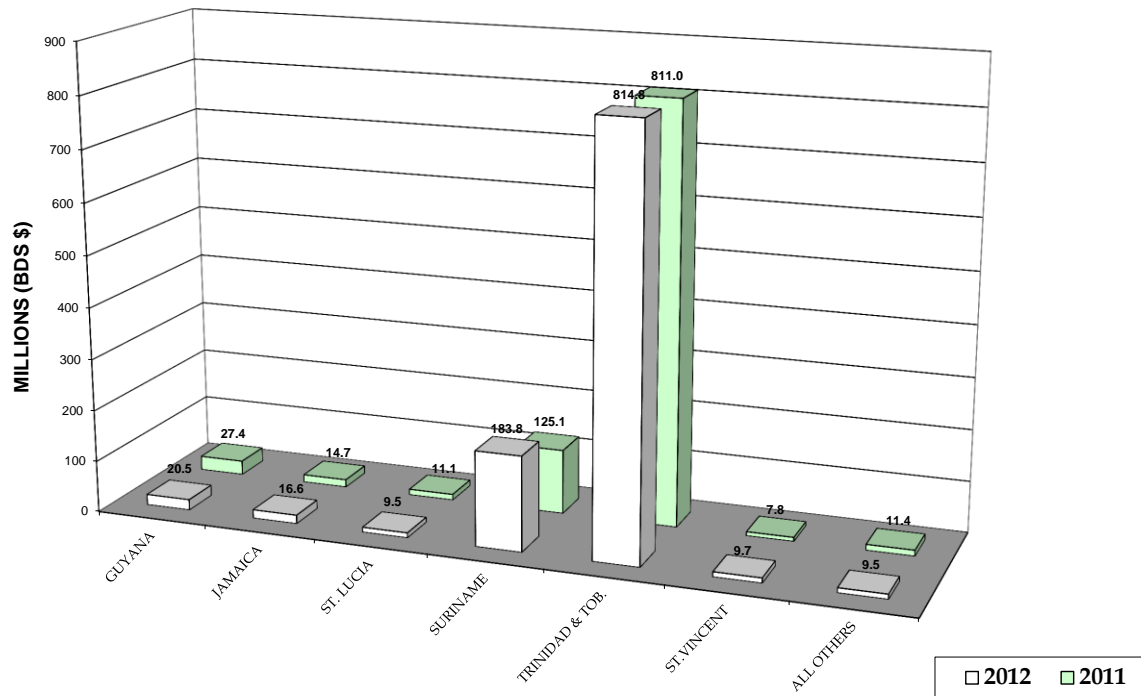

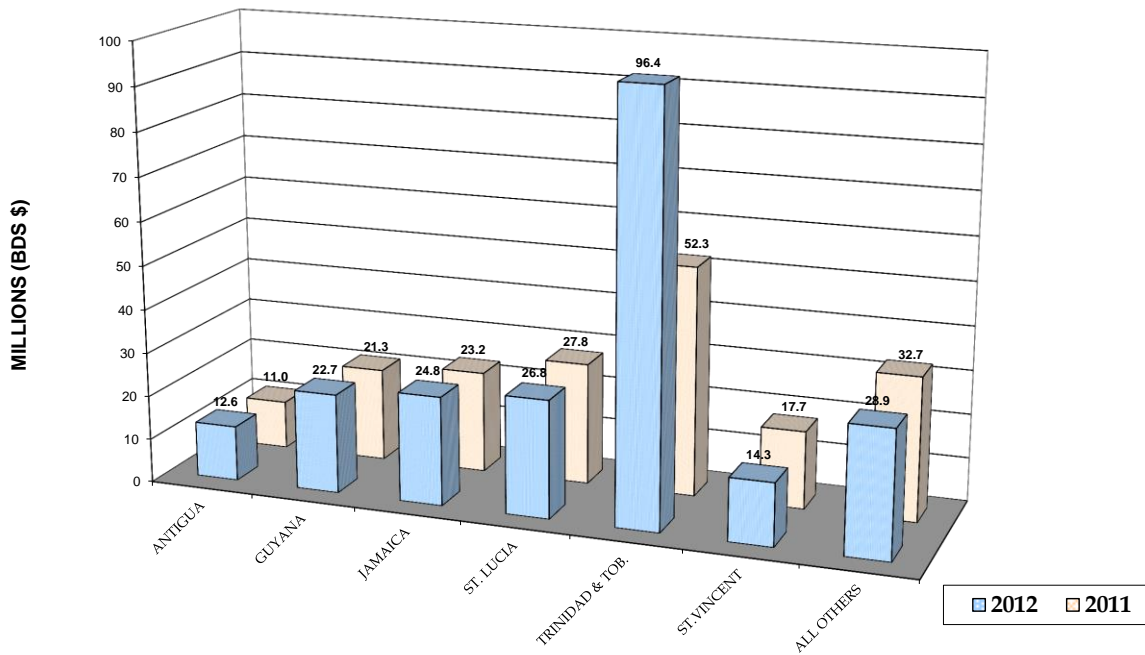
