REVIEW OF OVERSEAS TRADE

During the month of October 2014, total imports to Barbados were valued at \$335.7 million, whilst total exports from Barbados were valued at \$83.8 million. This resulted in a visible trade deficit of \$251.9 million, as compared with a visible trade deficit of \$238.9 for October 2013.

Imports for October 2014 were \$10.8 million more than imports for October 2013, an increase of 3.3%. Total exports decreased by \$2.8 million or 3.2% of the October 2013 figure. Domestic exports increased by \$1.9 million or 3.3% over October 2013, while the value of re-exports increased by \$2.8 million or 3.2% over the corresponding period 2013.

For the period January – October 2014, the value of imports to Barbados was \$2.9 billion, whilst the value of total exports was \$760.4 million representing an accumulated visible trade deficit of \$2.16 billion as compared to a similar deficit of \$2.12 billion for January – October 2013.

Imports for January – October 2014 were \$30.0 million more than imports for the same period 2013, an increase of 1.0%. Total exports showed a decrease of some \$15.4 million or 2.0% over the January - October 2013 figure. Domestic exports increased by \$2.0 million or 0.4% over January – October 2013. The value of re-exports decreased by \$17.4 million or 5.5% over the corresponding period 2013.

CARICOM TRADE

During the month of October 2014, total imports from CARICOM countries were valued at \$57.1 million, whilst total exports to CARICOM were valued at \$30.0 million, resulting in a trade deficit of \$27.1 million as compared with a visible trade deficit of \$75.6 million for October 2013.

Total CARICOM imports for October 2014 were \$43.7 million less than CARICOM imports for October 2013, a decrease of 43.4%. Total exports to CARICOM for October 2014 were \$4.8 million more than total exports for October 2013, an increase of 18.9%. Domestic exports increased by \$5.1 million or 24.3% over October 2013. The value of re-exports declined by some \$0.3 million, or 7.4%, over the October 2013 figure.

For the period January – October 2014, total imports from CARICOM were valued at \$869.0 million, whilst total exports were \$267.4 million resulting in an accumulated visible trade deficit of \$601.6 million as compared with a deficit of \$705.0 million for the same period of 2013.

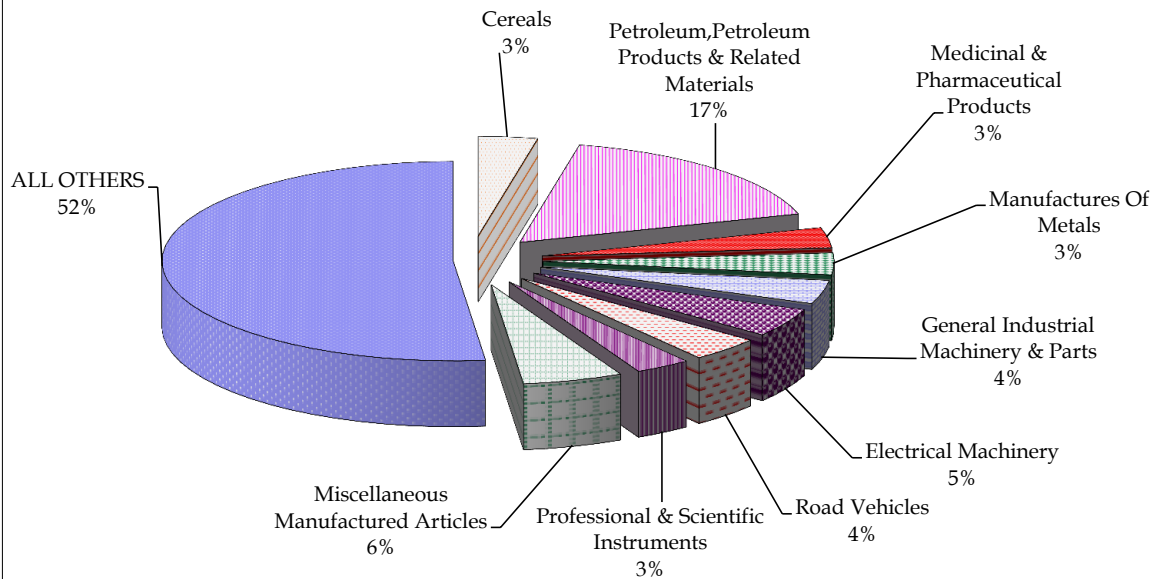
During this period, CARICOM imports were approximately \$116.1 million less than those over the same period in 2013, a decrease of 11.8%. Total exports to CARICOM for January – October 2014 were \$12.6 million less than total exports for the corresponding period 2013, a decrease of 4.5%. Domestic exports decreased by approximately \$6.9 million or 2.9% over the same period 2013. The value of re-exports decreased by \$5.7 million or 13.0% over the January – October 2013 figure.

OCTOBER 2014 WITH THE CORRESPONDING MONTH OF 2013

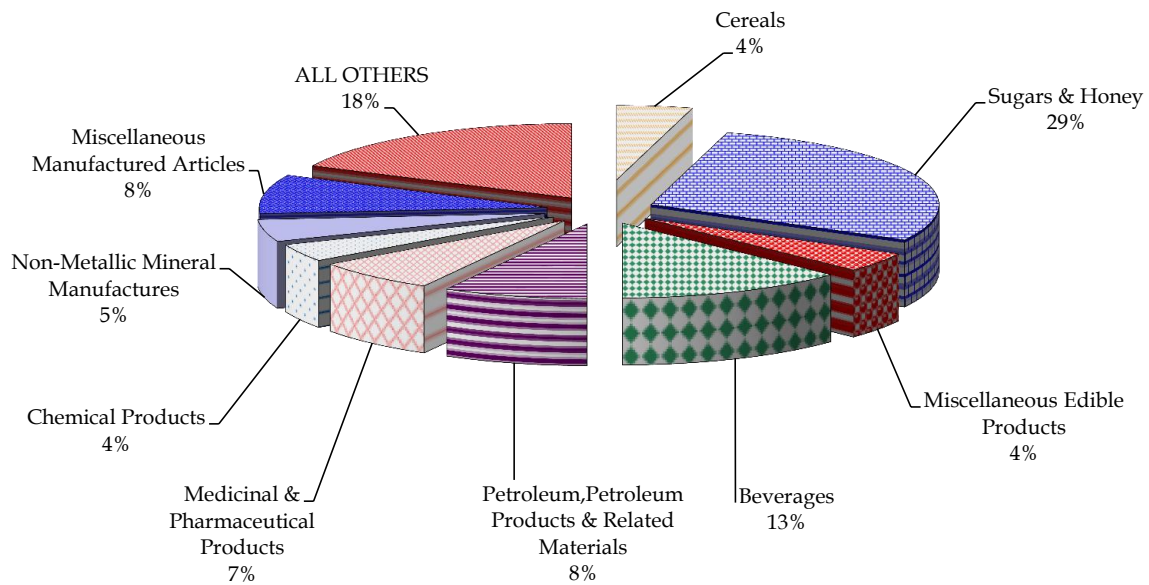

Principal Domestic Exports - October 2014



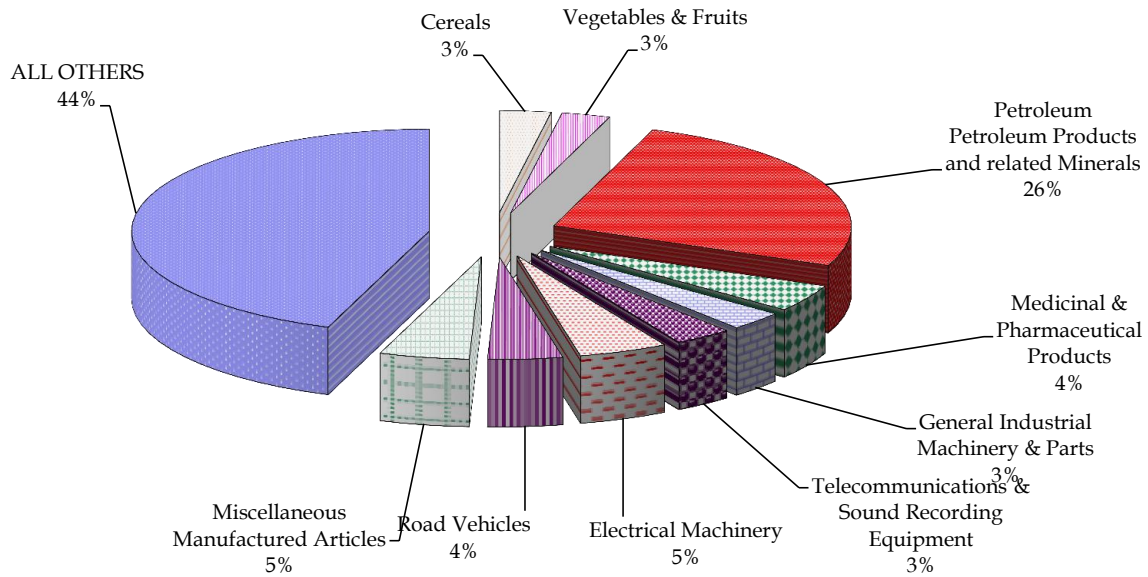

Principal Domestic Exports January- October 2014

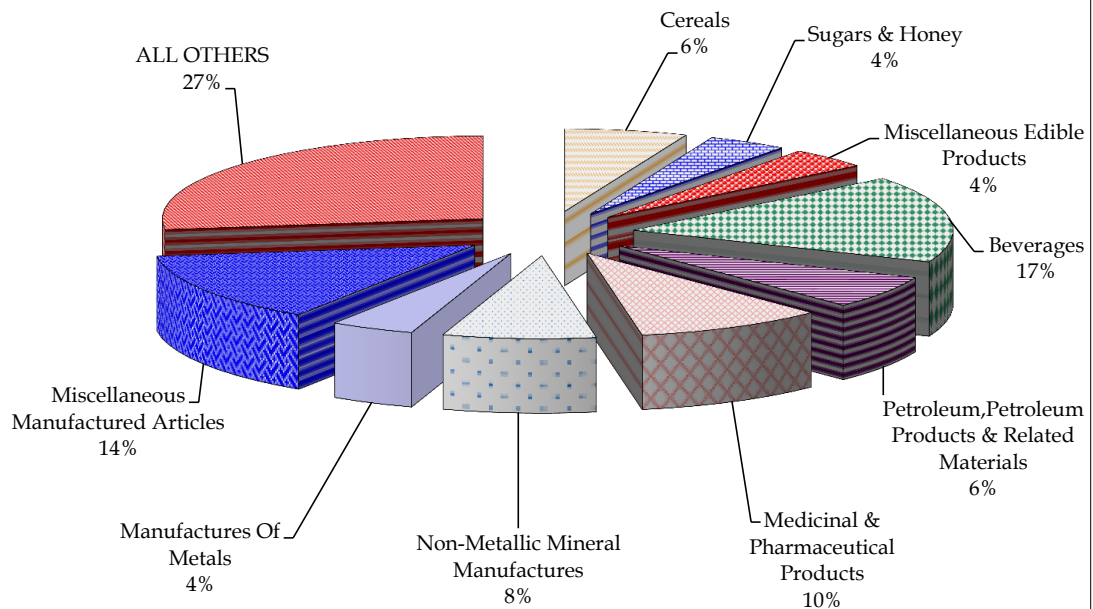

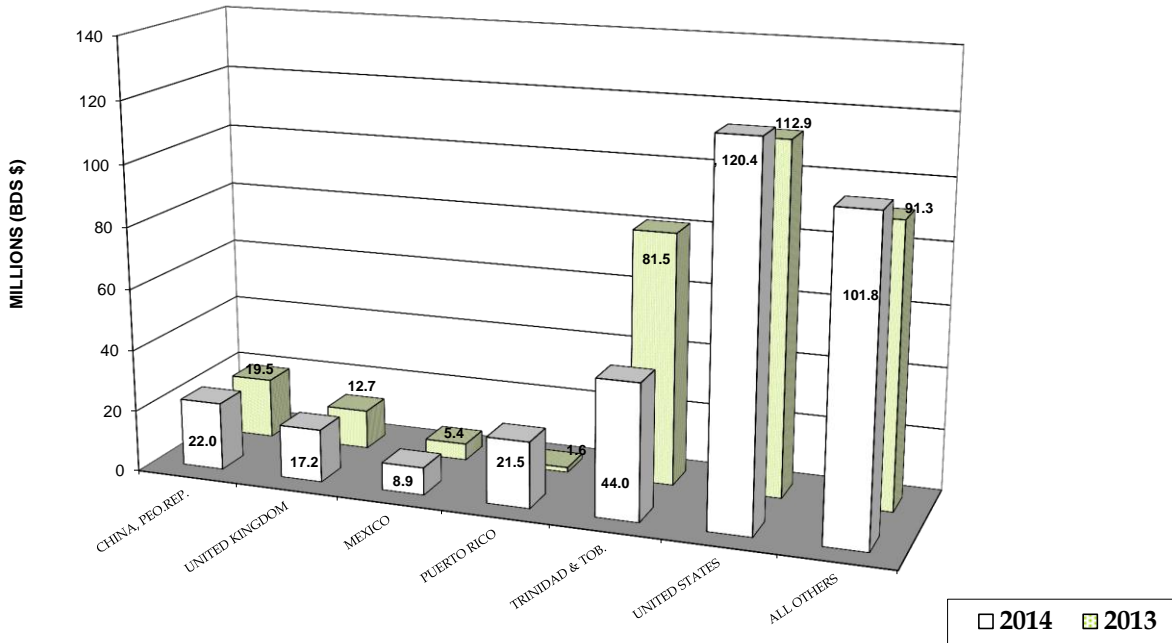

OCTOBER 2014 WITH THE CORRESPONDING MONTH OF 2013

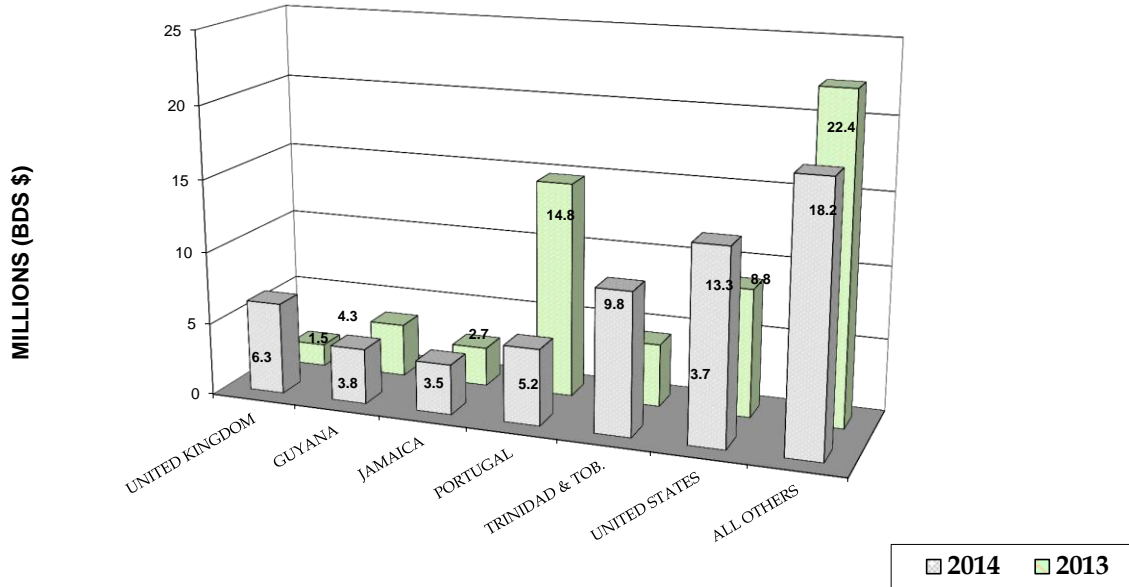


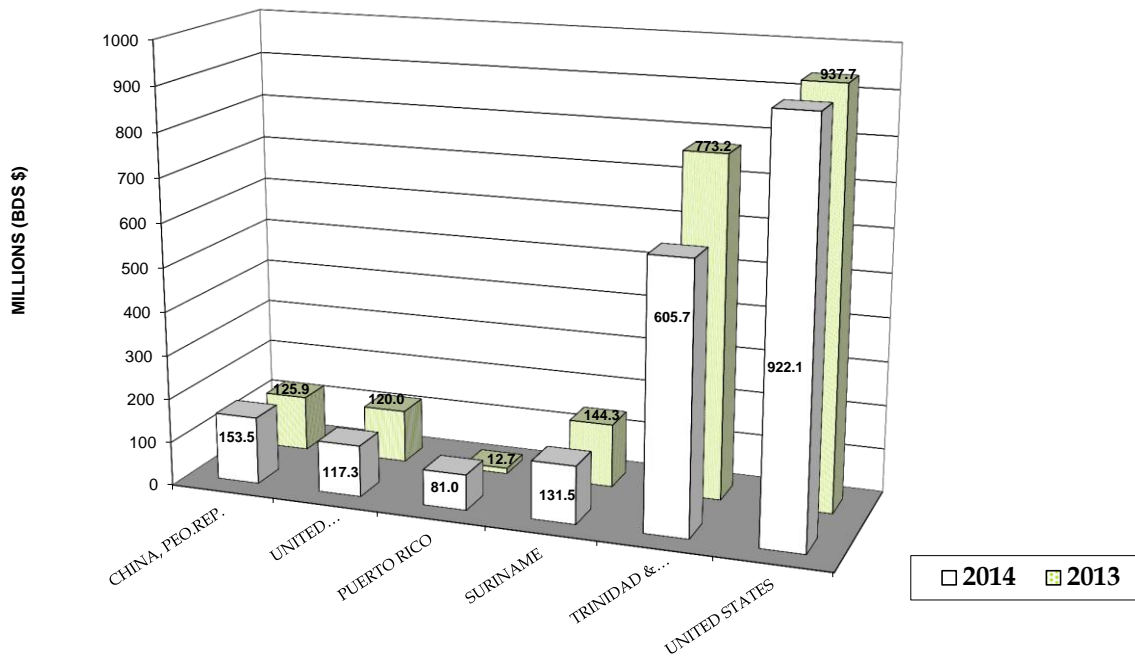

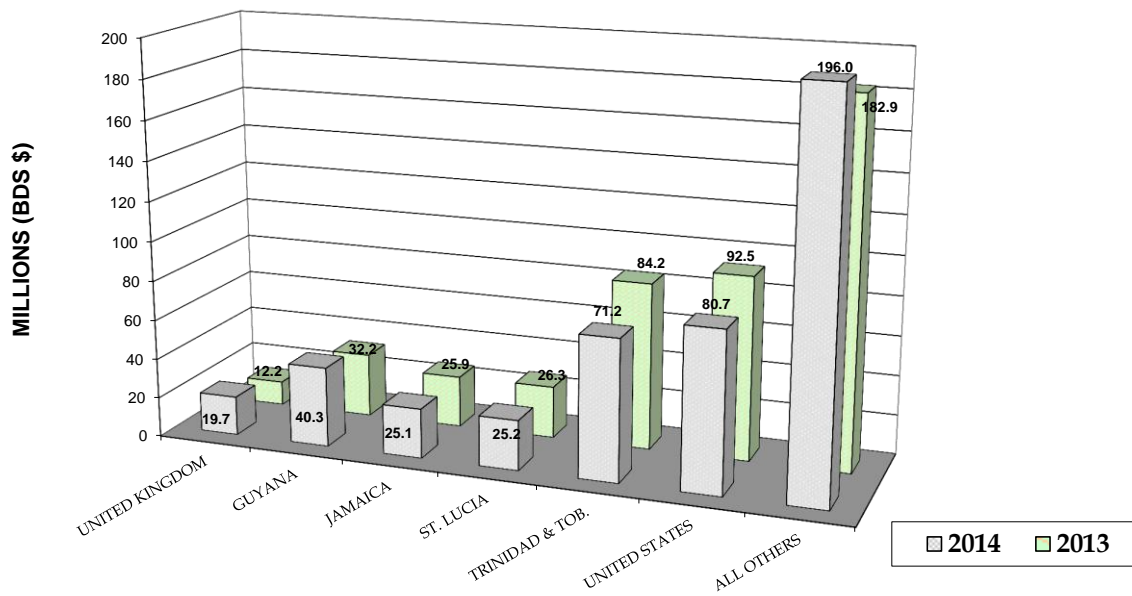

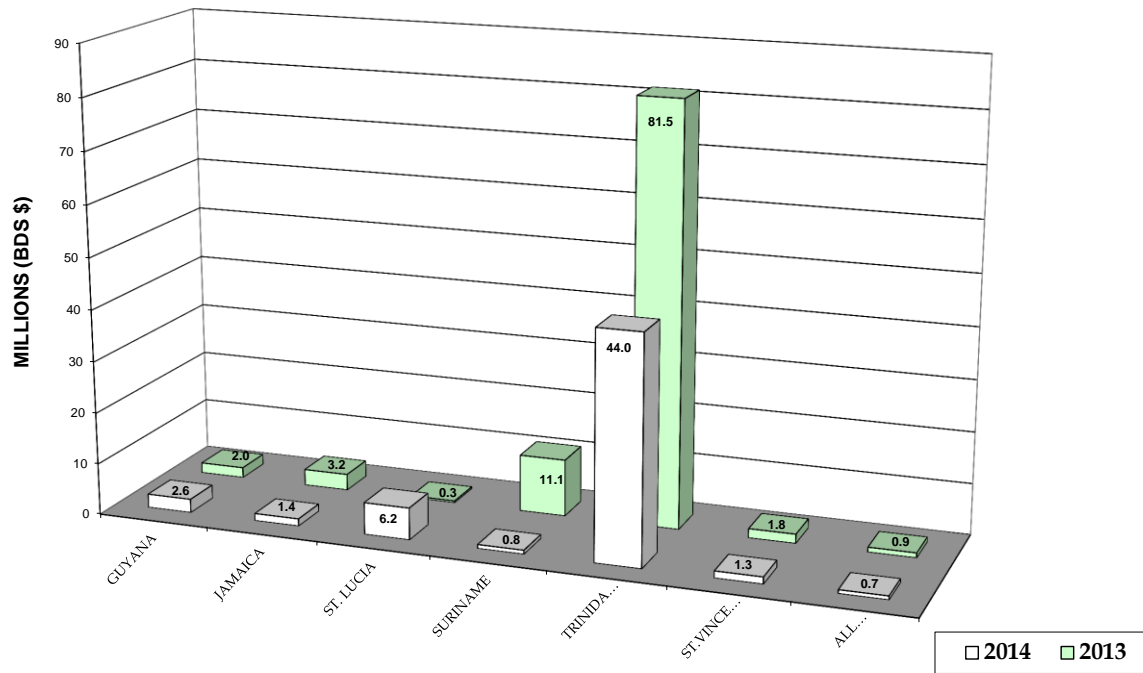

OCTOBER 2014 WITH THE CORRESPONDING MONTH OF 2013

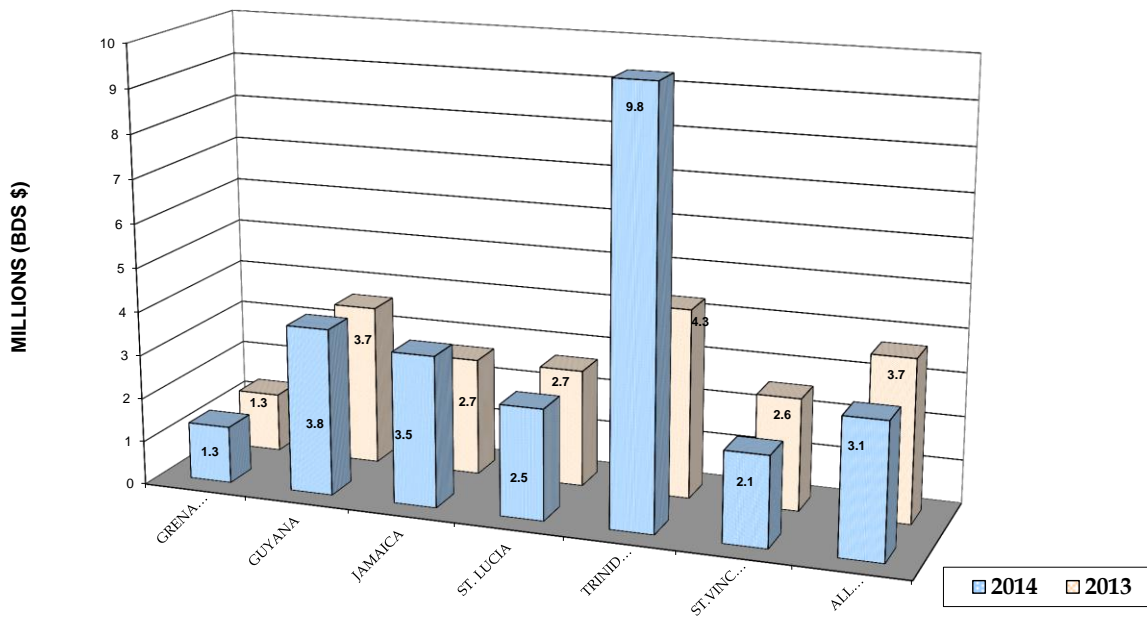
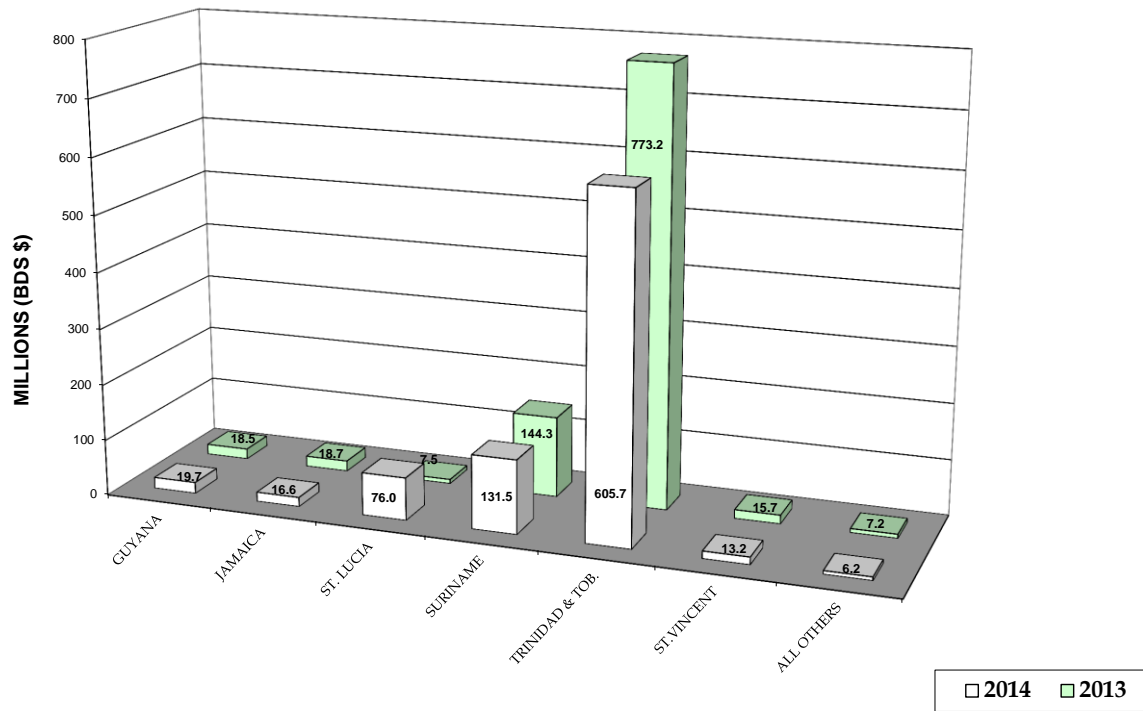

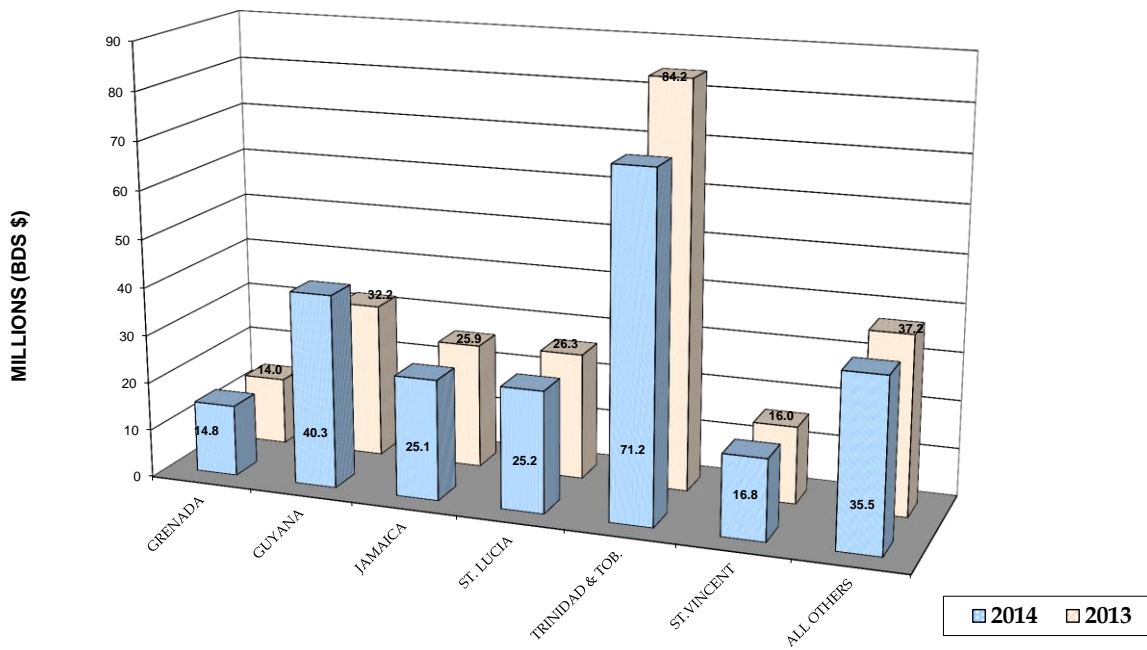
