REVIEW OF OVERSEAS TRADE

During the month of September 2014, total imports to Barbados were valued at \$298.72 million, whilst total exports from Barbados were valued at \$65.6 million. This resulted in a visible trade deficit of \$233.1 million, as compared with a visible trade deficit of \$204.0 million for September 2013.

Imports for September 2014 were \$29.9 million more than imports for September 2013, an increase of 11.1%. Total exports increased by \$0.7million or 1.1% of the September 2013 figure. Domestic exports increased by \$5.0 million or 12.5% over September 2013, while the value of re-exports decreased by \$4.3 million or 17.2% over the corresponding period 2013.

For the period January – September 2014, the value of imports to Barbados was \$2.59 billion, whilst the value of total exports was \$676.6 million representing an accumulated visible trade deficit of \$1.91 million as compared to a similar deficit of \$1.88 million for January – September 2013.

Imports for January – September 2014 were \$19.2 million less than imports for the same period 2013, a decrease of 0.7% Total exports showed a decrease of some \$12.6 million or 1.8% over the January - September2013 figure. Domestic exports decreased by \$0.1 million or 0.0% over January – September2013. The value of re-exports decreased by \$12.7 million, or 4.4%, over the corresponding period 2013.

CARICOM TRADE

During the month of September2014, total imports from CARICOM countries were valued at \$79.6 million, whilst total exports to CARICOM were valued at \$28.5 million, resulting in a trade deficit of \$51.1 million as compared with a visible trade deficit of \$61.9 million for September2013.

Total CARICOM imports for September2014 were \$6.0 million less than CARICOM imports for September2013, a decrease of 7.0%. Total exports to CARICOM for September2014 were \$4.8 million less than total exports for September 2014, a decrease of 20.4%. Domestic exports decreased by \$5.7 million or 29.9% over September2013. The value of re-exports declined by some \$0.9 million, or 18.2%, over the September2013 figure.

For the period January – September 2014, total imports from CARICOM were valued at \$811.9 million, whilst total exports were \$237.3 million resulting in an accumulated visible trade deficit of \$574.5 million as compared with a deficit of \$629.5 million for the same period of 2013.

During this period, CARICOM imports were approximately \$72.4 million less than those over the same period in 2013, a decrease of 8.2%. Total exports to CARICOM for January – September 2014 were \$17.4 million less than total exports for the corresponding period 2013, a decrease of 6.8%. Domestic exports decreased by approximately \$12.0million or 5.6% over the same period 2013. The value of re-exports decreased by \$5.4 million or 13.6% over the January – September 2013 figure.


