## **REVIEW OF OVERSEAS TRADE**

During the month of June 2020 total imports to Barbados were valued at \$258.2 million, whilst total exports from Barbados were valued at 62.6 million. This resulted in a visible trade deficit of \$195.6 million, as compared with a visible trade deficit of \$198.6 in June 2019

Imports for June 2020 were \$11.5 million less than imports for June 2020, a decrease of 4.3%. Total exports decreased by \$8.5 million or 11.9% of the June 2019 figure. Domestic exports decreased by \$5.4 million or 11.5% over June 2019 while the value of re-exports decreased by \$3.1million or 12.8% over the corresponding period 2019.

For the period January – June 2020, the value of imports to Barbados was \$1.48 billion, whilst the value of total exports was \$374 million representing an accumulated visible trade deficit of \$1.1 billion as compared to a similar deficit of \$1.10 billion for January – June 2019.

Imports for January – June 2020 were \$95.2 million less than imports for the same period 2019, a decrease of 6.0%. Total exports showed a decrease of some \$105.2 million or 22.5% over the January - June 2019 figure. Domestic exports decreased by \$49.3 million or 18.3% over January – June 2019. The value of re-exports decreased by \$55.9 million or 26.6% over the corresponding period 2019.

## **CARICOM TRADE**

During the month of June 2020, total imports from CARICOM countries were valued at \$41 million, whilst total exports to CARICOM were valued at \$25 million, resulting in a trade deficit of \$15.3 million as compared with a visible trade deficit of \$31.2 million for June 2019.

Total CARICOM imports for June 2020 were \$21.7 million less than CARICOM imports for June 2019, a decrease of 34.4%. Total exports to CARICOM for June 2019 were \$5.7 million less than total exports for June 2019, a decrease of 18.5%. Domestic exports decreased by \$6.4 million or 22.6% over June 2019. The value of re-exports decreased by some \$0.6 million, or 23.0%, over the June 2019 figure.

For the period January – June 2020, total imports from CARICOM were valued at \$294 million, whilst total exports were \$141 million resulting in an accumulated visible trade deficit of \$152.6 million as compared with a deficit of \$118.7 million for the same period of 2019.

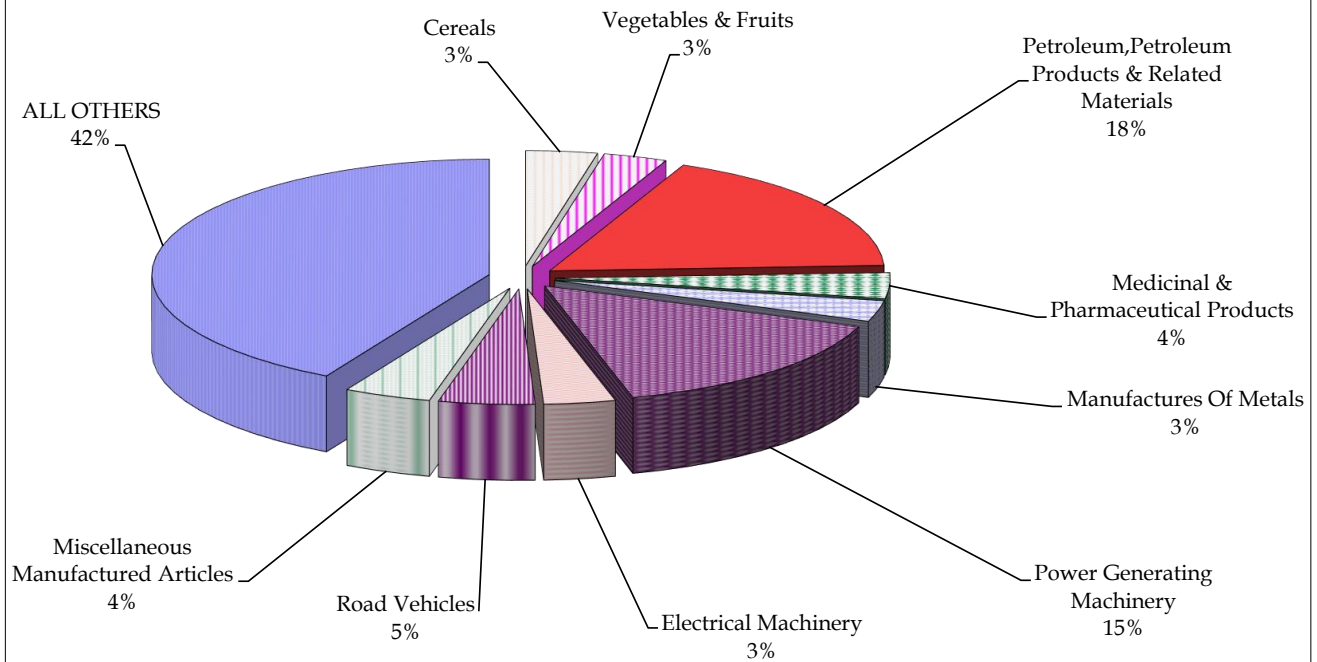
During this period, CARICOM imports were approximately \$0.8 million less than those over the same period in 2019, a decrease of 0.3%. Total exports to CARICOM for January – June 2020 were \$34.5million less than total exports for the corresponding period 2019, a decrease of 19.5%. Domestic exports decreased by approximately \$33.7 million or 21.5% over the same period 2019. The value of re-exports increased by \$0.7 million or 3.7% over the January – June 2019 figure.

JUNE 2020 WITH THE CORRESPONDING MONTH OF 2019**

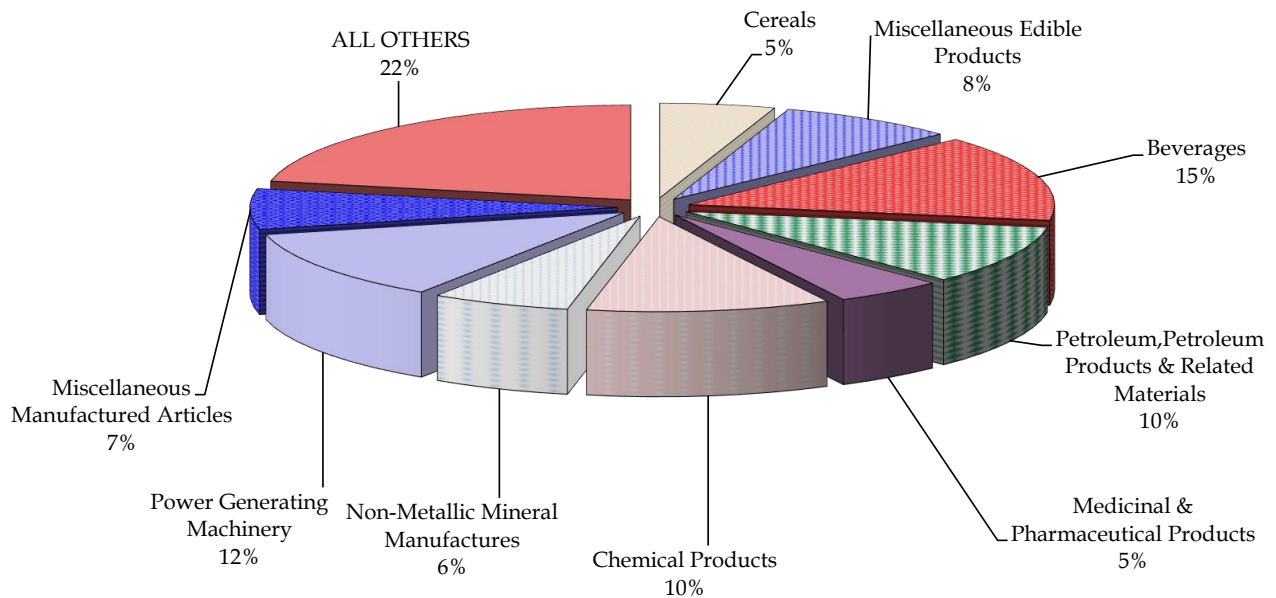

### Principal Domestic Exports - June 2020

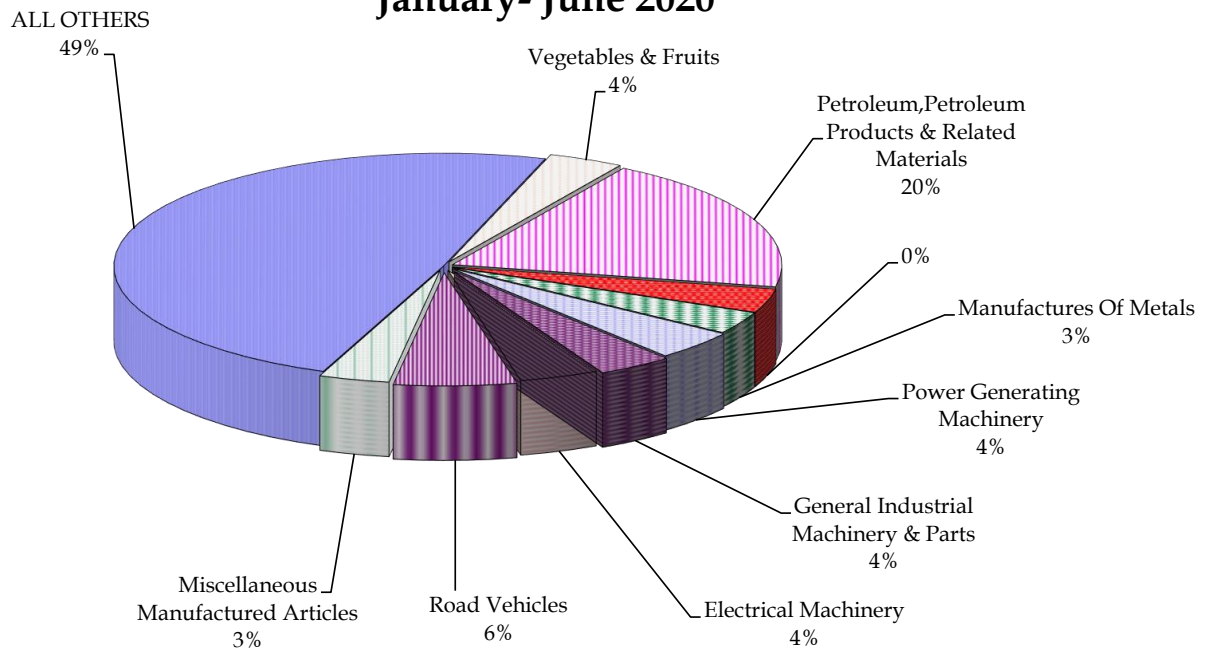

## Principal Domestic Exports January- June 2020

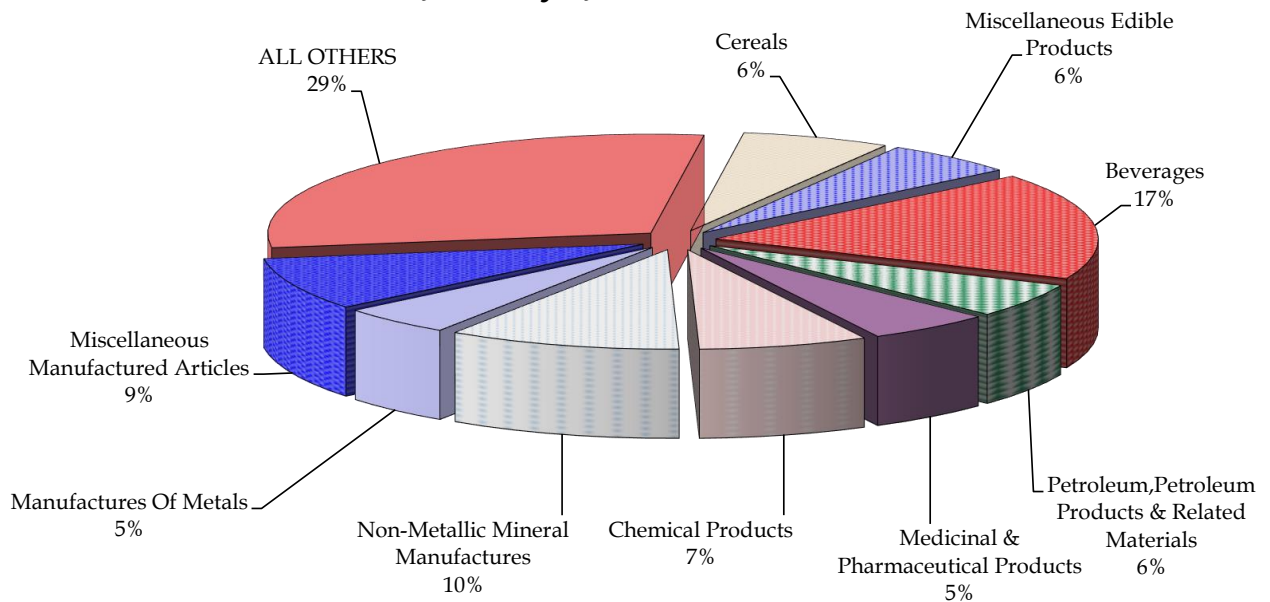

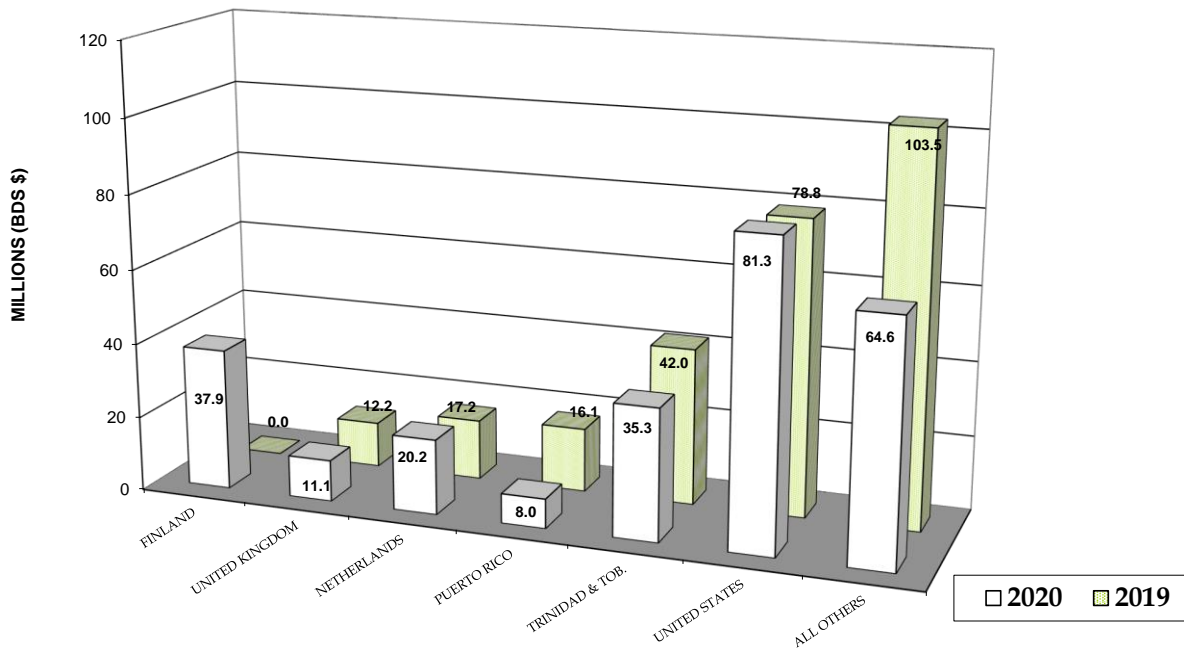

JUNE 2020 WITH THE CORRESPONDING MONTH OF 2019

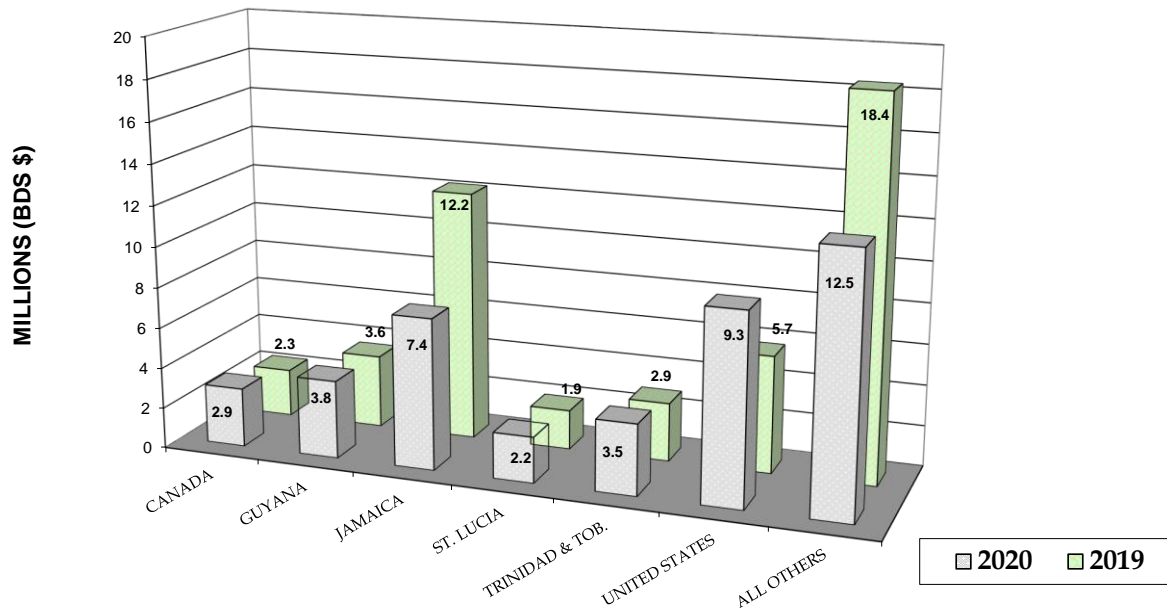


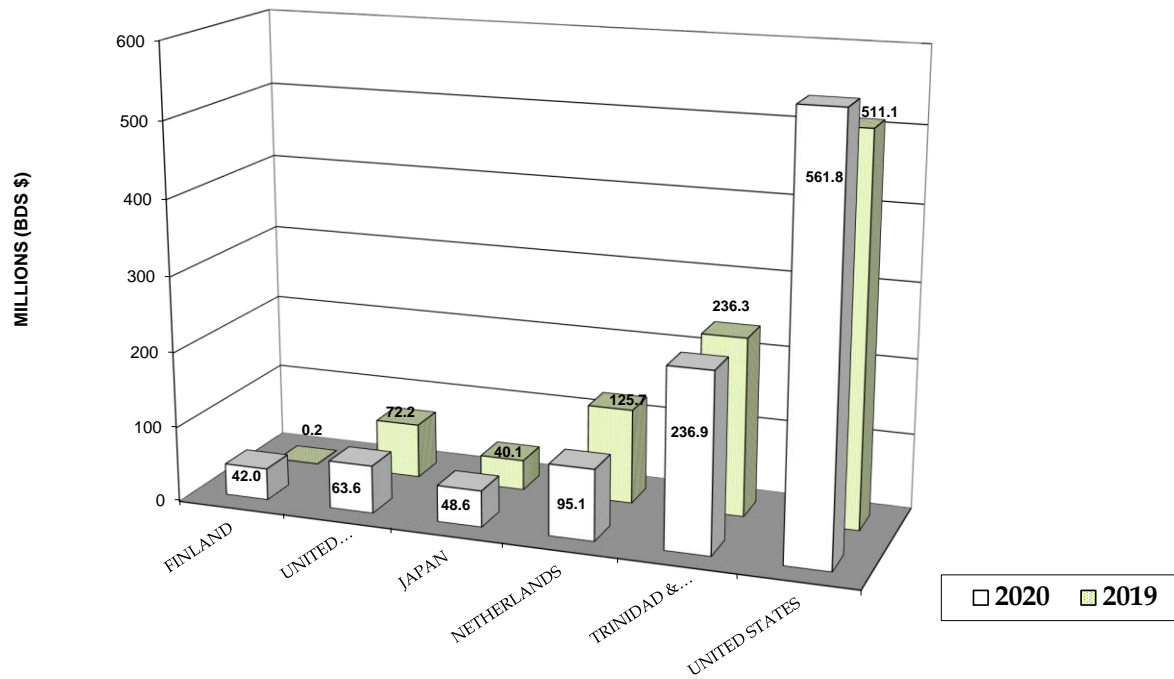

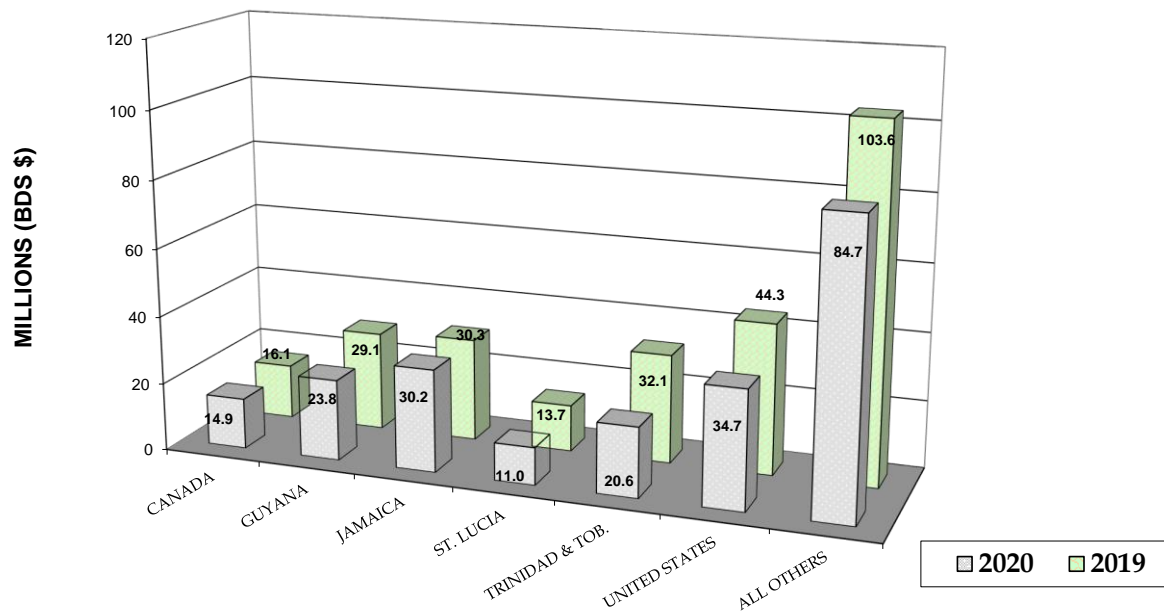

JUNE 2020 WITH THE CORRESPONDING MONTH OF 2019

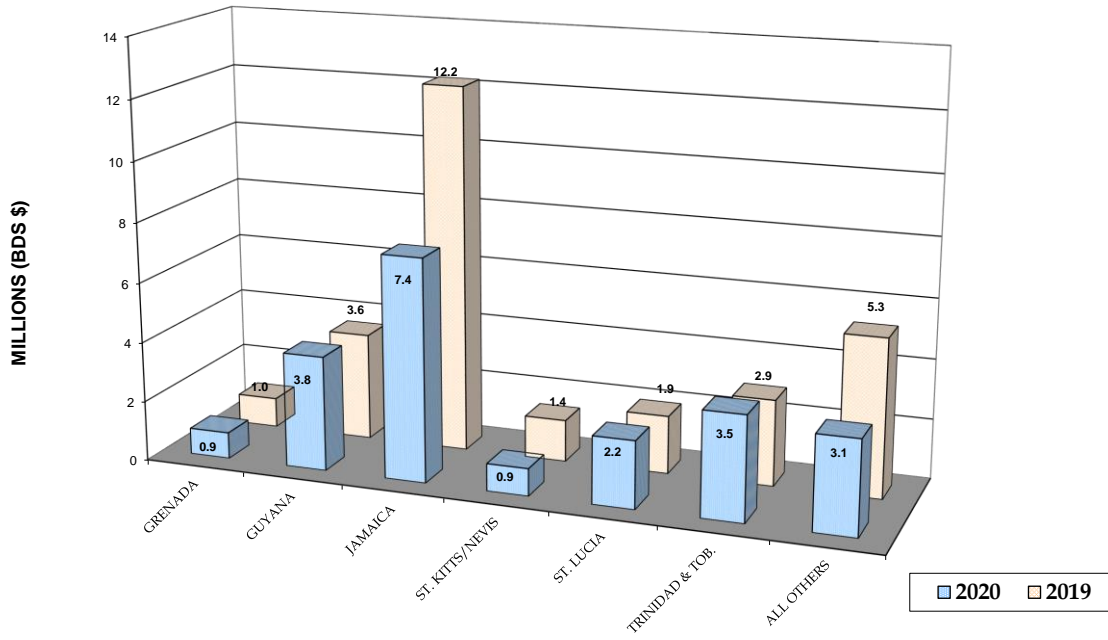


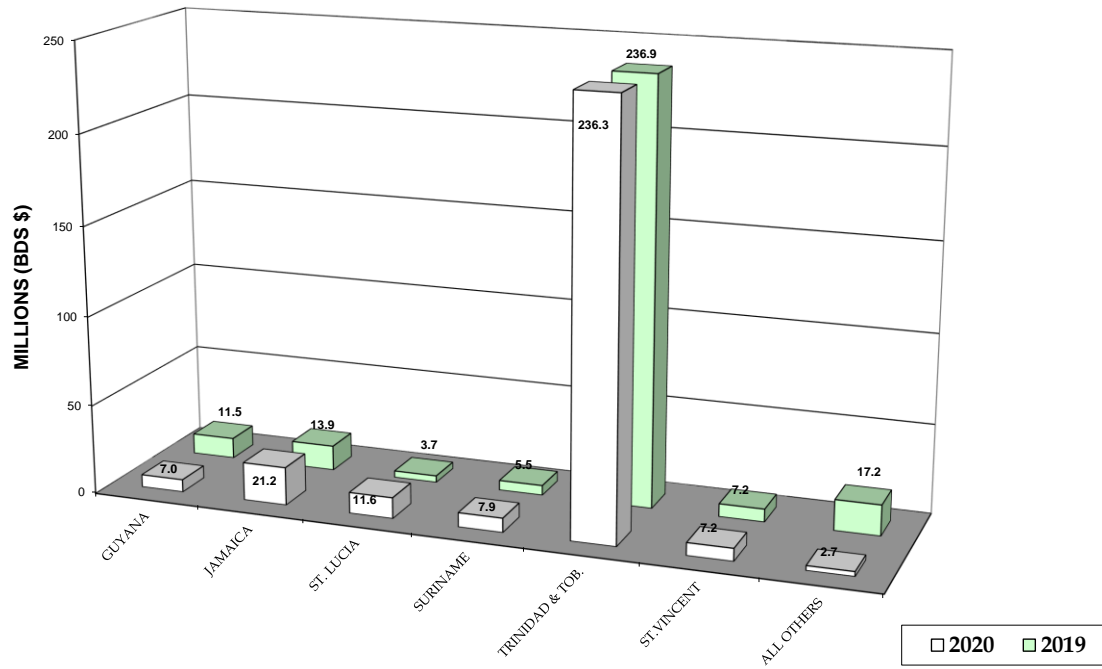

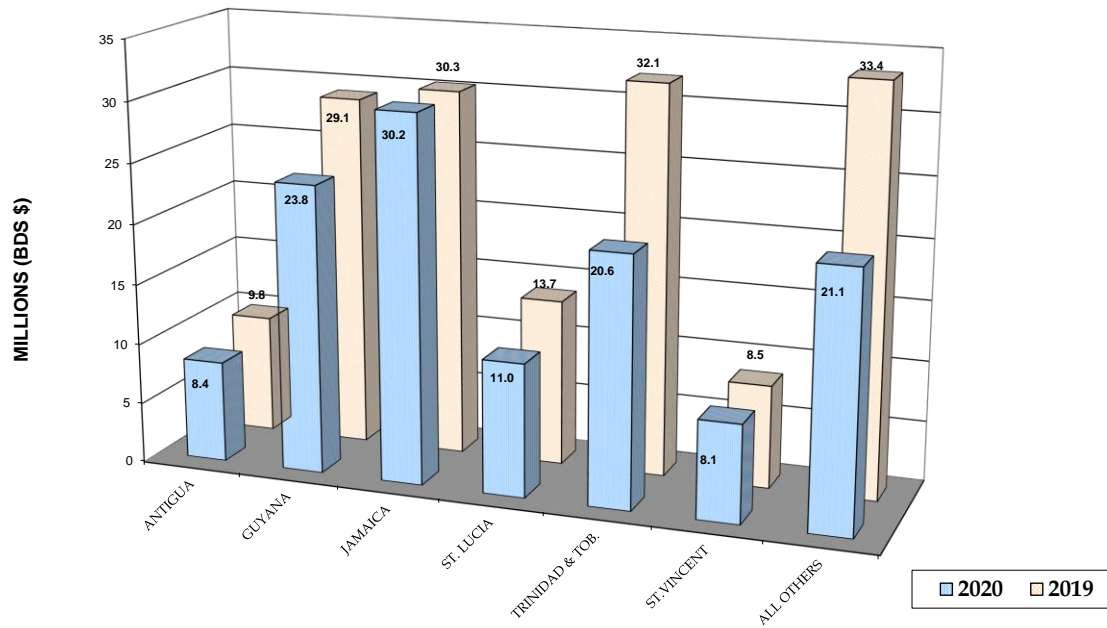
