## **REVIEW OF OVERSEAS TRADE**

During the month of August 2021, total imports to Barbados were valued at \$286.1 million, whilst total exports from Barbados were valued at \$53.6 million. This resulted in a visible trade deficit of \$232.5 million, as compared with a visible trade deficit of \$169.3 for August 2020.

Imports for August 2021 were \$63.7 million more than imports for August 2020, a increase of 28.7%. Total exports increased by \$0.5 million or 0.9% of the August 2020 figure. Domestic exports decreased by \$2.5 million or 6.6% over August 2020, while the value of re-exports increased by \$3.0 million or 19.4% over the corresponding period 2020.

For the period January – August 2021, the value of imports to Barbados was \$2.01 billion, whilst the value of total exports was \$423.7 million representing an accumulated visible trade deficit of \$1.59 billion as compared to a similar deficit of \$1.48 billion for January – August 2020.

Imports for January – August 2021 were \$45.8 million more than imports for the same period 2020, an increase of 2.3%. Total exports showed a decrease of some \$63.4 million or 13.0% over the January - August 2020 figure. Domestic exports decreased by \$2.8 million or 0.9% over January – August 2020. The value of re-exports decreased by \$60.6 million or 31.5% over the corresponding period 2020.

## **CARICOM TRADE**

During the month of August 2021, total imports from CARICOM countries were valued at \$56.3 million, whilst total exports to CARICOM were valued at \$22.4 million, resulting in a trade deficit of \$33.9 million as compared with a visible trade deficit of \$12.0 million for August 2020.

Total CARICOM imports for August 2021 were \$22.2 million more than CARICOM imports for August 2020, an increase of 65.0%. Total exports to CARICOM for August 2021 were \$0.3 million more than total exports for August 2020, an increase of 1.3%. Domestic exports increased by \$1.8 million or 9.8% over August 2020. The value of re-exports decreased by some \$1.5 million, or 40.3%, over the August 2020 figure.

For the period January – August 2021, total imports from CARICOM were valued at \$322.9 million, whilst total exports were \$178.2 million resulting in an accumulated visible trade deficit of \$144.7 million as compared with a deficit of \$182.9 million for the same period of 2020.

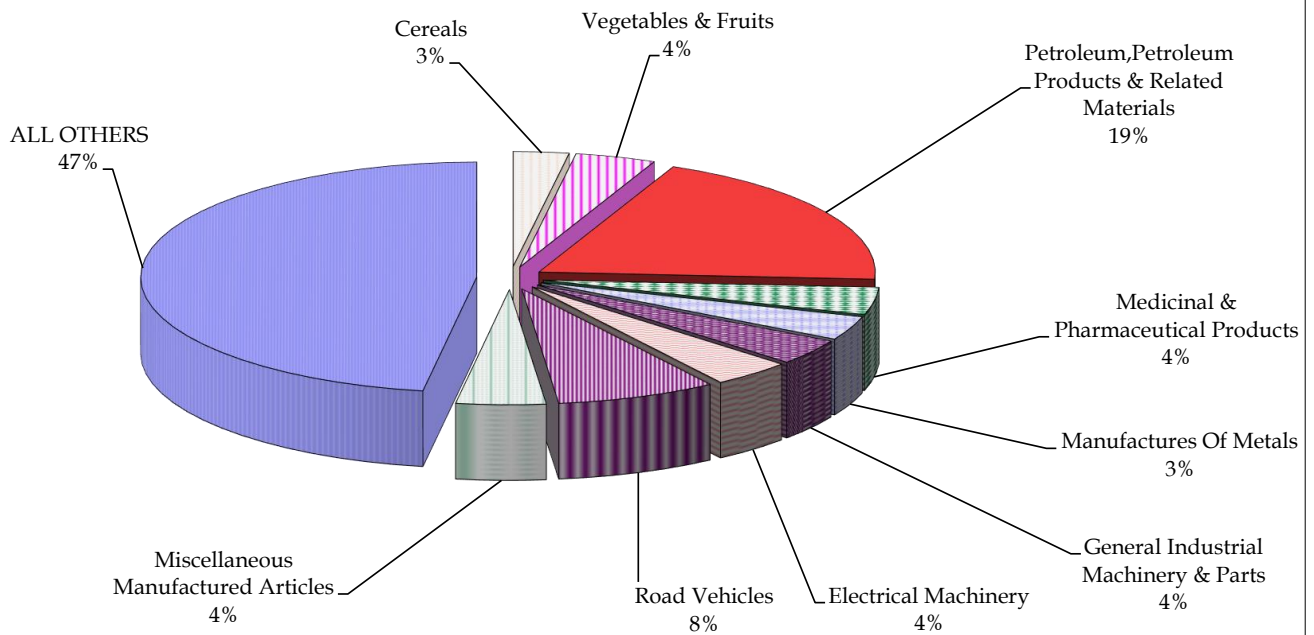
During this period, CARICOM imports were approximately \$51.4 million less than those over the same period in 2020, a decrease of 13.7%. Total exports to CARICOM for January – August 2021 were \$13.1 million less than total exports for the corresponding period 2020, a decrease of 6.9%. Domestic exports decreased by approximately \$9.4 million or 5.9% over the same period 2020. The value of re-exports decreased by \$3.7 million or 11.8% over the January – August 2020 figure.

AUGUST 2021 WITH THE CORRESPONDING MONTH OF 2020**

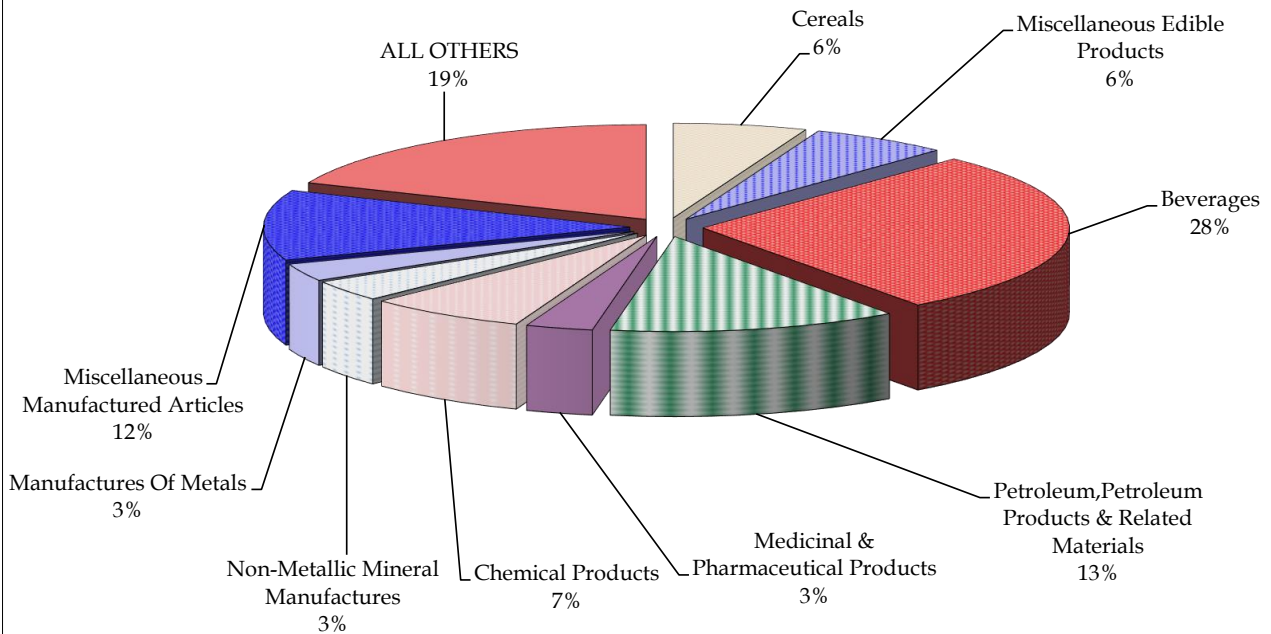

## Principal Domestic Exports - August 2021

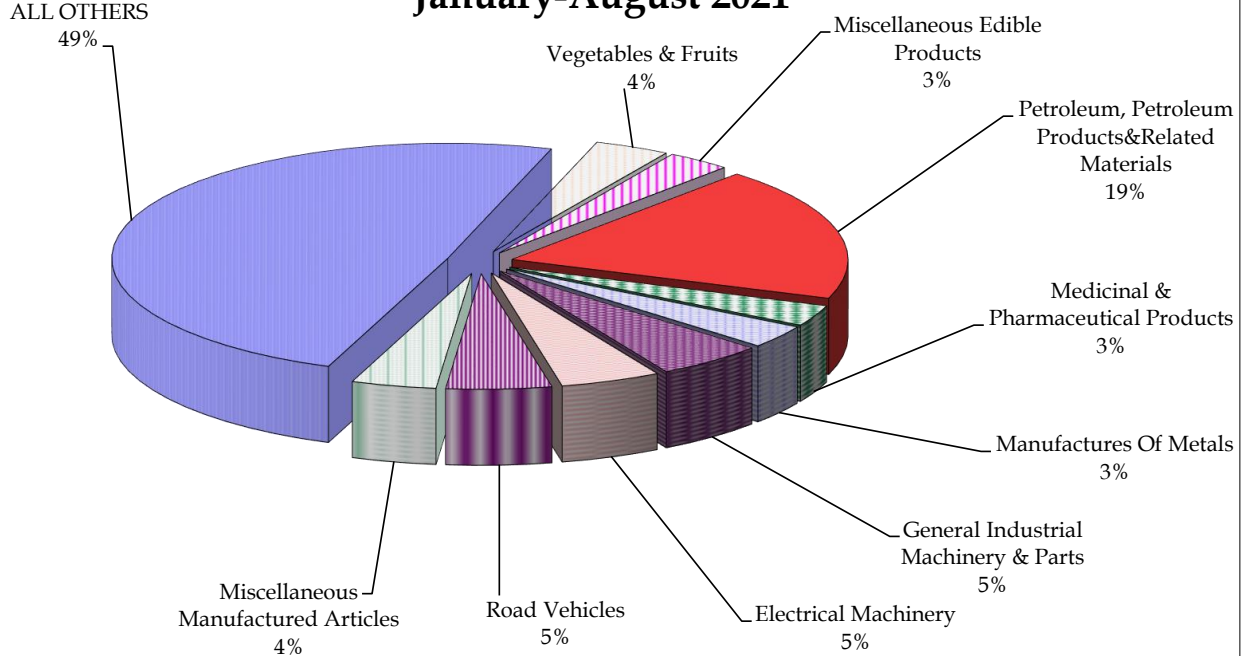

## Principal Domestic Exports January- August 2021

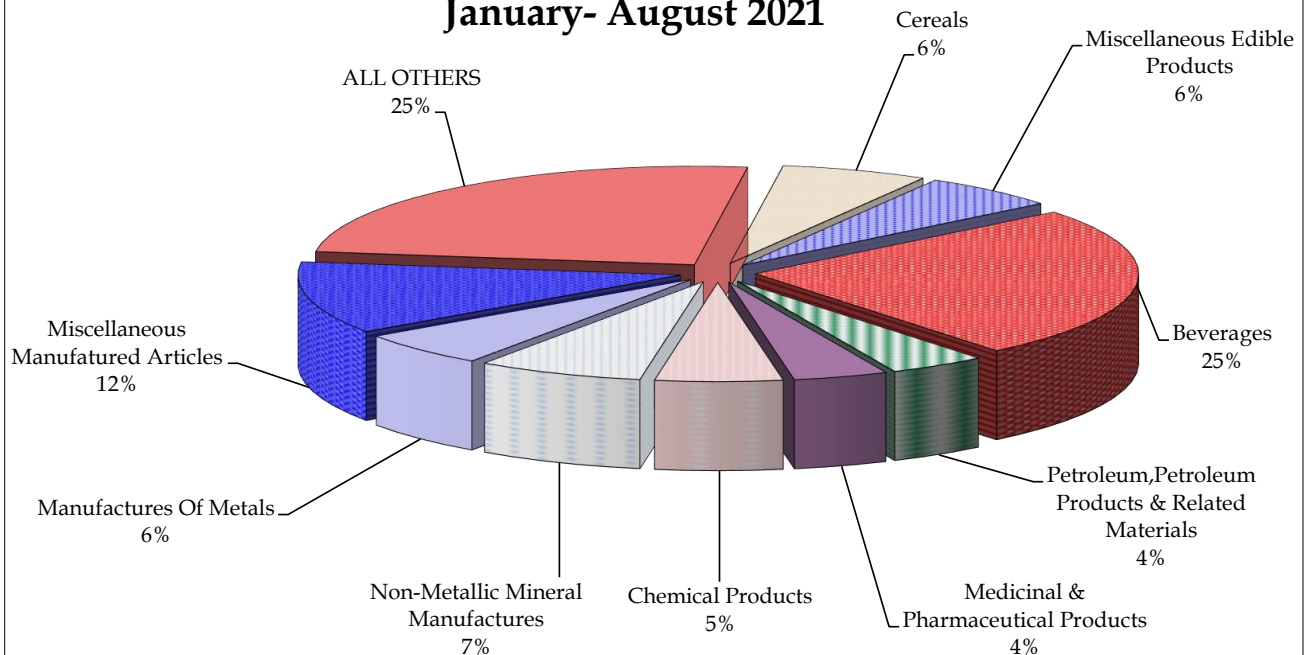

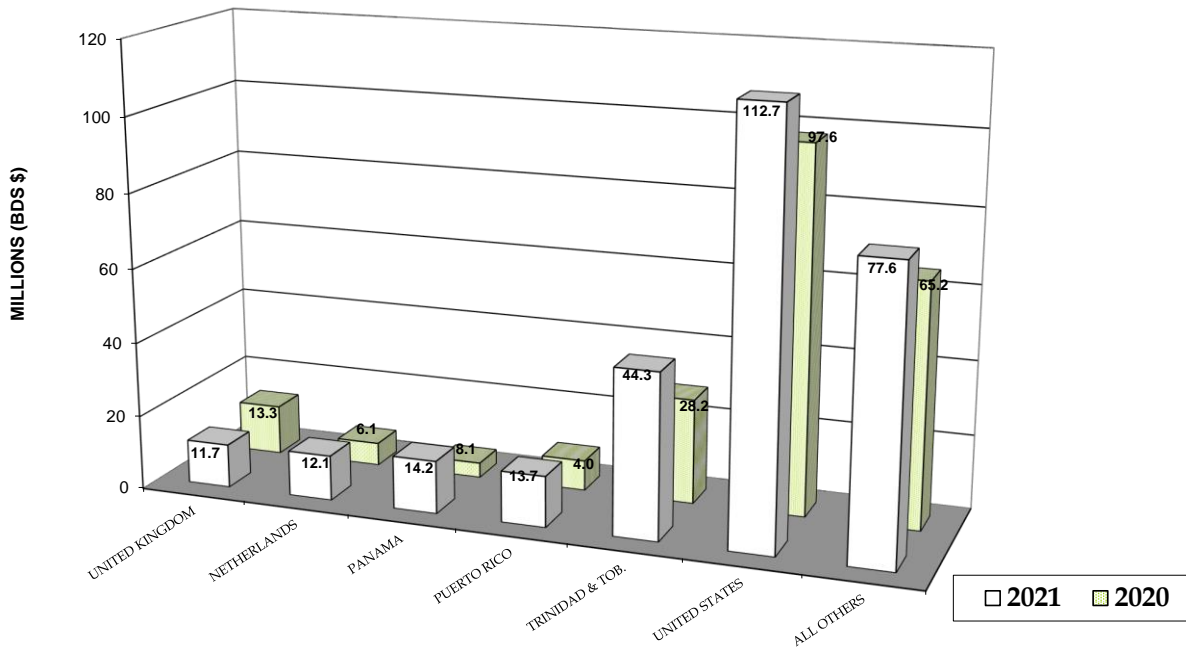

AUGUST 2021 WITH THE CORRESPONDING MONTH OF 2020

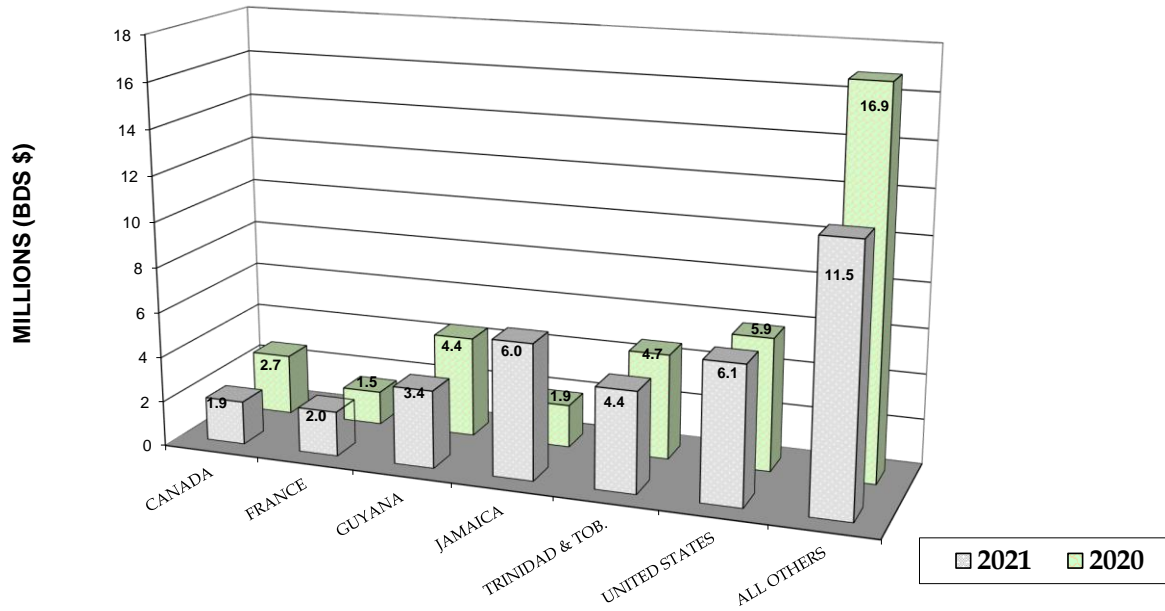


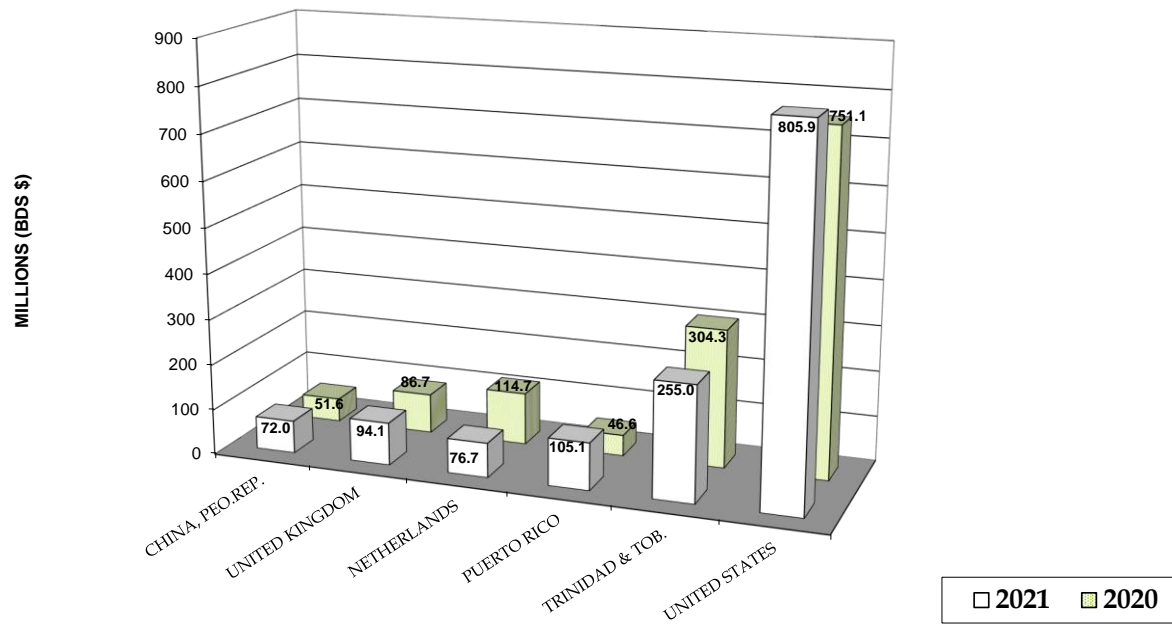

AUGUST 2021 WITH THE CORRESPONDING MONTH OF 2020

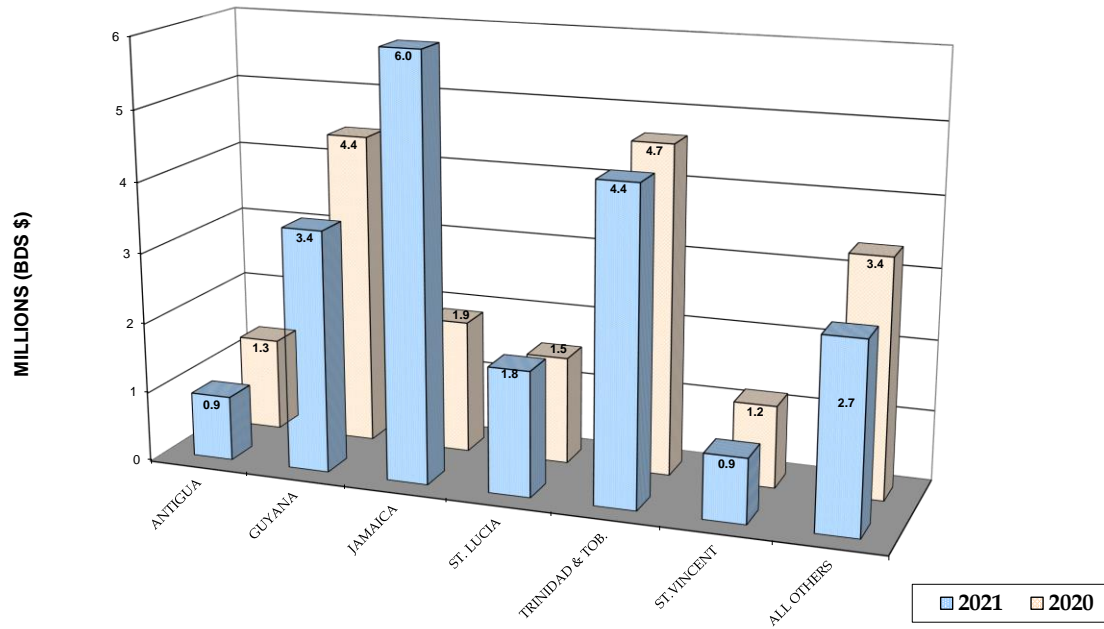


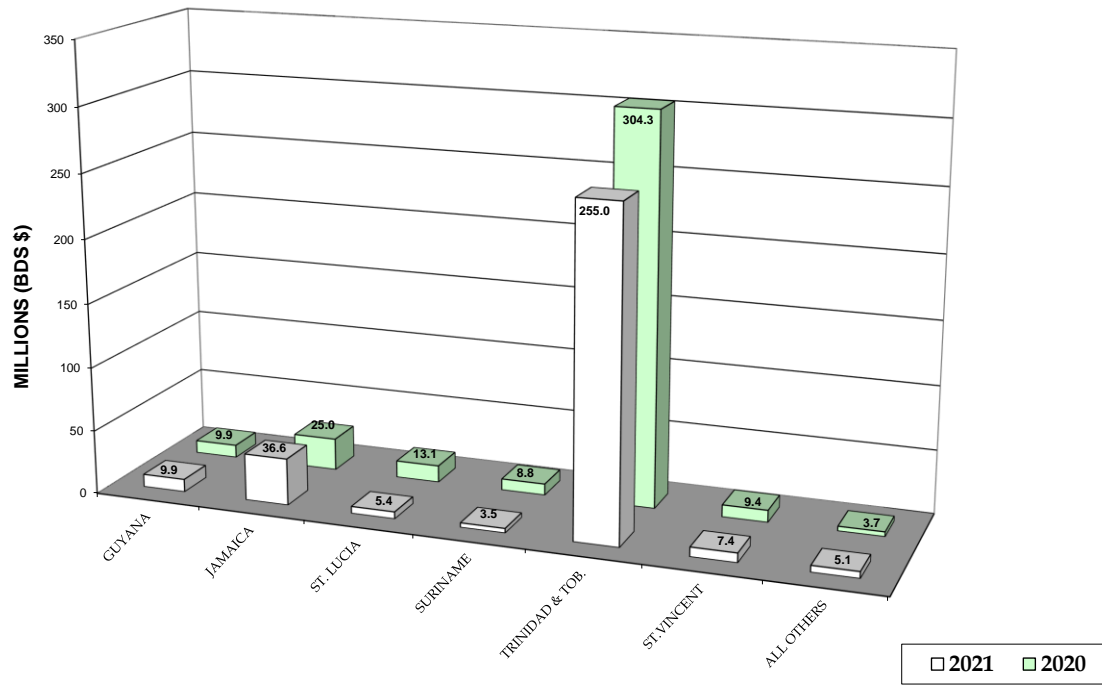

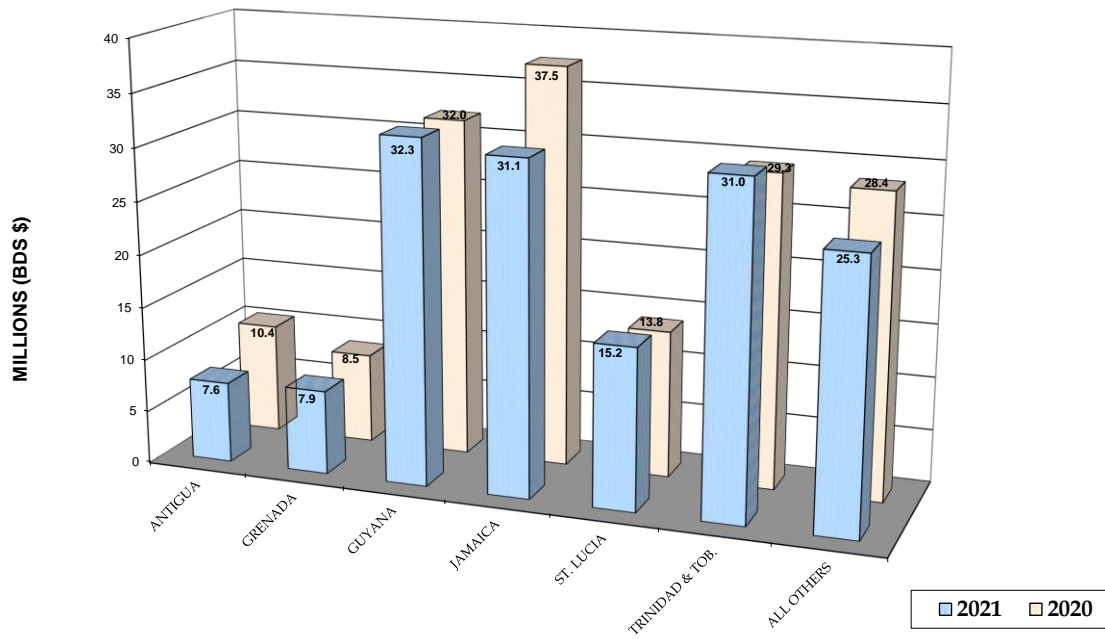
