## **REVIEW OF OVERSEAS TRADE**

During the month of July 2021, total imports to Barbados were valued at \$284.0 million, whilst total exports from Barbados were valued at \$49.4 million. This resulted in a visible trade deficit of \$234.6 million, as compared with a visible trade deficit of \$196.9 for July 2020.

Imports for July 2021 were \$27.3 million more than imports for July 2020, an increase of 10.6%. Total exports decreased by \$10.5 million or 17.5% of the July 2020 figure. Domestic exports decreased by \$0.9 million or 2.4% over July 2020, while the value of re-exports decreased by \$9.6 million or 42.2% over the corresponding period 2020.

For the period January – July 2021, the value of imports to Barbados was \$1.7 billion, whilst the value of total exports was \$370.1 million representing an accumulated visible trade deficit of \$1.36 billion as compared to a similar deficit of \$1.31 billion for January – July 2020.

Imports for January – July 2021 were \$18.0 million less than imports for the same period 2020, a decrease of 1.0%. Total exports showed a decrease of some \$63.9 million or 14.7% over the January - July 2020 figure. Domestic exports decreased by \$0.3 million or 0.1% over January – July 2020. The value of re-exports decreased by \$63.6 million or 35.9% over the corresponding period 2020.

## **CARICOM TRADE**

During the month of July 2021, total imports from CARICOM countries were valued at \$51.4 million, whilst total exports to CARICOM were valued at \$22.6 million, resulting in a trade deficit of \$28.8 million as compared with a visible trade deficit of \$18.4 million for July 2020.

Total CARICOM imports for July 2021 were \$5.6 million more than CARICOM imports for July 2020, an increase of 12.2%. Total exports to CARICOM for July 2021 were \$4.8 million less than total exports for July 2020, a decrease of 17.5%. Domestic exports increased by \$1.1 million or 5.8% over July 2020. The value of re-exports decreased by some \$5.9 million, or 65.3%, over the July 2020 figure.

For the period January – July 2021 total imports from CARICOM were valued at \$266.6 million, whilst total exports were \$155.8 million resulting in an accumulated visible trade deficit of \$110.8 million as compared with a deficit of \$170.9 million for the same period of 2020.

During this period, CARICOM imports were approximately \$73.6 million less than those over the same period in 2020, a decrease of 21.6%. Total exports to CARICOM for January – July 2021 were \$13.4 million less than total exports for the corresponding period 2020, a decrease of 7.9%. Domestic exports decreased by approximately \$11.2 million or 7.9% over the same period 2020. The value of re-exports decreased by \$2.2 million or 7.9% over the January – July 2020 figure.

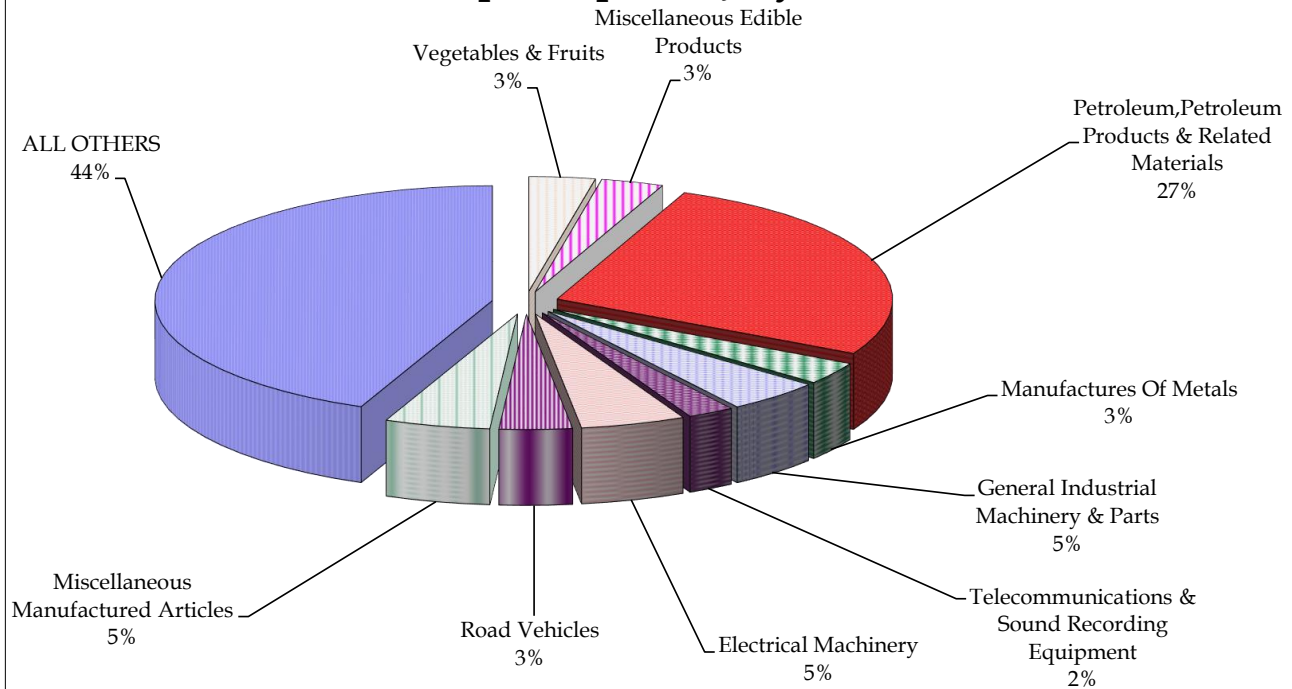

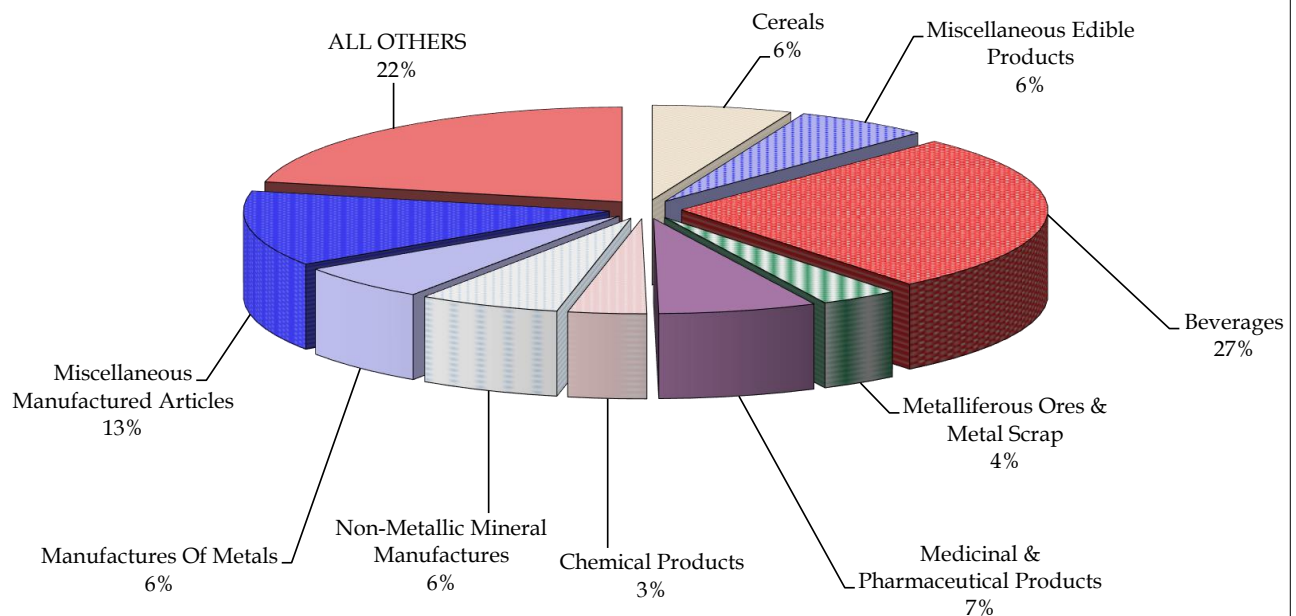

## Principal Domestic Exports - July 2021



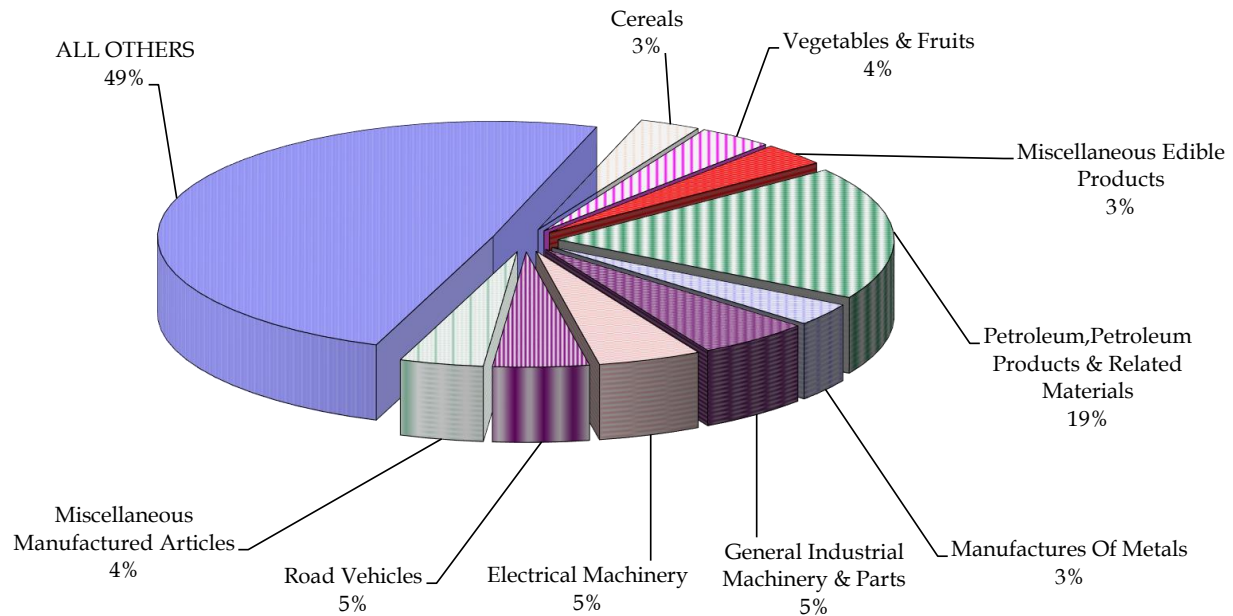

## Principal Domestic Exports January - July 2021

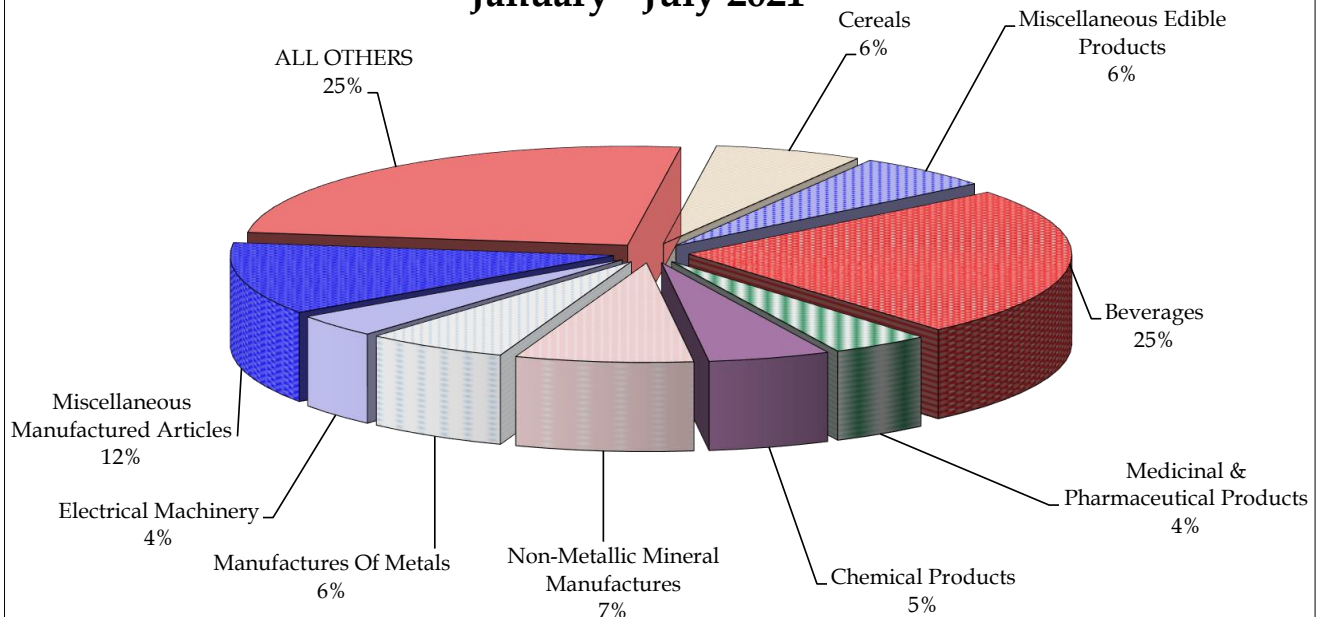

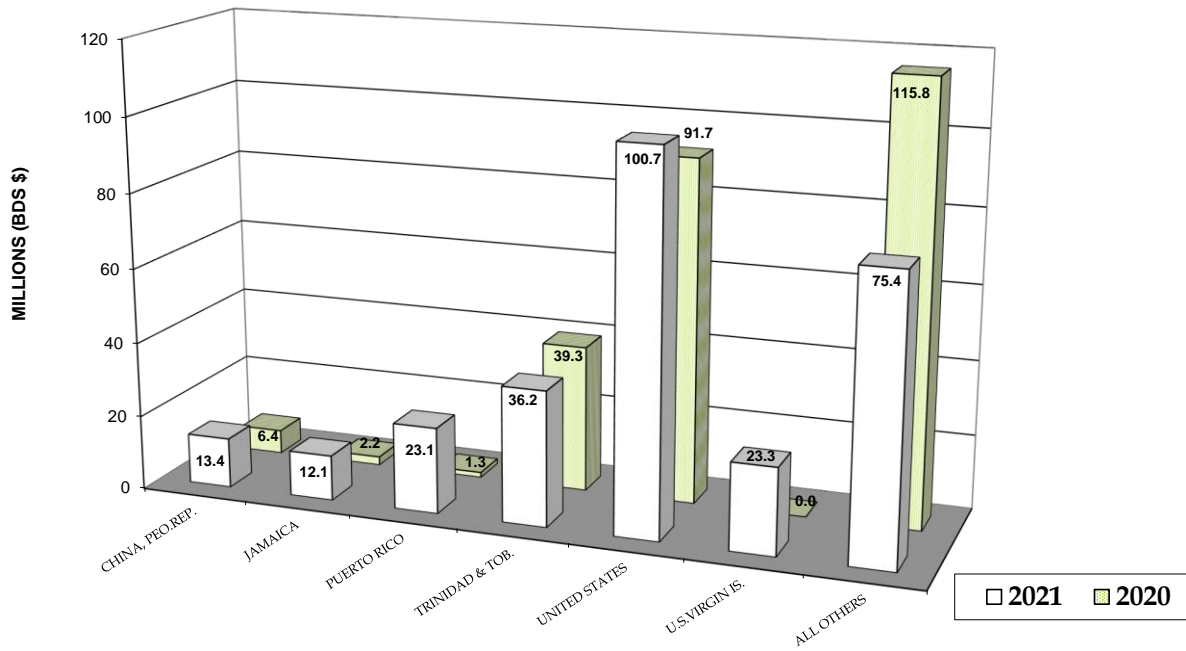

JULY 2021 WITH THE CORRESPONDING MONTH OF 2020

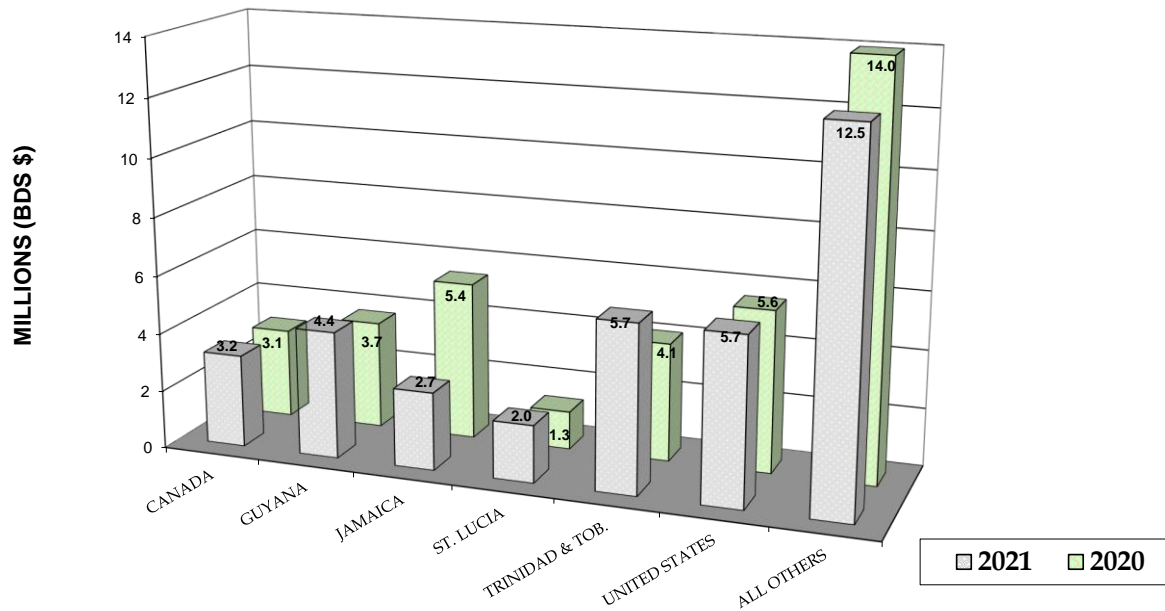
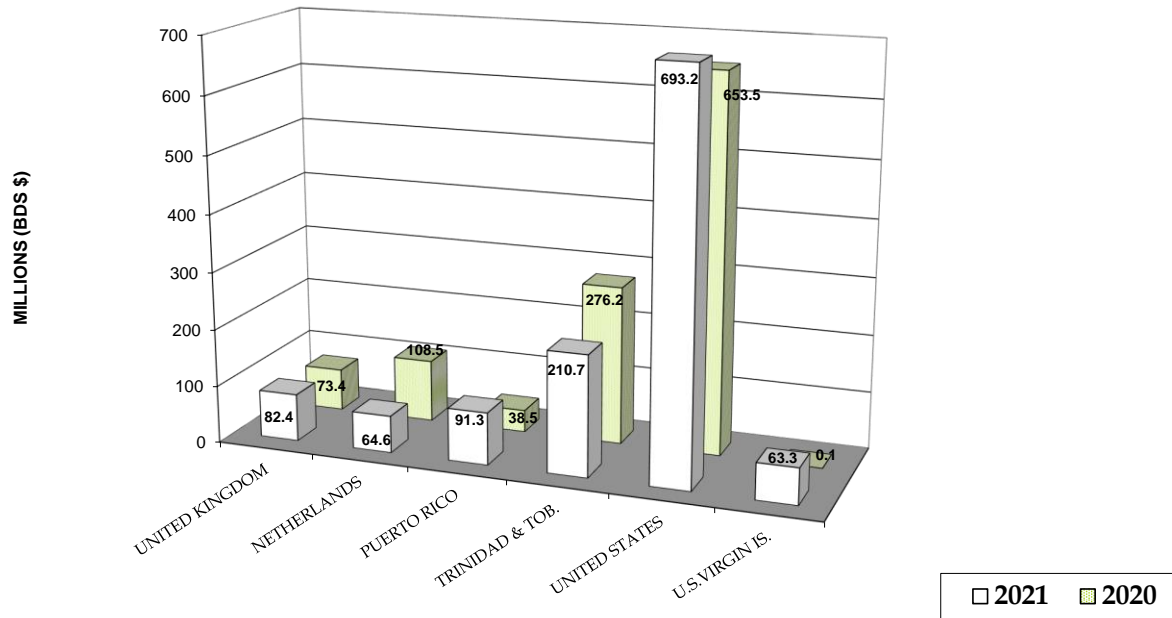

JULY 2021 WITH THE CORRESPONDING MONTH OF 2020

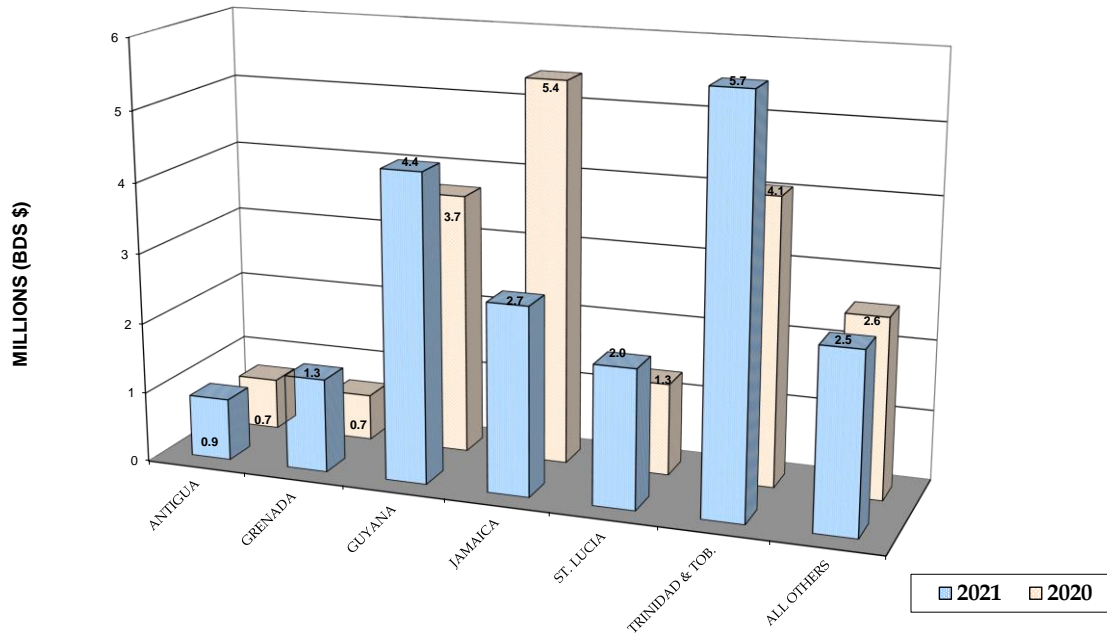


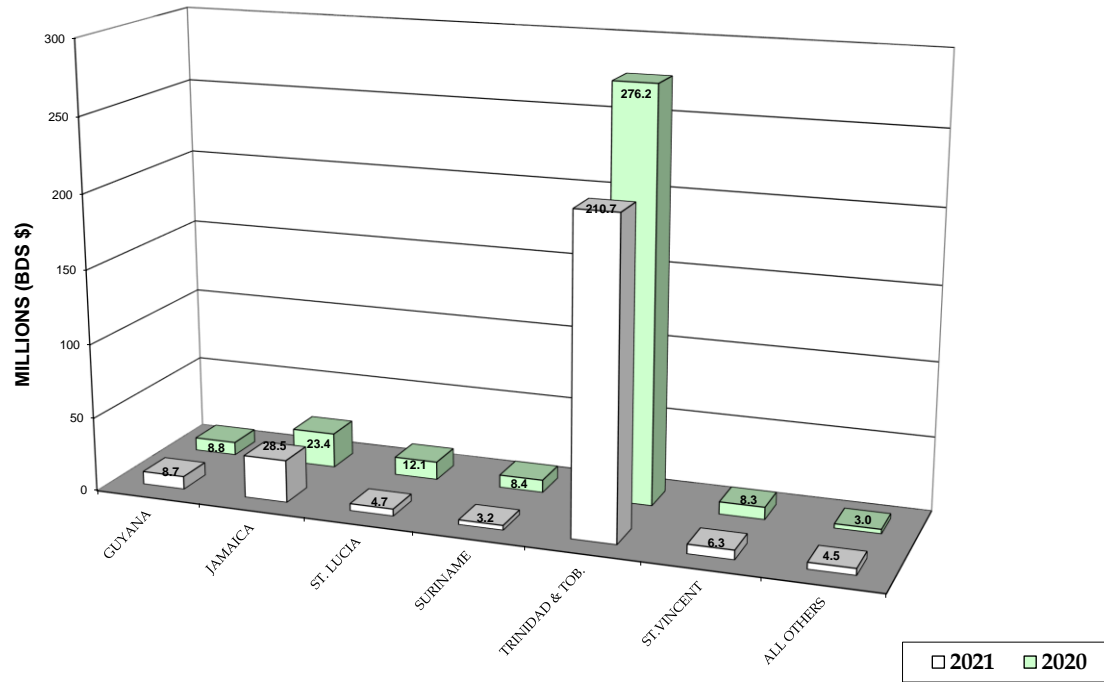

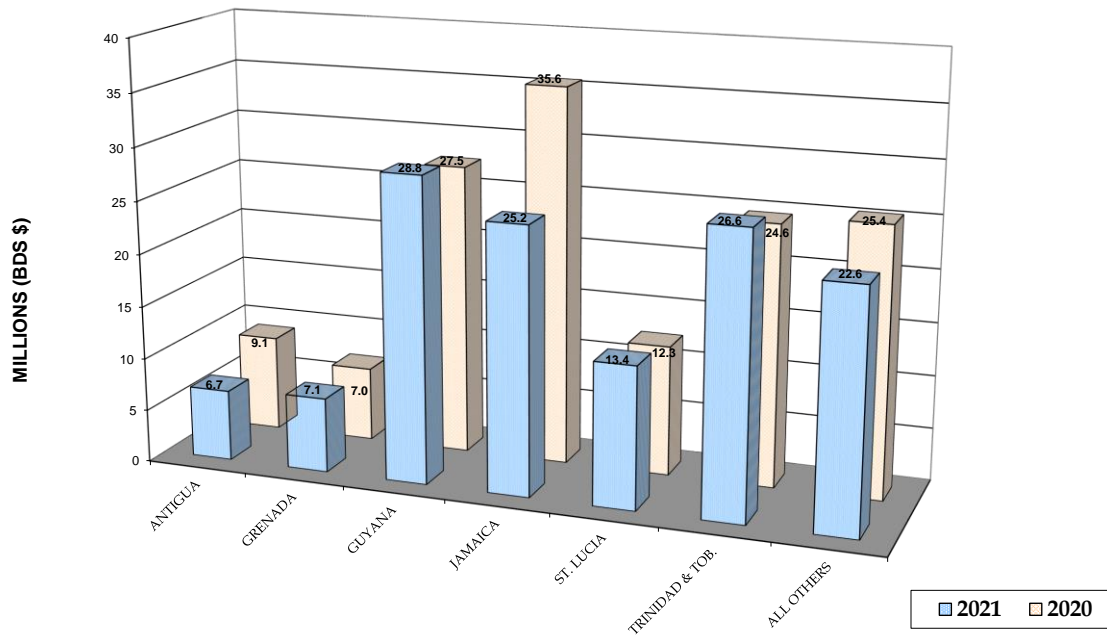
