## **REVIEW OF OVERSEAS TRADE**

During the month of October 2021, total imports to Barbados were valued at \$315.5 million, whilst total exports from Barbados were valued at \$59.0 million. This resulted in a visible trade deficit of \$256.5 million, as compared with a visible trade deficit of \$199.6 for October 2020.

Imports for October 2021 were \$67.3 million more than imports for October 2020 an increase of 27.1%. Total exports increased by \$10.4 million or 21.3% of the October 2020 figure. Domestic exports increased by \$1.0 million or 2.6% over October 2020, while the value of re-exports increased by \$9.4 million or 84.8% over the corresponding period 2020.

For the period January – October 2021, the value of imports to Barbados was \$2.61 billion, whilst the value of total exports was \$543.9 million representing an accumulated visible trade deficit of \$2.07 billion as compared to a similar deficit of \$1.88 billion for January – October 2020.

Imports for January – October 2021 were \$141.5 million more than imports for the same period in 2020, an increase of 5.7%. Total exports showed a decrease of some \$47.8 million or 8.1% less than the January - October 2020 figure. Domestic exports decreased by \$9.4 million or 2.5% over January – October 2020. The value of re-exports decreased by \$38.3 million or 18.0% over the corresponding period in 2020.

## **CARICOM TRADE**

During the month of October 2021, total imports from CARICOM countries were valued at \$72.3 million, whilst total exports to CARICOM were valued at \$28.5 million, resulting in a trade deficit of \$43.8 million as compared with a visible trade deficit of \$4.8 million for October 2020.

Total CARICOM imports for October 2021 were \$43.6 million more than CARICOM imports for October 2020, an increase of 151.8%. Total exports to CARICOM for October 2021 were \$4.6 million more than total exports for October 2020, an increase of 19.2%. Domestic exports increased by \$3.5 million or 16.6% over October 2020. The value of re-exports increased by some \$1.1 million, or 38.6%, over the October 2020 figure.

For the period January – October 2021, total imports from CARICOM were valued at \$431.6 million, whilst total exports were \$232.8 million resulting in an accumulated visible trade deficit of \$198.8 million as compared with a deficit of \$197.3 million for the same period of 2020.

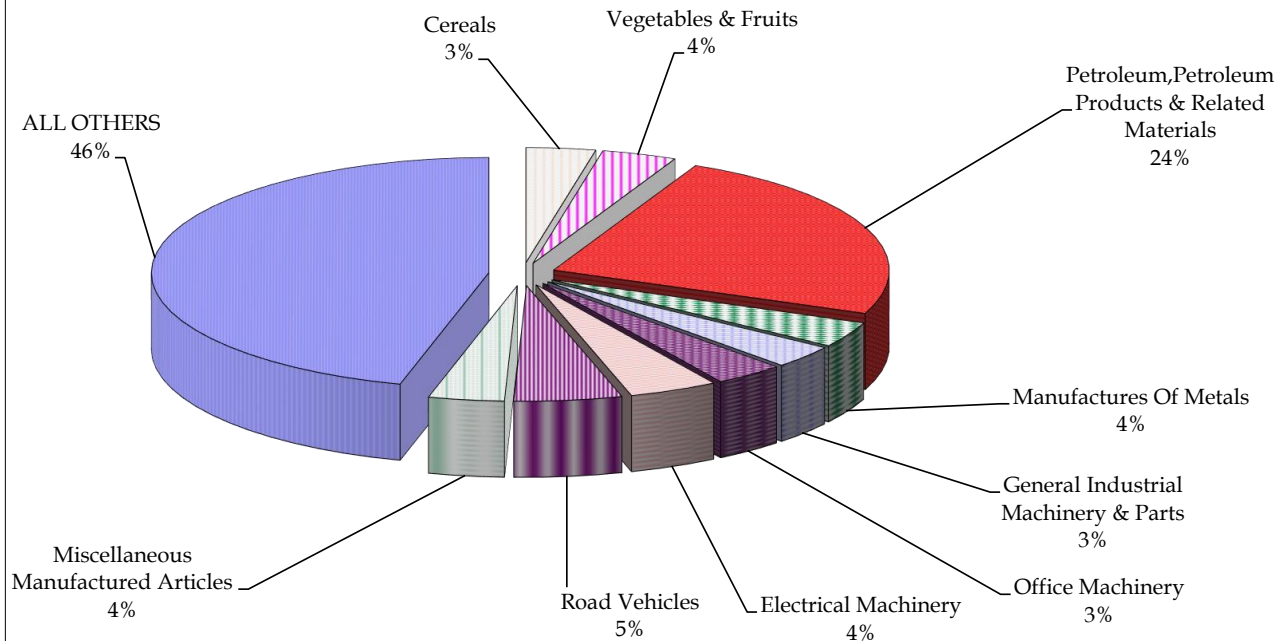
During this period, CARICOM imports were approximately \$7.3 million less than those over the same period in 2020, a decrease of 1.7%. Total exports to CARICOM for January – October 2021 were \$8.9 million less than total exports for the corresponding period in 2020, a decrease of 3.7%. Domestic exports decreased by approximately \$8.0 million or 3.9% over the same period in 2020. The value of re-exports decreased by \$0.9 million or 2.4% over the January – October 2020 figure.

OCTOBER 2021 WITH THE CORRESPONDING MONTH OF 2020

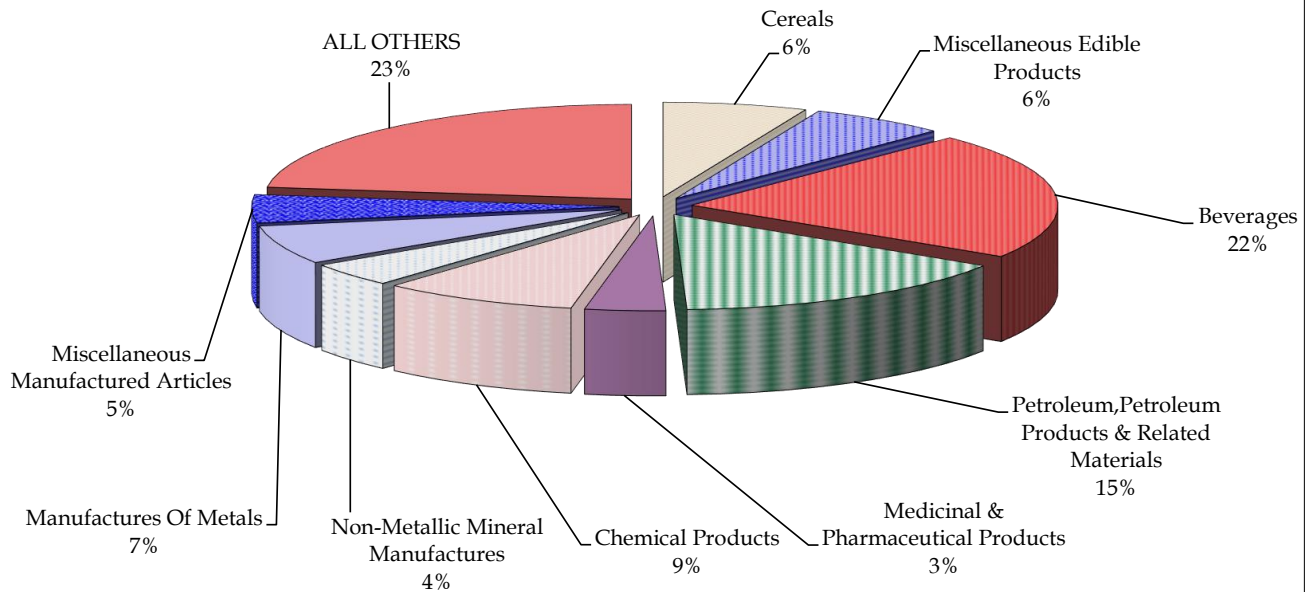

## Principal Domestic Exports - October 2021



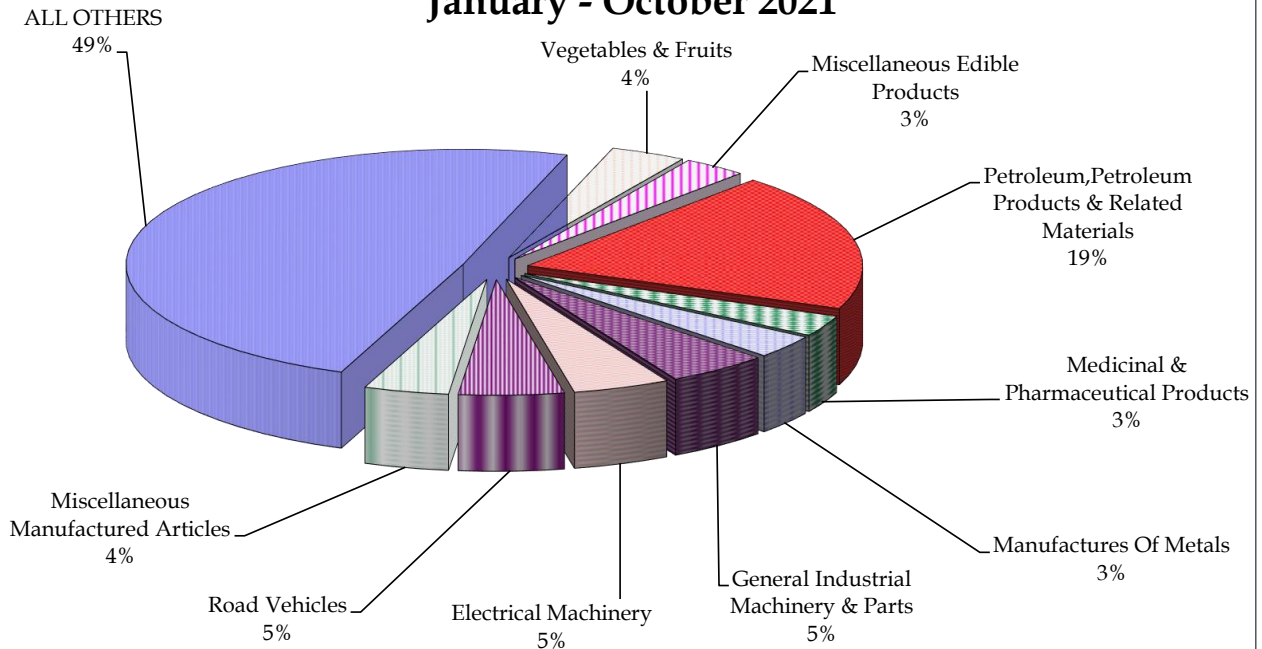

### Principal Domestic Exports January - October 2021

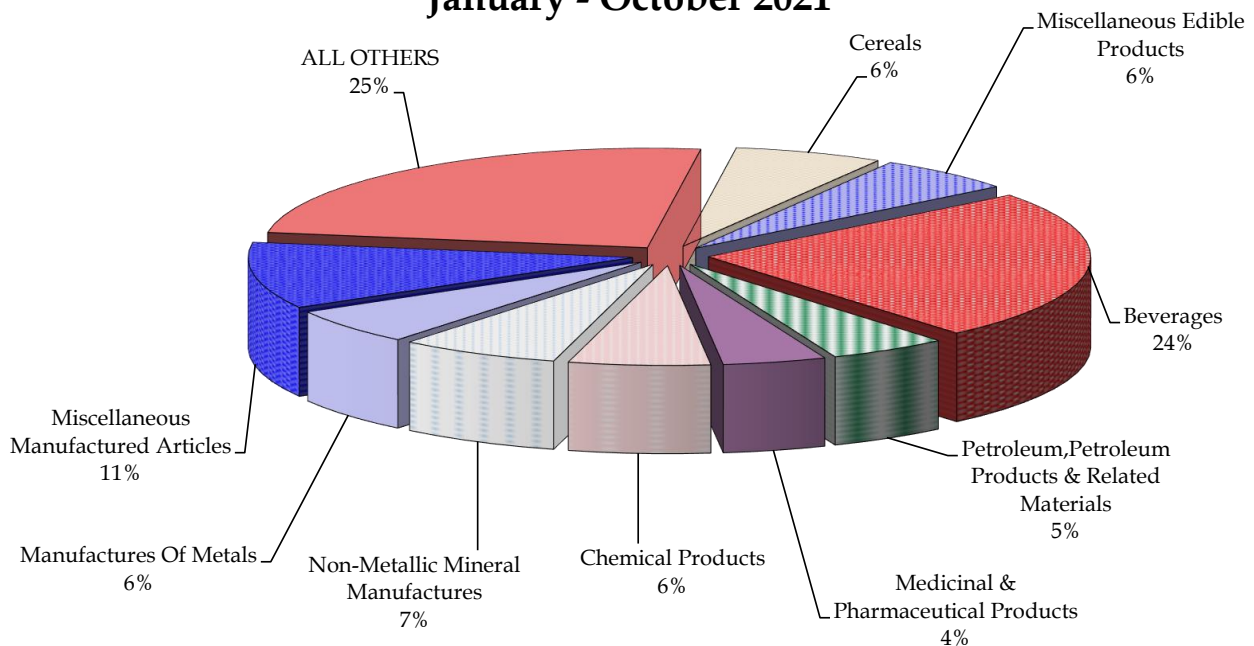

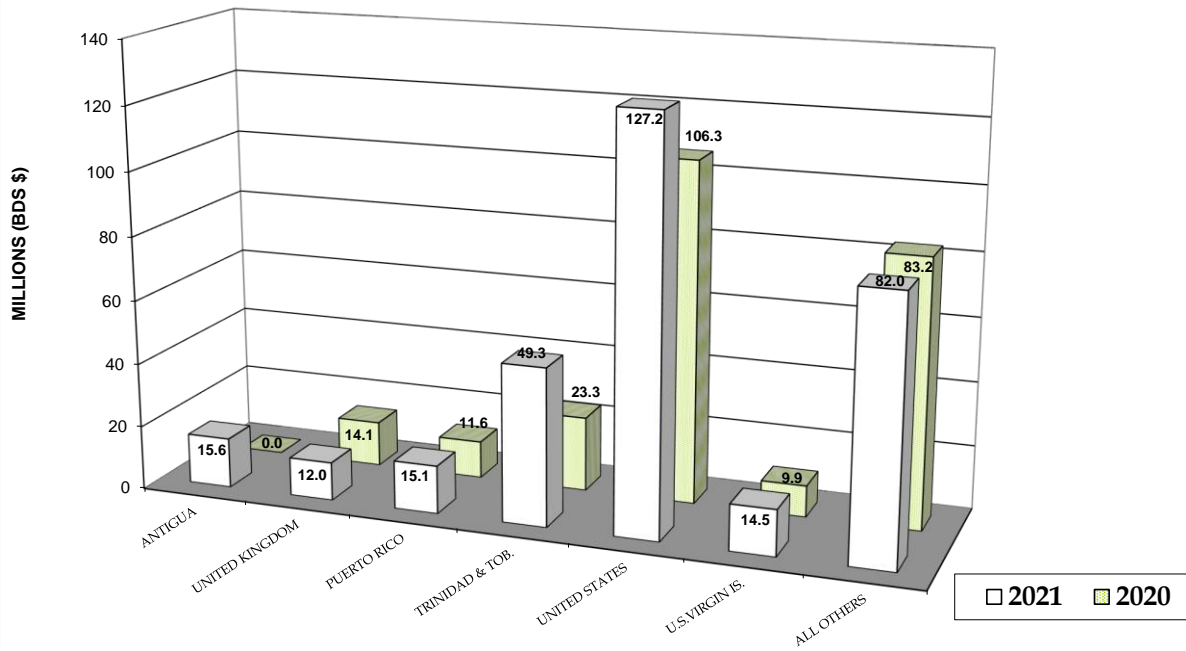

OCTOBER 2021 WITH THE CORRESPONDING MONTH OF 2020

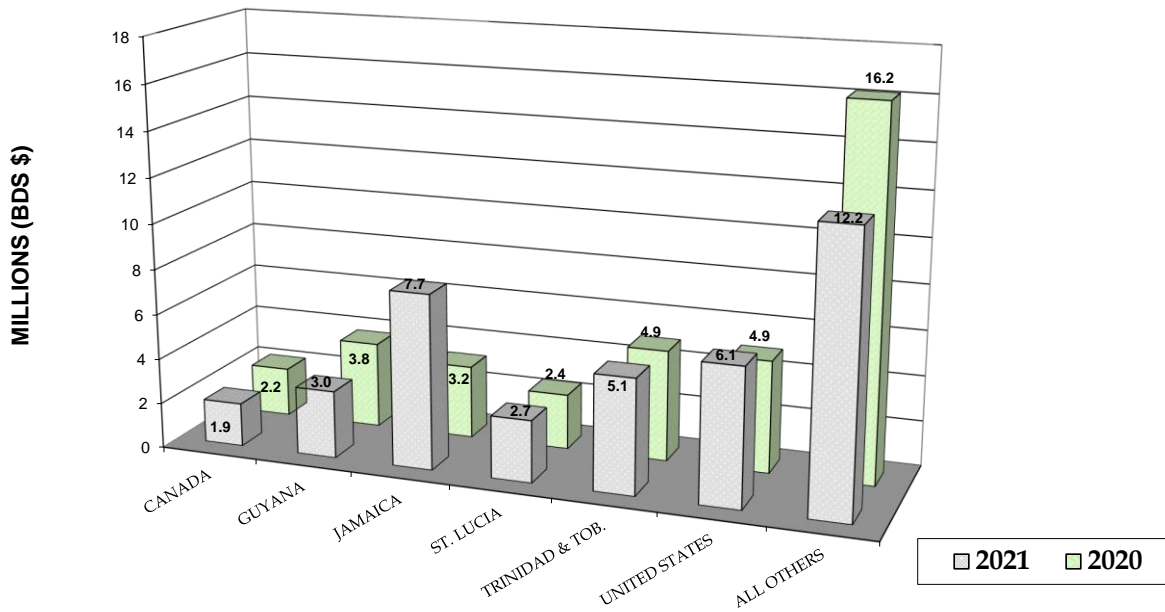


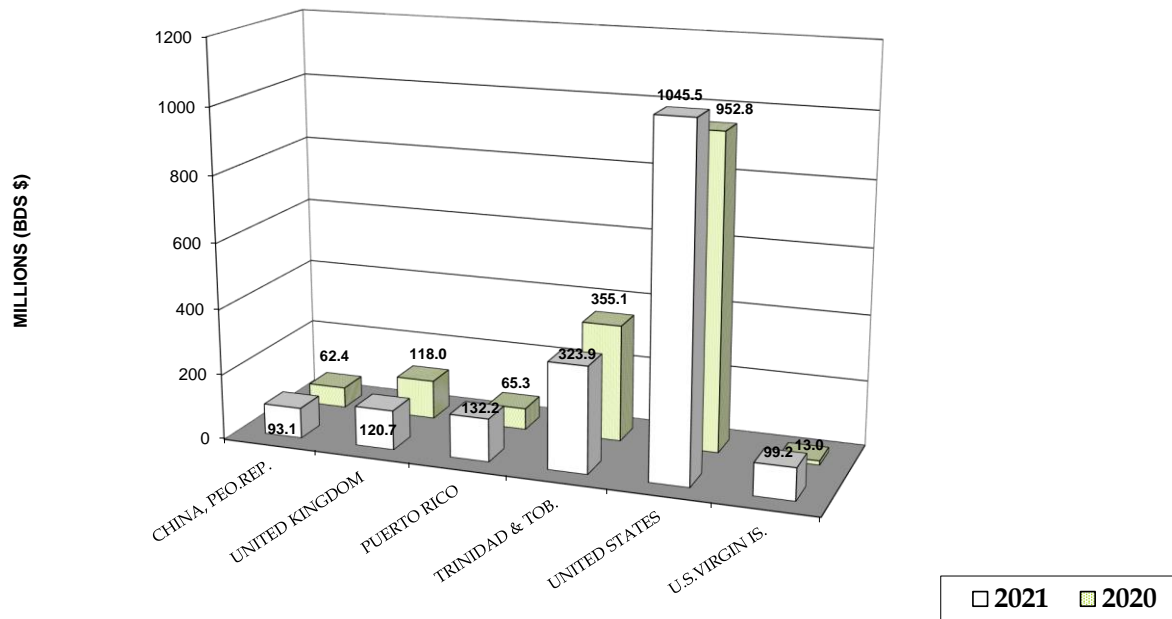

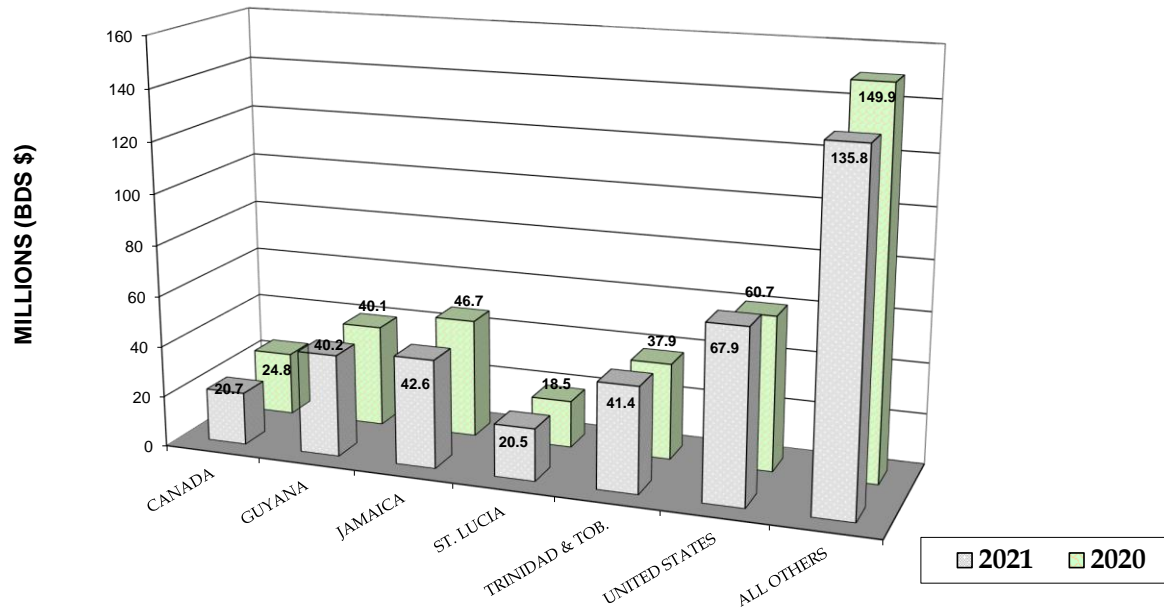

OCTOBER 2021 WITH THE CORRESPONDING MONTH OF 2020

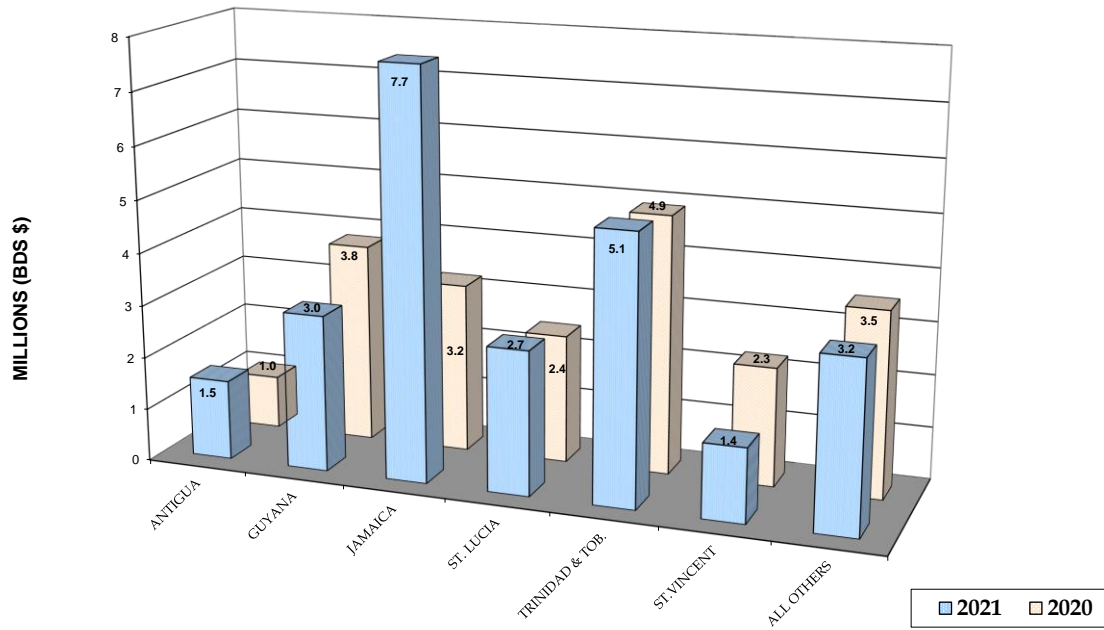


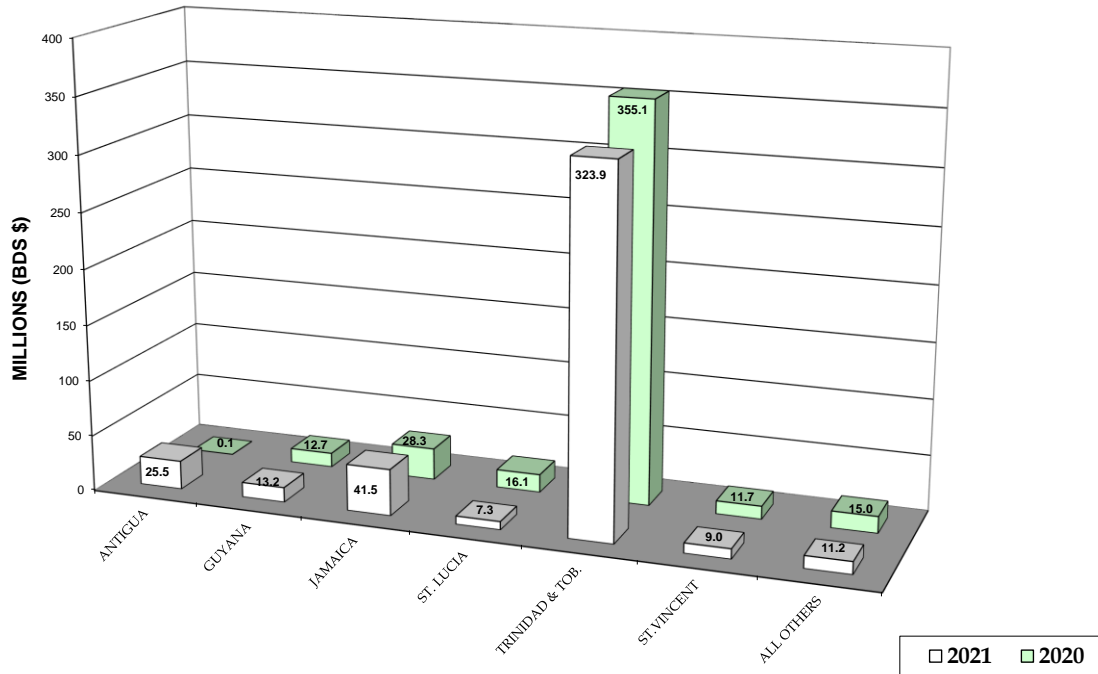

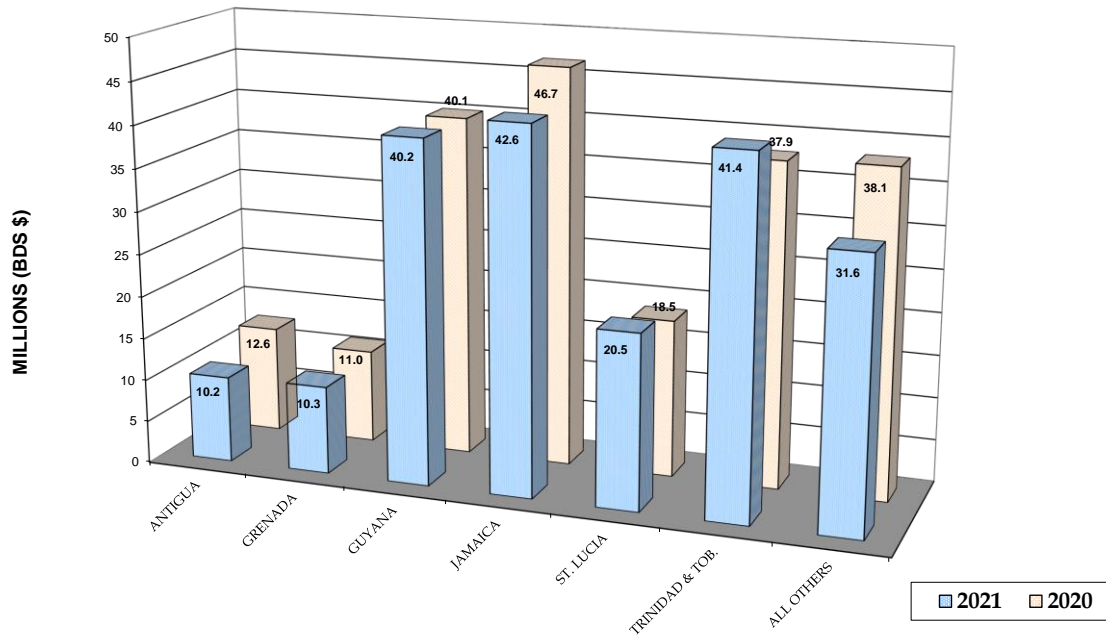
