





## **Stay-Over Visitors and Cruise Ship Passenger Arrivals**

February 2020 saw negative growth in visitor arrivals. Among stay-over visitors, arrivals decreased by **5,485** tourists (or **8.0%**) to **63,124** compared to **68,609** in the year 2019 (**Figure 1**). Conversely, total cruise arrivals increased by **1.6%** over the review period to **115,356** passengers.





A large increase was observed among stay-over arrivals from Trinidad & Tobago (166.7%)

Stay-over visitors from other countries totalled 5,501 (★220.0%)

Tourists arrivals from Other Europe expanded to 5,291 (♠86.1%)

Tourist arrivals from the U.K totalled 19,984 down from 27,081 in 2019 (♣26.2%)

#### Cruise


Landed passengers fell off to 30,142 (♣3.8%)


Intransit cruise passengers numbered 85,214 (**↑3.6%**)

The number of cruise calls totalled 65 (**↑10.2%**)

## **Other Highlights:**

Among the **63,124** stay-over arrivals recorded for this period, **53,361** (or 84.5%) visited for recreational purposes, predominantly for holiday (**40,987** tourists). This represents a decline of **10.2%** among all recreational visitors. The average number of days spent in Barbados among stay-over visitor arrivals was approximately **9.63** days over the review period.





Study arrivals totalled 631 (**151.4%**)

Intransit visits increased to 1,972 (**188.7**%)

Health care visits totalled 1,160 (**↑700.0**%)

Visits for the purpose of honeymoon/getting married rose to 1,216 ( \$\daggeq 419.7%)

Recreation visits totalled 53,361 (**₹10.2%**)

Sporting visits fell to 5621 (♣3.3%)

#### **Length of stay**


One day stay totalled 4,350 (♣35.4%)


Stays of 15-21 days changed significantly, moving from 3,436 to 6,071 (♠76.7%)

Average length of stay was 9.6 days (**₹2.7**%)

### **YEAR TO DATE**

January - February 2020 saw a decline in visitor arrivals. Among stay-over visitors, arrivals decreased by **15,409** tourists (or **11.2%**) to **122,696** compared to **138,105** in the year 2019 (**Figure 5**). Total cruise arrivals rose by **2.8%** over the review period to **262,368** passengers.







An increase was observed among stay-over arrivals from Other Countries (**111.9**%) Trinidad & Tobago stay-over visitors totalled 4,176 (**123.7**%) Tourist arrivals from Germany totalled 609 **(₹78.8%)** UK also had a dip in tourist arrivals 39,019 (**₹28.7**%) **Cruise** Intransit cruise passengers numbered 194,386 (**12.4%**) Landed passengers also rose **(1**3.8%) The number of cruise calls

totalled 144 (**15.9**%)

## **Other Highlights:**

Among the **122,969** stay-over arrivals recorded for this period, **103,123** (or 84%) visited for recreational purposes, predominantly for holiday (**77,487** tourists). The average number of days spent in Barbados among stay-over visitor arrivals was approximately **11.9** days over the review period.





Study arrivals totalled 2,677 (**126.8**%) Sports visits significantly decreased to 930 (**₹18.7%**) Other purposes of visit decreased to 1,295 (**₹5.8%**) Intransit visits totalled 3,339 (180.5%) Visiting of friends rose to 19,045 (**250.2%**) Recreation visits totalled 103,123 (**12.2%**) **Length of stay** Stay for 29-182 stay totalled 6,690 (**\$\rightarrow\$28.1%**) Average length of stay was 11.9days (**₹0.3%**)




