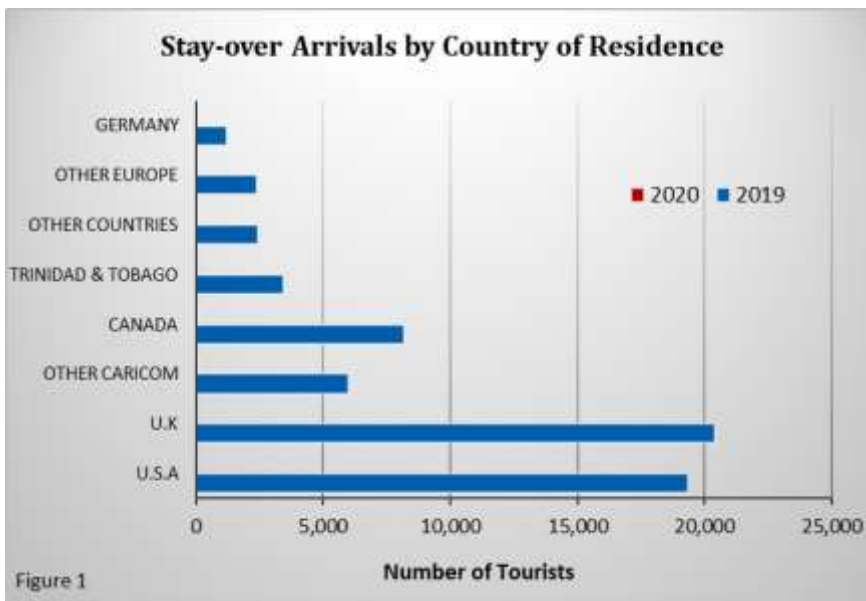


### Stay-Over Visitors and Cruise Ship Passenger Arrivals

April 2020 recorded the lowest number of stay-over visitors for the year thus far falling to a mere **136** passengers. This reflected a **(Figure 1)**. Total cruise arrivals also declined significantly over the review period to **3** passengers.



A decrease was observed among stay-over arrivals from Other Europe to 50 persons. (↓97.9%)

Arrivals from Other Countries totalled 43 (↓98.2%)

Tourists arrivals from Germany declined to 6 (↓99.5%)

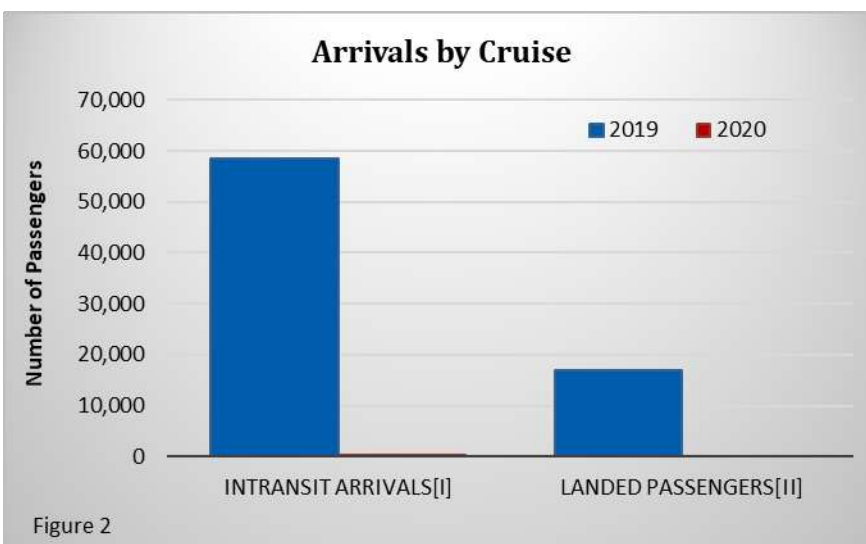
Tourist arrivals from the U.K and USA totalled 0 (↓100%)

#### Cruise

Zero landed passengers were recorded (↓100%)

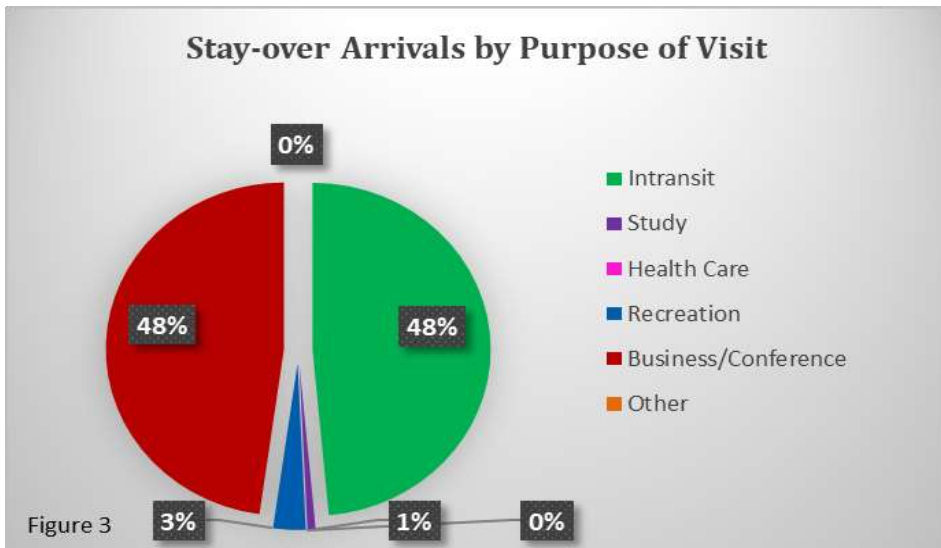
Intransit cruise passengers numbered 3 (↓100%)

The number of cruise calls totalled 4 (↓89.7%)



**Other Highlights:**

Among the **136** stay-over arrivals recorded for this period, **66** were intransit, while **65** were visiting for business/conference. redominantly for holiday (**14,809** tourists). The average number of days spent in Barbados among stay-over visitor arrivals was approximately **2** over the review period.



Business/Conference arrivals totalled 65, a drastic reduction from 6,854 (**↓99.1%**)

Recreation visits totalled 4 (**↓100.0%**)

**Length of stay**

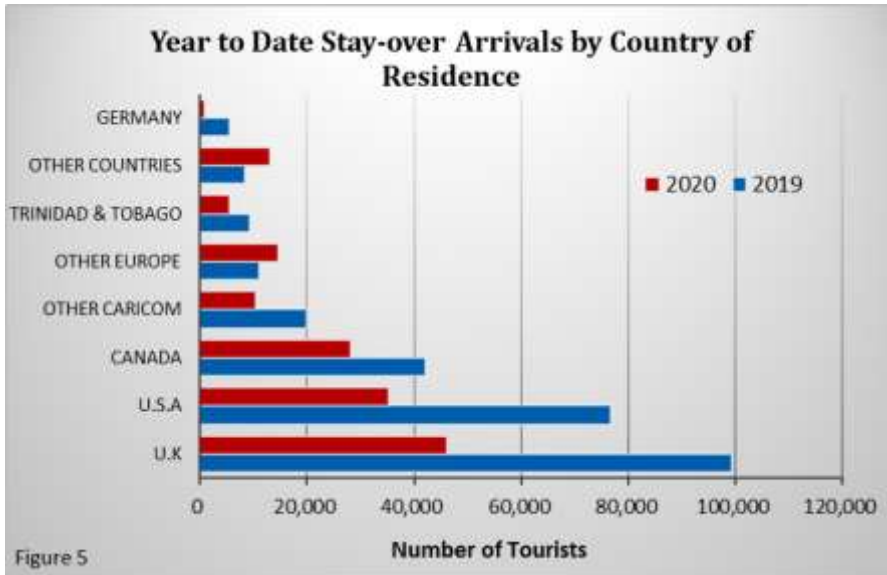
One day stays totalled 1,920 (**↓72.6%**)

Average length of stay was 9.2 days (**↑3.8%**)



## YEAR TO DATE

Between January - April 2020, there was a downturn in visitor arrivals of **43.4** percent. Among stay-over visitors, arrivals decreased by **118,154** tourists (or **43.4%**) to **153,984** compared to **272,138** in the year 2019 (**Figure 1**). Total cruise arrivals decreased by **19.3%** over the review period to **343,781** passengers.



An increase was observed among stay-over arrivals from Other Europe (**↑33.7%**)

U.K stay-over visitors totalled 46,190 (**↓41.5%**)

Tourist arrivals from Trinidad & Tobago totalled 5,490 (**↓4.8%**)

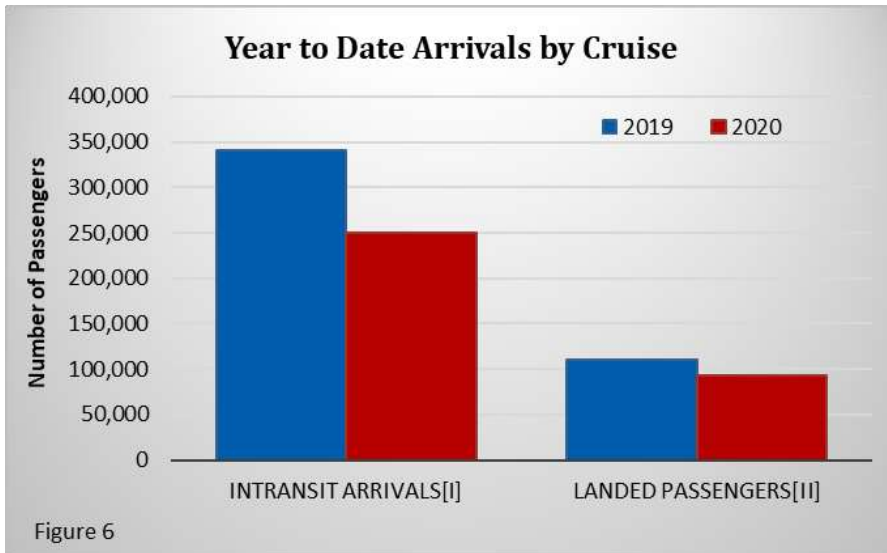
Tourists arrivals from Other Countries rose to 13,141 (**↑54.7%**)

### Cruise

Intransit cruise passengers fell to (**↓26.5%**)

Landed passengers also recorded a decline (**↓15.1%**)

The number of cruise calls totalled 196 (**↓19.3%**)



## Other Highlights:

Among the **153,984** stay-over arrivals recorded for this period, **127,592** visited for recreational purposes, predominantly for holiday (**92,299** tourists). This represents a fall off of **45.0%** among all recreational visitors. The average number of days spent in Barbados among stay-over visitor arrivals was approximately **11.8** days over the review period.

### Year to Date Stay-over Arrivals by Purpose of Visit

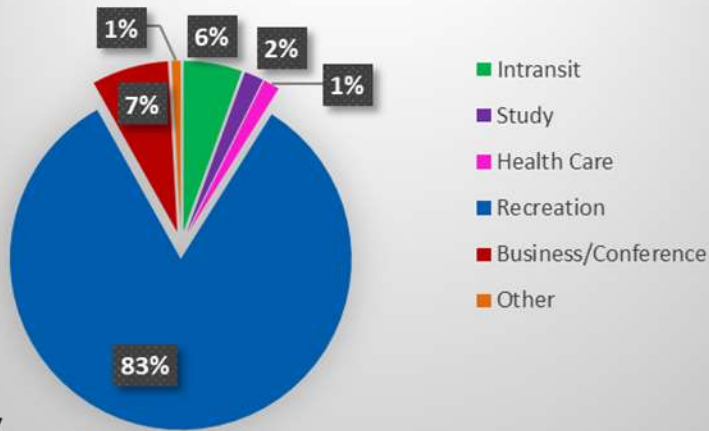

### Year to Date Stay-over Arrivals by Length of Stay

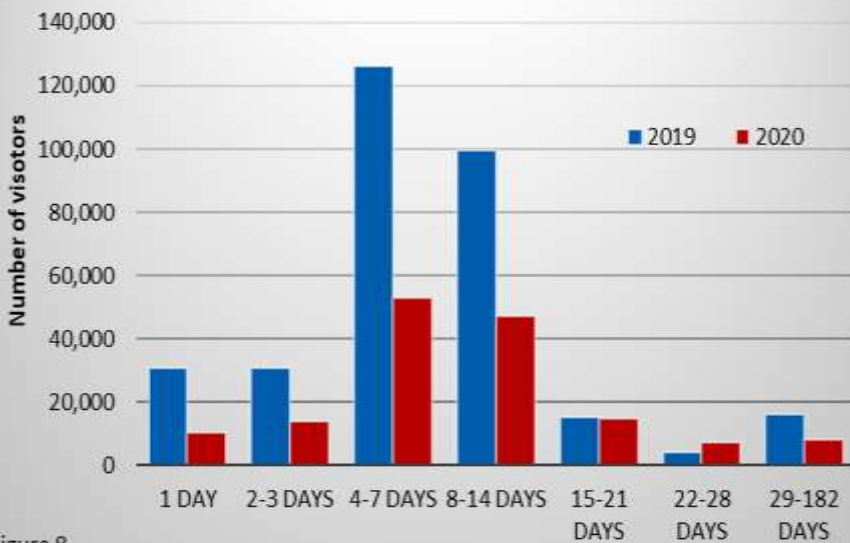

Visits for study decreased to 2,823 (↓3.3%)

#### Length of stay

Visits for 29 – 182 days decreased to 8,065 (↓50.6%)

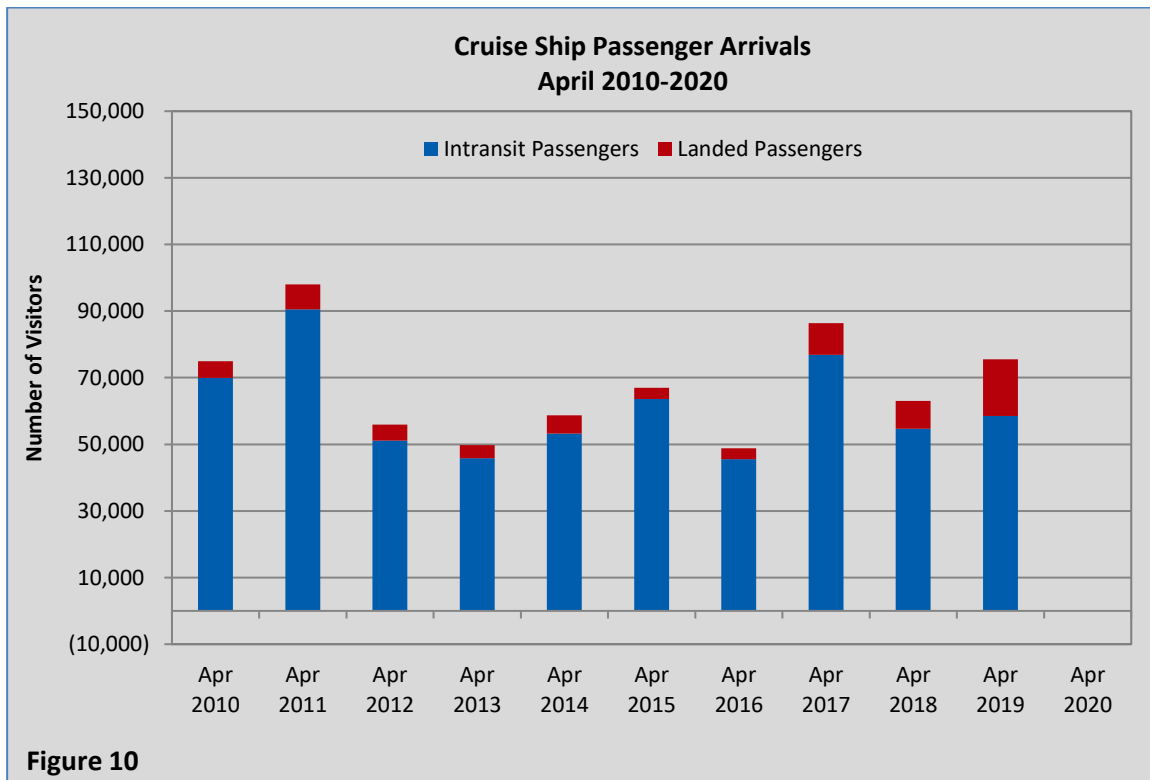
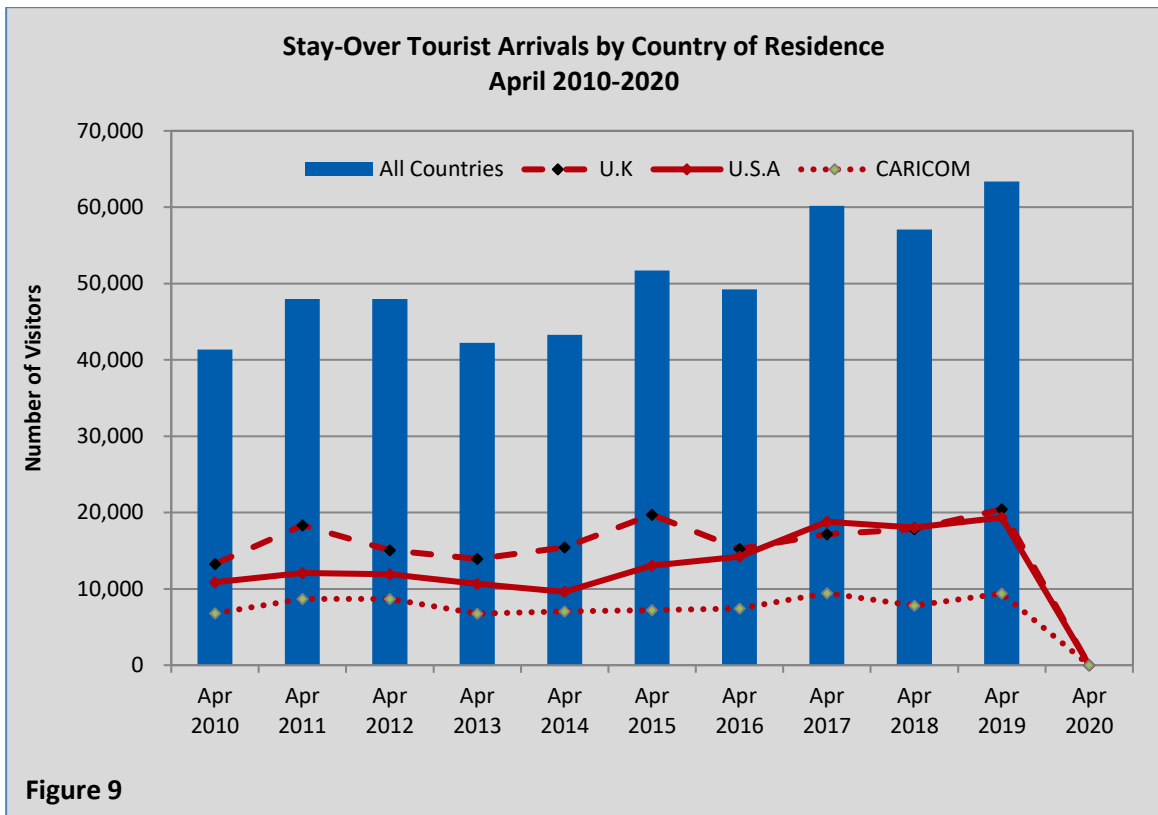
