REVIEW OF OVERSEAS TRADE

During the month of November 2021, total imports to Barbados were valued at \$367.6 million, whilst total exports from Barbados were valued at \$71.6 million. This resulted in a visible trade deficit of \$296.0 million, as compared with a visible trade deficit of \$193.2 million for November 2020.

Imports for November 2021 were \$123.4 million more than imports for November 2020, an increase of 50.5%. Total exports increased by \$20.6 million or 40.3% of the November 2020 figure. Domestic exports decreased by \$1.2 million or 2.9% over November 2020, while the value of re-exports increased by \$21.7 million or 190.8% over the corresponding period 2020.

For the period January – November 2021, the value of imports to Barbados was \$2.98 billion, whilst the value of total exports was \$615.6 million representing an accumulated visible trade deficit of \$2.36 billion as compared to a similar deficit of \$2.07 billion for January – November 2020.

Imports for January – November 2021 were \$264.9 million more than imports for the same period 2020, an increase of 9.8%. Total exports showed a decrease of some \$27.2 million or 4.2% over the January - November 2020 figure. Domestic exports decreased by \$10.6 million or 2.5% over January – November 2020. The value of re-exports decreased by \$16.6 million or 7.4% over the corresponding period 2020.

CARICOM TRADE

During the month of November 2021, total imports from CARICOM countries were valued at \$86.7 million, whilst total exports to CARICOM were valued at \$27.5 million, resulting in a trade deficit of \$59.2 million as compared with a visible trade deficit of \$11.6 million for November 2020.

Total CARICOM imports for November 2021 were \$47.1 million more than CARICOM imports for November 2020, an increase of 118.7%. Total exports to CARICOM for November 2021 were \$0.5 million less than total exports for November 2020, a decrease of 1.9%. Domestic exports decreased by \$1.0 million or 4.1% over November 2020. The value of re-exports increased by some \$0.4 million, or 9.7%, over the November 2020 figure.

For the period January – November 2021, total imports from CARICOM were valued at \$518.3 million, whilst total exports were \$260.3 million resulting in an accumulated visible trade deficit of \$258.0 million as compared with a deficit of \$208.9 million for the same period of 2020.

During this period, CARICOM imports were approximately \$39.8 million more than those over the same period in 2020, an increase of 8.3%. Total exports to CARICOM for January – November 2021 were \$9.4 million less than total exports for the corresponding period 2020, a decrease of 3.5%. Domestic exports decreased by approximately \$9.0 million or 3.9% over the same period 2020. The value of re-exports increased by \$0.4 million or 1.1% over the January – November 2020 figure.

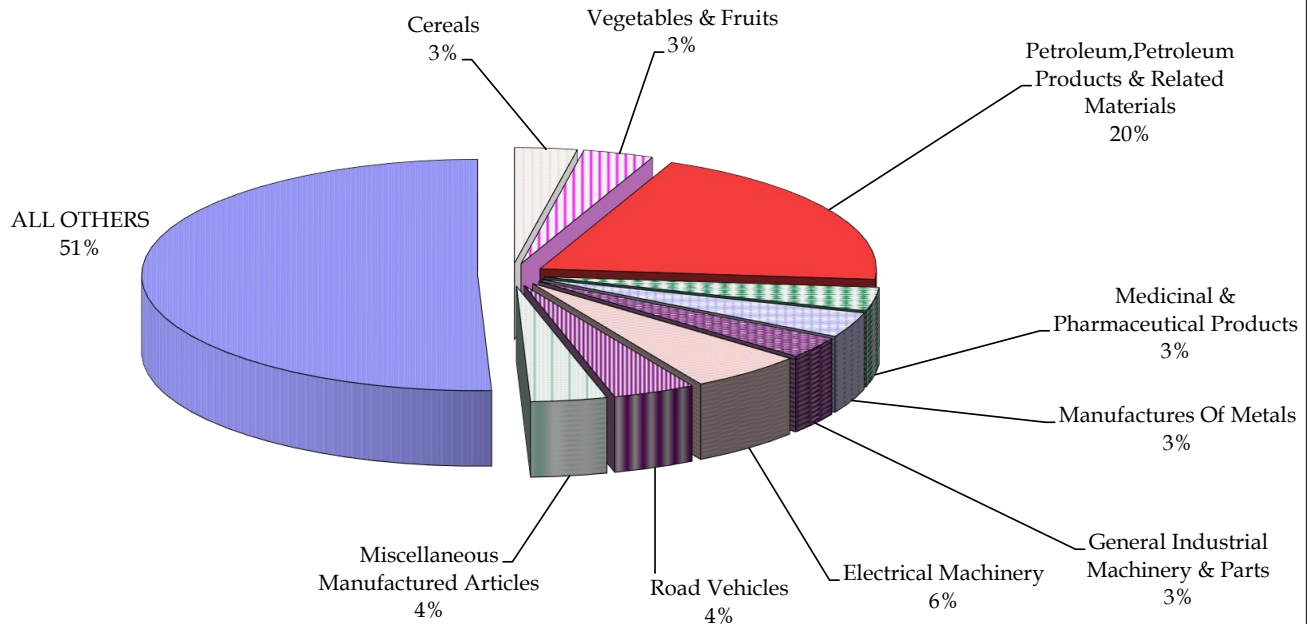

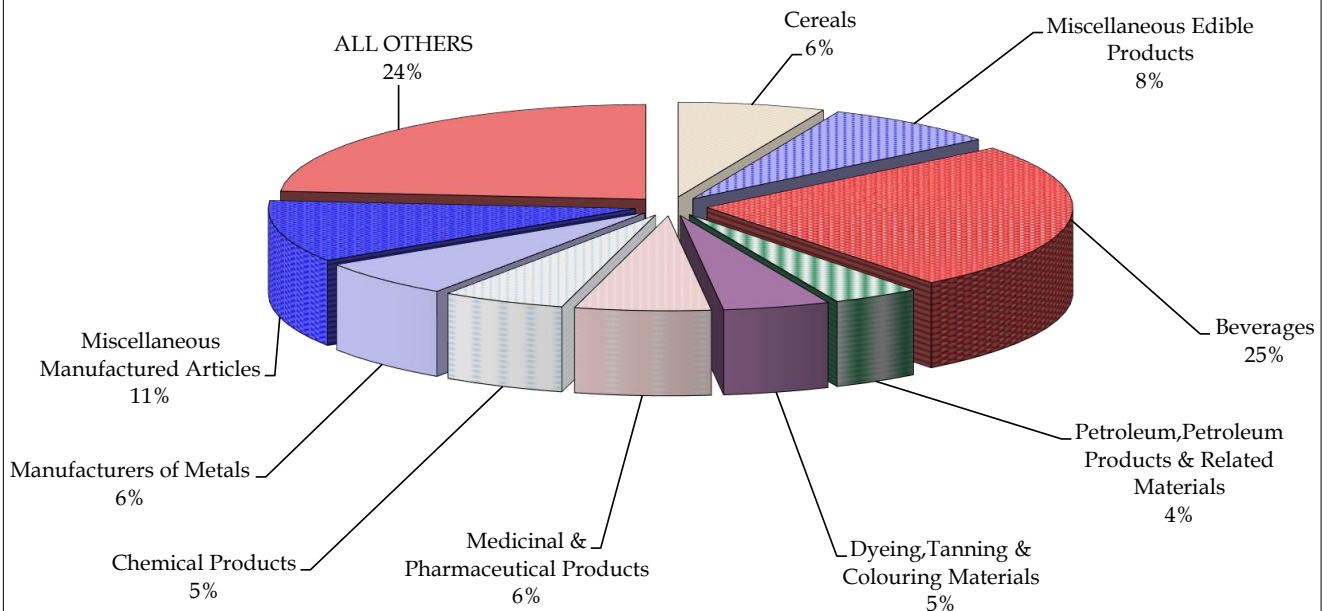

Principal Domestic Exports - November 2021



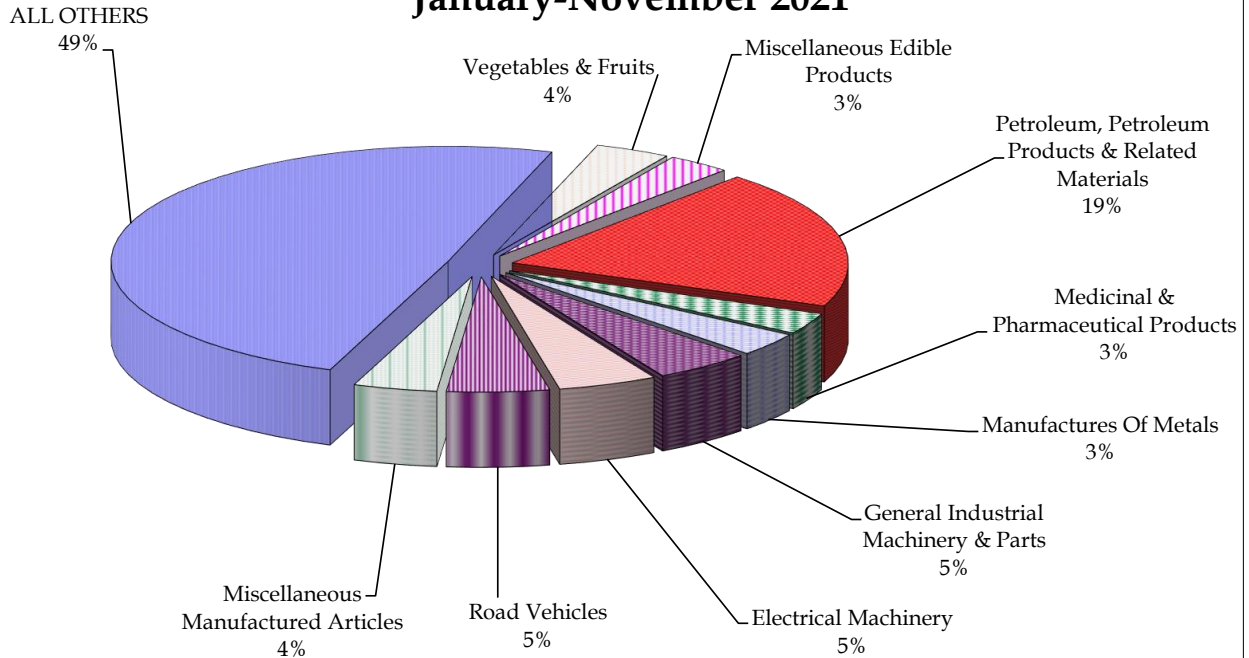

Principal Domestic Exports January- November 2021

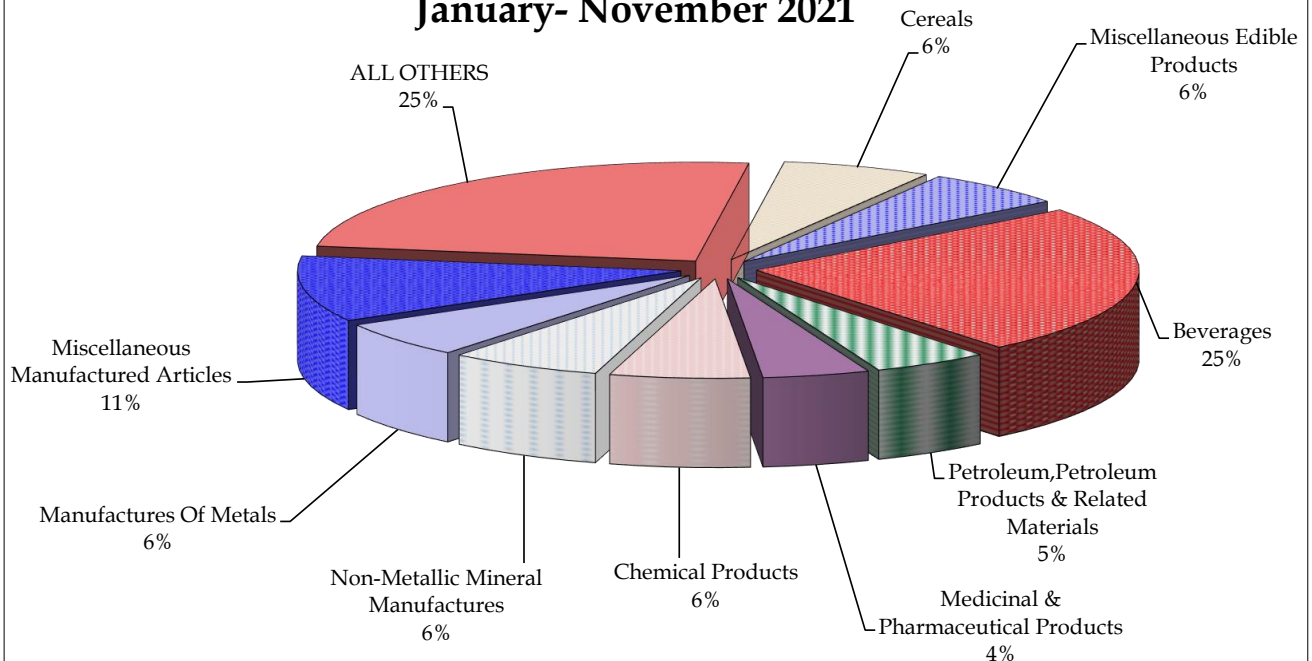

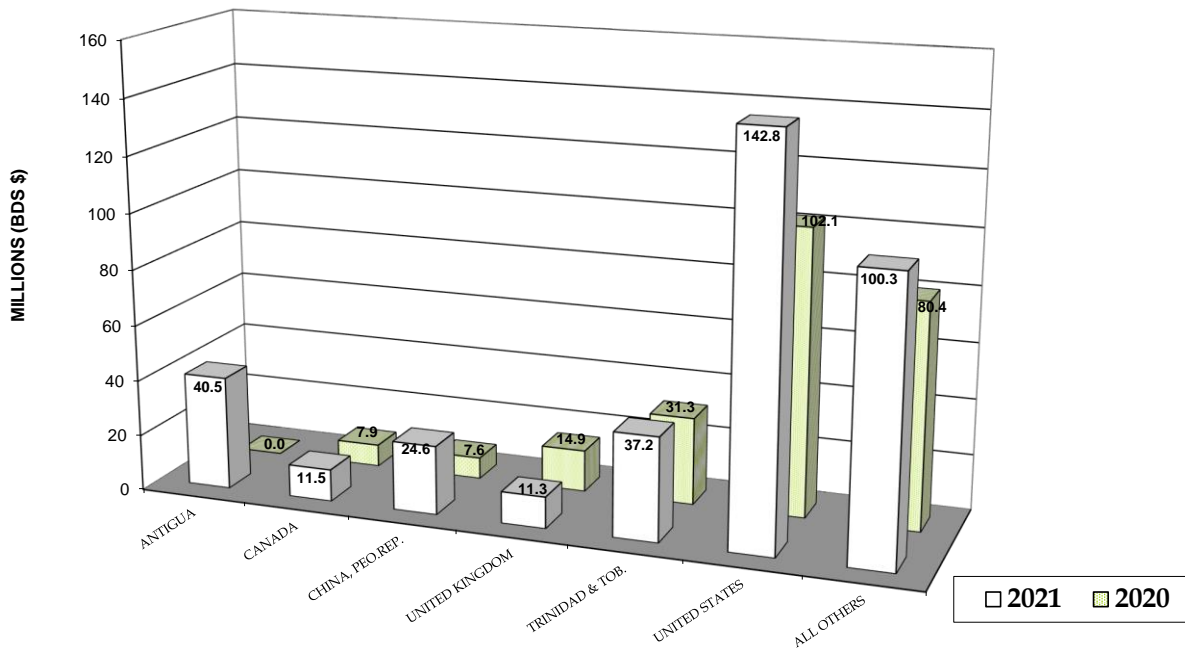

NOVEMBER 2021 WITH THE CORRESPONDING MONTH OF 2020

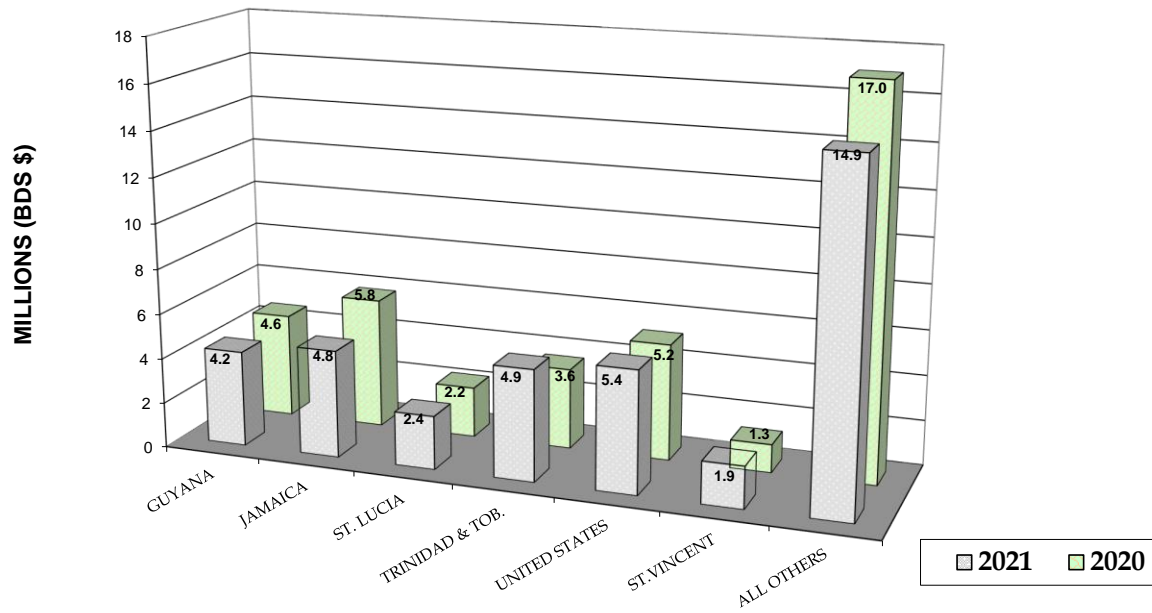


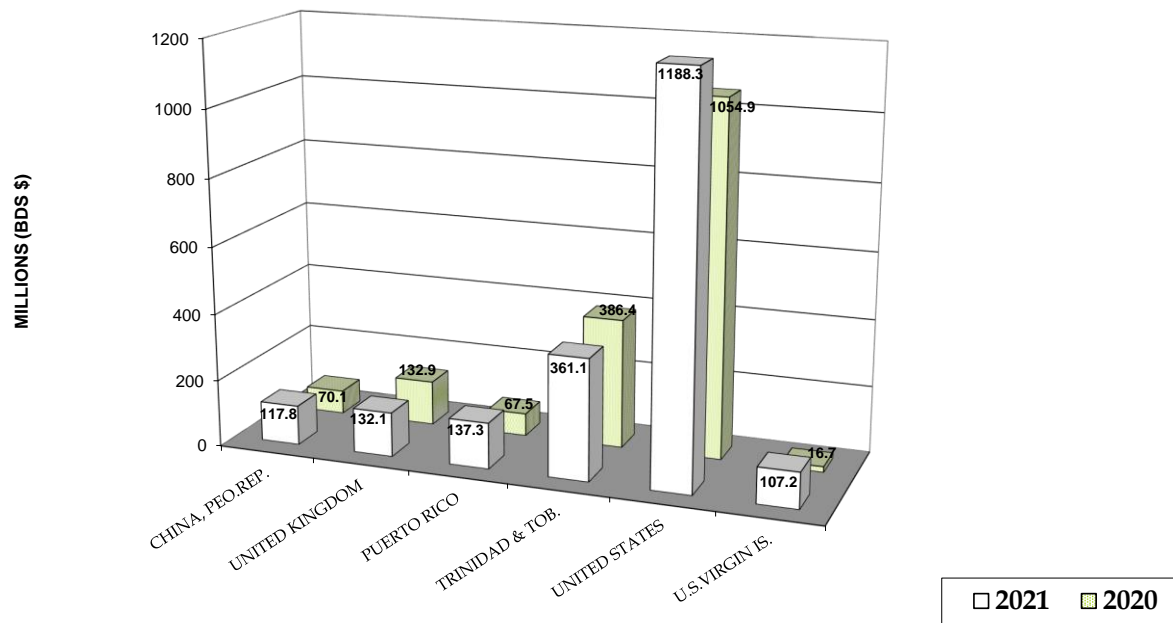

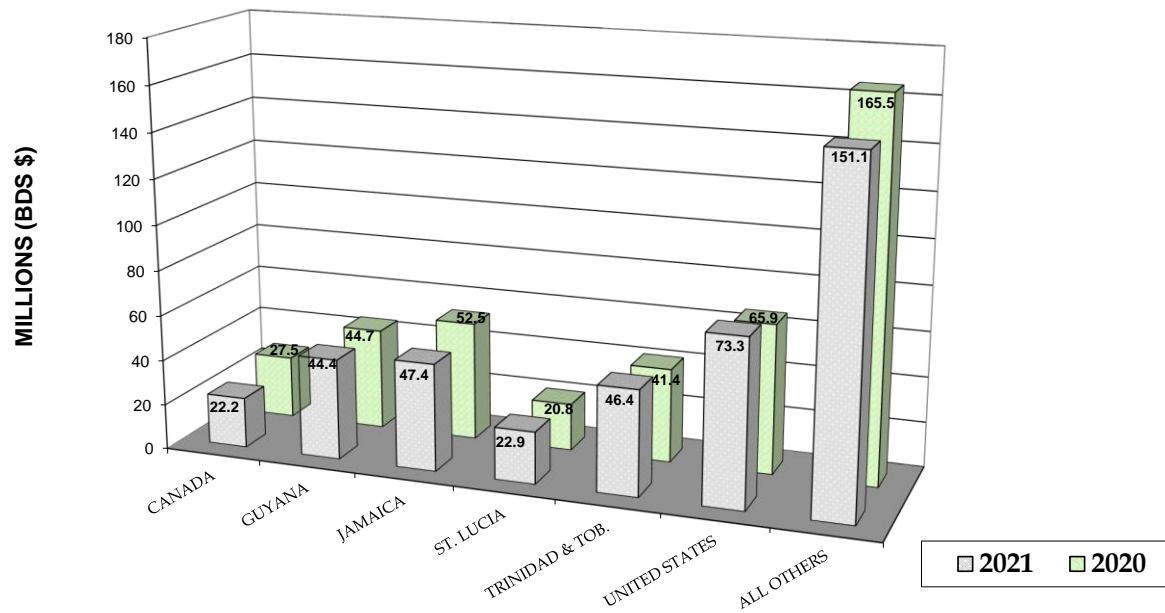

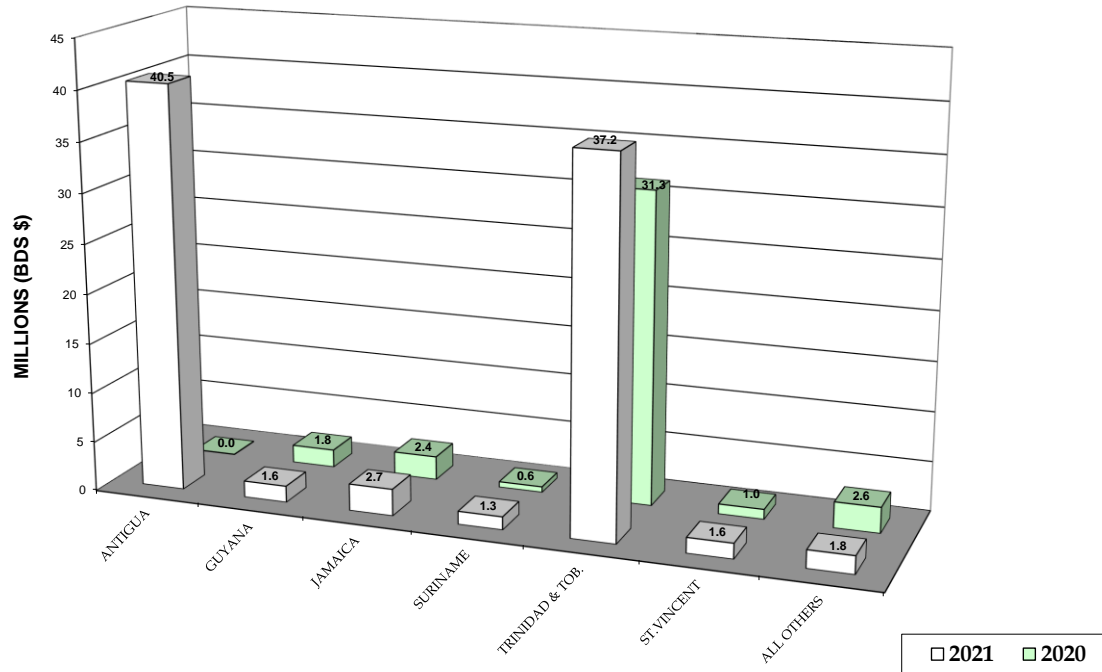

NOVEMBER 2021 WITH THE CORRESPONDING MONTH OF 2020

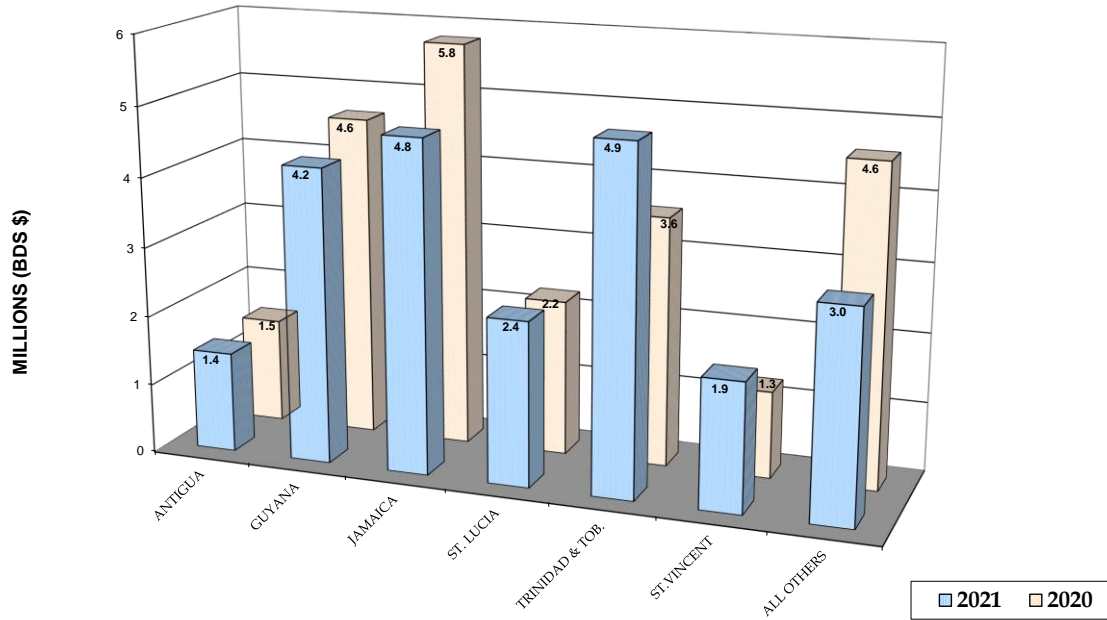


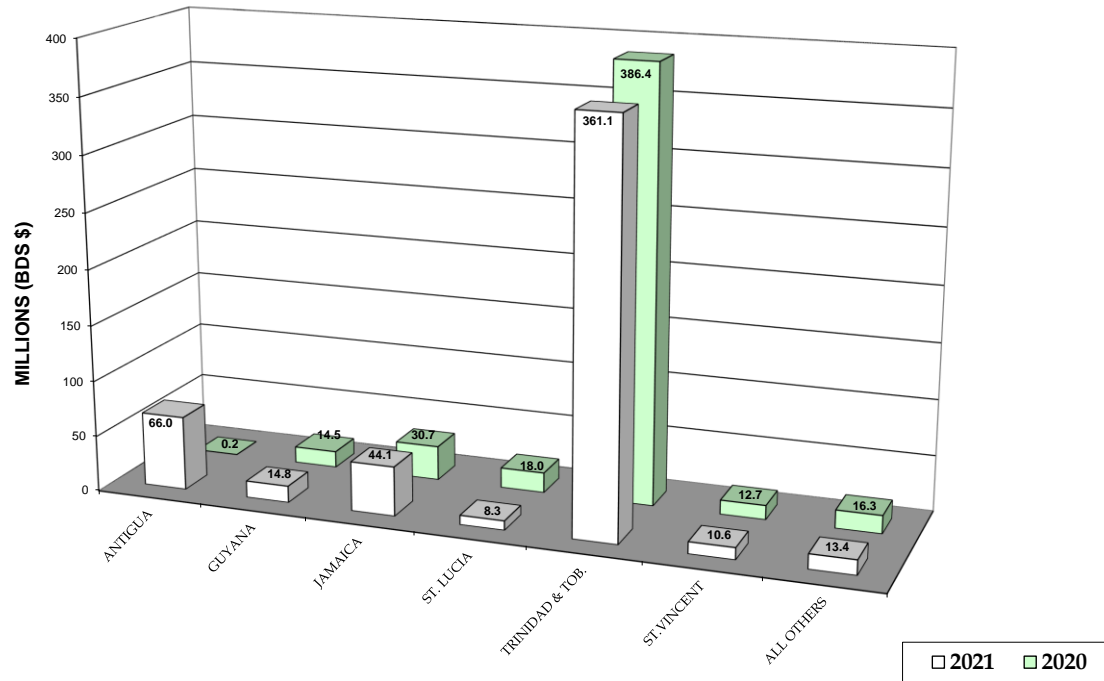

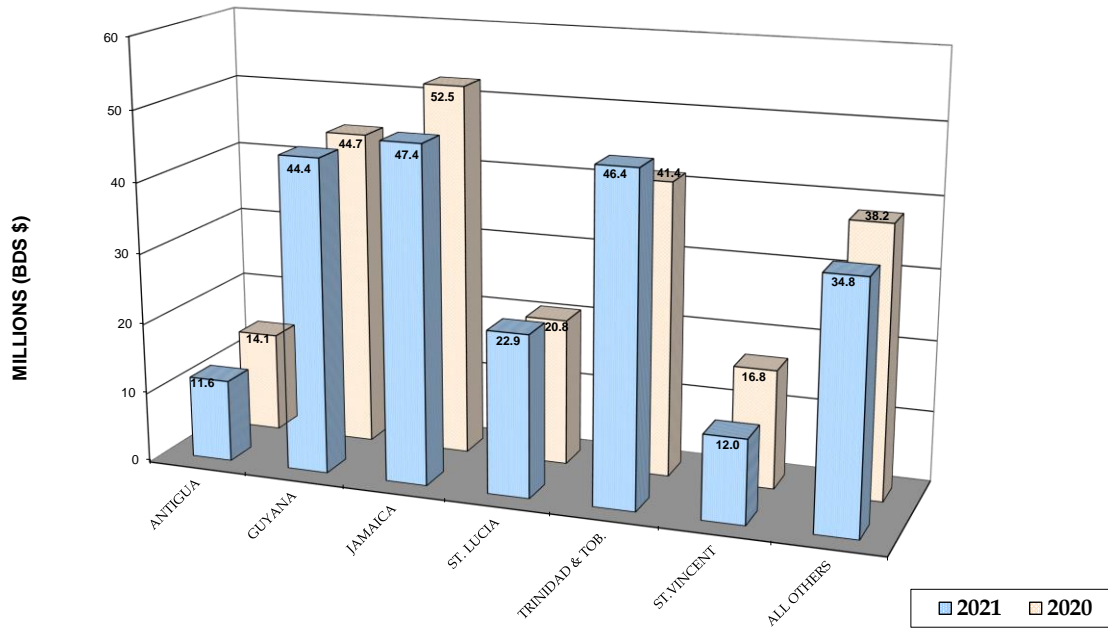
