REVIEW OF OVERSEAS TRADE

During the month of June 2022, total imports to Barbados were valued at \$328.1 million, whilst total exports from Barbados were valued at \$64.8 million. This resulted in a visible trade deficit of \$263.3 million, as compared with a visible trade deficit of \$231.8 million for June 2021.

Imports for June 2022 were \$44.7 million more than imports for June 2021, an increase of 15.8%. Total exports increased by \$13.2 million or 25.7% of the June 2021 figure. Domestic exports decreased by \$0.8 million or 2.1% over June 2021, while the value of re-exports increased by \$14.1 million or 109.8% over the corresponding period 2021.

For the period January – June 2022, the value of imports to Barbados was \$2.156 billion, whilst the value of total exports was \$504.6 million representing an accumulated visible trade deficit of \$1.649 billion as compared to a similar deficit of \$1.122 billion for January – June 2021.

Imports for January – June 2022 were \$713.2 million more than imports for the same period 2021, an increase of 49.4%. Total exports showed an increase of some \$185.9 million or 58.0% over the January - June 2021 figure. Domestic exports increased by \$26.5 million or 12.0% over January – June 2021. The value of re-exports increased by \$159.4 million or 159.0% over the corresponding period 2021.

CARICOM TRADE

During the month of June 2022, total imports from CARICOM countries were valued at \$87.1 million, whilst total exports to CARICOM were valued at \$26.3 million, resulting in a trade deficit of \$60.8 million as compared with a visible trade deficit of \$12.7 million for June 2021.

Total CARICOM imports for June 2022 were \$50.5 million more than CARICOM imports for June 2021, an increase of 137.7%. Total exports to CARICOM for June 2022 were \$2.3 million more than total exports for June 2021, an increase of 9.8%. Domestic exports increased by \$2.2 million or 11.0% over June 2021. The value of re-exports increased by some \$0.1 million, or 3.9%, over the June 2021 figure.

For the period January – June 2022, total imports from CARICOM were valued at \$526.6 million, whilst total exports were \$162.7 million resulting in an accumulated visible trade deficit of \$363.9 million as compared with a deficit of \$82.0 million for the same period of 2021.

During this period, CARICOM imports were approximately \$311.3 million more than those over the same period in 2021, an increase of 144.6%. Total exports to CARICOM for January – June 2022 were \$29.4 million more than total exports for the corresponding period 2021, an increase of 22.1%. Domestic exports increased by approximately \$27.7 million or 25.0% over the same period 2021. The value of re-exports increased by \$1.8 million or 7.9% over the January – June 2021 figure.

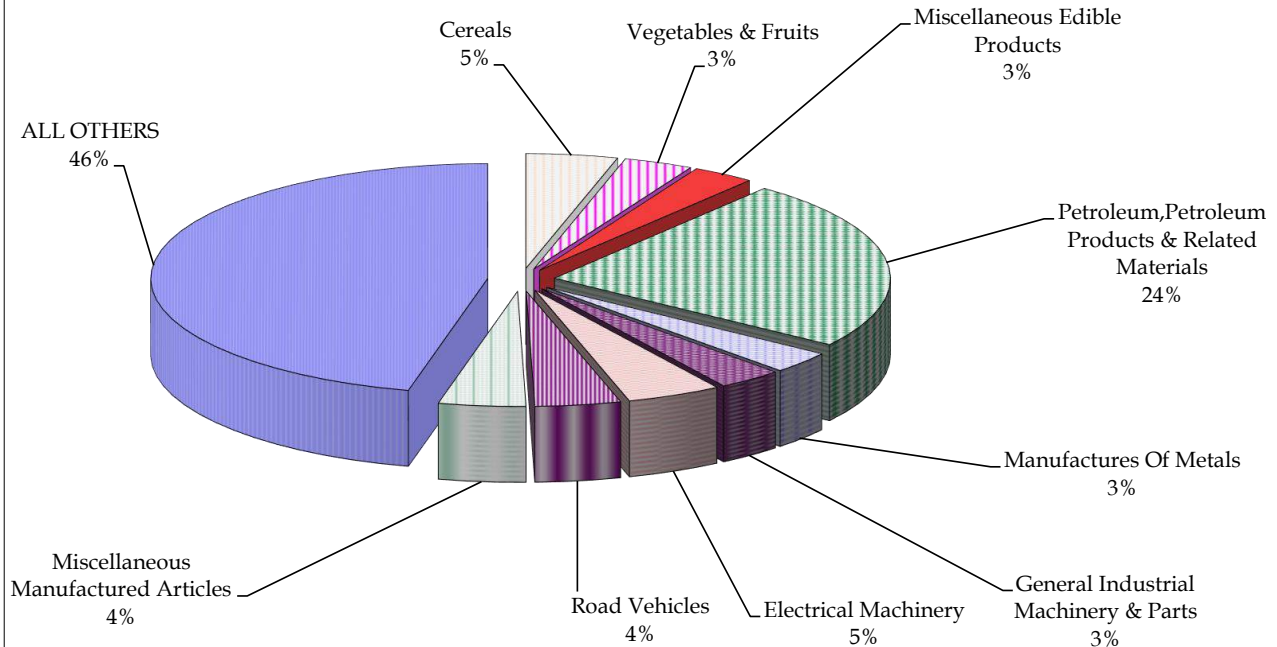

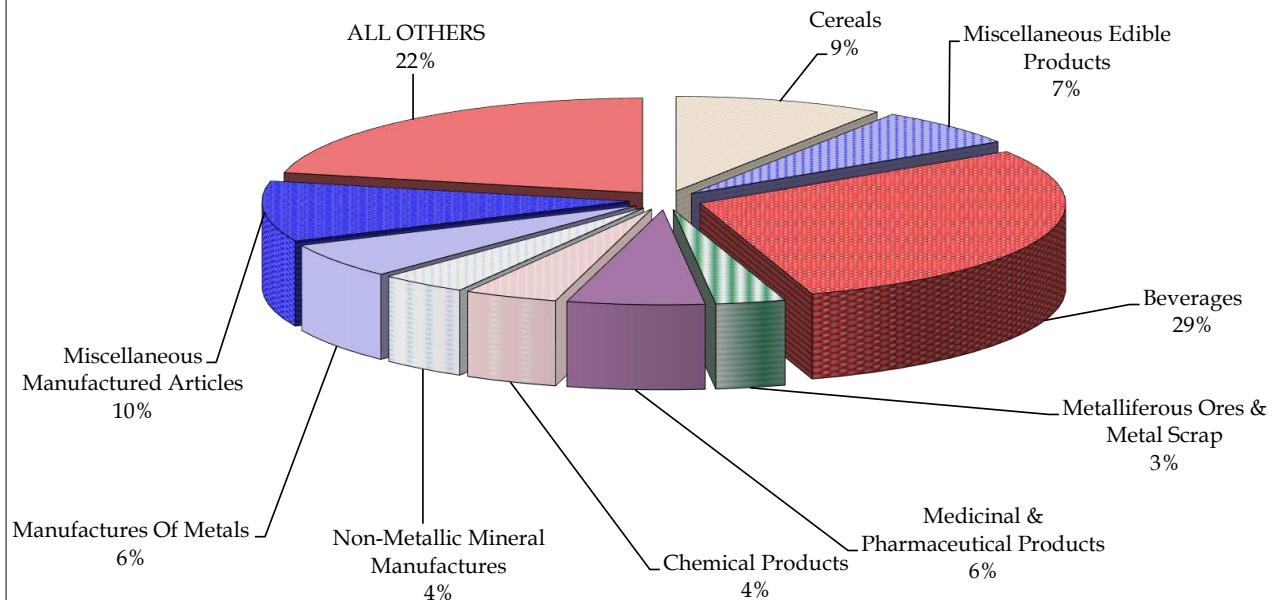

Principal Domestic Exports - June 2022



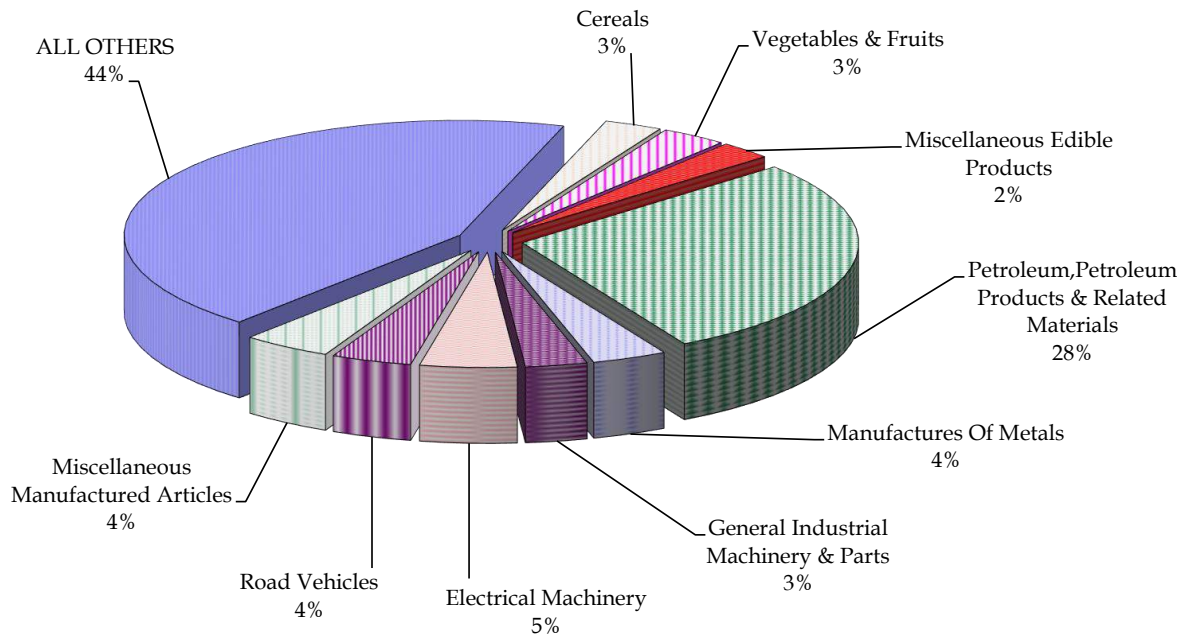

Principal Domestic Exports January- June 2022

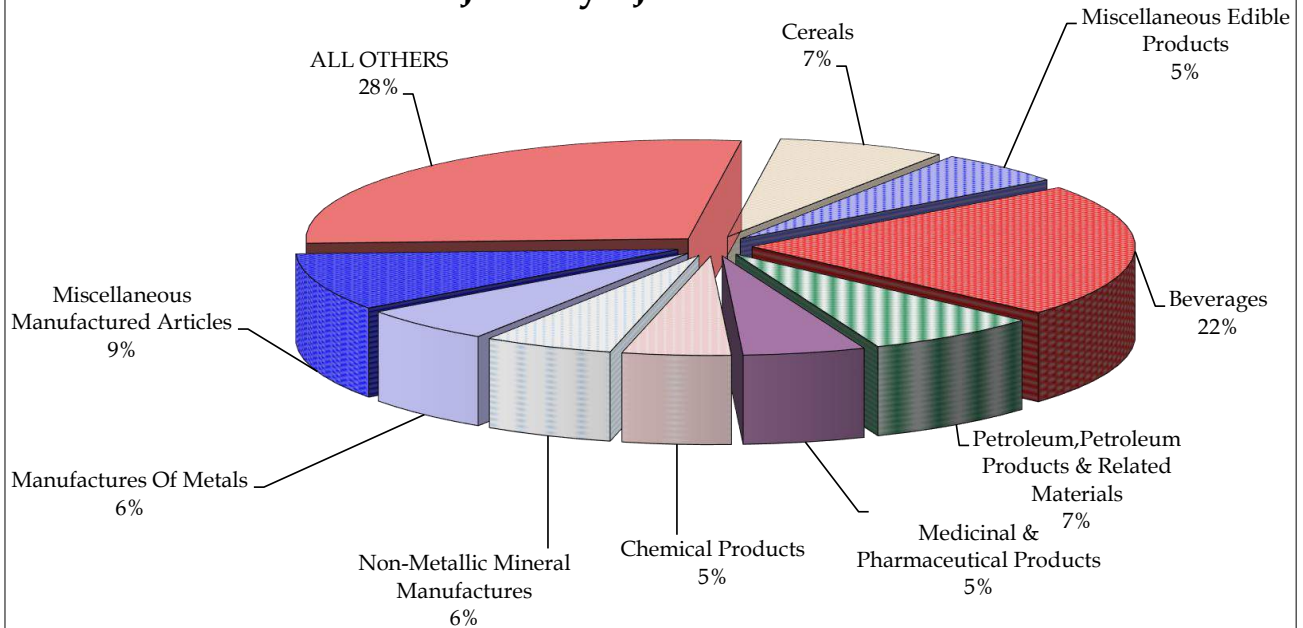

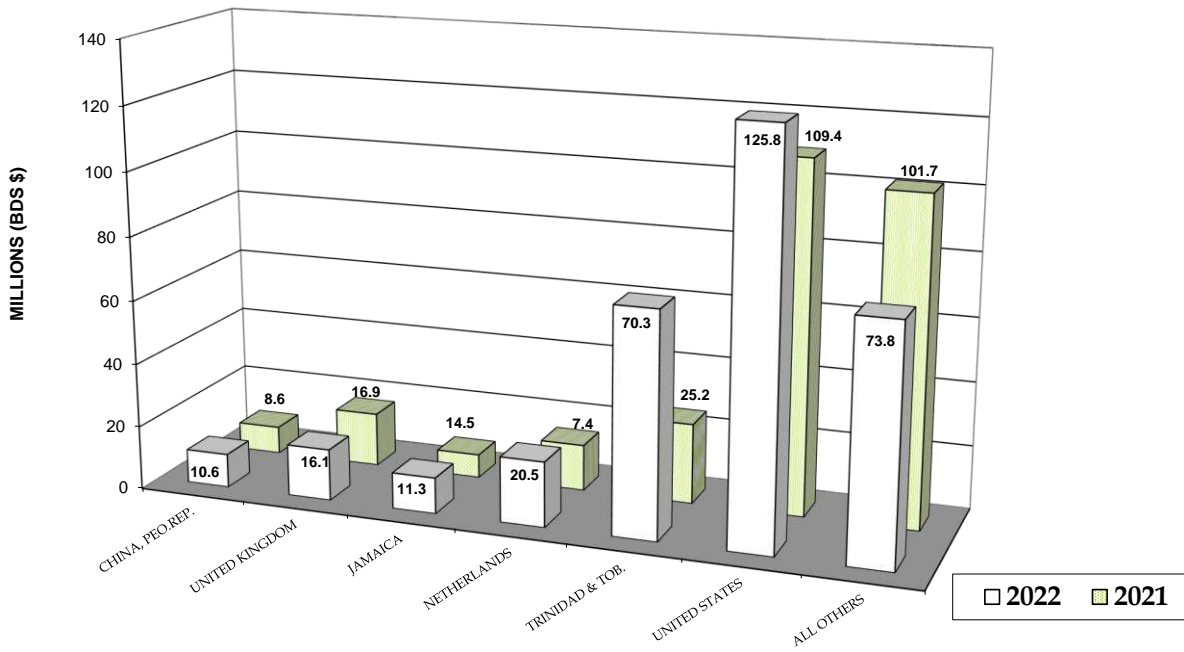

JUNE 2022 WITH THE CORRESPONDING MONTH OF 2021

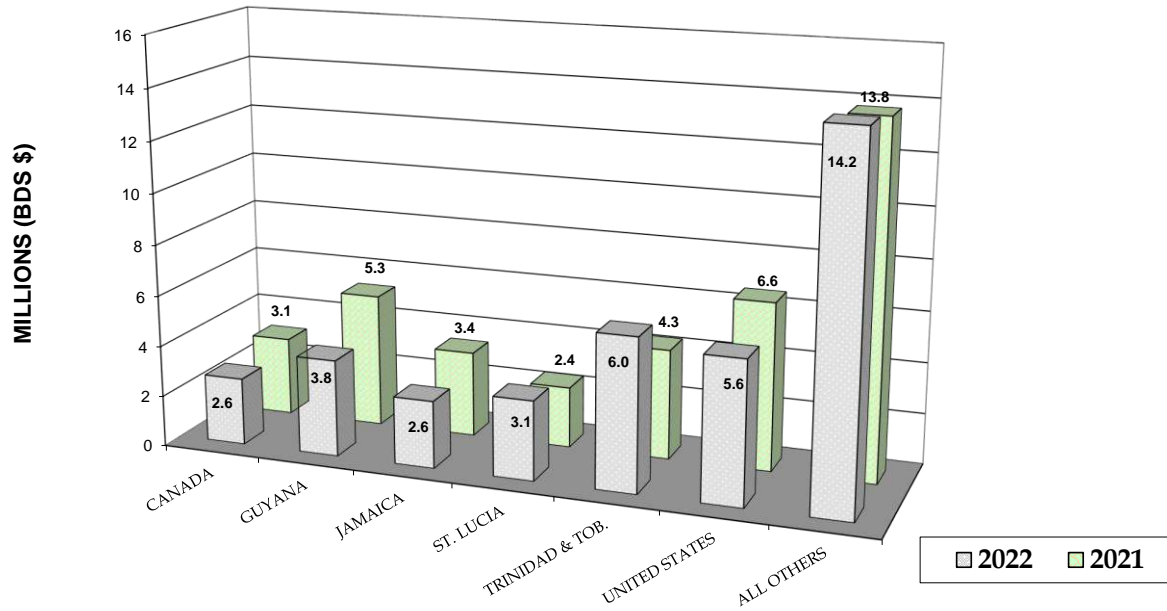


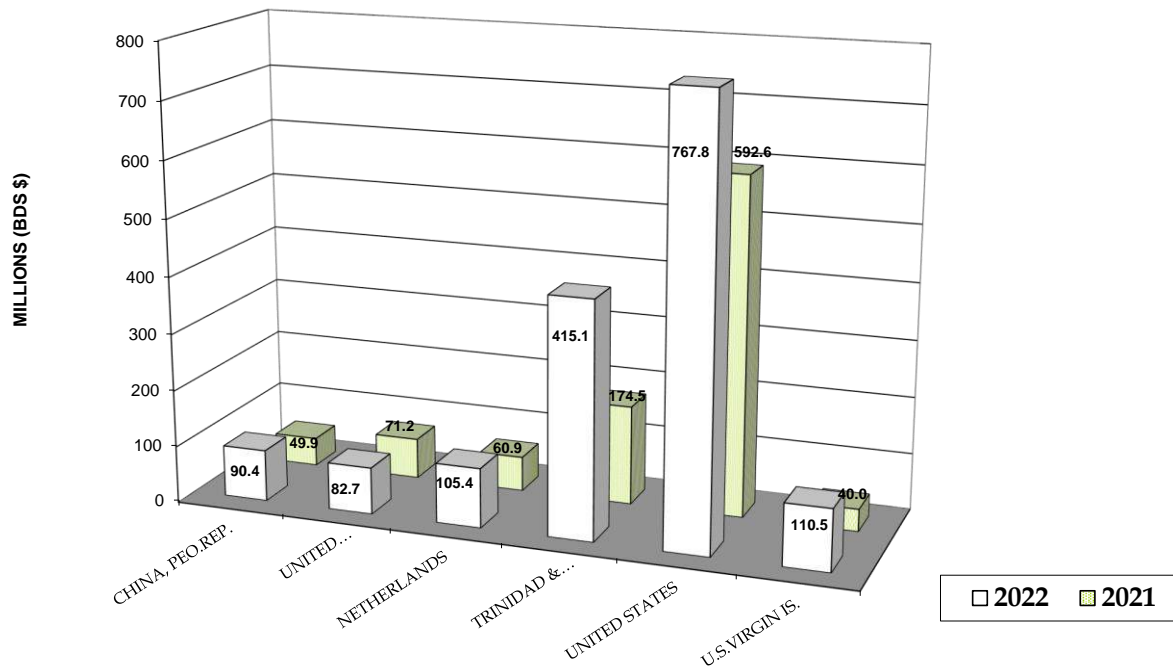

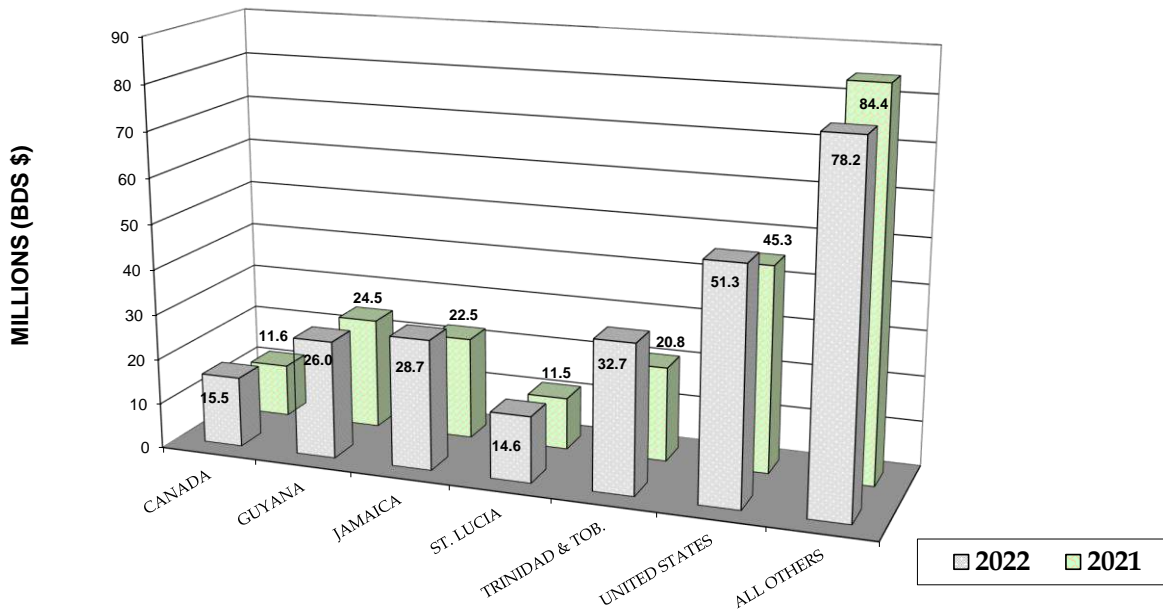

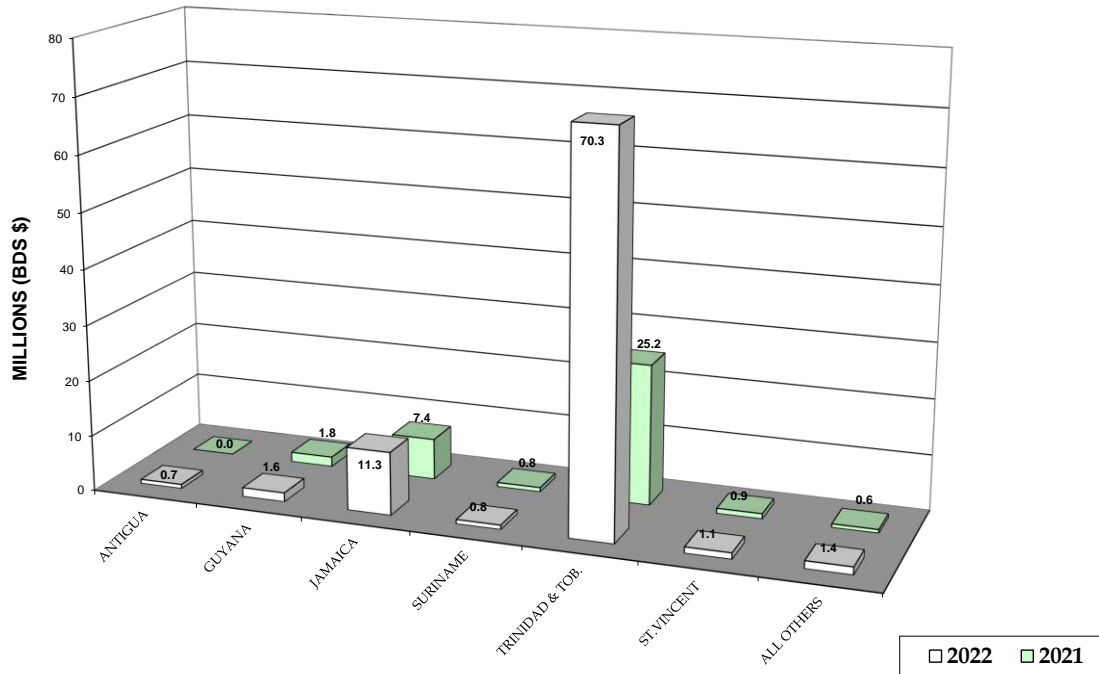

JUNE 2022 WITH THE CORRESPONDING MONTH OF 2021

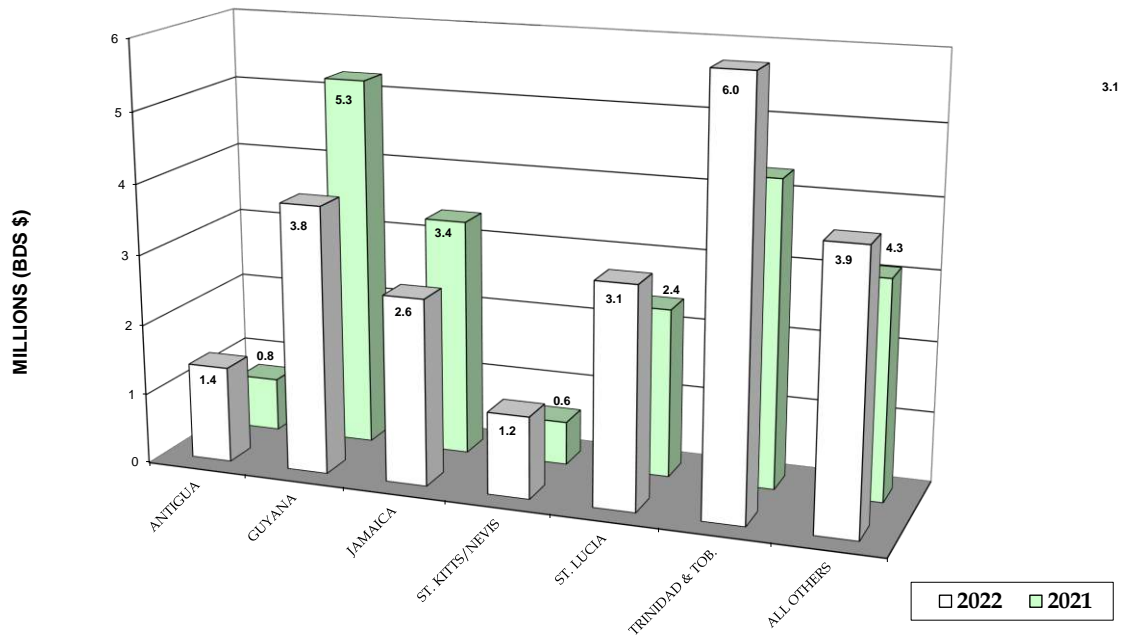


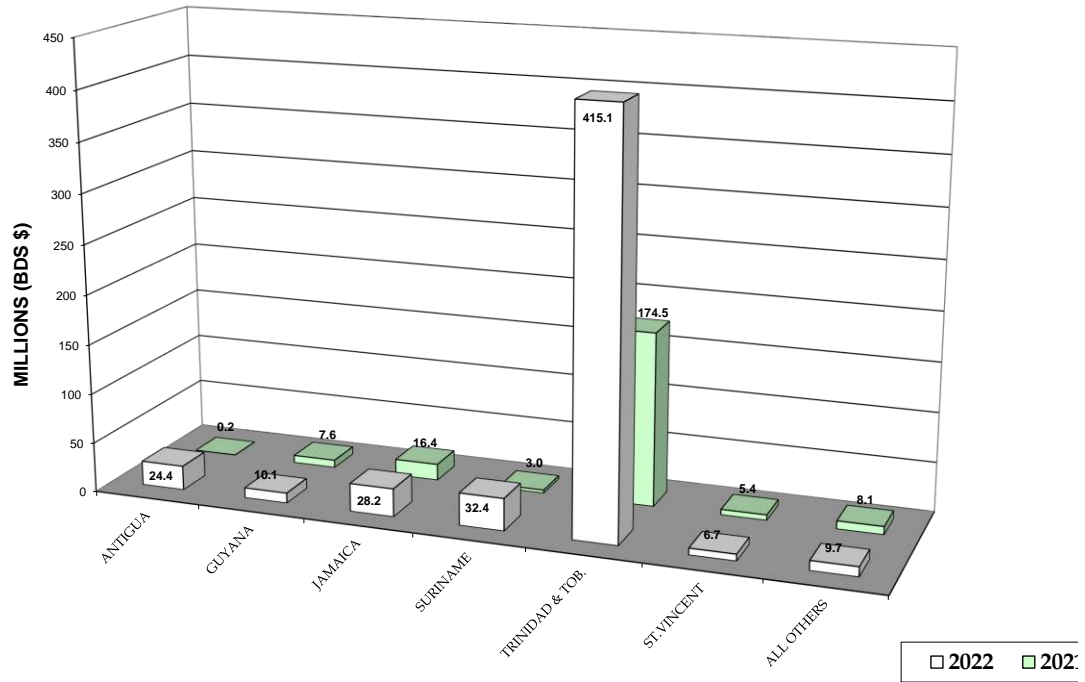

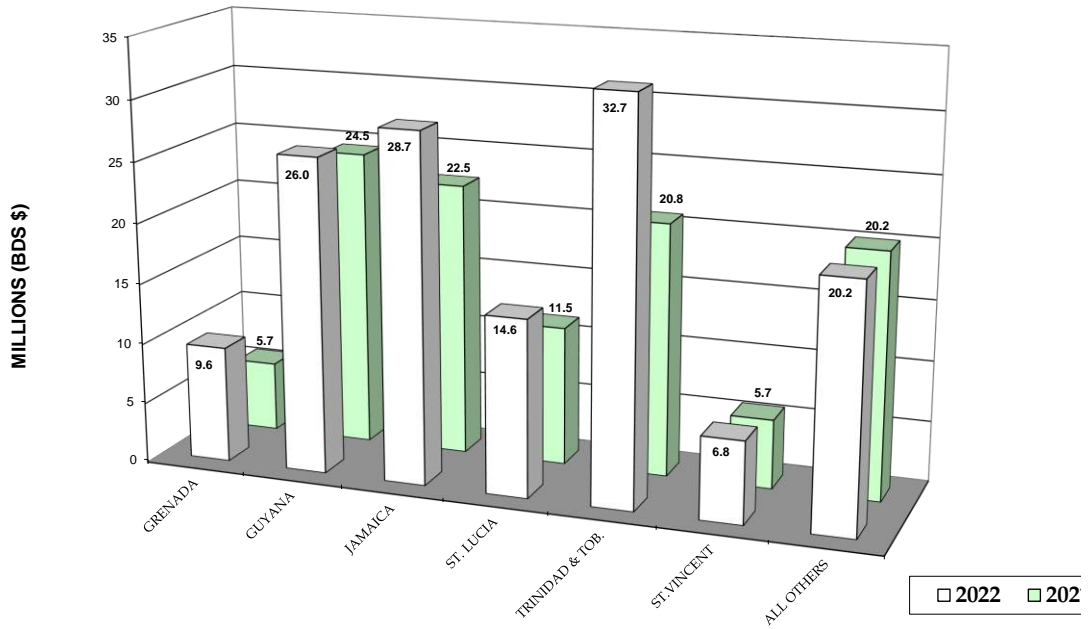
