REVIEW OF OVERSEAS TRADE

During the month of May 2022, total imports to Barbados were valued at \$367.3 million, whilst total exports from Barbados were valued at \$74.0 million. This resulted in a visible trade deficit of \$293.3 million, as compared with a visible trade deficit of \$195.5 million for May 2021.

Imports for May 2022 were \$119.6 million more than imports for May 2021, an increase of 48.3%. Total exports increased by \$21.8 million or 41.8% of the May 2021 figure. Domestic exports increased by \$6.8 million or 18.0% over May 2021, while the value of re-exports increased by \$15.0 million or 104.3% over the corresponding period 2021.

For the period January – May 2022, the value of imports to Barbados was \$1.83 billion, whilst the value of total exports was \$441.8 million representing an accumulated visible trade deficit of \$1.39 billion as compared to a similar deficit of \$890.5 million for January – May 2021.

Imports for January – May 2022 were \$668.5 million more than imports for the same period 2021, an increase of 57.6%. Total exports showed an increase of some \$172.6 million or 64.1% over the January - May 2021 figure. Domestic exports increased by \$27.3 million or 15.0% over January – May 2021. The value of re-exports increased by \$145.3 million or 166.2% over the corresponding period 2021.

CARICOM TRADE

During the month of May 2022, total imports from CARICOM countries were valued at \$83.7 million, whilst total exports to CARICOM were valued at \$28.8 million, resulting in a trade deficit of \$54.9 million as compared with a visible trade deficit of \$2.6 million for May 2021.

Total CARICOM imports for May 2022 were \$55.1 million more than CARICOM imports for May 2021, an increase of 193.0%. Total exports to CARICOM for May 2022 were \$2.8 million more than total exports for May 2021, an increase of 11.0%. Domestic exports increased by \$3.0 million or 13.8% over May 2021. The value of re-exports decreased by some \$0.2 million, or 4.5%, over the May 2021 figure.


For the period January – May 2022, total imports from CARICOM were valued at \$439.4 million, whilst total exports were \$136.3 million resulting in an accumulated visible trade deficit of \$303.1 million as compared with a deficit of \$69.4 million for the same period of 2021.


During this period, CARICOM imports were approximately \$260.9 million more than those over the same period in 2021, an increase of 146.1%. Total exports to CARICOM for January – May 2022 were \$27.1 million more than total exports for the corresponding period 2021, an increase of 24.8%. Domestic exports increased by approximately \$25.5 million or 28.0% over the same period 2021. The value of re-exports increased by \$1.6 million or 8.9% over the January – May 2021 figure.
