REVIEW OF OVERSEAS TRADE

During the month of September, 2022, total imports to Barbados were valued at \$334.8 million, whilst total exports from Barbados were valued at \$75.5 million. This resulted in a visible trade deficit of \$259.3 million, as compared with a visible trade deficit of \$224.1 million for September 2021.

Imports for September 2022 were \$49.5 million more than imports for September 2021, an increase of 17.3%. Total exports increased by \$14.3 million or 23.3% of the September 2021 figure. Domestic exports increased by \$8.8 million or 23.0% over September 2021, while the value of re-exports increased by \$5.4 million or 23.8% over the corresponding period 2021.

For the period January –September 2022, the value of imports to Barbados was \$3.2 billion, whilst the value of total exports was \$750.8 million representing an accumulated visible trade deficit of \$2.43 billion as compared to a similar deficit of \$1.81 billion for January – September 2021.

Imports for January – September 2022 were \$890.2 million more than imports for the same period 2021, an increase of 38.7%. Total exports showed an increase of some \$265.9 million or 54.8% over the January - September 2021 figure. Domestic exports increased by \$66.7 million or 20.2% over January – September 2021. The value of re-exports increased by \$199.2 million or 129.0% over the corresponding period 2021.

CARICOM TRADE

During the month of September 2022, total imports from CARICOM countries were valued at \$77.5 million, whilst total exports to CARICOM were valued at \$32.8 million, resulting in a trade deficit of \$44.7 million as compared with a visible trade deficit of \$10.4 million for September 2021.

Total CARICOM imports for September 2022 were \$41.1 million more than CARICOM imports for September 2021, an increase of 112.7%. Total exports to CARICOM for September 2021 were \$6.7 million more than total exports for September 2021, an increase of 25.8%. Domestic exports increased by \$4.2 million or 19.2% over September 2021. The value of re-exports increased by some \$2.5 million, or 59.1%, over the September 2021 figure.

For the period January – September 2022, total imports from CARICOM were valued at \$729.6 million, whilst total exports were \$269.4 million resulting in an accumulated visible trade deficit of \$460.2 million as compared with a deficit of \$155.1 million for the same period of 2021.

During this period, CARICOM imports were approximately \$370.3 million more than those over the same period in 2021, an increase of 103.0%. Total exports to CARICOM for January – September 2022 were \$65.1 million more than total exports for the corresponding period 2021, an increase of 31.9%. Domestic exports increased by approximately \$59.3 million or 34.4% over the same period 2021. The value of re-exports increased by \$5.8 million or 18.2% over the January – September 2021 figure.

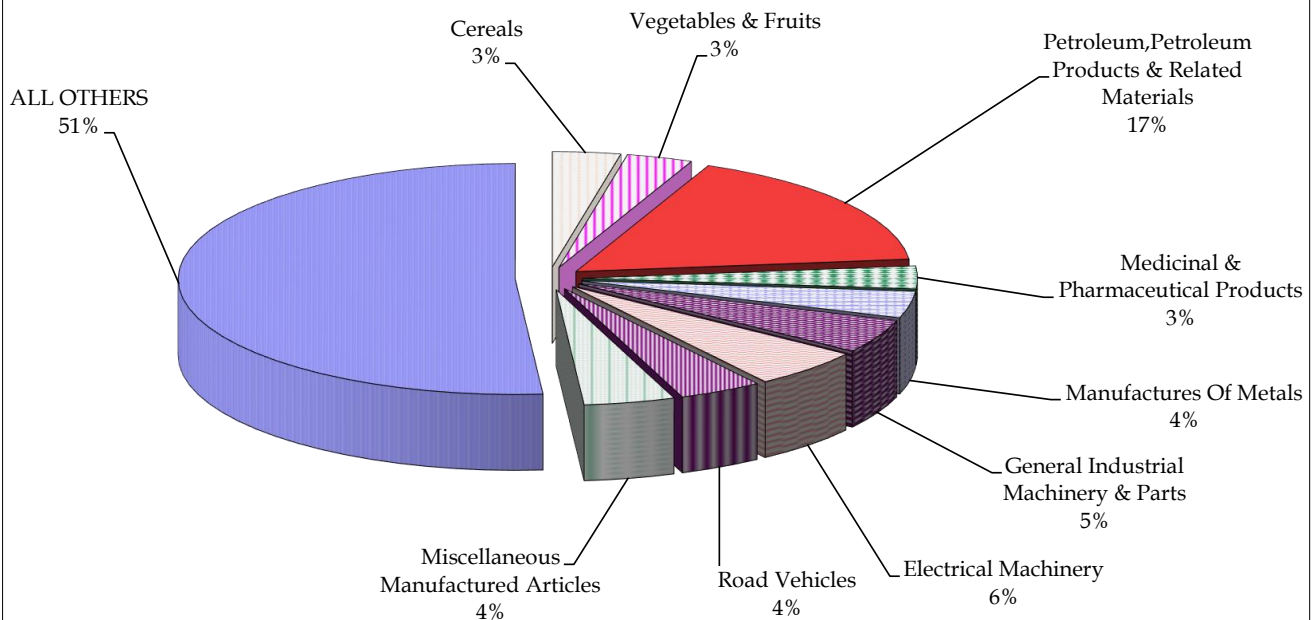

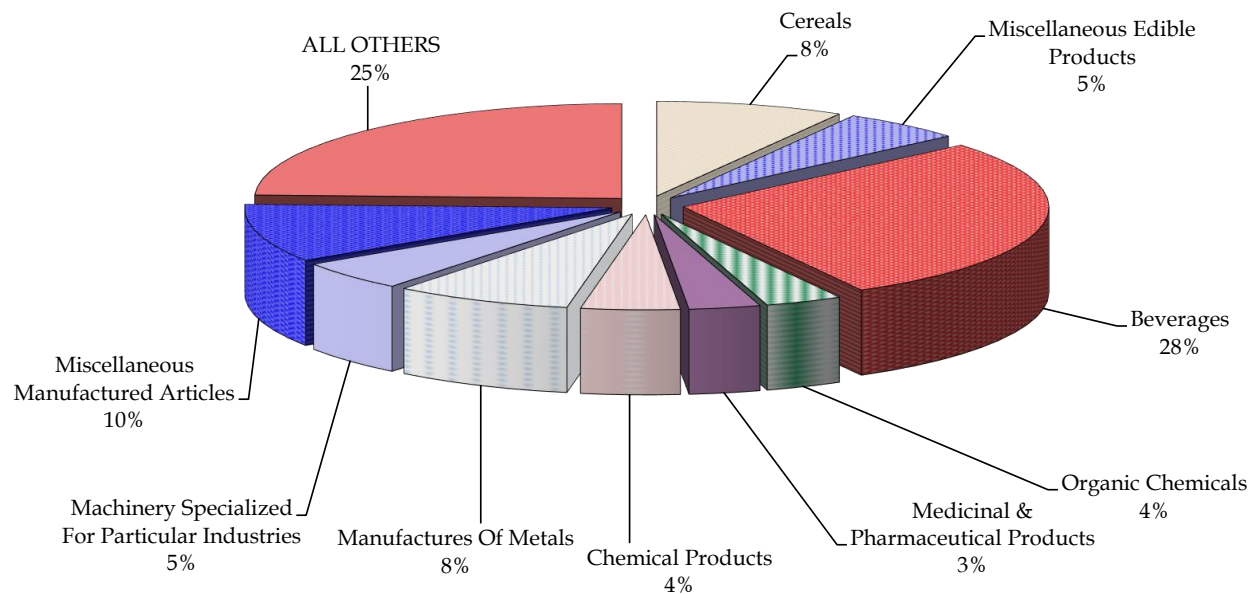

Principal Domestic Exports - September 2022

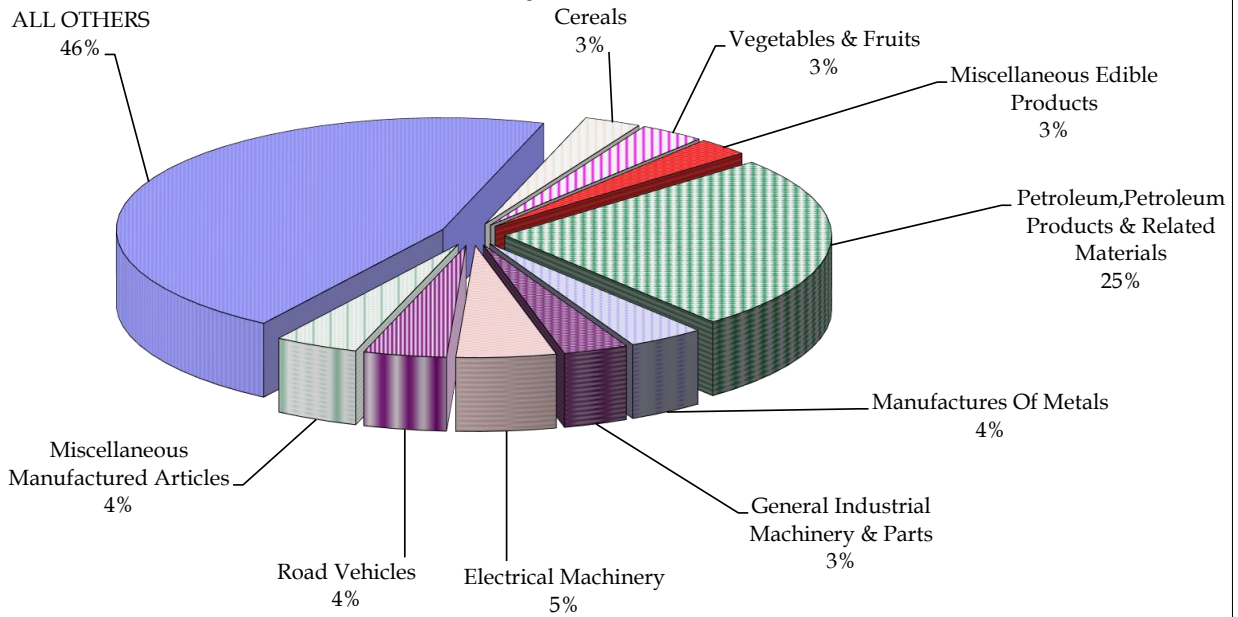

Principal Domestic Exports January- September 2022

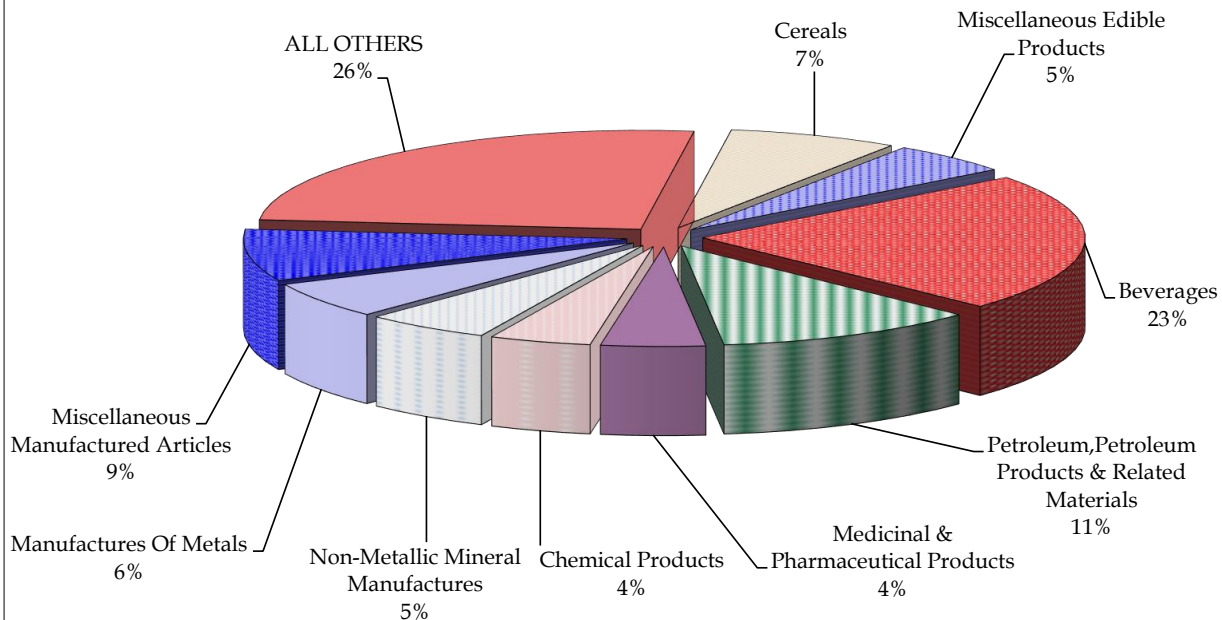

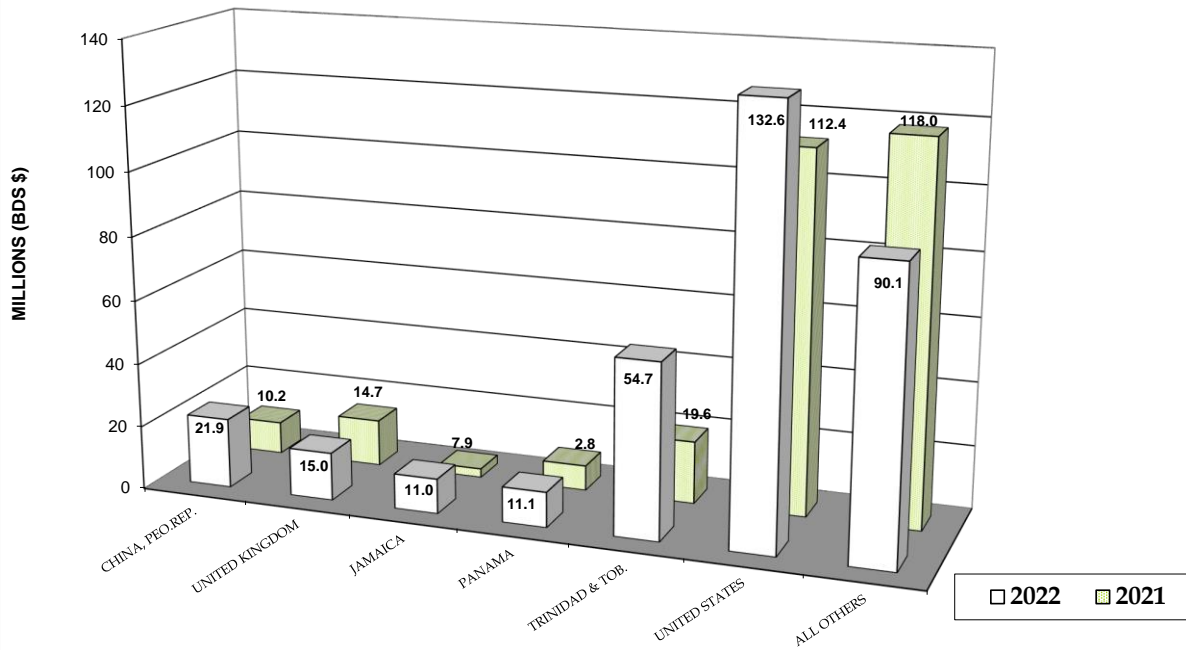

SEPTEMBER 2022 WITH THE CORRESPONDING MONTH OF 2021

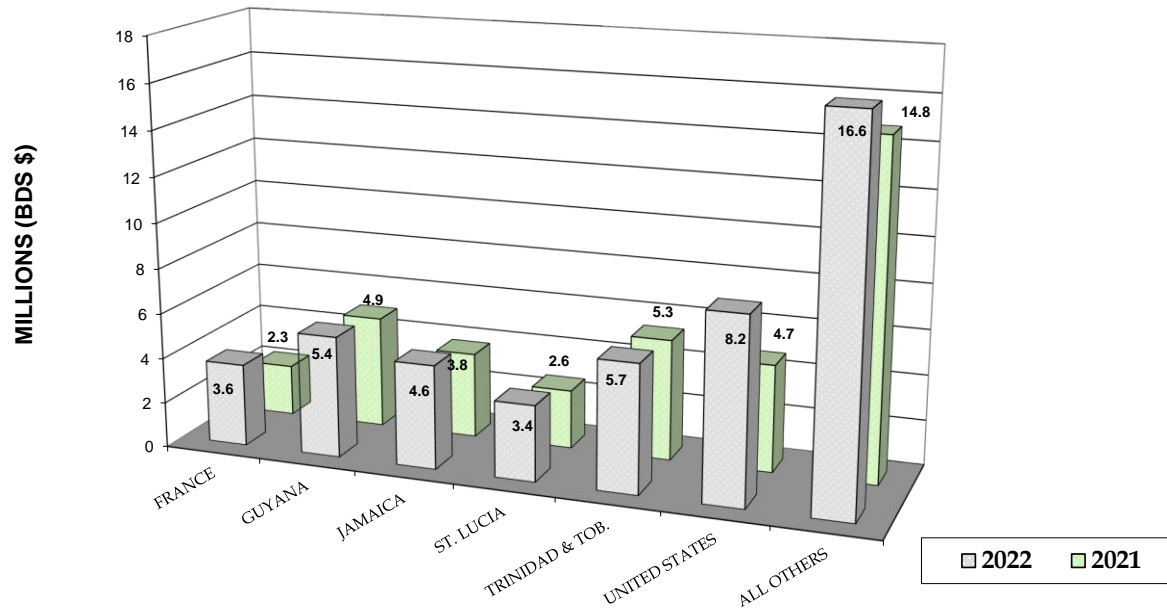


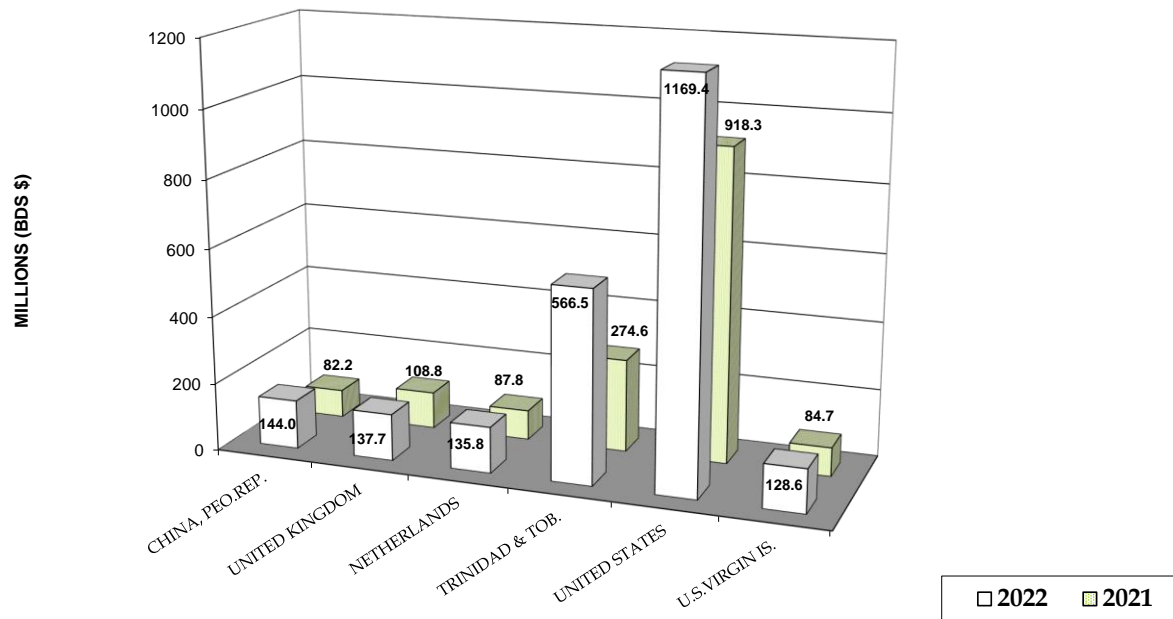

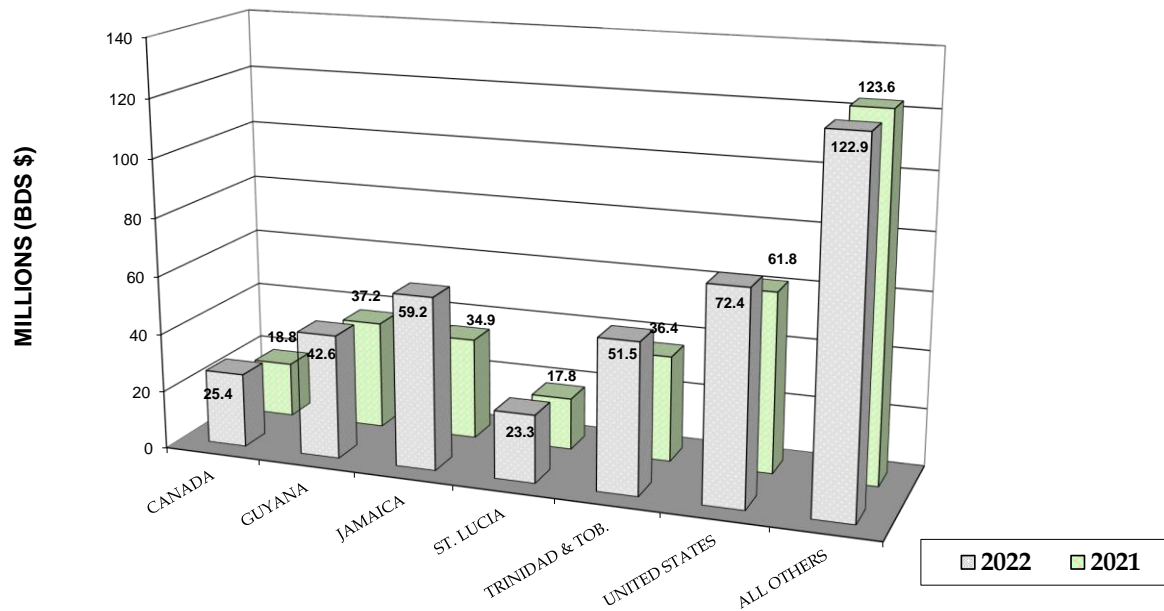

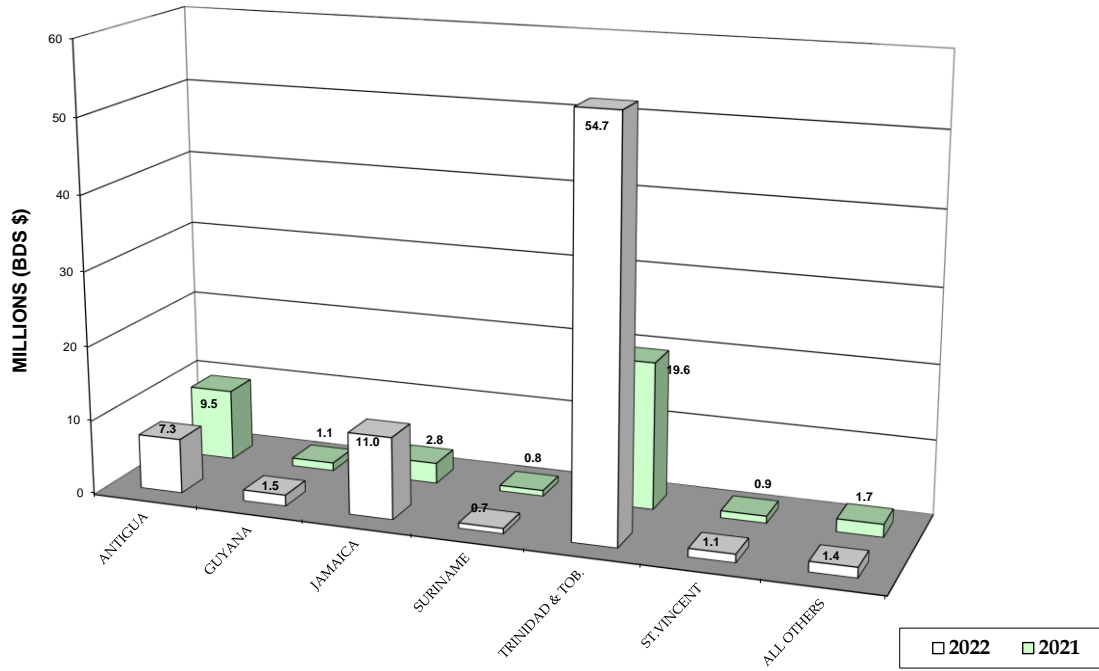

SEPTEMBER 2022 WITH THE CORRESPONDING MONTH OF 2021

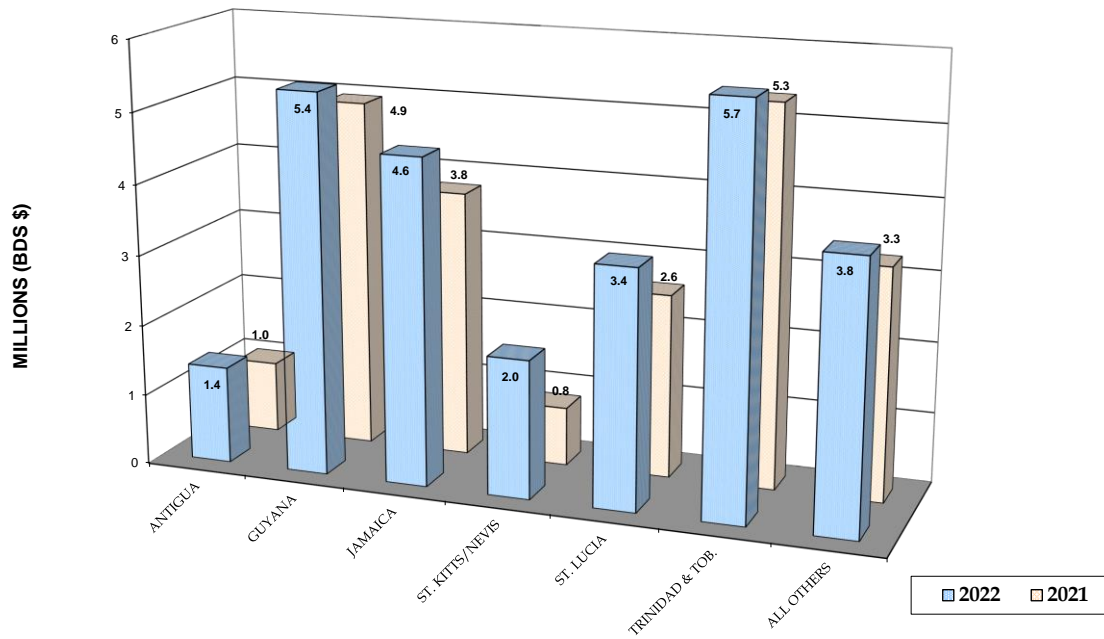


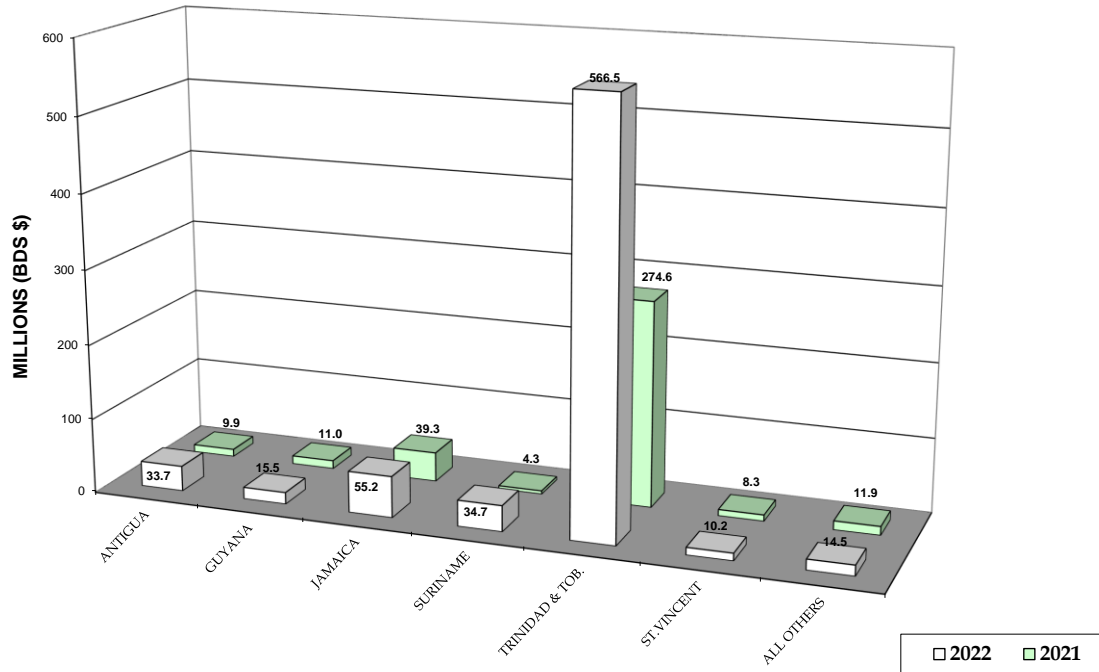

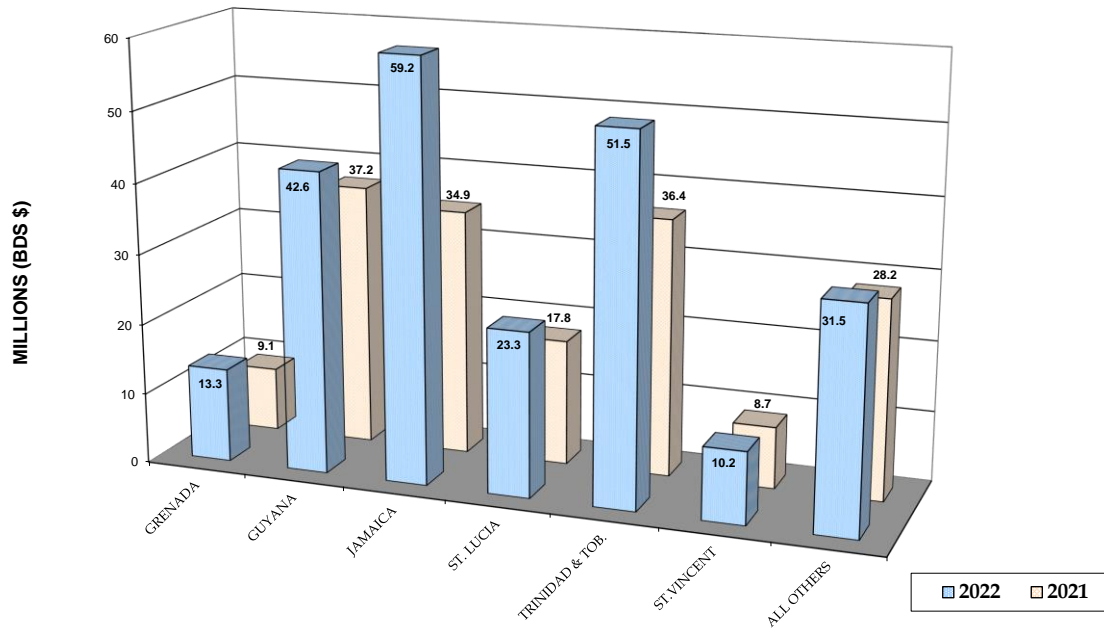
