#### **REVIEW OF OVERSEAS TRADE**

During the month of November 2022, total imports to Barbados were valued at \$373 million, whilst total exports from Barbados were valued at \$85 million. This resulted in a visible trade deficit of \$287.2 million, as compared with a visible trade deficit of \$296.0 for November 2021.

Imports for November 2022 were \$5.4 million more than imports for November 2021, an increase of 1.5%. Total exports increased by \$14.3 million or 19.9% of the November 2021 figure. Domestic exports decreased by \$2.5 million or 6.5% over November 2021, while the value of re-exports increased by \$16.7 million or 50.6% over the corresponding period 2021.

For the period January – November 2022, the value of imports to Barbados was \$3 billion, whilst the value of total exports was \$901 million representing an accumulated visible trade deficit of \$2983.0 million as compared to a similar deficit of \$2366.2 million for January – November 2021.

Imports for January – November 2022 were \$902.6 million more than imports for the same period 2021, an increase of 30.3%. Total exports showed an increase of some \$285.9 million or 46.4% over the January - November 2021 figure. Domestic exports increased by \$56.4 million or 13.8% over January – November 2021. The value of reexports increased by \$229.5.1 million or 110.3% over the corresponding period 2021.

#### **CARICOM TRADE**

During the month of November 2021, total imports from CARICOM countries were valued at \$83 million, whilst total exports to CARICOM were valued at \$24 million, resulting in a trade deficit of \$59.1 million as compared with a visible trade deficit of \$59.2 million for November 2021.

Total CARICOM imports for November 2022 were \$3.2 million less than CARICOM imports for November 2021, a decrease of 3.7%. Total exports to CARICOM for November 2022 were \$3.1 million less than total exports for November 2021, a decrease of 11.3%. Domestic exports decreased by \$2.3 million or 10.3% over November 2021. The value of re-exports decreased by some \$0.8 million, or 16.1%, over the November 2021 figure.


For the period January – November 2022, total imports from CARICOM were valued at \$889 million, whilst total exports were \$317 million resulting in an accumulated visible trade deficit of \$572.7 million as compared with a deficit of \$258.0 million for the same period of 2021.


During this period, CARICOM imports were approximately \$371.4 million more than those over the same period in 2021, an increase of 71.7%. Total exports to CARICOM for January – November 2021 were \$56.8 million more than total exports for the corresponding period 2021, an increase of 21.8%. Domestic exports increased by approximately \$49.7 million or 22.6% over the same period 2021. The value of re-exports increased by \$7.1million or 17.3% over the January – November 2021 figure.
