REVIEW OF OVERSEAS TRADE

During the month of December 2022, total imports to Barbados were valued at \$408.6 million, whilst total exports from Barbados were valued at \$93.8 million. This resulted in a visible trade deficit of \$314.8 million, as compared with a visible trade deficit of \$278.9 million for December 2021.

Imports for December 2022 were \$45.0 million more than imports for December 2021 an increase of 12.4%. Total exports increased by \$9.1 million or 10.7% of the December 2021 figure. Domestic exports decreased by 1.6 million or 4.0% over December 2021, while the value of re-exports increased by \$10.6 million or 23.4% over the corresponding period 2021.

For the period January – December 2022, the value of imports to Barbados was \$4.29 billion, whilst the value of total exports was \$995.3 million representing an accumulated visible trade deficit of \$3.3 billion as compared to a similar deficit of \$2.65 billion for January – December 2021.

Imports for January – December 2022 were \$947.6 million more than imports for the same period 2021, an increase of 28.3%. Total exports showed an increase of some \$294.9 million or 42.1% over the January - December 2021 figure. Domestic exports increased by \$54.8 million or 12.3% over January – December 2021. The value of re-exports increased by \$240.1 million or 94.8% over the corresponding period 2021.

CARICOM TRADE

During the month of December 2022, total imports from CARICOM countries were valued at \$144.5 million, whilst total exports to CARICOM were valued at \$27.9 million, resulting in a trade deficit of \$116.6 million as compared with a visible trade deficit of \$59.4 million for December 2021.

Total CARICOM imports for December 2022 were \$59.6 million more than CARICOM imports for December 2021, an increase of 70.3%. Total exports to CARICOM for December 2022 were \$2.4 million more than total exports for December 2021, an increase of 9.5%. Domestic exports increased by \$2.5 million or 11.4% over December 2021. The value of re-exports decreased by some \$0.1 million, or 2.8%, over the December 2021 figure.

For the period January –December 2022, total imports from CARICOM were valued at \$1.03 billion, whilst total exports were \$345.1 million resulting in an accumulated visible trade deficit of \$689.3 million as compared with a deficit of \$317.4 million for the same period of 2021.

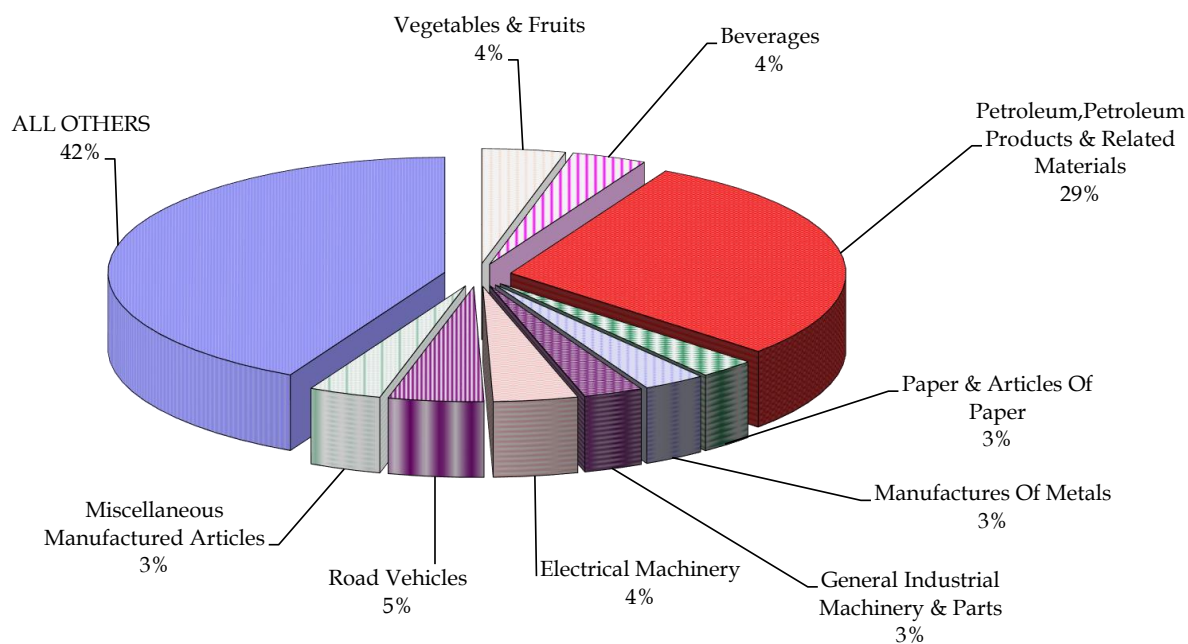
During this period, CARICOM imports were approximately \$431.1 million more than those over the same period in 2021, an increase of 71.5%. Total exports to CARICOM for January- December 2021 were \$59.2 million more than total exports for the corresponding period 2021, an increase of 20.7%. Domestic exports increased by approximately \$52.2 million or 21.6% over the same period 2021. The value of re-exports increased by \$7.0 million or 15.8% over the January – December 2021 figure.

DECEMBER 2022 WITH THE CORRESPONDING MONTH OF 2021

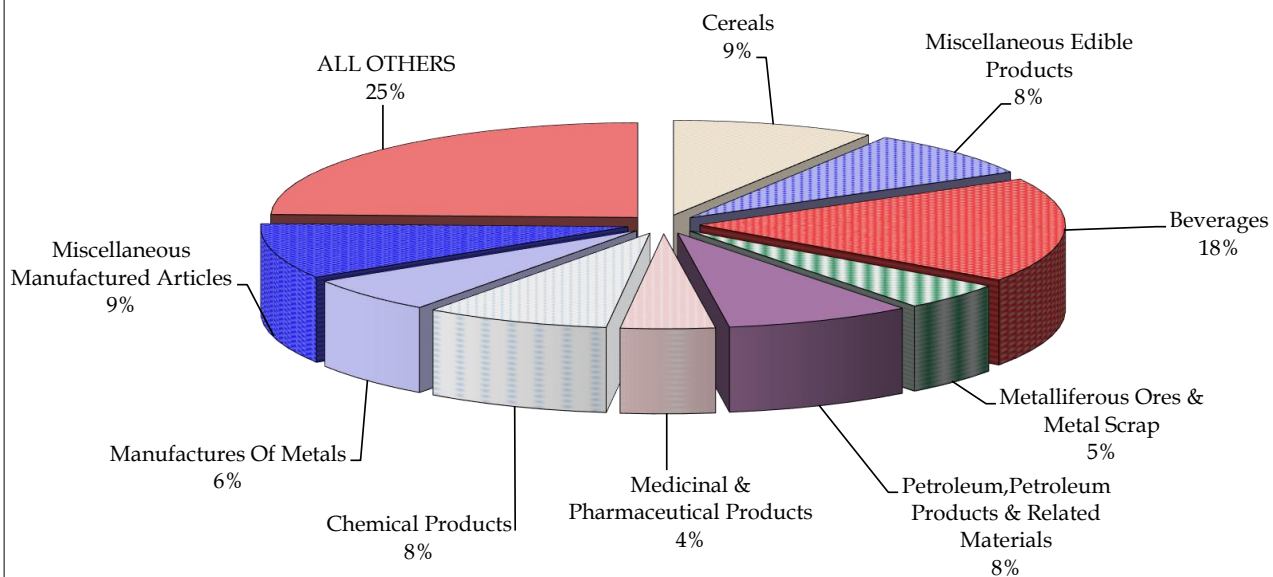

Principal Domestic Exports - December 2022

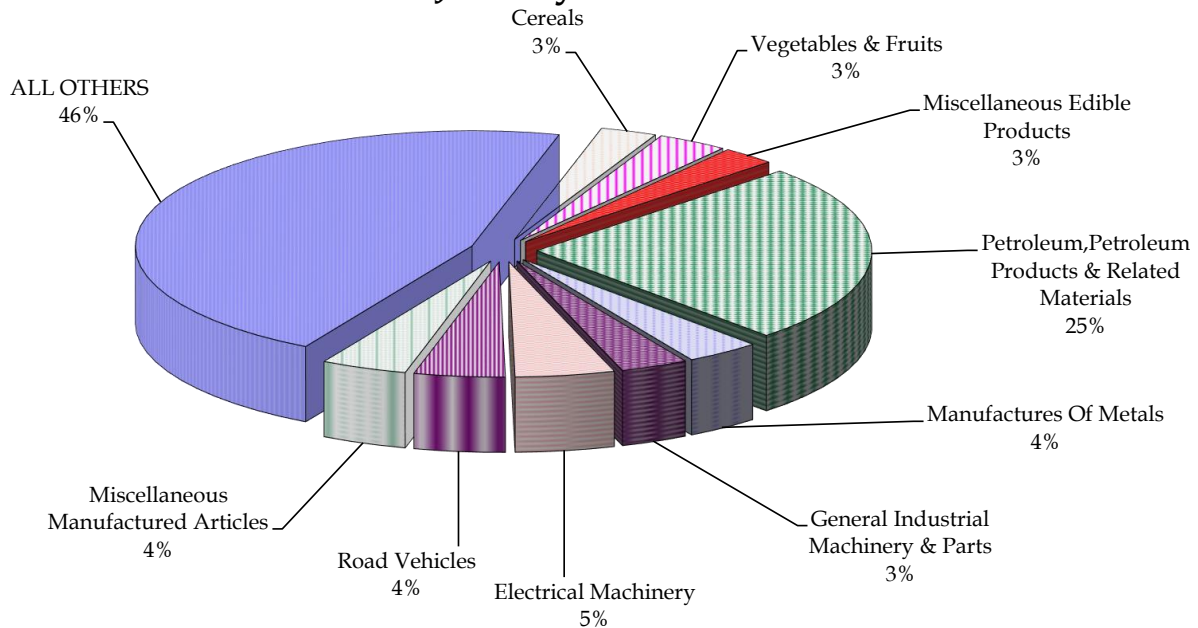

Principal Domestic Exports January- December 2022

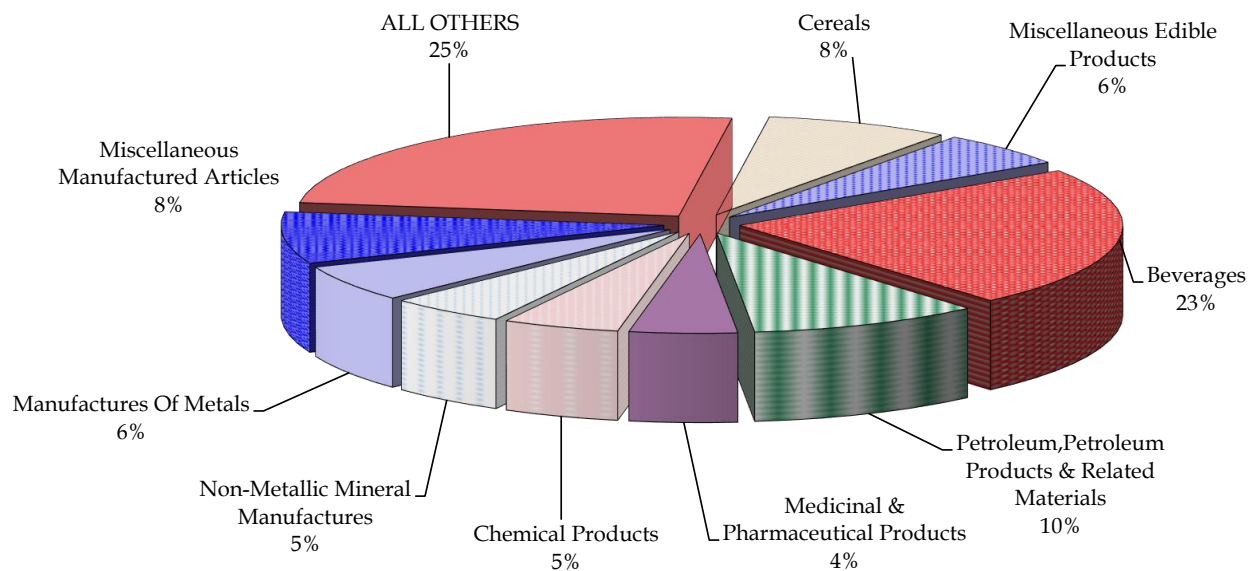

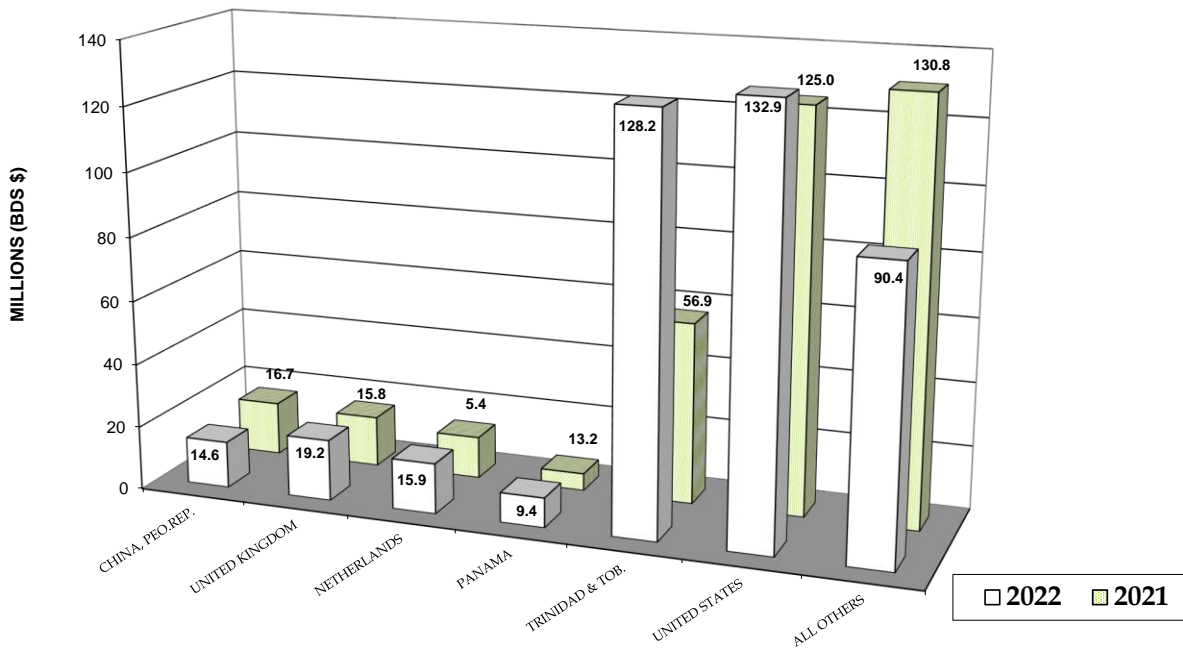

DECEMBER 2022 WITH THE CORRESPONDING MONTH OF 2021

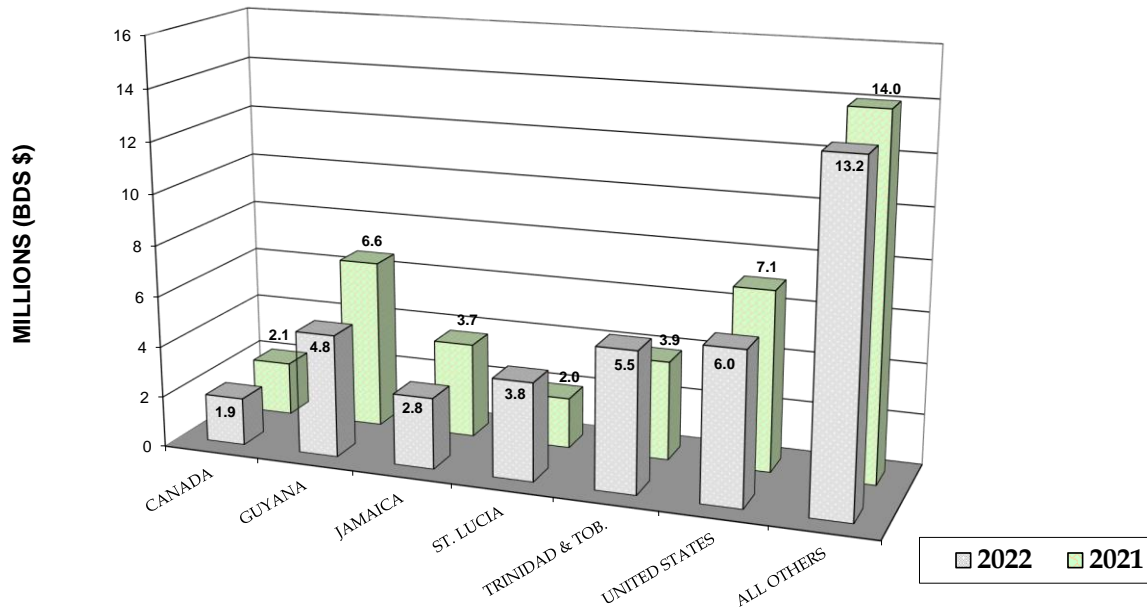


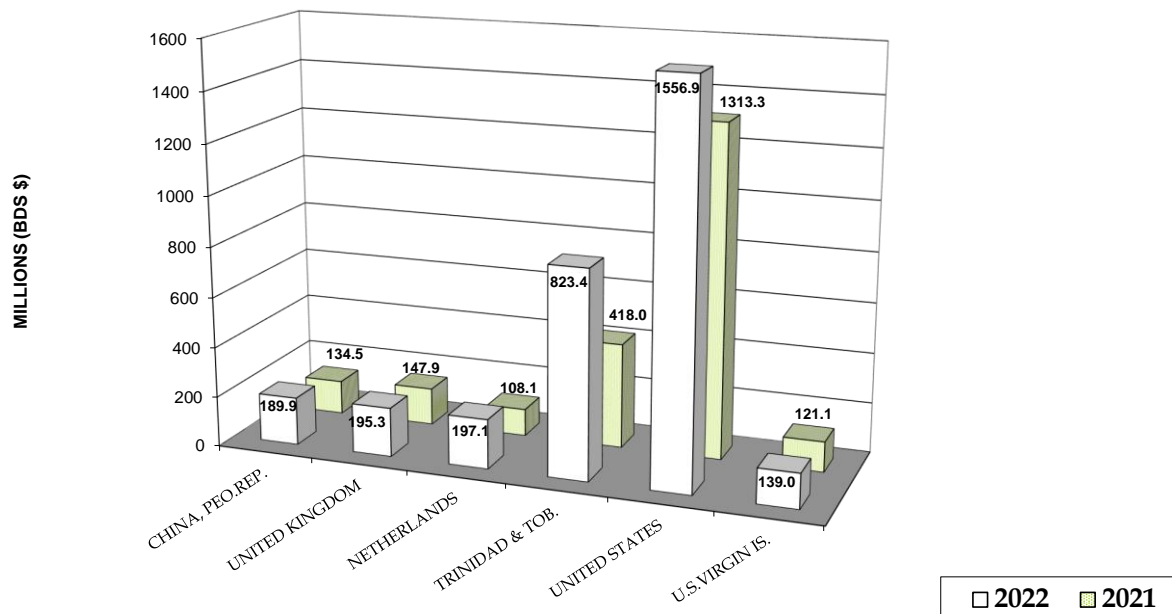

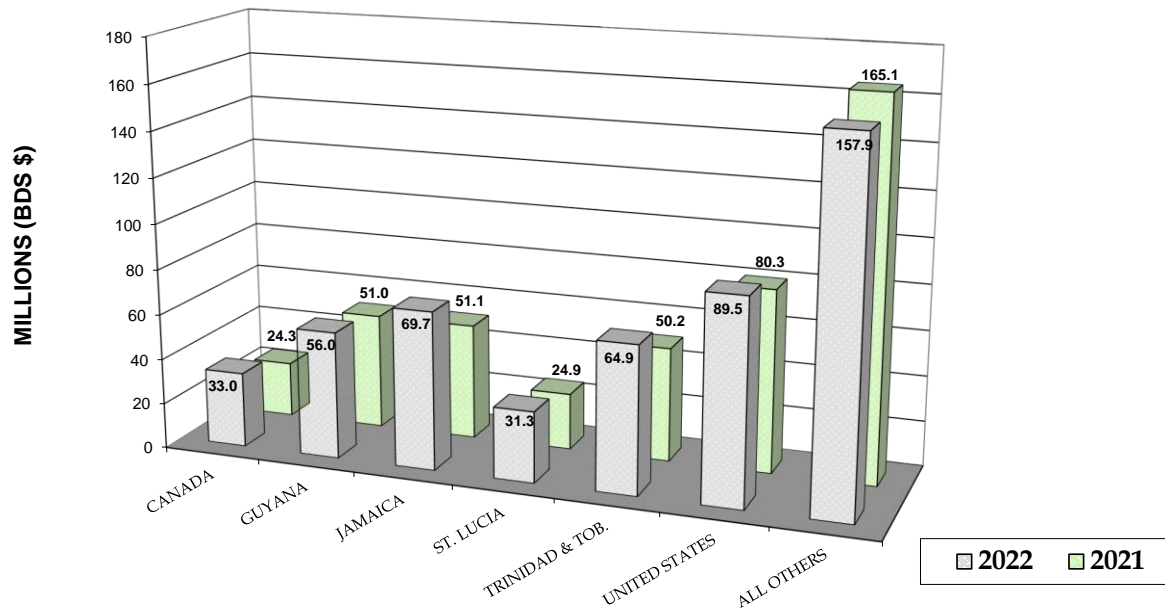

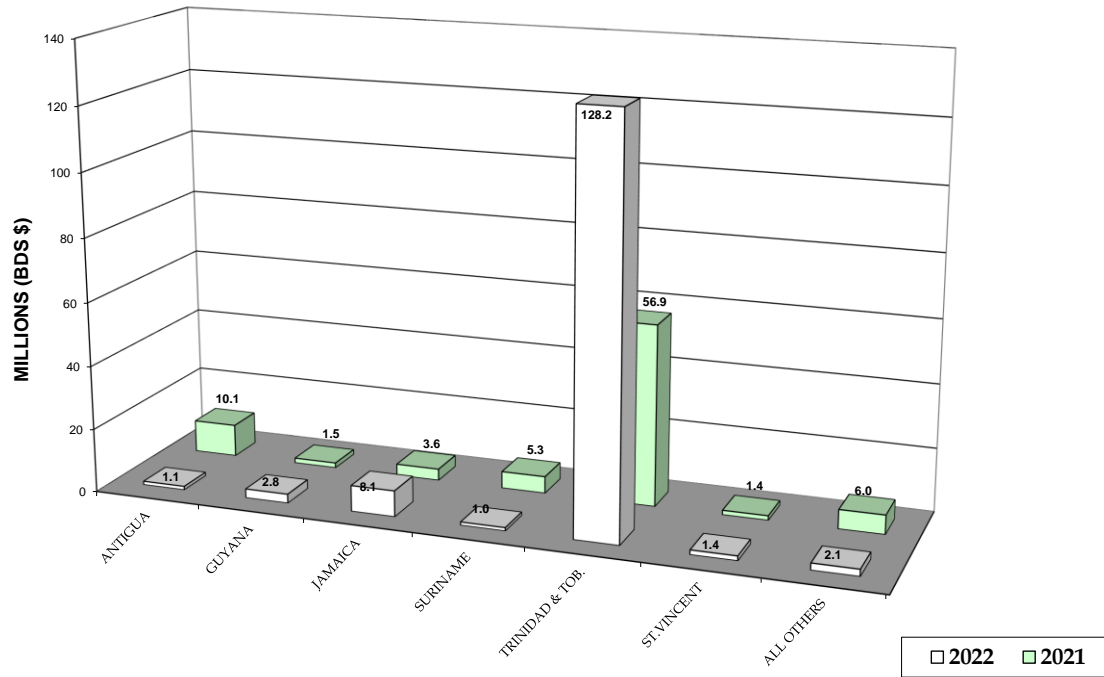

DECEMBER 2021 WITH THE CORRESPONDING MONTH OF 2021

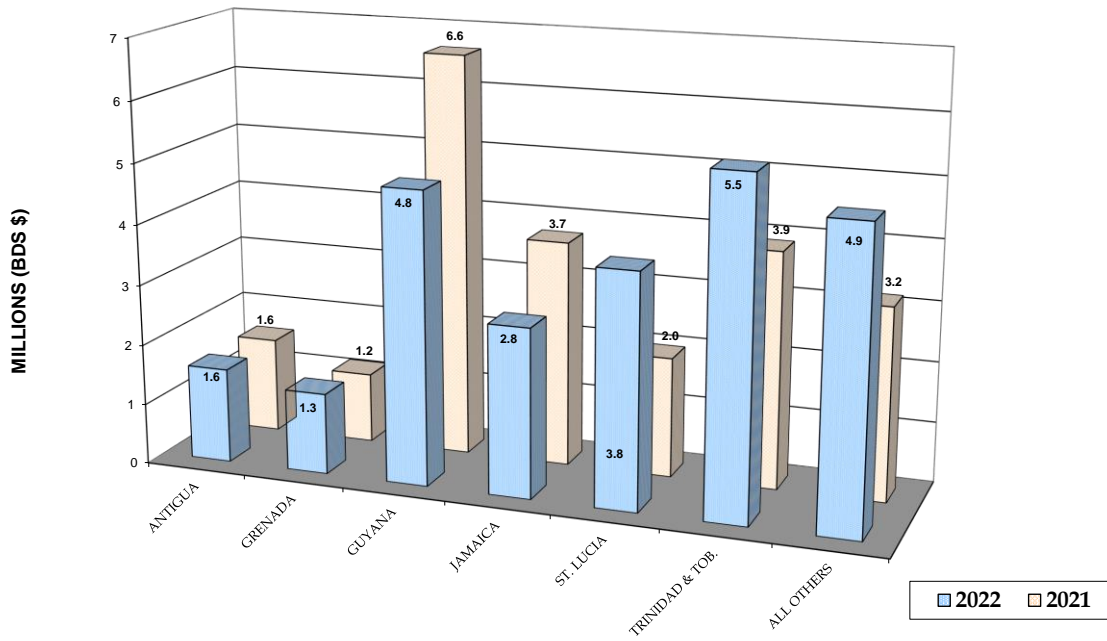


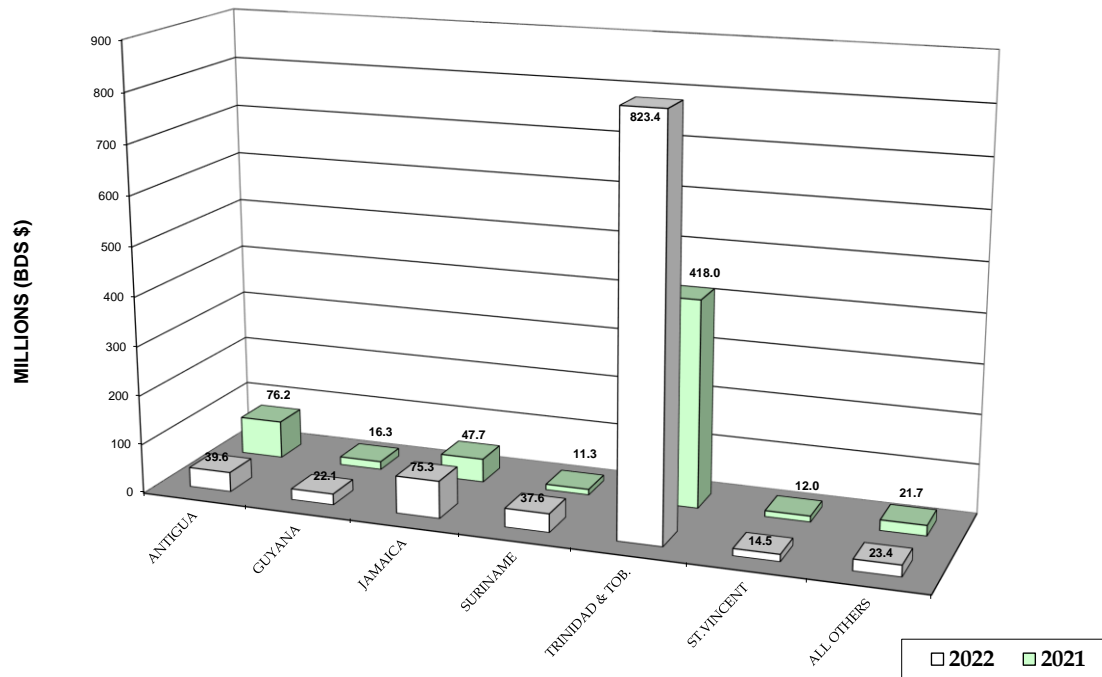

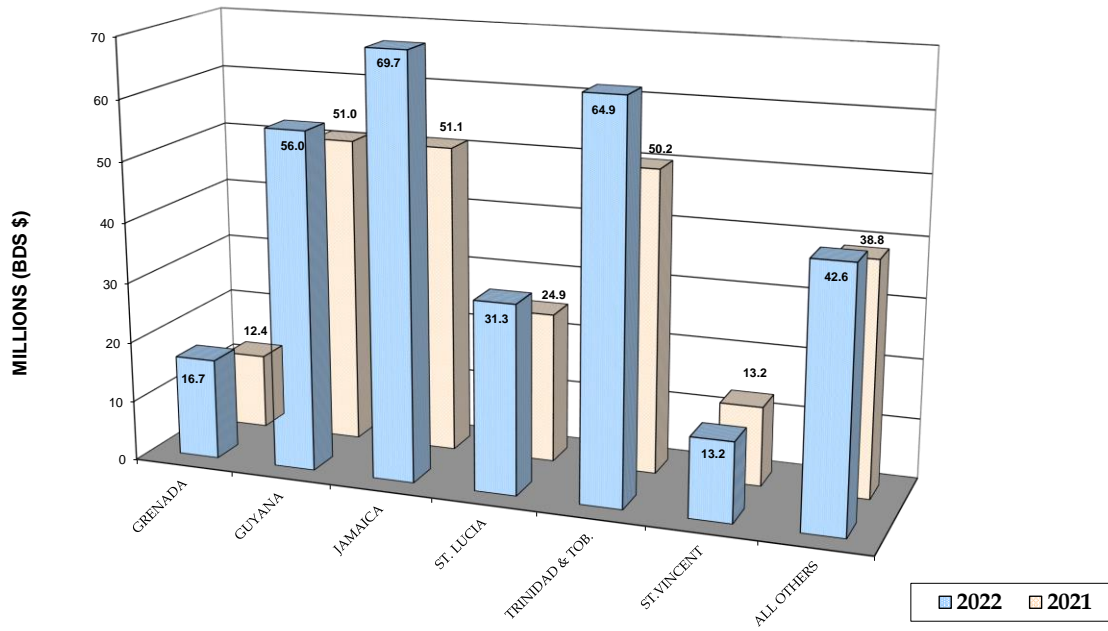
