

# STAY-OVER VISITORS AND CRUISE SHIP PASSENGER ARRIVALS

# Stay-Over Arrivals by Country of Residence



For August 2023, the number of stayover visitors to Barbados was recorded at **47,430**. (△) This number represents a significant increase over the **34,329** seen for the same period in 2022.

For the third consecutive month of the year, cruise arrivals totalled **0** passengers equalling that of the cruise arrivals for August 2022.

The U.S.A and U.K denoted the majority of stay-over visitors, registered at **16,724** (▲) and **10,975** (▲) respectively.

Visitors from Oceania (**146** tourists) represented the smallest number of stay-over visitors for the month under review. ( $\triangle$ )


### CRUISE ARRIVALS

Cruise passenger arrivals (Intransit and Landed) for August 2023 remained at **0**.

Cruise calls for August in both the period under review and the previous year was 0.

# PURPOSE OF VISIT AND LENGTH OF STAY

#### **Stay-Over Arrivals By Purpose of** Visit



Within the stay-over arrivals who visited for the month of August, recreational purposes increased to **34,074** (▲) from 28,100 for the previous period. Those visiting primarily for holiday represented more than half the total stay-over arrivals (25,521). ( $\triangle$ )

6,595 persons visited the island to attend Business/Conferences. (A)

Persons visiting friends and family during the review period totalled 4,791. (A)

Other purposes of visit were recorded at 3,914. (🔺)

Health care visits were made by 159 persons. **( \ )**

#### **Stay-Over Arrivals By Length Of Stay**



# **LENGTH OF** STAY


The average number of days spent in Barbados among stay-over visitors was approximately 10.08 days for August 2023. (\(\nabla\)

The highest number of tourists (19,566) visited during the period under review for 4-7 days. (**^**)

Long-stay visitor arrivals, 29 - 182 days, totalled **1,868**. (🔺)

### YEAR TO DATE

Year To Date Stay-Over Arrivals by Country of Residence



The total number of stay-over arrivals by the end of August for the year amassed to **417,519**. ( $\triangle$ )

Total cruise arrivals were recorded at **434,565** passengers over the eightmonth period from a total of **245** cruise calls. ( $\triangle$ )

For the first eight months of 2023, while remaining the leading source of stay-over visitors to the island, UK arrivals increased to **159,393**. ( $\triangle$ )

Visitors from USA followed closely with **116,666** persons. ( $\triangle$ )

Canadian arrivals registered **50,906** visitors. (🔺)

# Year To Date Arrivals By Cruise Ship



# CRUISE ARRIVALS

As a result of no additional cruise calls, Intransit passengers stayed unchanged at **295,386**.

Likewise, landed passengers for the year remained at **139,179**.

#### **Year To Date Stay-Over Arrivals By Purpose**



Visitors for recreational purposes, 333,154, made up 80 per cent of the total stay-over arrivals for this period. **( \ )** 

Holiday stay-overs accounted for a large proportion of the recreational visitors (278,298). (🔺)

Although the overall number of stay-over arrivals to Barbados increased for the year over the same period for 2022, the number of study visitors significantly decreased to **7,522** from 9,027 in the previous year. (▼)

All other purposes of visits improved over the corresponding recorded figures for the period prior.

Of significant note was the increase in visits for business and conferences, **46.319**. ( $\triangle$ )

#### **Year To Date Stay-Over Arrivals By Length Of Stay**










