## **REVIEW OF OVERSEAS TRADE**

During the month of June 2023, total imports to Barbados were valued at \$343.0 million, whilst total exports from Barbados were valued at \$64.7 million. This resulted in a visible trade deficit of \$278.3 million, as compared with a visible trade deficit of \$263.5 million for June 2022.

Imports for June 2023 were \$14.7 million more than imports for June 2022, an increase of 4.5%. Total exports decreased by \$0.04 million or 0.1% of the June 2022 figure. Domestic exports increased by \$5.1 million or 13.5% over June 2022, while the value of re-exports decreased by \$5.1 million or 19.2% over the corresponding period 2022.

For the period January – June 2023, the value of imports to Barbados was \$2.08 billion, whilst the value of total exports was \$502.6 million representing an accumulated visible trade deficit of \$1.58 billion as compared to a similar deficit of \$1.65 billion for January – June 2022.

Imports for January – June 2023 were \$67.3 million less than imports for the same period 2022, a decrease of 3.1%. Total exports showed a decrease of some \$4.0 million or 0.8% over the January - June 2022 figure. Domestic exports increased by \$3.8 million or 1.5% over January – June 2022. The value of re-exports decreased by \$7.8 million or 3.0% over the corresponding period 2022.

## **CARICOM TRADE**

During the month of June 2023, total imports from CARICOM countries were valued at \$85.4 million, whilst total exports to CARICOM were valued at \$31.0 million, resulting in a trade deficit of \$54.4 million as compared with a visible trade deficit of \$60.8 million for June 2022.

Total CARICOM imports for June 2023 were \$1.8 million less than CARICOM imports for June 2022, a decrease of 2.0%. Total exports to CARICOM for June 2023 were \$4.7 million more than total exports for June 2022, an increase of 17.8%. Domestic exports increased by \$4.9 million or 22.4% over June 2022. The value of re-exports decreased by some \$0.2 million, or 5.4%, over the June 2022 figure.

For the period January – June 2023, total imports from CARICOM were valued at \$558.7 million, whilst total exports were \$172.0 million resulting in an accumulated visible trade deficit of \$386.7 million as compared with a deficit of \$364.0 million for the same period of 2022.

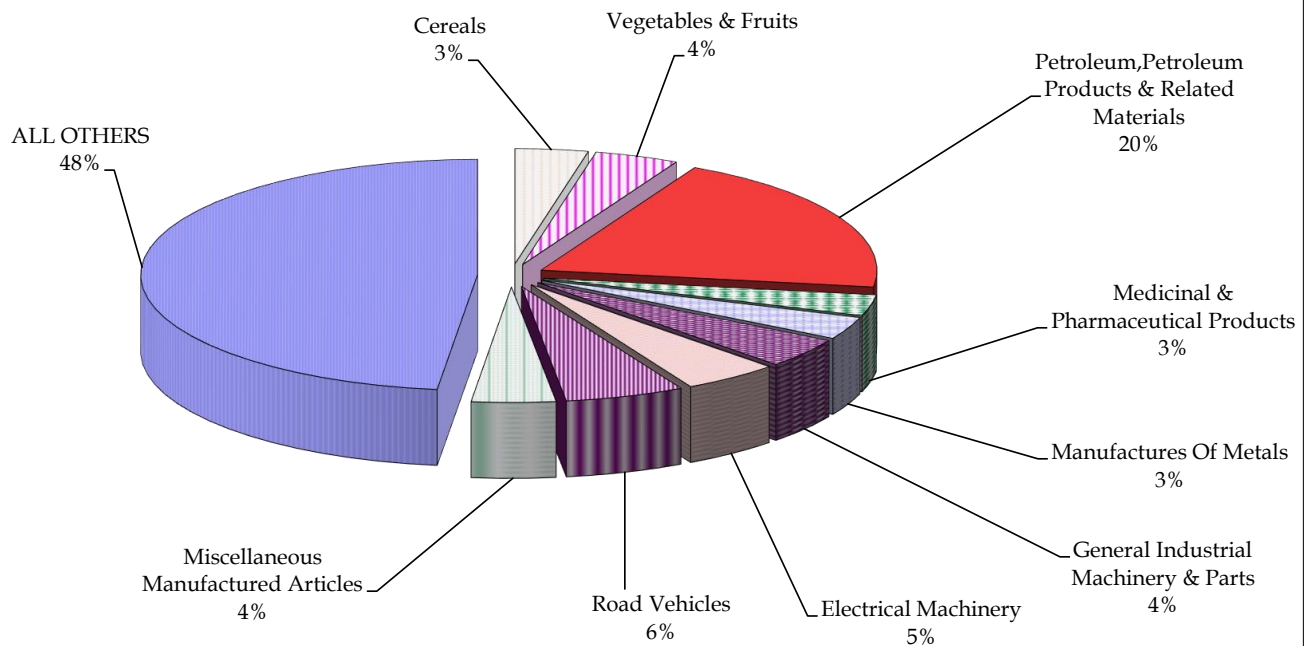
During this period, CARICOM imports were approximately \$32.1 million more than those over the same period in 2022, an increase of 6.1%. Total exports to CARICOM for January – June 2023 were \$9.4 million more than total exports for the corresponding period 2022, an increase of 5.8%. Domestic exports increased by approximately \$8.0 million or 5.8% over the same period 2022. The value of re-exports increased by \$1.4 million or 5.6% over the January – June 2022 figure.

JUNE 2023 WITH THE CORRESPONDING MONTH OF 2022

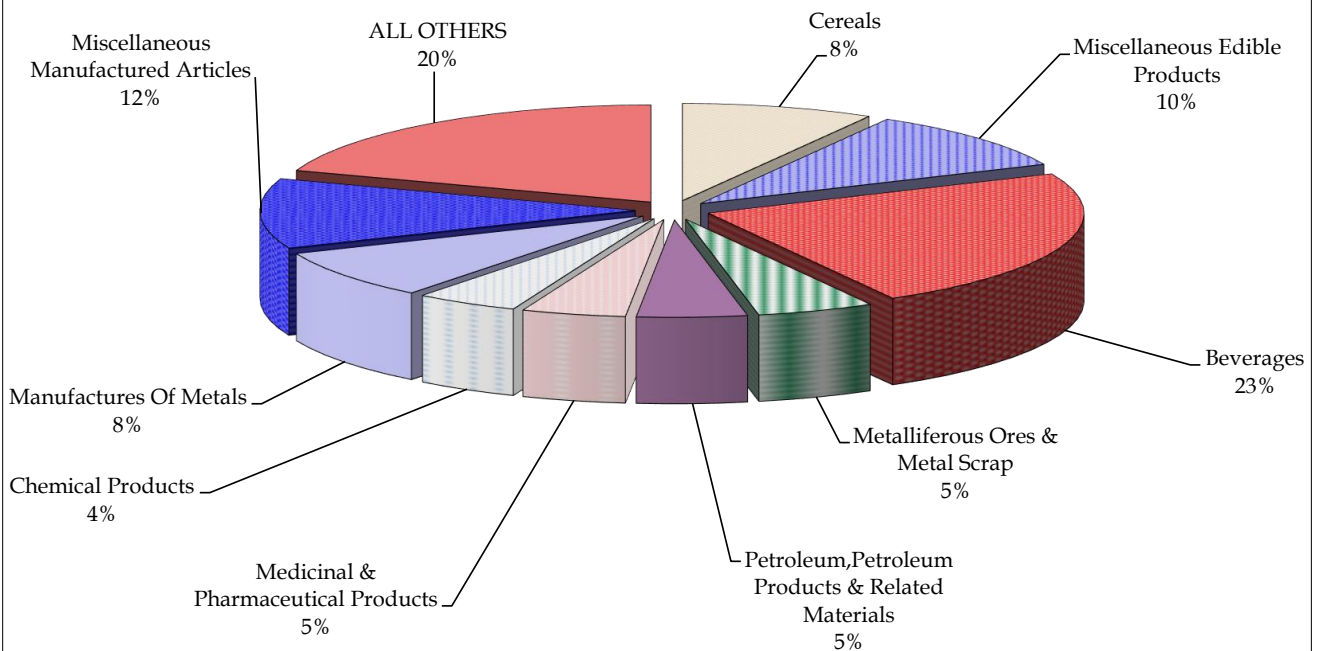

## Principal Domestic Exports - June 2023

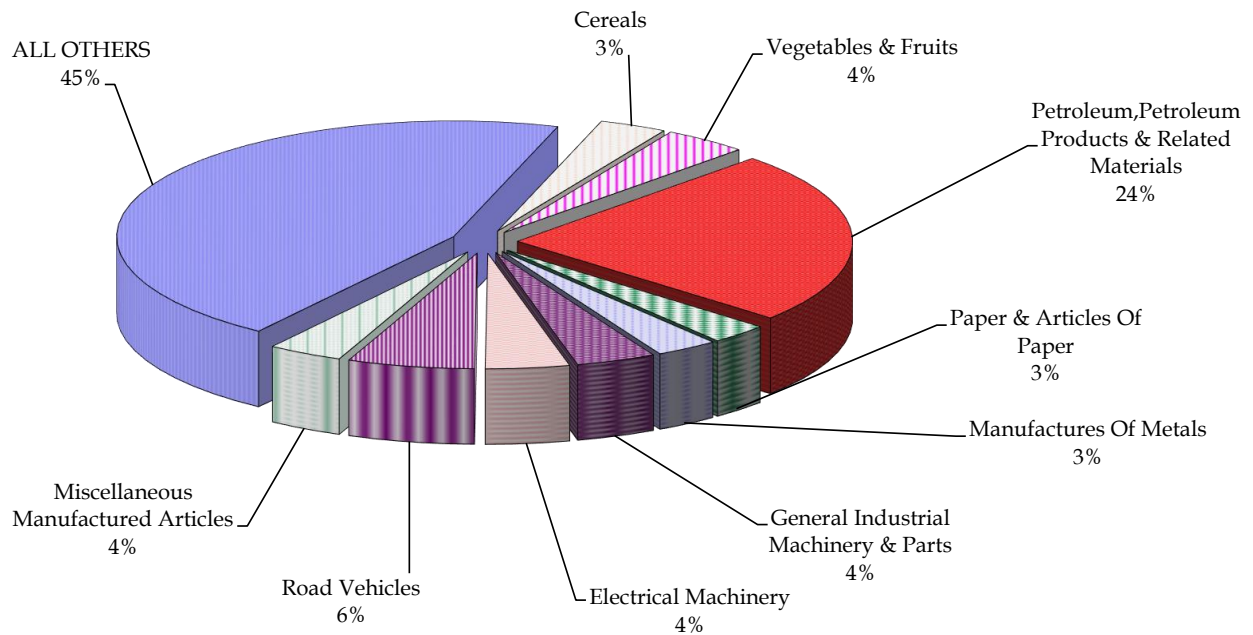

## Principal Domestic Exports January- June 2023

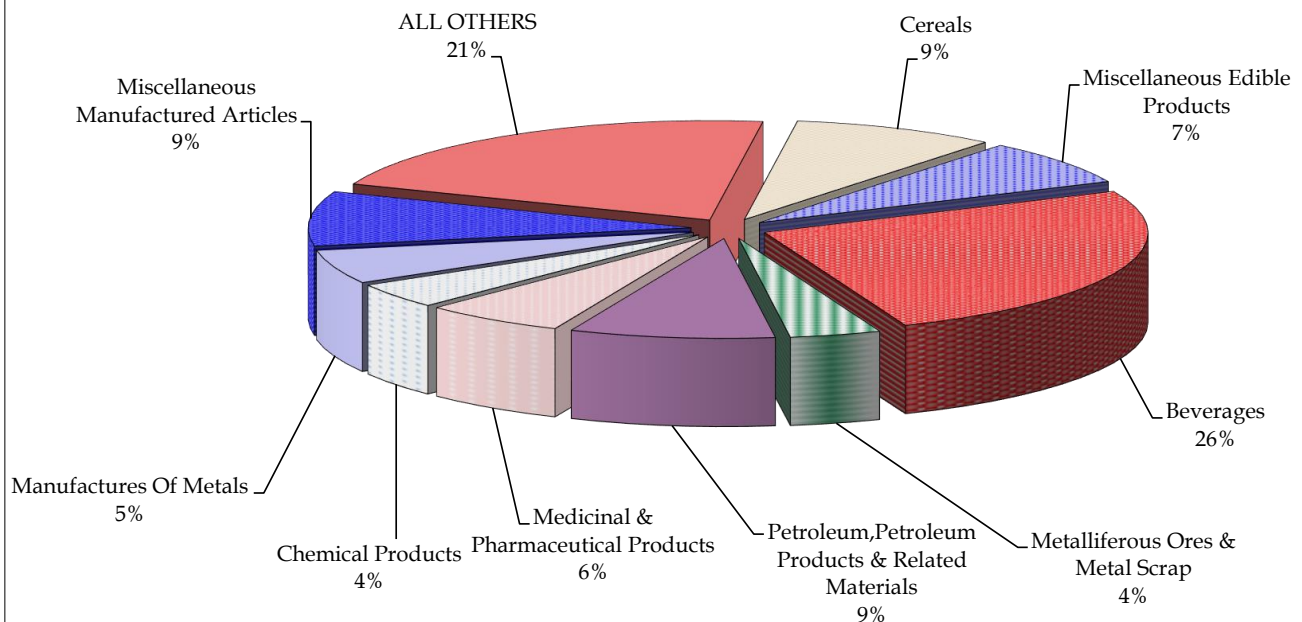

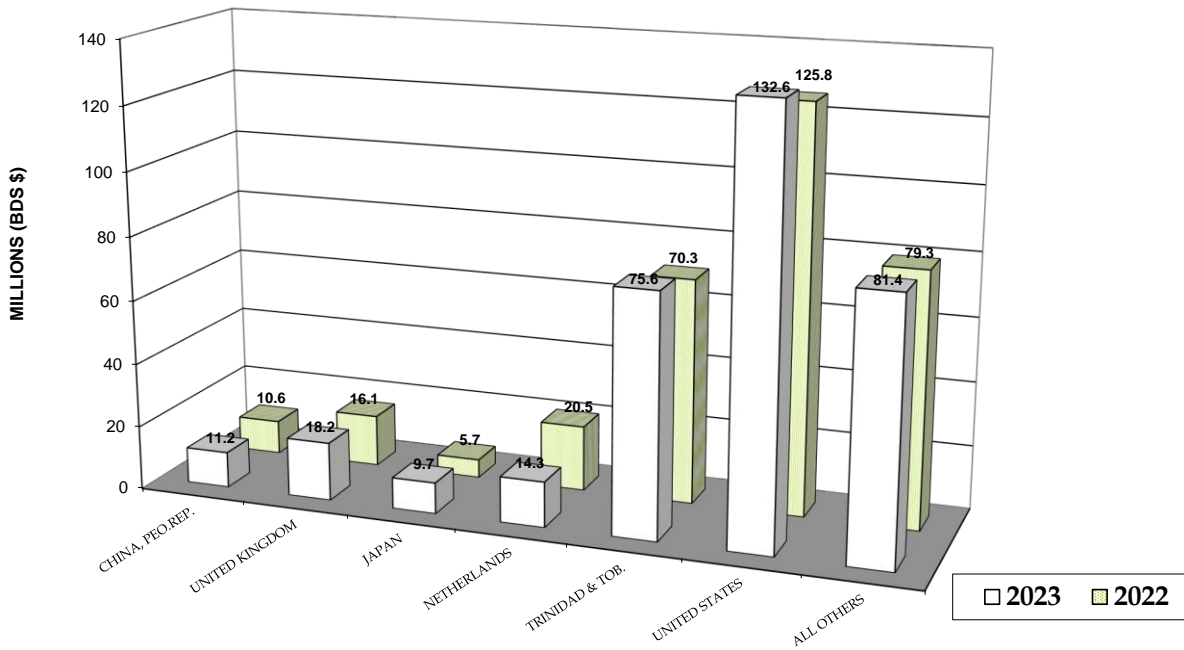

JUNE 2023 WITH THE CORRESPONDING MONTH OF 2022

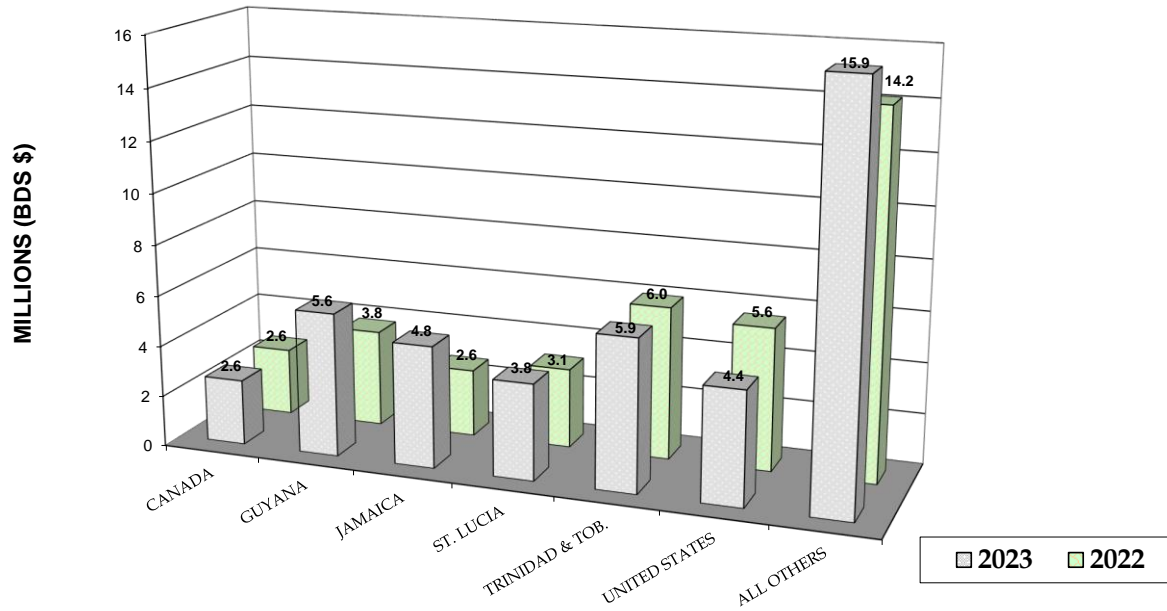


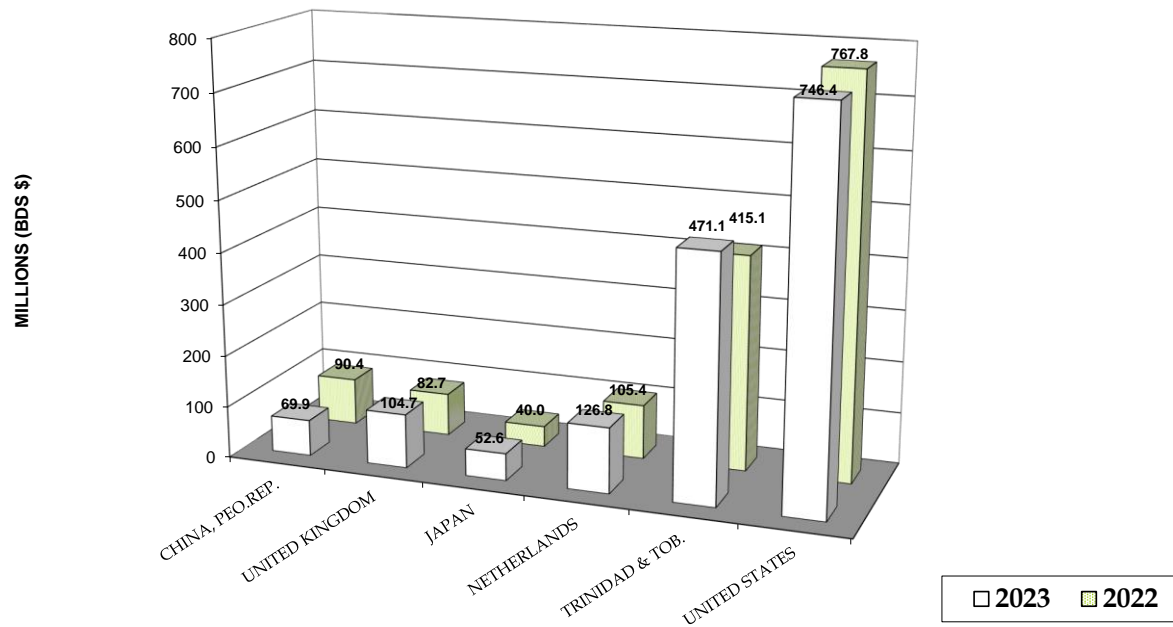

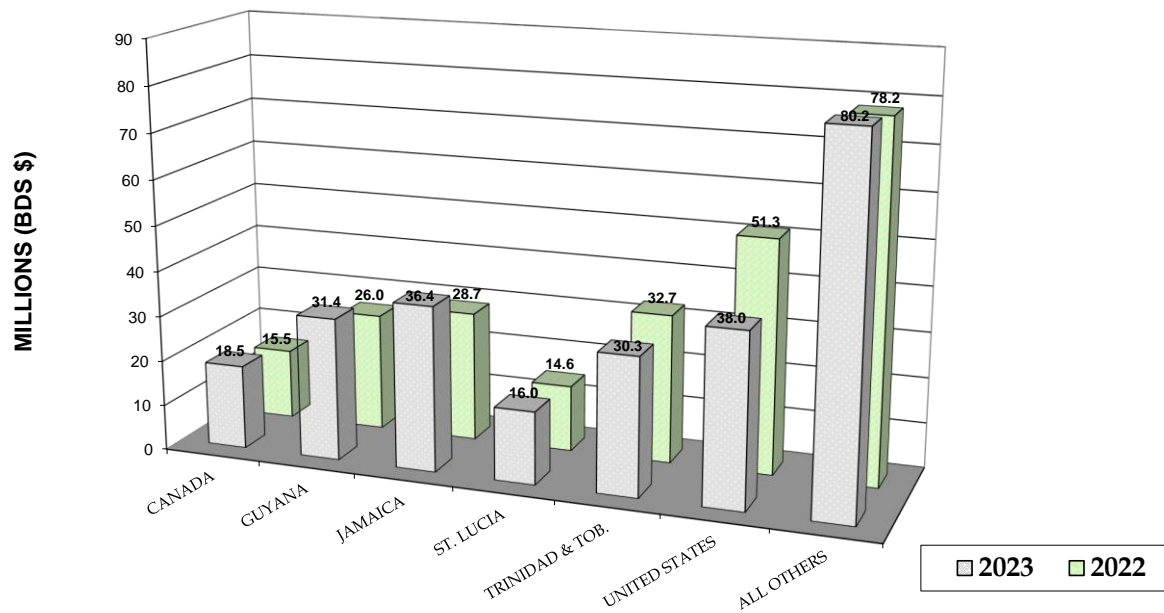

JUNE 2023 WITH THE CORRESPONDING MONTH OF 2022

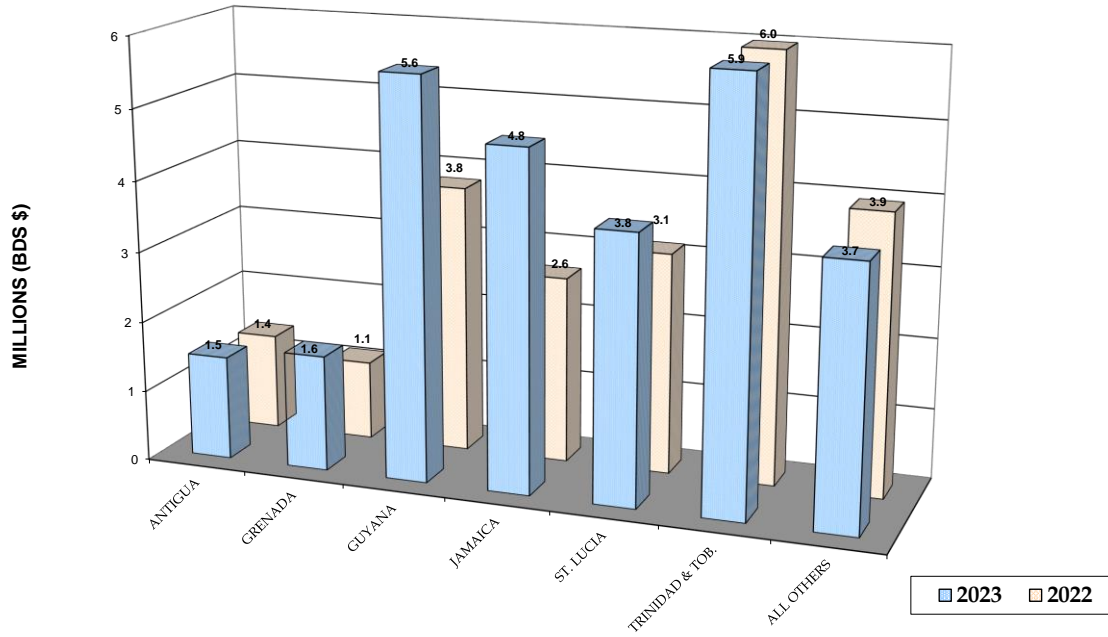


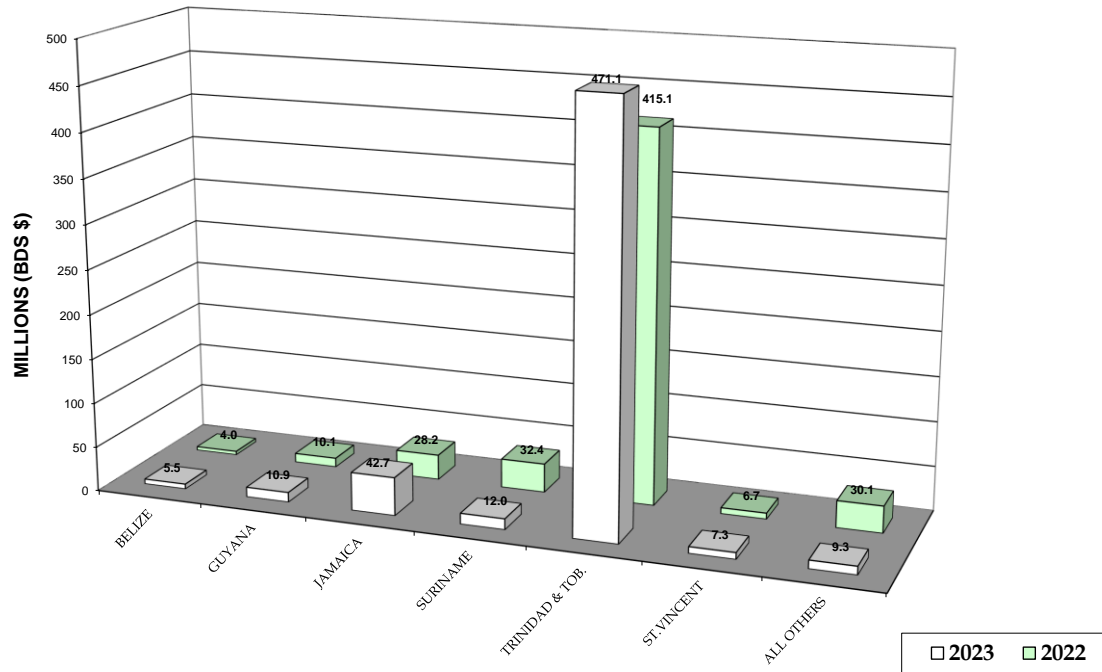

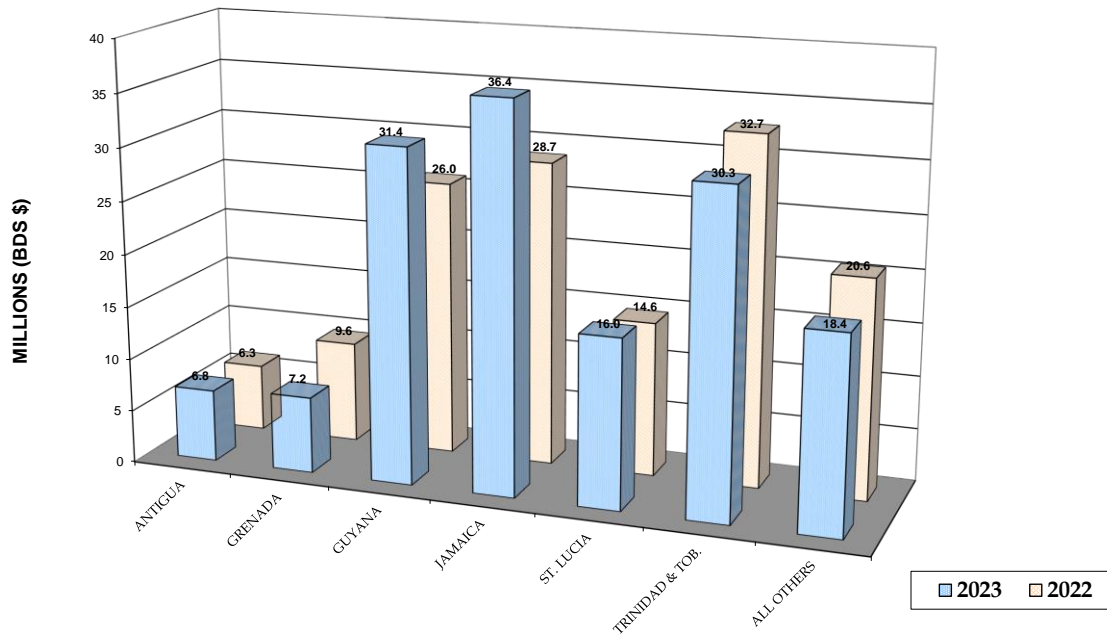
