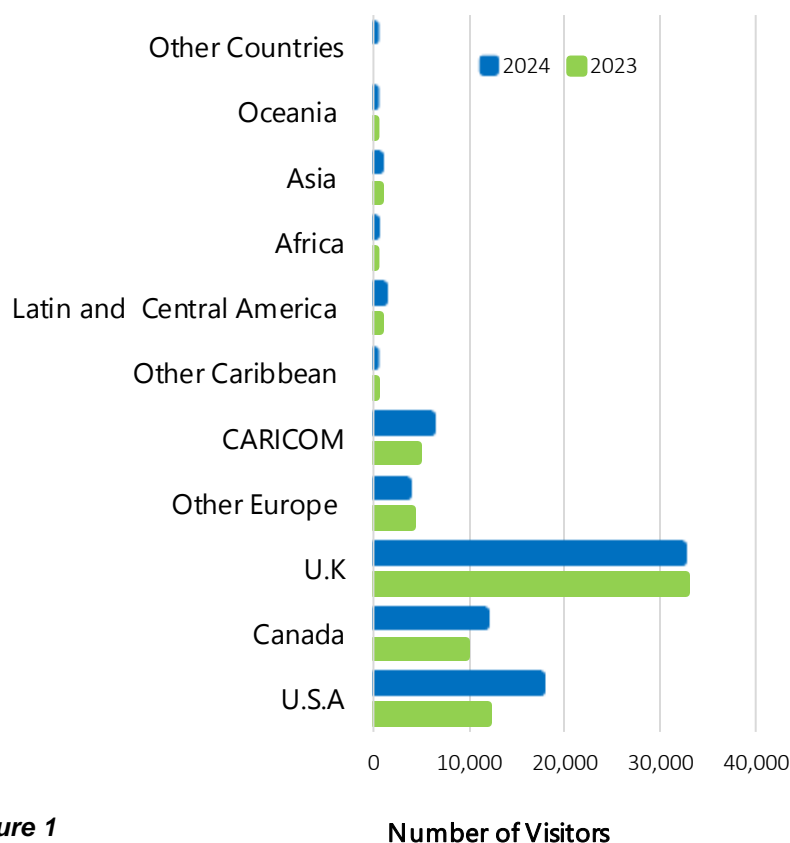

STAY-OVER VISITORS AND CRUISE SHIP PASSENGER ARRIVALS

Stay-Over Arrivals by Country of Residence



The second month of 2024 recorded **74,010** stay-over visitors. (▲)

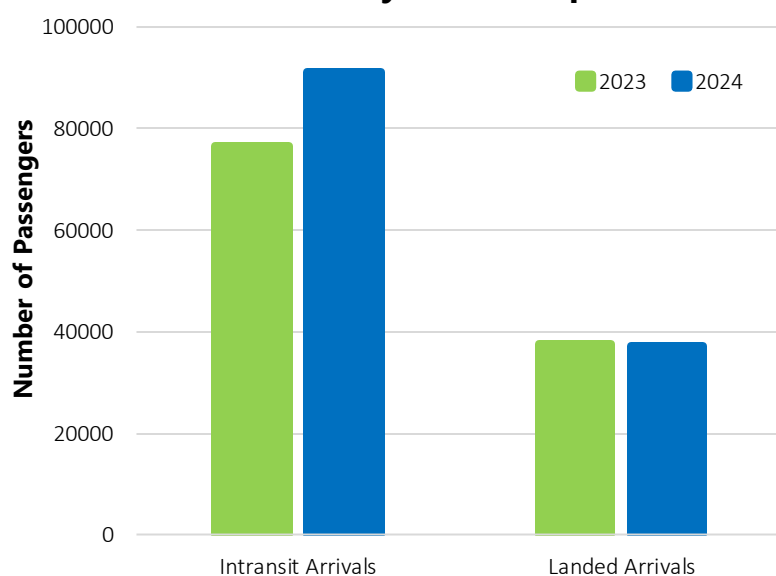
Cruise arrivals totalled **128,410** passengers, for the period under review. (▲)

32,448 of the stay-over visitors to the island came from the UK for the month of February. (▼)

The US reported just over one half of the aforementioned number from the UK, **17,588** persons. (▲)

Other countries registered **2,478** stay-over visitors, while CARICOM had **6,057** tourists for the month. (▲)

CRUISE ARRIVALS

There were **128,410** cruise passenger arrivals in February 2024 (**91,207** – Intransit Passengers and **37,203** – Landed). (▲)

The number of cruise calls was **73**, 7 more than that in 2023. (▲)

Stay-Over Arrivals By Purpose of Visit

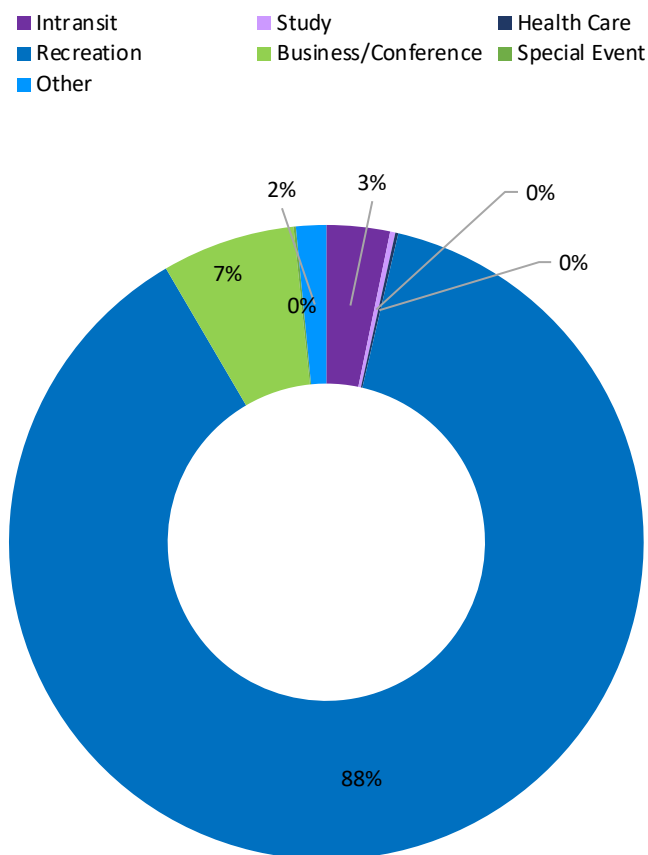

Study visits were registered at **197**. (▼)

Visits for sports totalled **588** persons. (▲)

Other purposes of visit recorded **1,135**. (▲)

Business/Conferences were recorded at **5,020**. (▼)

While the Visiting friends and family category had **4,681** visitors doing so. (▲)

Stay-Over Arrivals By Length Of Stay

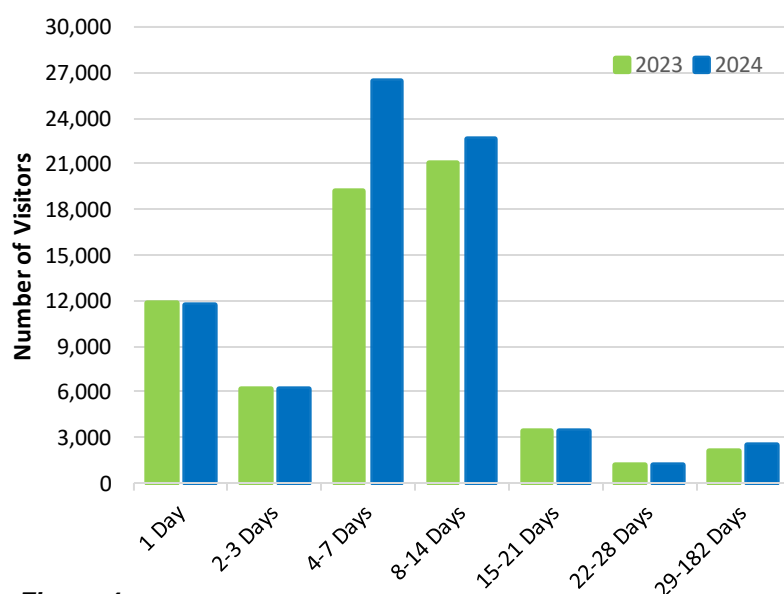

Year To Date Stay-Over Arrivals by Country of Residence

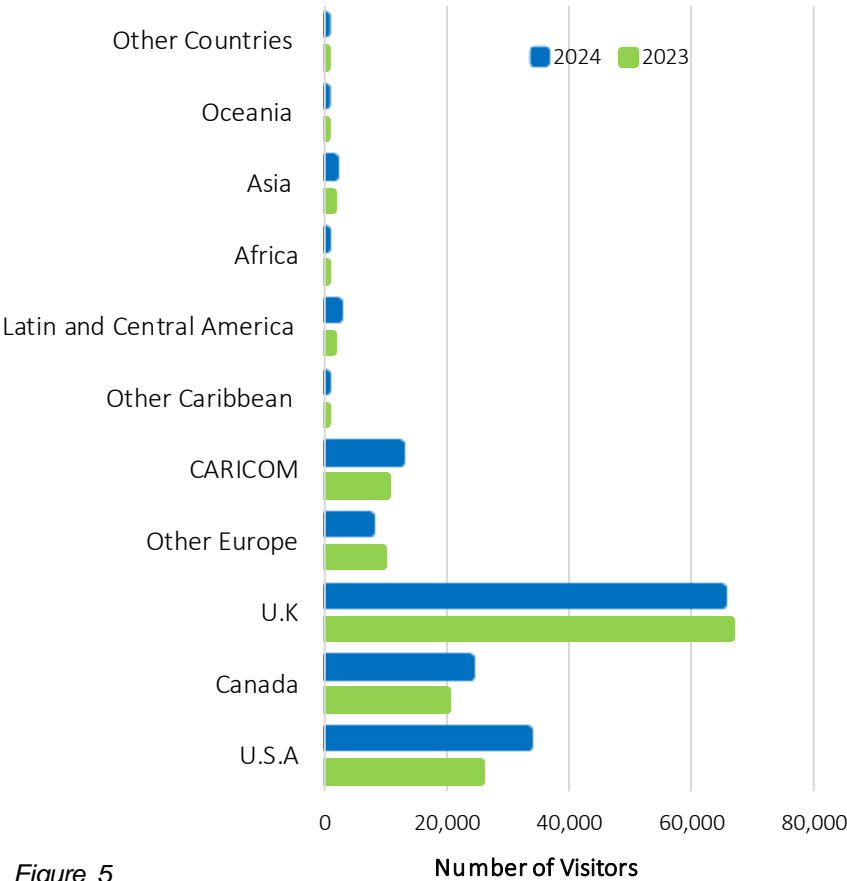

Year to Date Arrivals By Cruise Ship

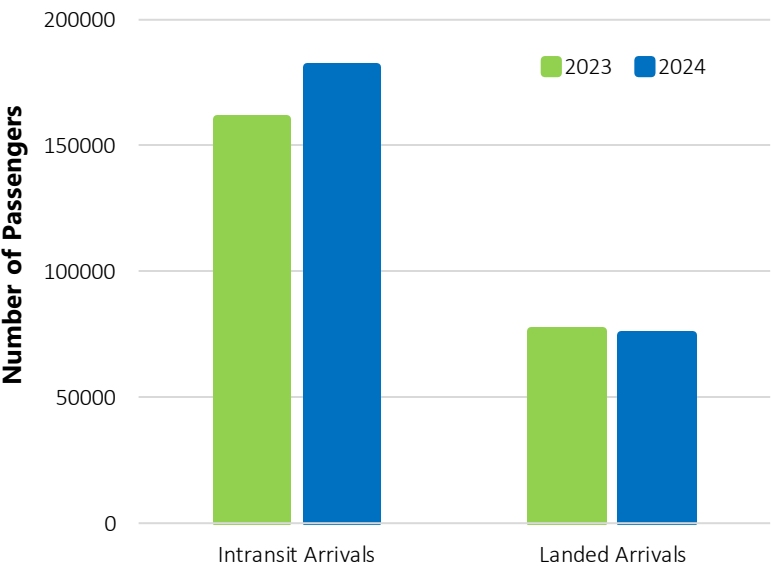

Year to Date Stay-Over Arrivals By Purpose of Visit

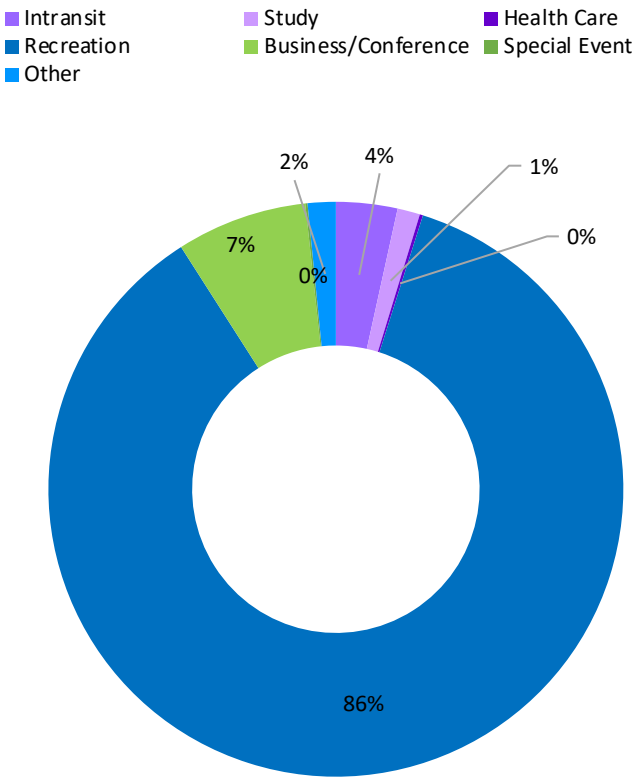

Year To Date Stay-Over Arrivals By Length Of Stay

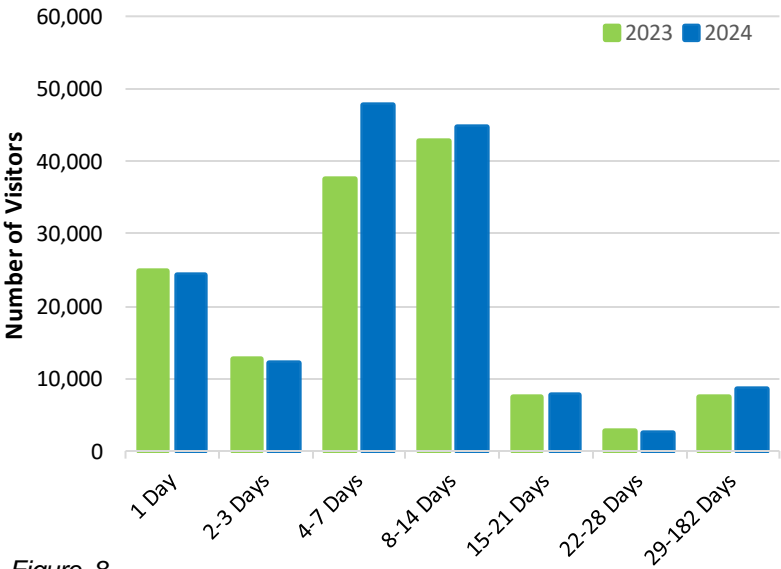

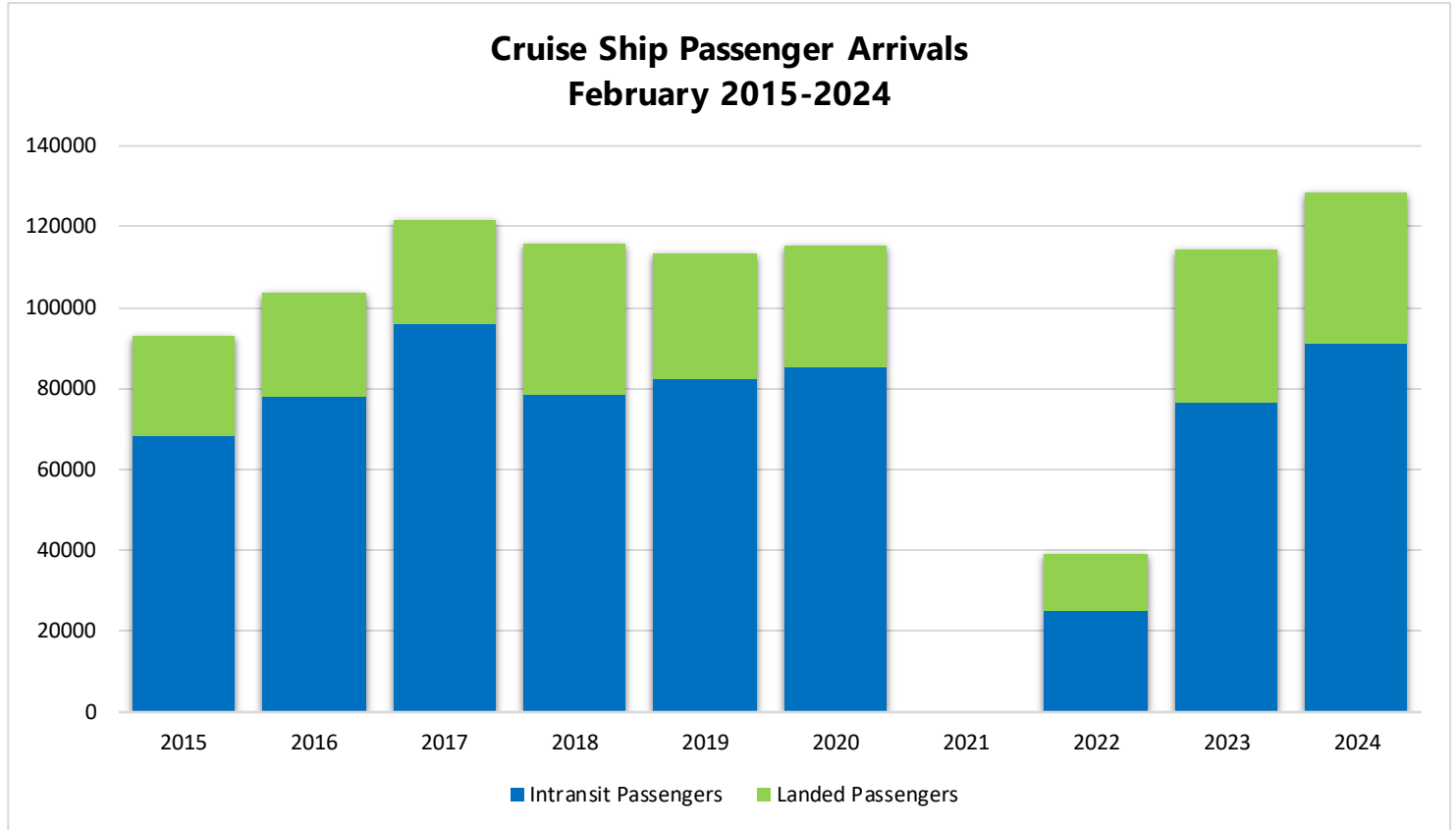

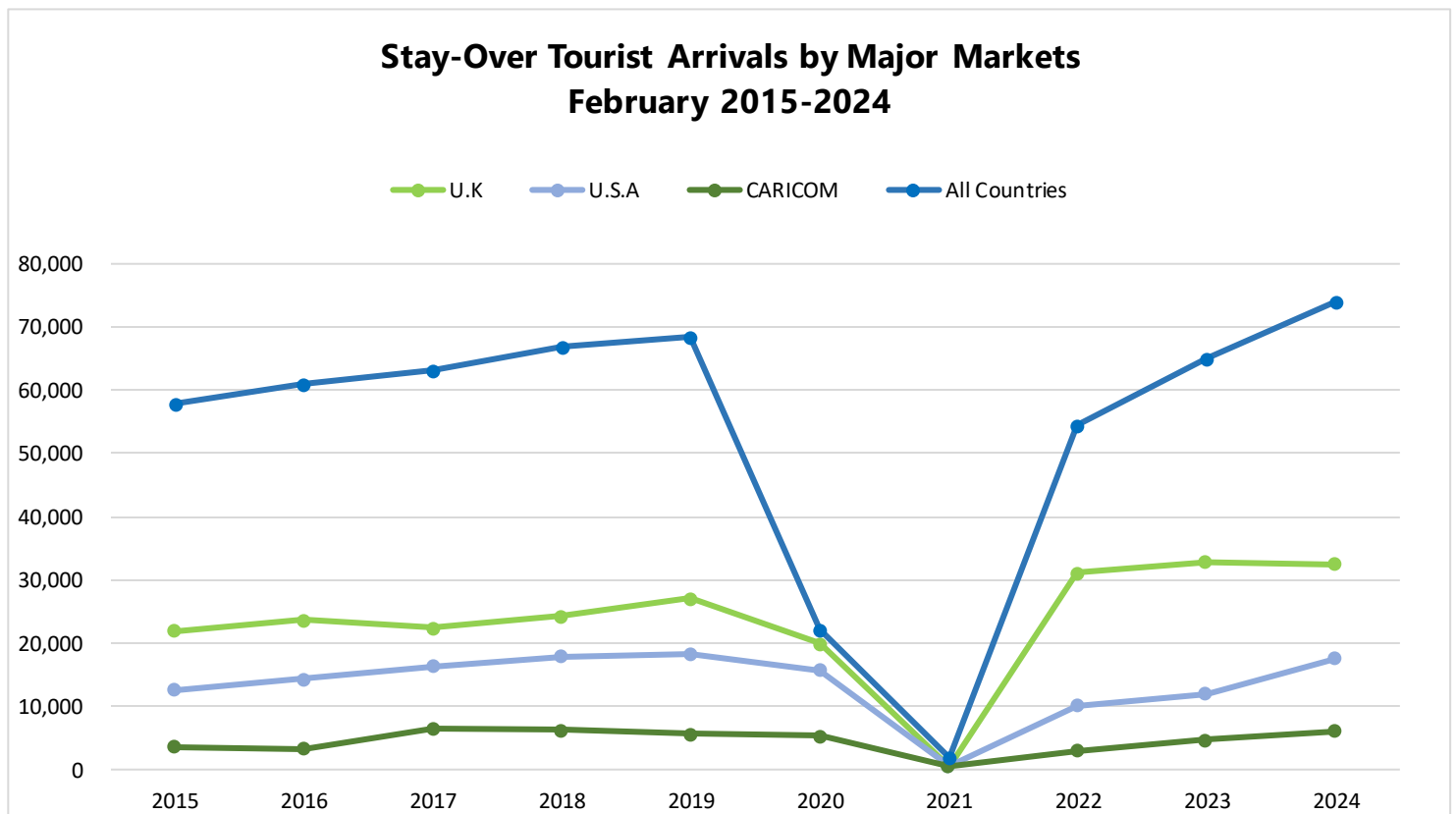

January - February 2015-2024**

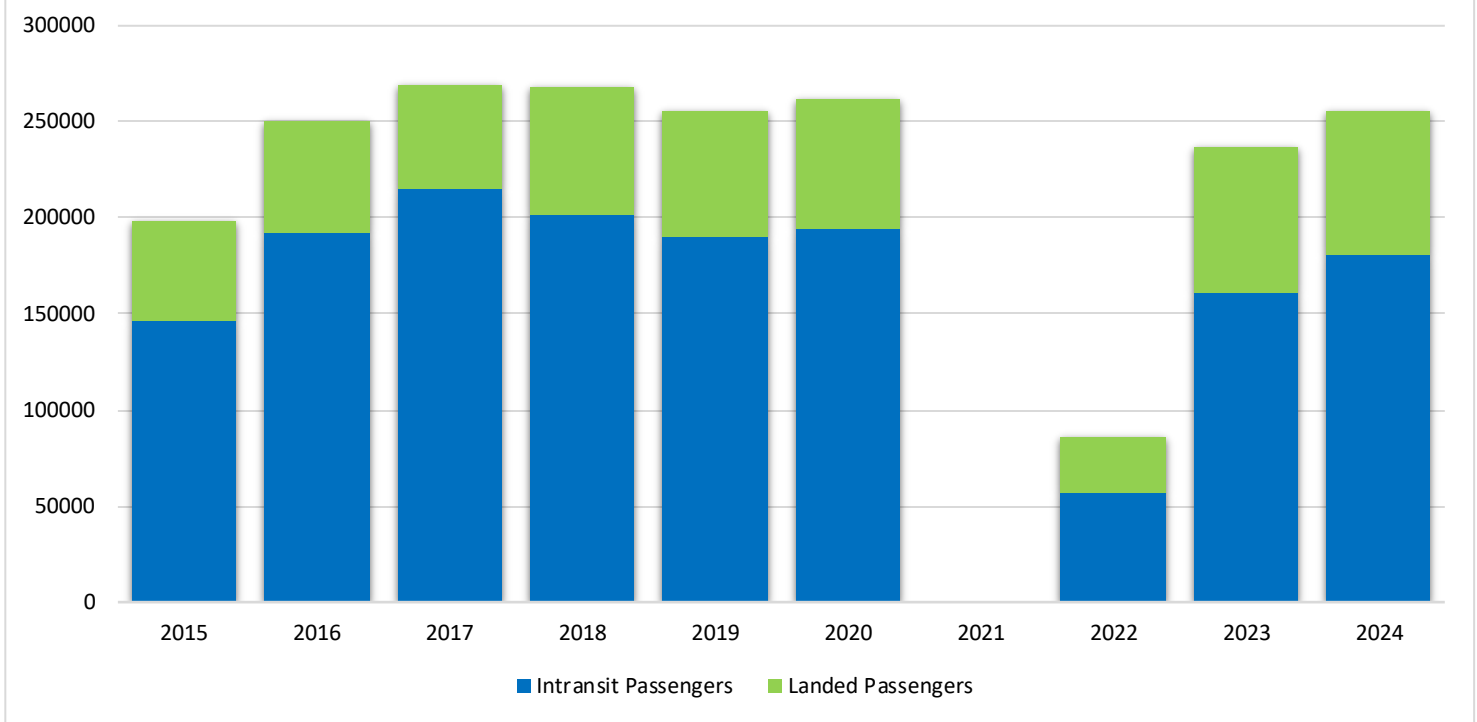

January - February 2015-2024**

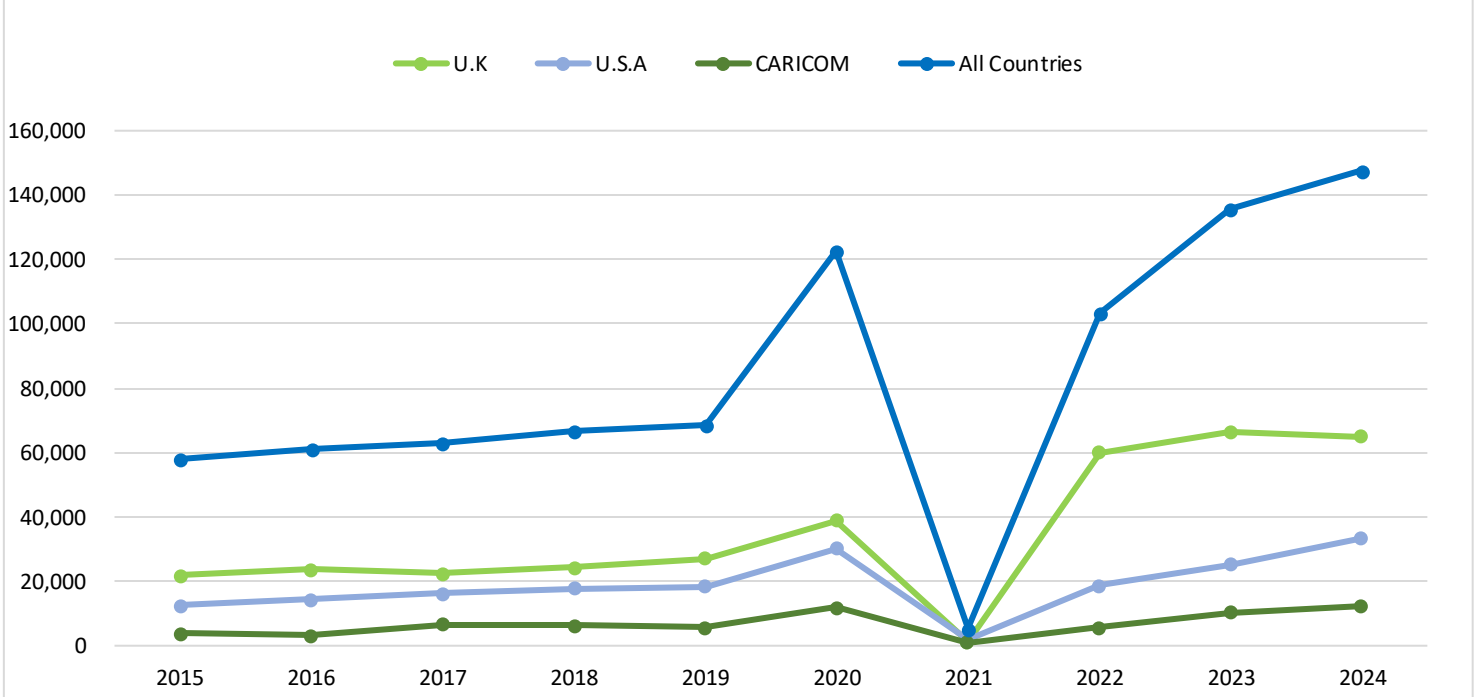
