## **REVIEW OF OVERSEAS TRADE**

During the month of July 2024, total imports to Barbados were valued at \$365.7 million, whilst total exports from Barbados were valued at \$73.8 million. This resulted in a visible trade deficit of \$291.9 million, as compared with a visible trade deficit of \$276.1 million for July 2023.

Imports for July 2024 were \$28.8 million more than imports for July 2023, an increase of 8.6%. Total exports increased by \$12.9 million or 21.2% of the July 2023 figure. Domestic exports increased by \$10.2 million or 26.1% over July 2023, while the value of re-exports increased by \$2.7 million or 12.6% over the corresponding period 2023.

For the period January – July 2024, the value of imports to Barbados was \$2.51 billion, whilst the value of total exports was \$573.8 million representing an accumulated visible trade deficit of \$1.94 billion as compared to a similar deficit of \$1.86 billion for January – July 2023.

Imports for January – July 2024 were \$83.4 million more than imports for the same period 2023, an increase of 3.4%. Total exports showed an increase of some \$10.3 million or 1.8% over the January - July 2023 figure. Domestic exports increased by \$0.4 million or 0.1% over January – July 2023. The value of re-exports increased by \$9.9 million or 3.6% over the corresponding period 2023.

## **CARICOM TRADE**

During the month of July 2024, total imports from CARICOM countries were valued at \$87.5 million, whilst total exports to CARICOM were valued at \$32.7 million, resulting in a trade deficit of \$54.8 million as compared with a visible trade deficit of \$41.8 million for July 2023.

Total CARICOM imports for July 2024 were \$19.3 million more than CARICOM imports for July 2023, an increase of 28.3%. Total exports to CARICOM for July 2024 were \$6.3 million more than total exports for July 2023, an increase of 23.9%. Domestic exports increased by \$5.7 million or 25.7% over July 2023. The value of re-exports increased by some \$0.6 million, or 14.7%, over the July 2023 figure.

For the period January – July 2024, total imports from CARICOM were valued at \$662.7 million, whilst total exports were \$190.5 million resulting in an accumulated visible trade deficit of \$472.2 million as compared with a deficit of \$428.6 million for the same period of 2023.

During this period, CARICOM imports were approximately \$35.8 million more than those over the same period in 2023, an increase of 5.7%. Total exports to CARICOM for January – July 2024 were \$7.8 million less than total exports for the corresponding period 2023, a decrease of 4.0%. Domestic exports decreased by approximately \$9.9 million or 5.9% over the same period 2023. The value of re-exports increased by \$2.1 million or 7.0% over the January – July 2023 figure.

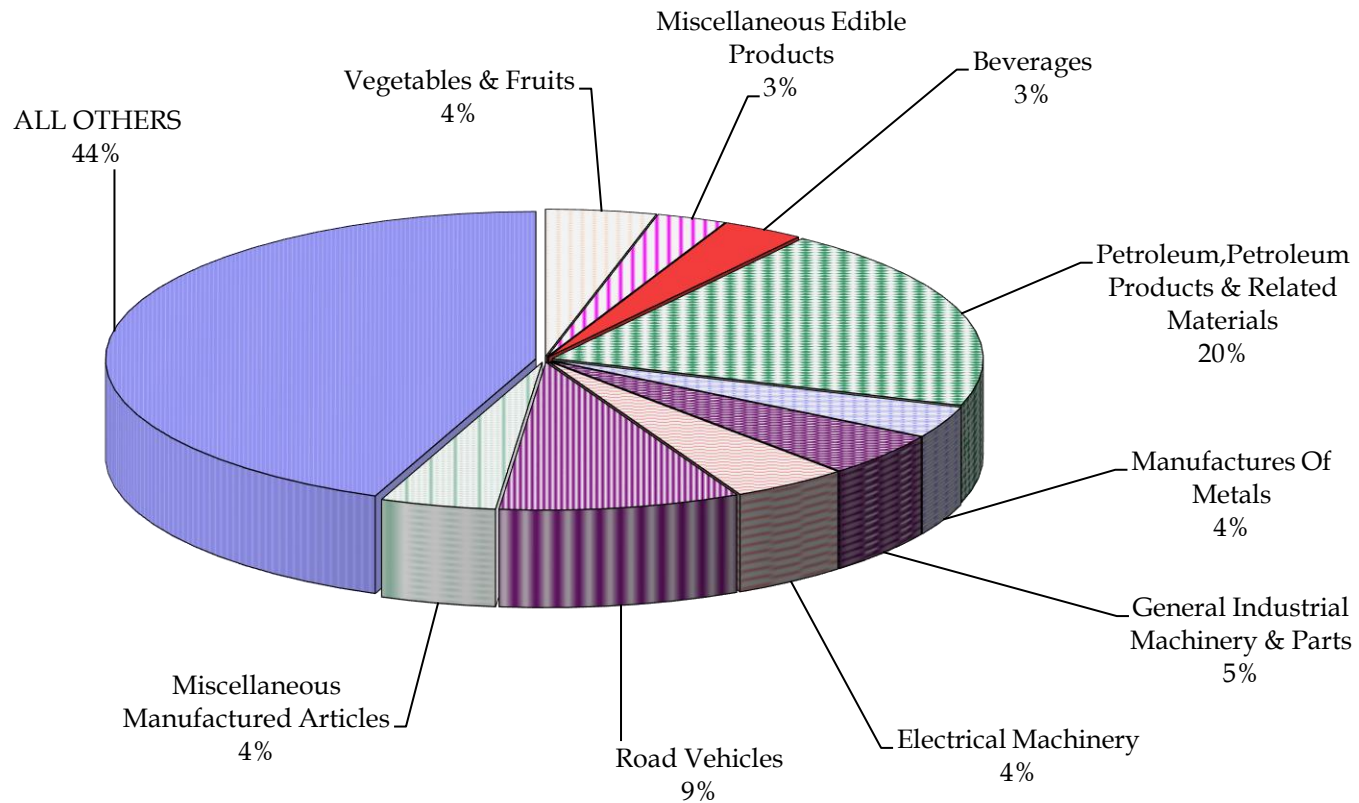

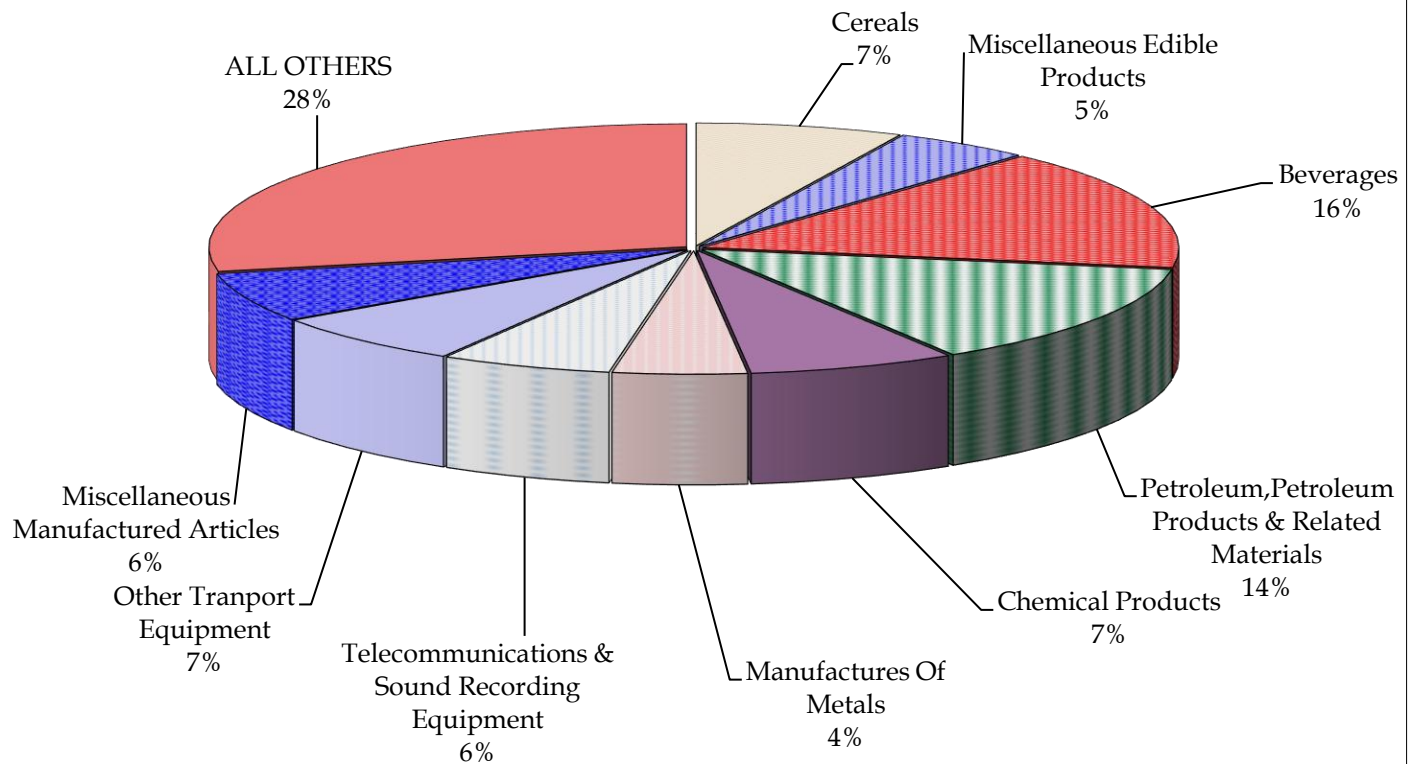

## Principal Domestic Exports - July 2024



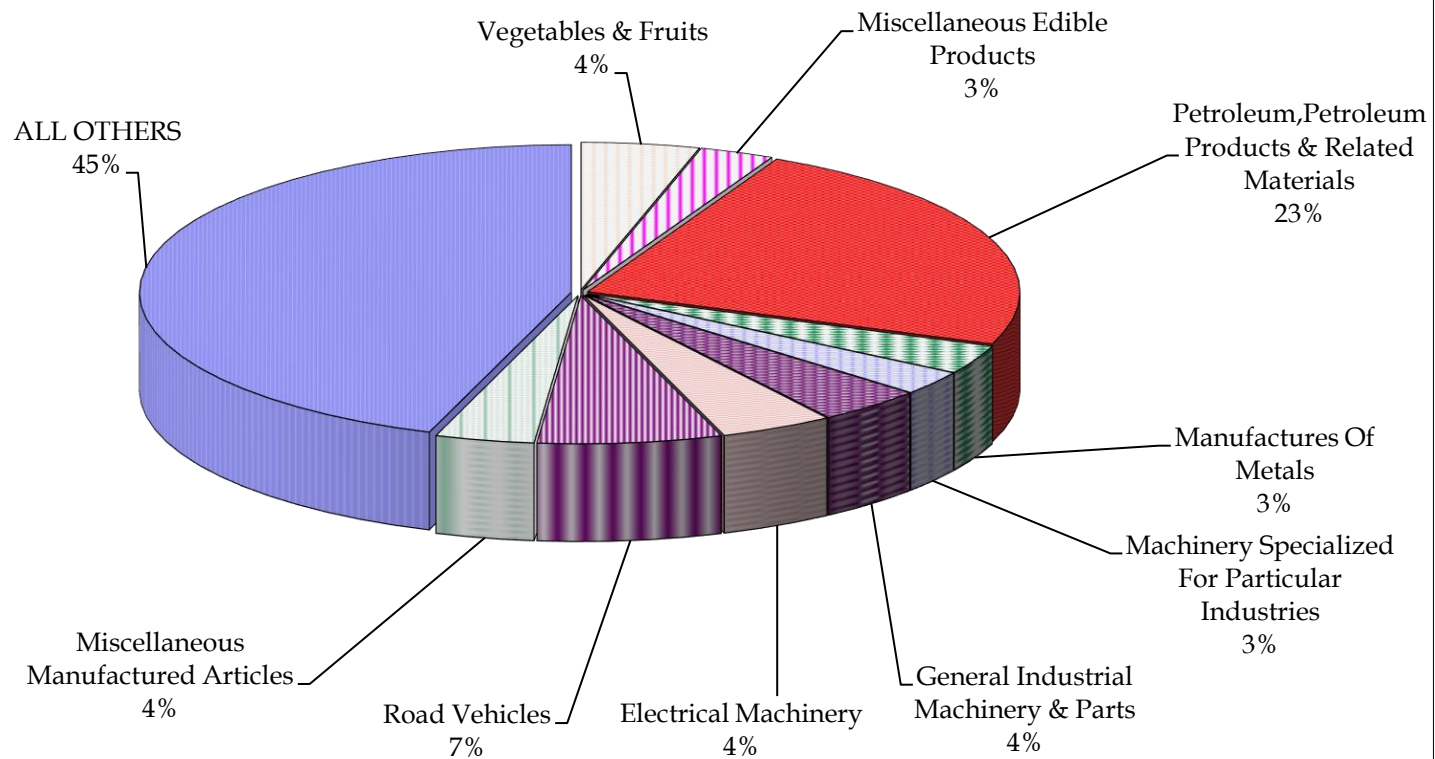

## Principal Domestic Exports January - July 2024

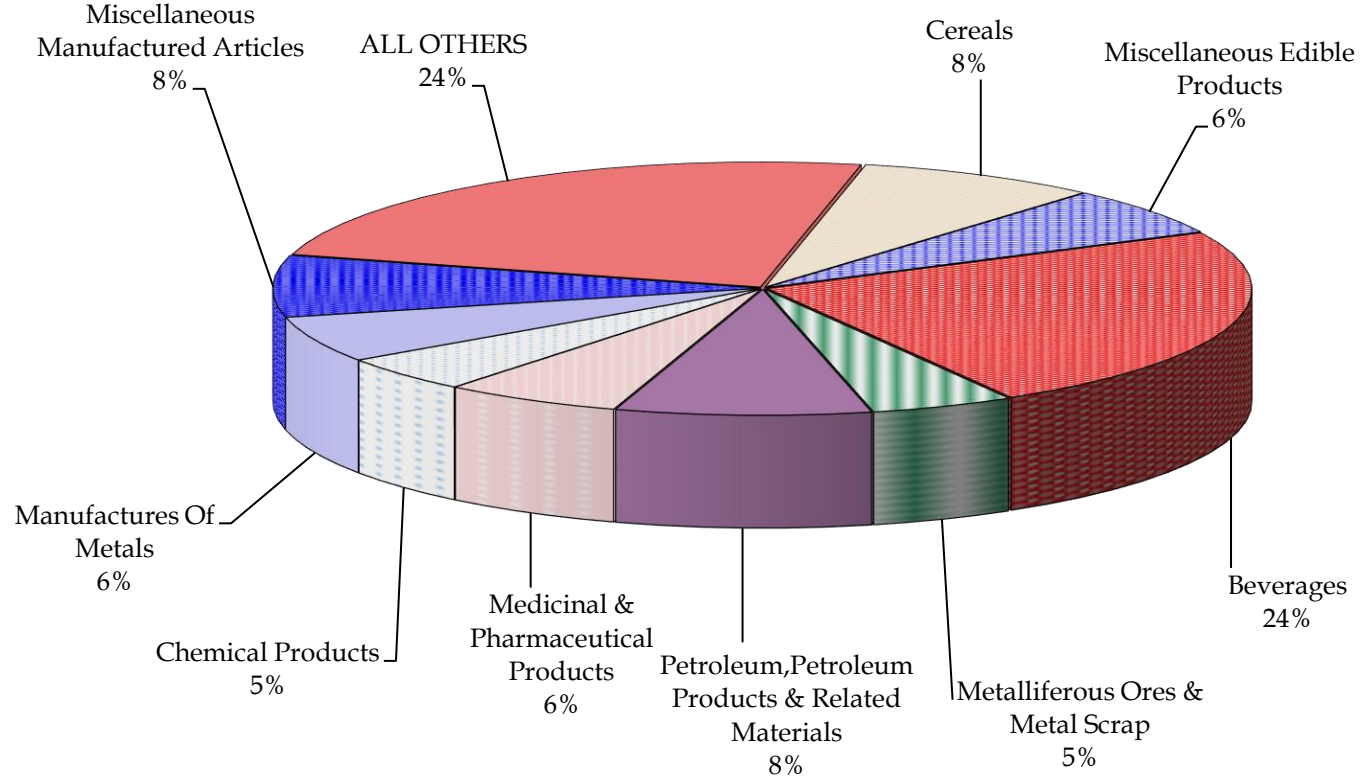

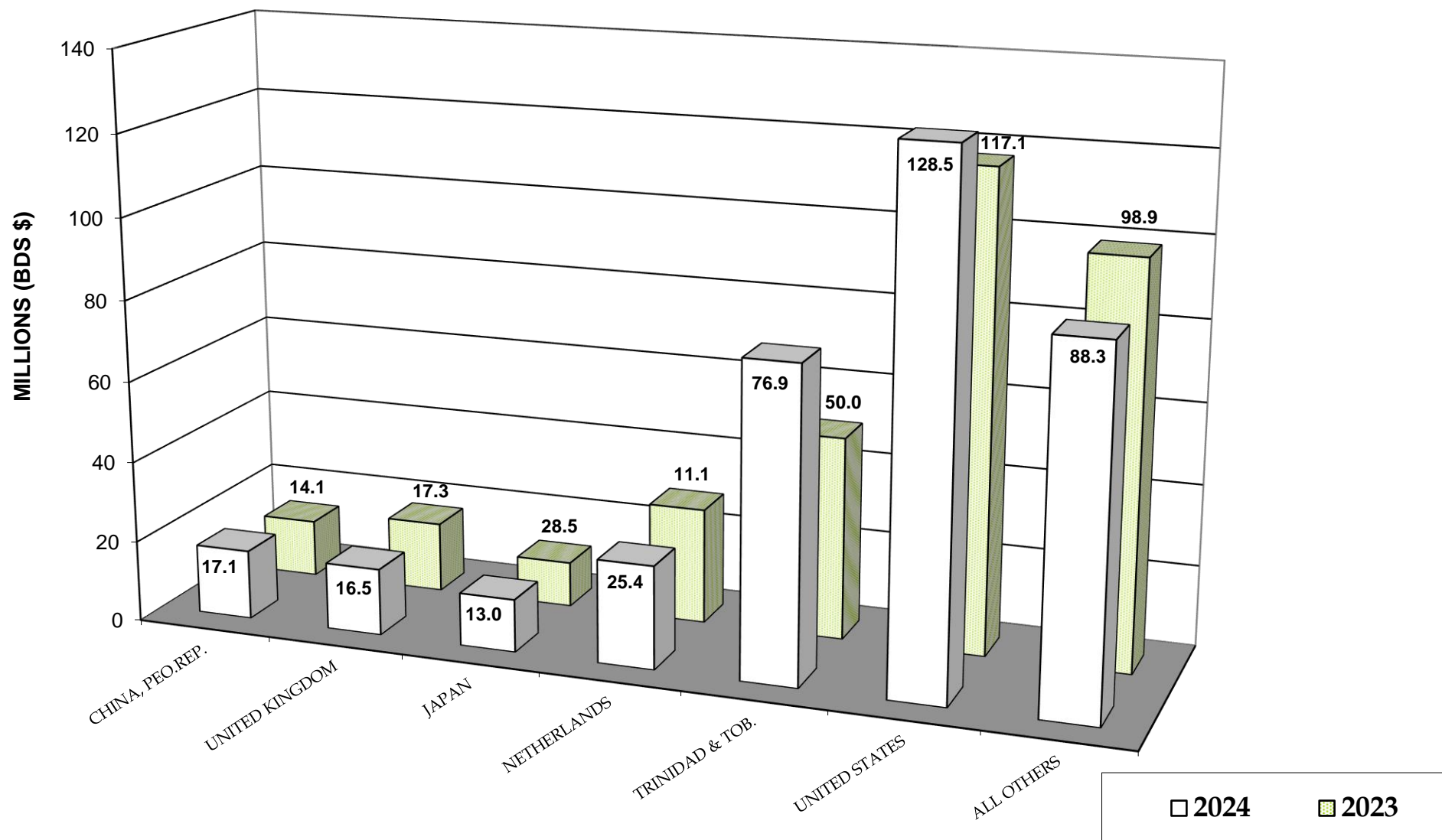

JULY 2024 WITH THE CORRESPONDING MONTH OF 2023

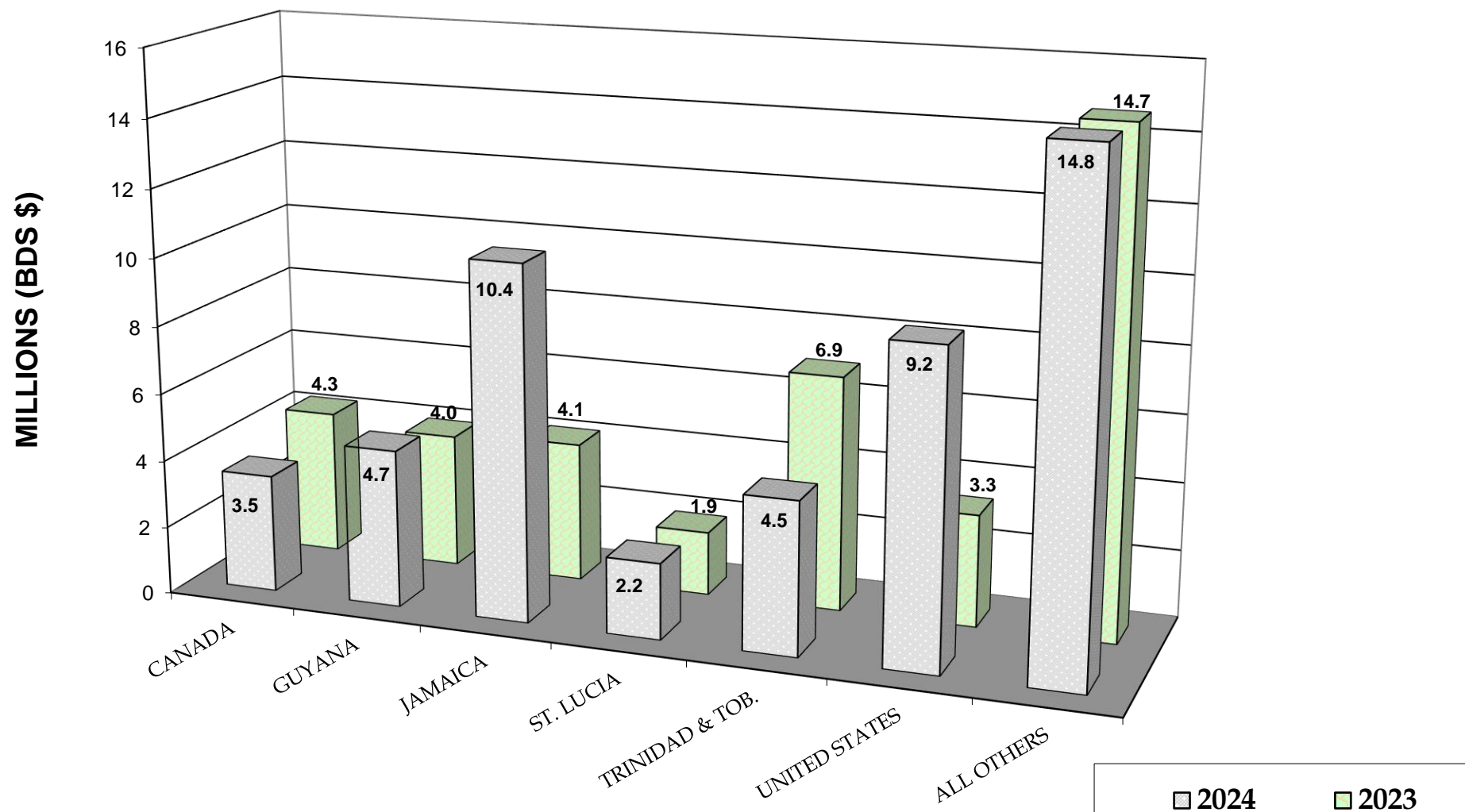
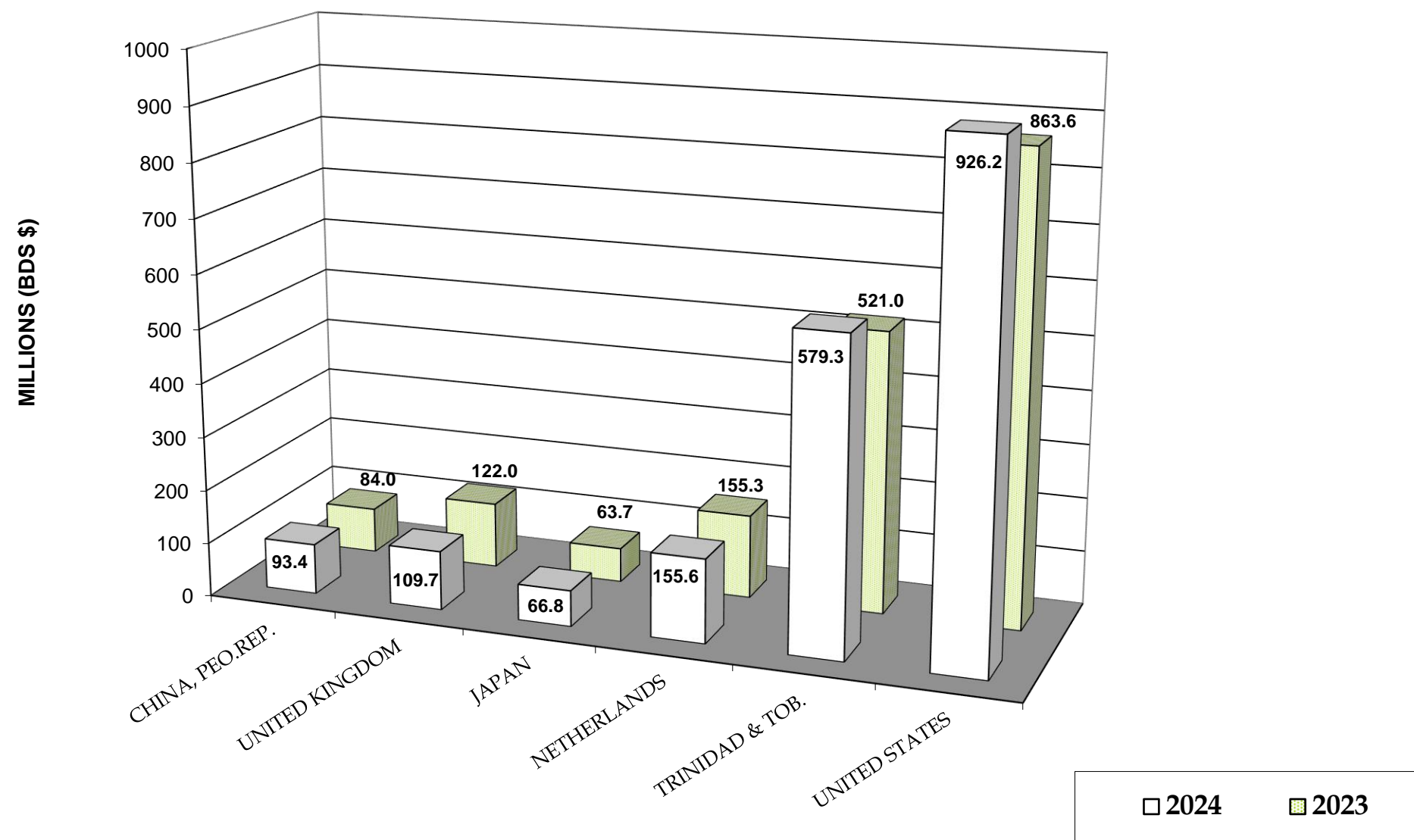

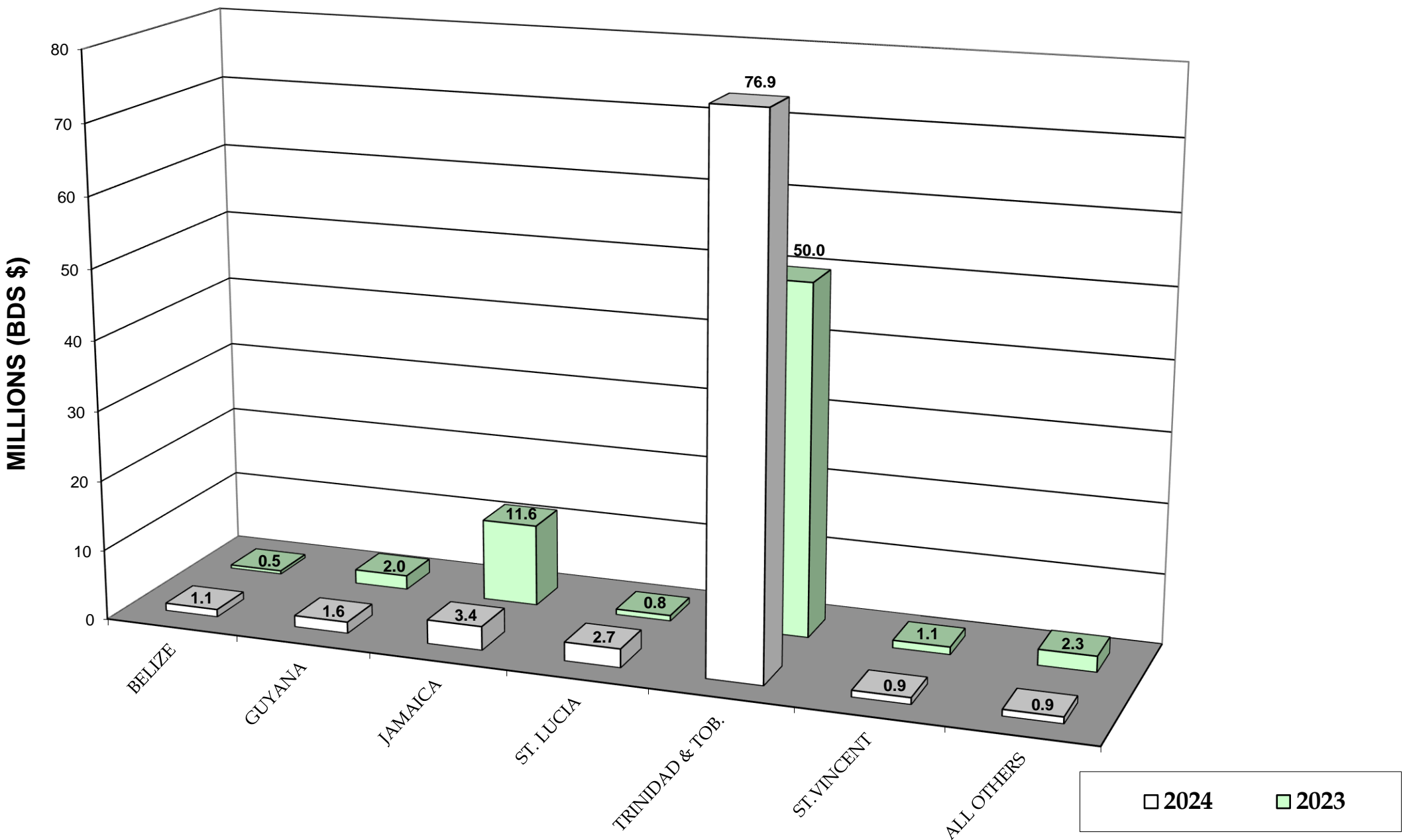

JULY 2024 WITH THE CORRESPONDING MONTH OF 2023

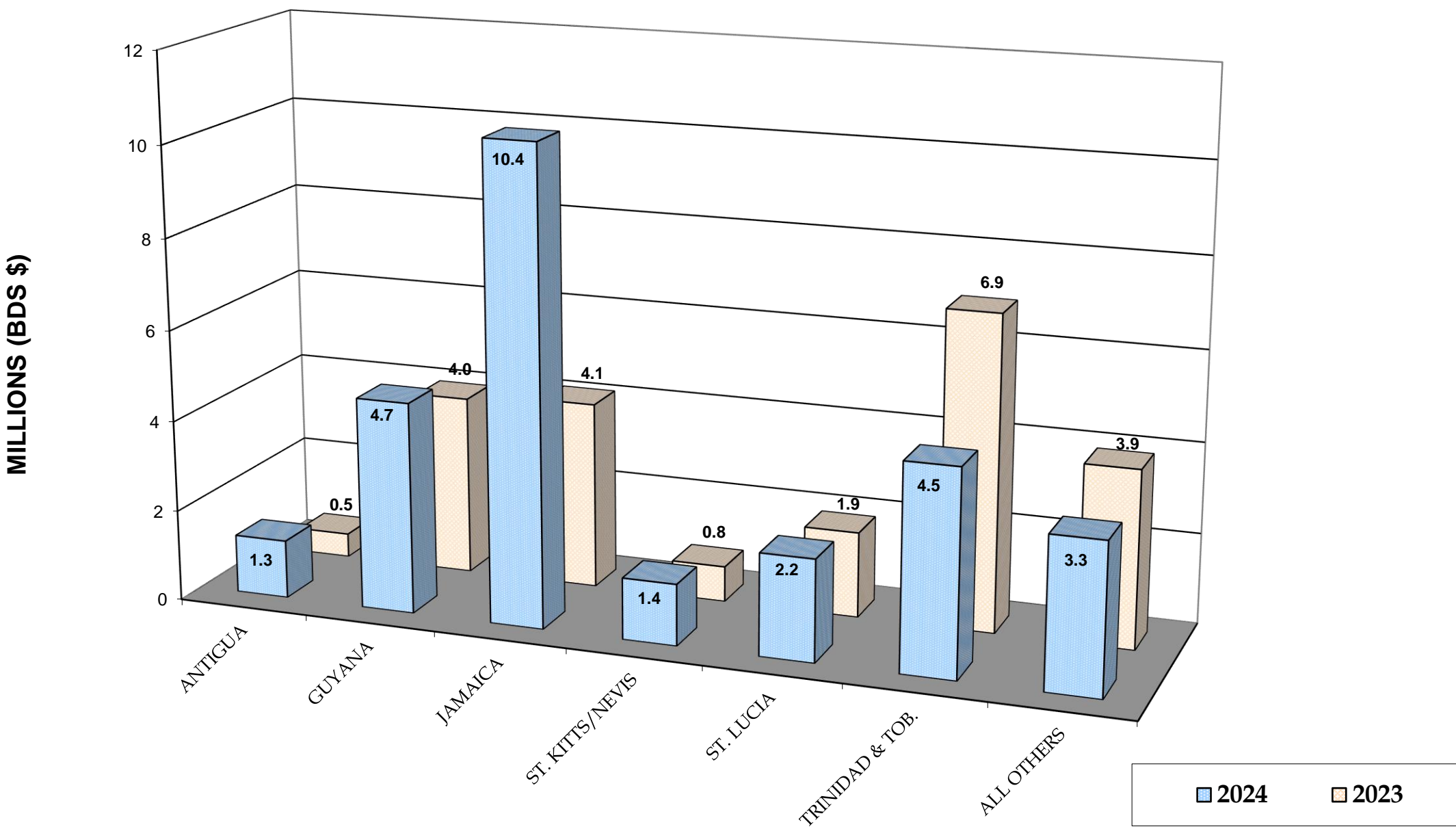
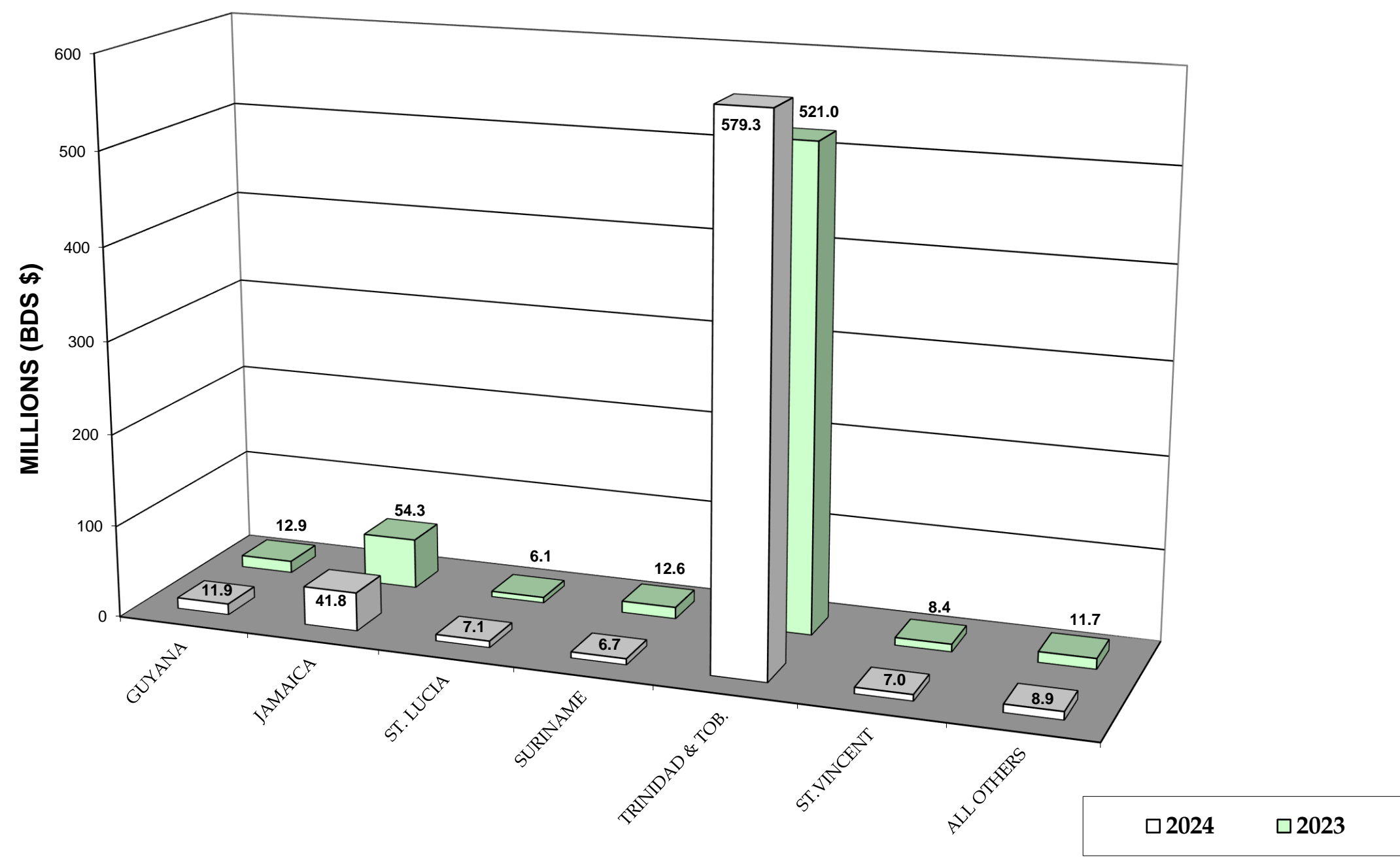

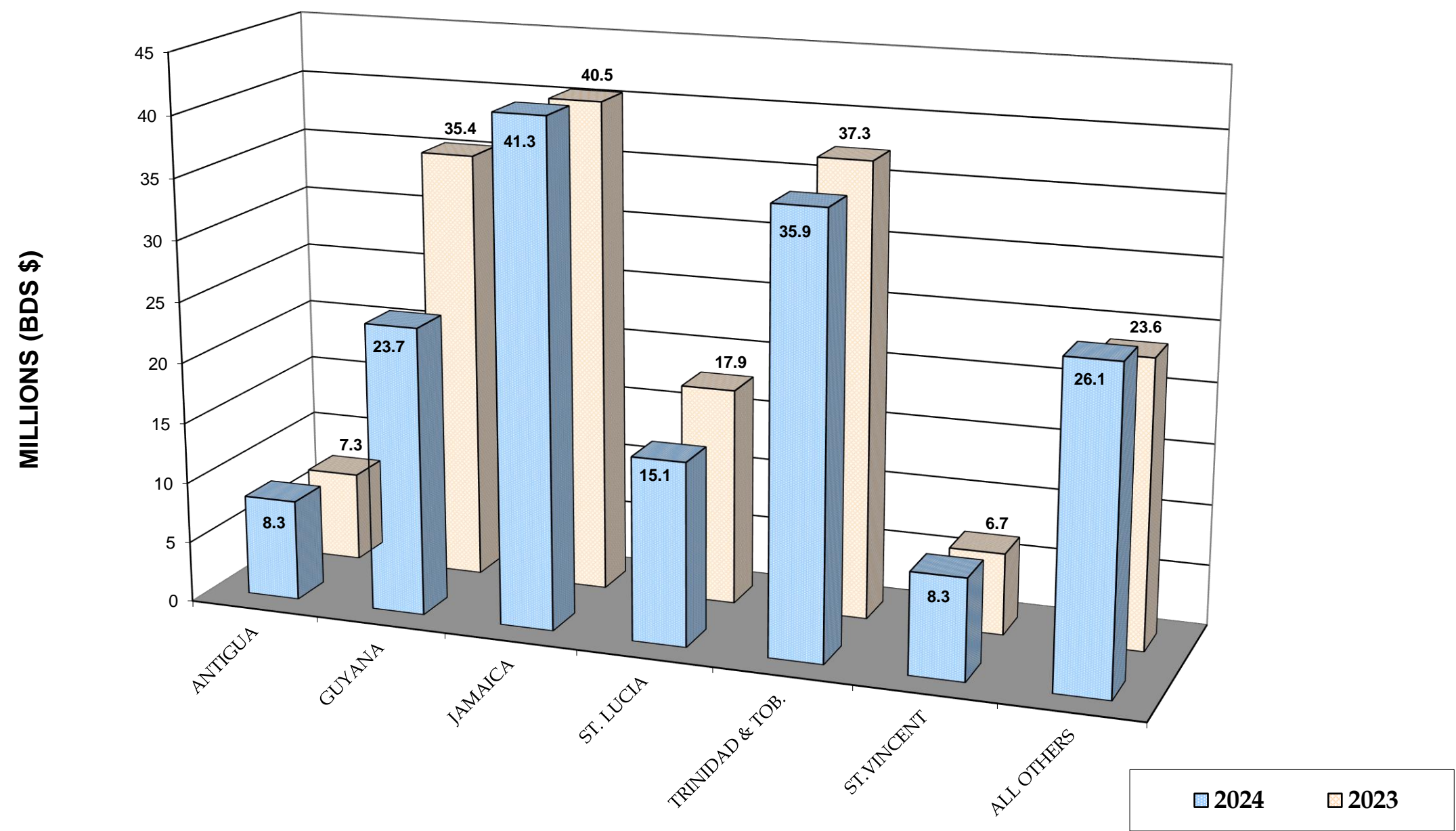
