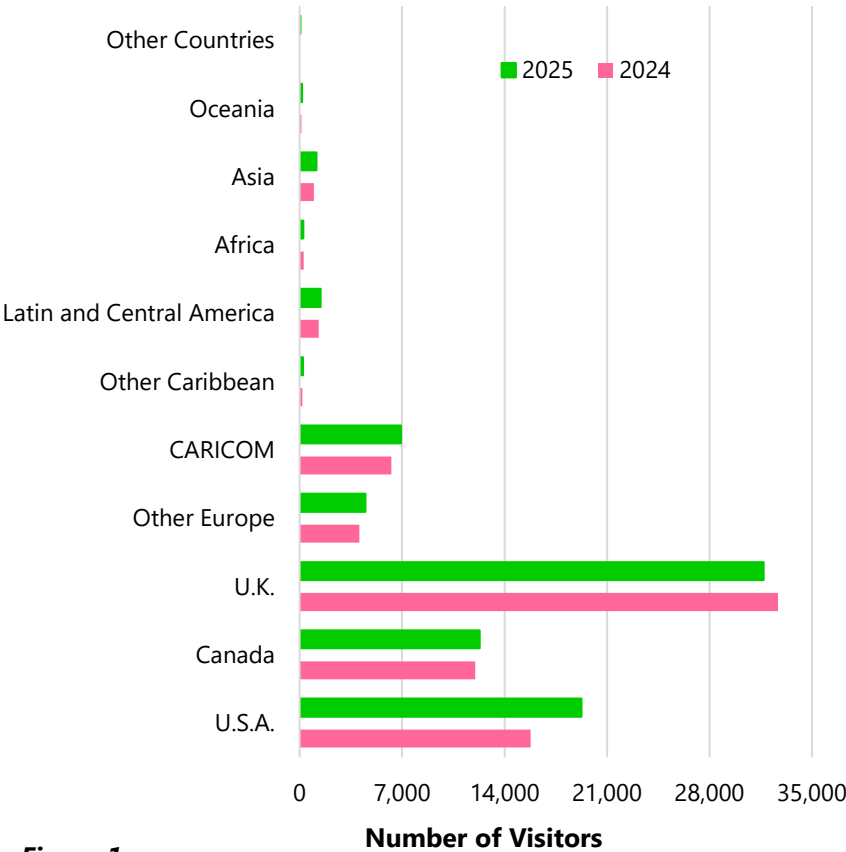

STAY-OVER VISITORS AND CRUISE SHIP PASSENGER ARRIVALS

Stay-Over Arrivals by Country of Residence



January 2025 ended with **(77,967)** stay-over visitors when compared to the previous year **(73,693)**, there was a small increase of **(4,274)**. (▲)

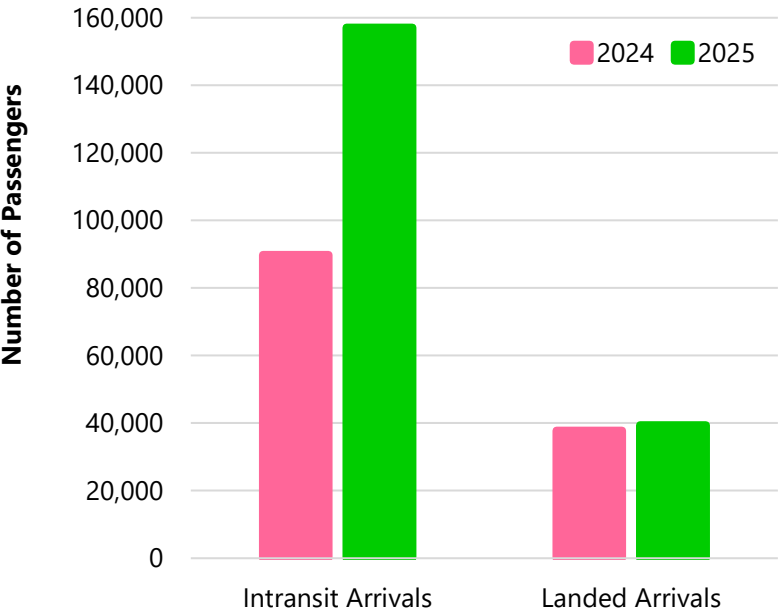
Most of the visitors arrived from the UK **(31,695)** (▼), down, albeit slight from the **32,677** recorded in January 2024.

U.S.A. registered **(19,252)** visitors (▲) and Canada had a total of **12,301** (▲), though significantly less than U.K., were the second and third highest numbers of visitors.

Stay-over arrivals from Africa were noted at **(258)** (▼) and Latin and Central America **(1,429)** (▲).

Cruise arrivals for January 2025 saw significant increases in both Intransit and Landed Passengers with **(157,093)** and **(39,405)** respectively. (▲)

(83) cruise ships landed on the island; this was an increase compared to the **(71)** in the previous year. (▲)

Stay-Over Arrivals by Purpose of Visit

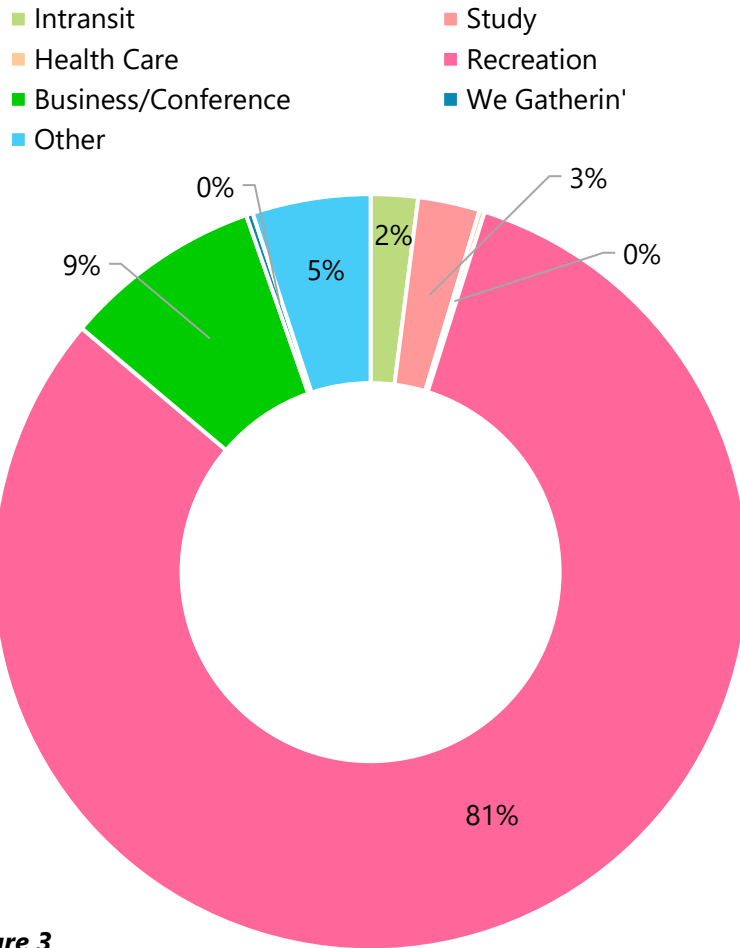

Other Recreation purposes of visit were **1,037** (▲).

The Special Event of note was We Gathering which boasted **223** visitors (▲).

Stay-Over Arrivals by Length Of Stay

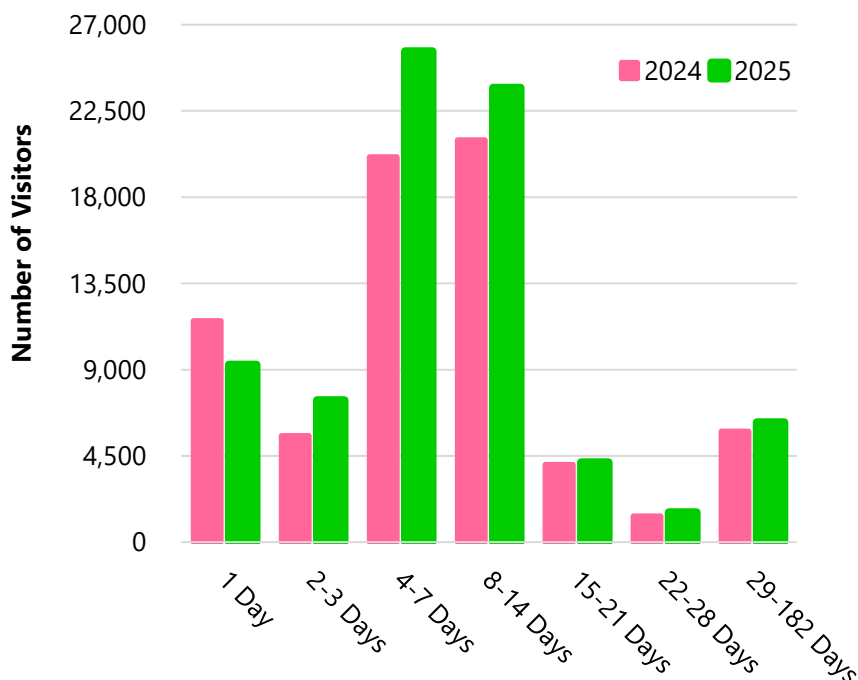

LENGTH OF STAY

The 4-7 days period saw **25,614** persons (▲) followed by **23,711** (▲) in the 8-14 day period. The least number of visitors stayed for the 22-28 days period (**1,556**) (▲).

The average length of stay rose to **15.4** days (▲), up from 12.8, one year prior.

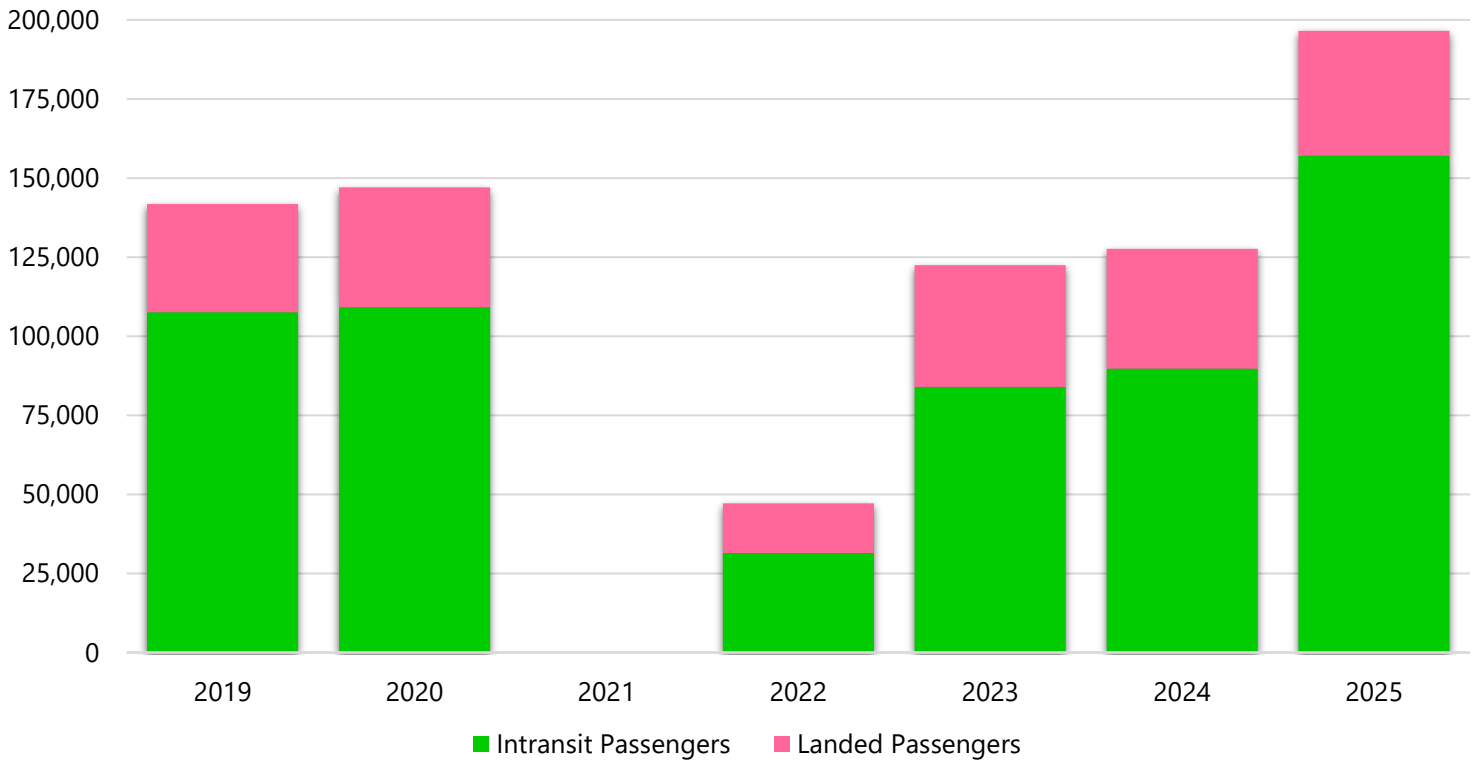

Stay-Over Tourist Arrivals by Major Markets January 2019-2025

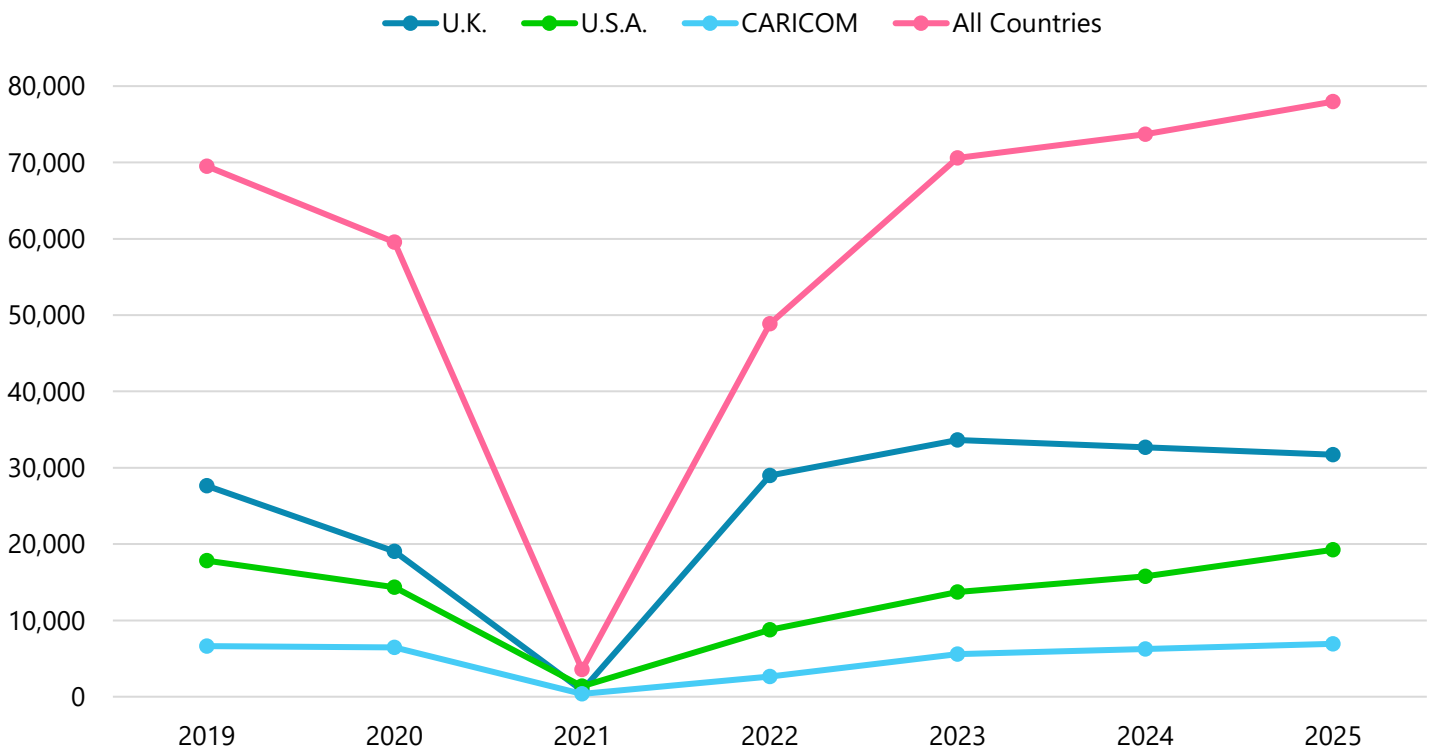
