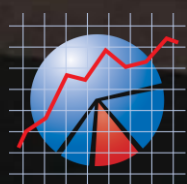

STAY-OVER VISITORS AND CRUISE SHIP PASSENGER ARRIVALS

Stay-Over Arrivals by Country of Residence

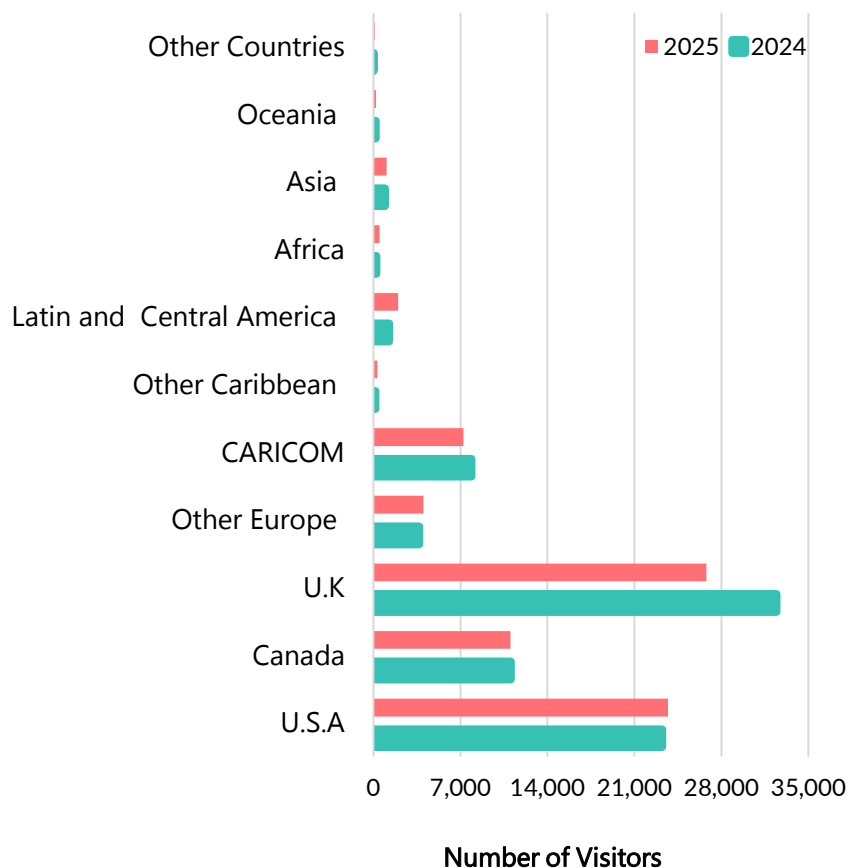

In March 2025, this island saw **76,938** stay-over visitors which when compared to last year is a decrease of **4,187**. (▼)

There was an expansion seen in the number of cruise arrivals passengers, **146,851**. (▲)

In March 2025, majority of the stay-over visitors arrived from the U.K., with **26,783** which showed a decline from the same period in 2024. (▼)

The US and Canada, with stay-over visitors counted at **23,704** (▼) and **11,040** respectively, both showed slight declines (▼).

Barbados has also seen a slight inflation in visitors from Asia (**1,060**) (▲) and Oceania (**202**) (▲) compared to the previous year.

Arrivals By Cruise Ship

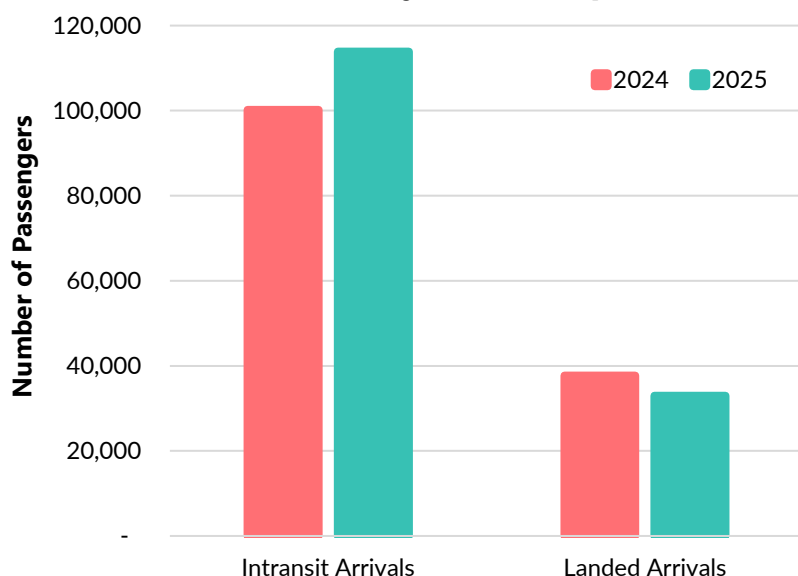

CRUISE ARRIVALS

There was an upsurge in the number of cruise passenger arrivals in March, which rose from **137,893** (▲) to **146,851**, with (**113,851** – Intransit Passengers (▲) and **33,000** – Landed (▼)).

Cruise calls totalled **69** (▼), down from **82** in March 2024.

PURPOSE OF VISIT AND LENGTH OF STAY

Stay-Over Arrivals By Purpose of Visit

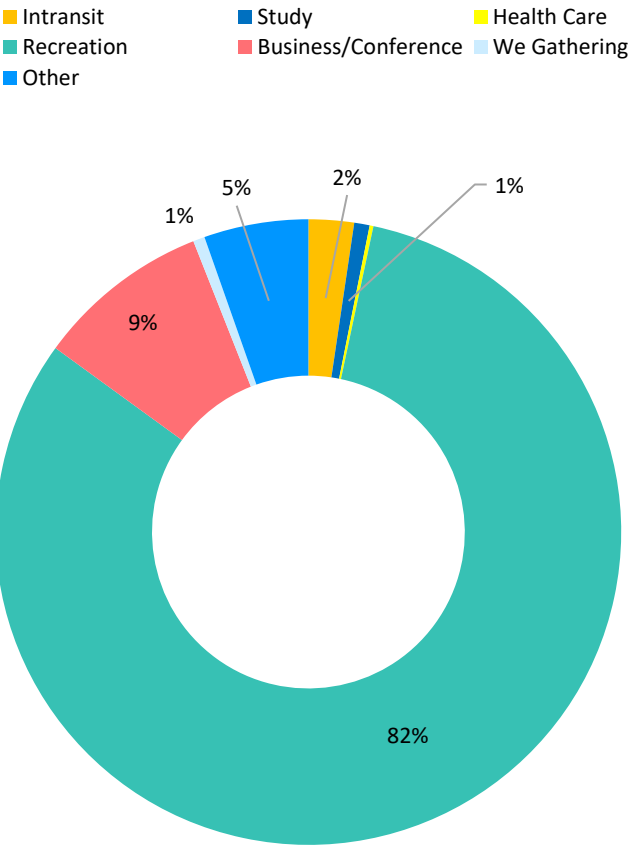

The main purpose of visit was for recreational purposes with **62,836** passengers (▼). Special note should be made of the **462** visitors who came for **We Gathering - St. Thomas**.

Intransit visits were registered at **1,805** persons (▼).

Visits for sports totalled **1,020** persons (▲).

Other purposes of visit recorded **4,150** persons (▲) coming to the island.

Business/Conferences visits were counted at **6,922** (▲).

Educational/Study visits were **611** (▲).

The number of visitors celebrating weddings and honeymoons was **1,121** (▼).

Stay-Over Arrivals By Length Of Stay

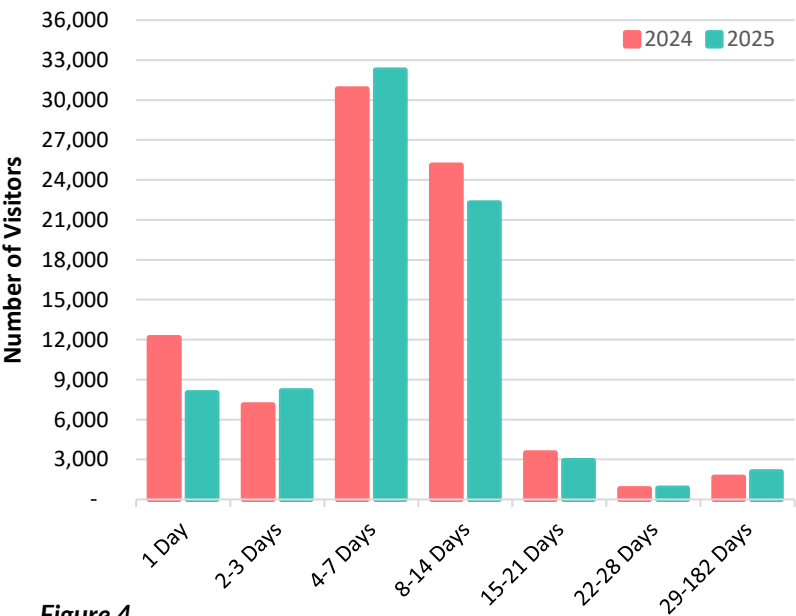

LENGTH OF STAY

The 4-7 days category had the most passengers visiting (**32,261**) (▲), compared to last year's total of **30,833** for the same length of stay.

The period of 8-14 days followed behind with (**22,691**), despite the decline from last year (▼).

The average number of days spent increased from **8.13** in March 2024 to approximately **9.92** in 2025 (▲).

Year To Date Stay-Over Arrivals by Country of Residence

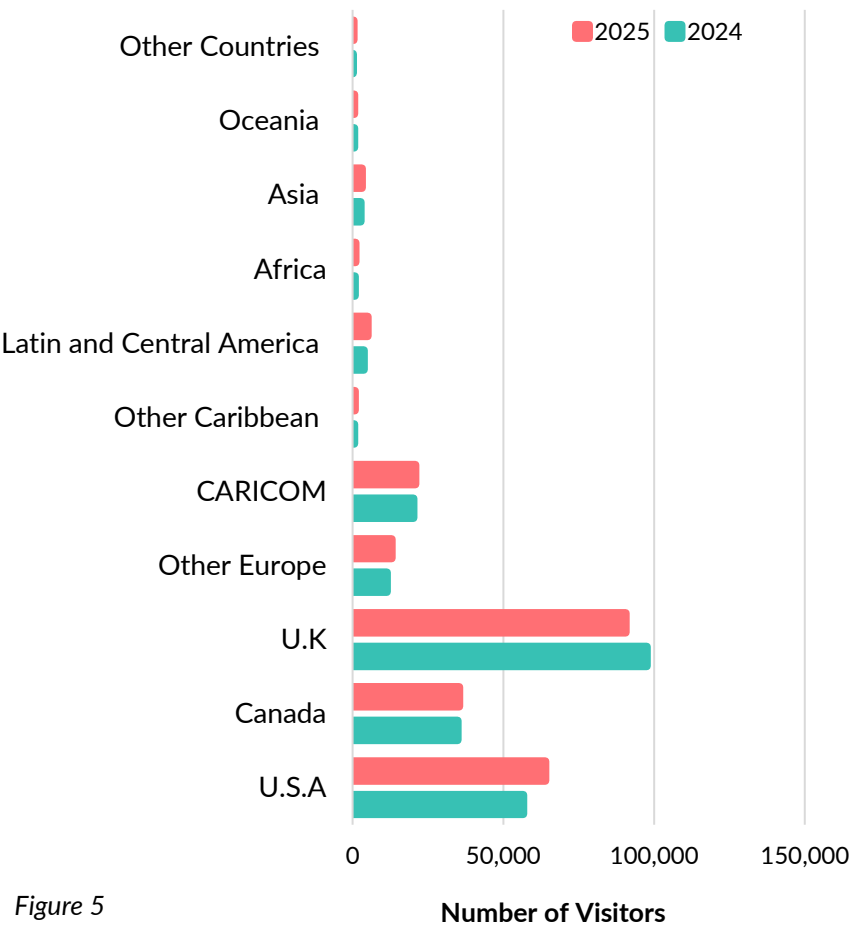

For the first quarter of the year, a total of **234,311** stay-over arrivals were recorded (▼).

The cruise arrival passengers were up to **494,950** (▲) from **225** cruise calls (▼).

Barbados welcomed the greatest number of visitors - **90,546** from the UK. However, this figure declined by 7,022 (▼) persons in comparison to 2024.

Stay-over arrivals from U.S.A were reported at **63,953** (▲).

CARICOM tourist arrivals totalled **20,809** (▼).

3,095 persons (▲) from Asia graced our beautiful shores.

Year to Date Arrivals By Cruise Ship

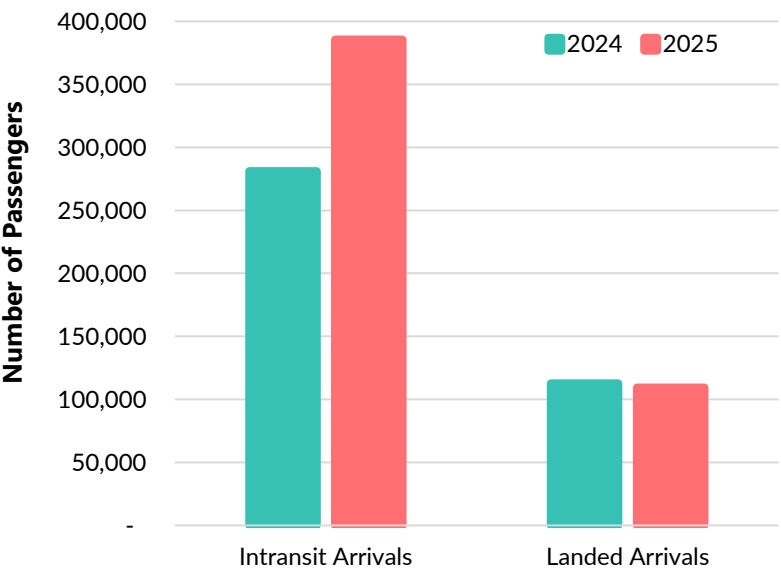

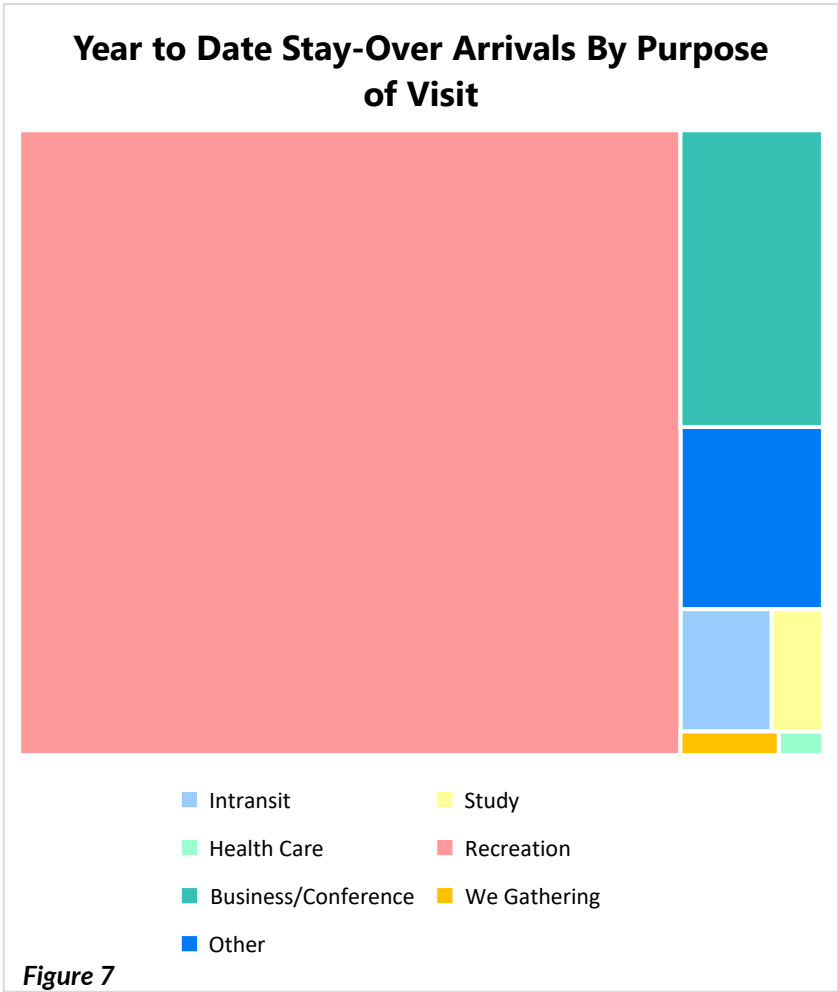
CRUISE ARRIVALS

In the first quarter of 2025, the total number of passengers that landed were **109,482** (▼).

Intransit cruise passengers increased to **385,468** from **281,172** in 2024 (▲).

Cruise calls were **225**, this showed a decrease of 1 (▼).

OTHER HIGHLIGHTS: YEAR TO DATE



181,446 of the total **220,746** visitors for January to March 2025 came for recreational purposes (▼).

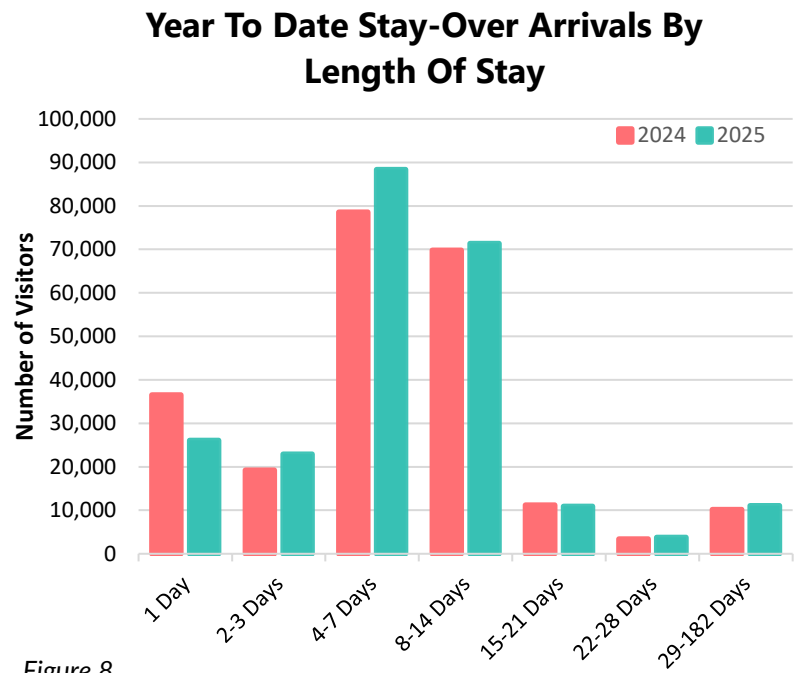
For the same period, the average number of days spent was approximately **12.06**, a **2.14** increase from last year (▲).

Educational visits increased to **2,882** (▲).

Other purposes of visit expanded to **11,347** (▲).

Visits for medical attention rose to **461** slightly from **425** in 2024 (▲).

Visits for honeymoon/getting married, rose from **3,166** to **3,196** (▲).



LENGTH OF STAY

Stay overs for 4-7 days surpassed all the categories with **88,327**(▲) visitors, followed by length of stay for 15-21 days which had **10,916** (▼), 29-182 days boasted **11,028** visitors (▲).

Average length of stay was **12.07** days (▲).

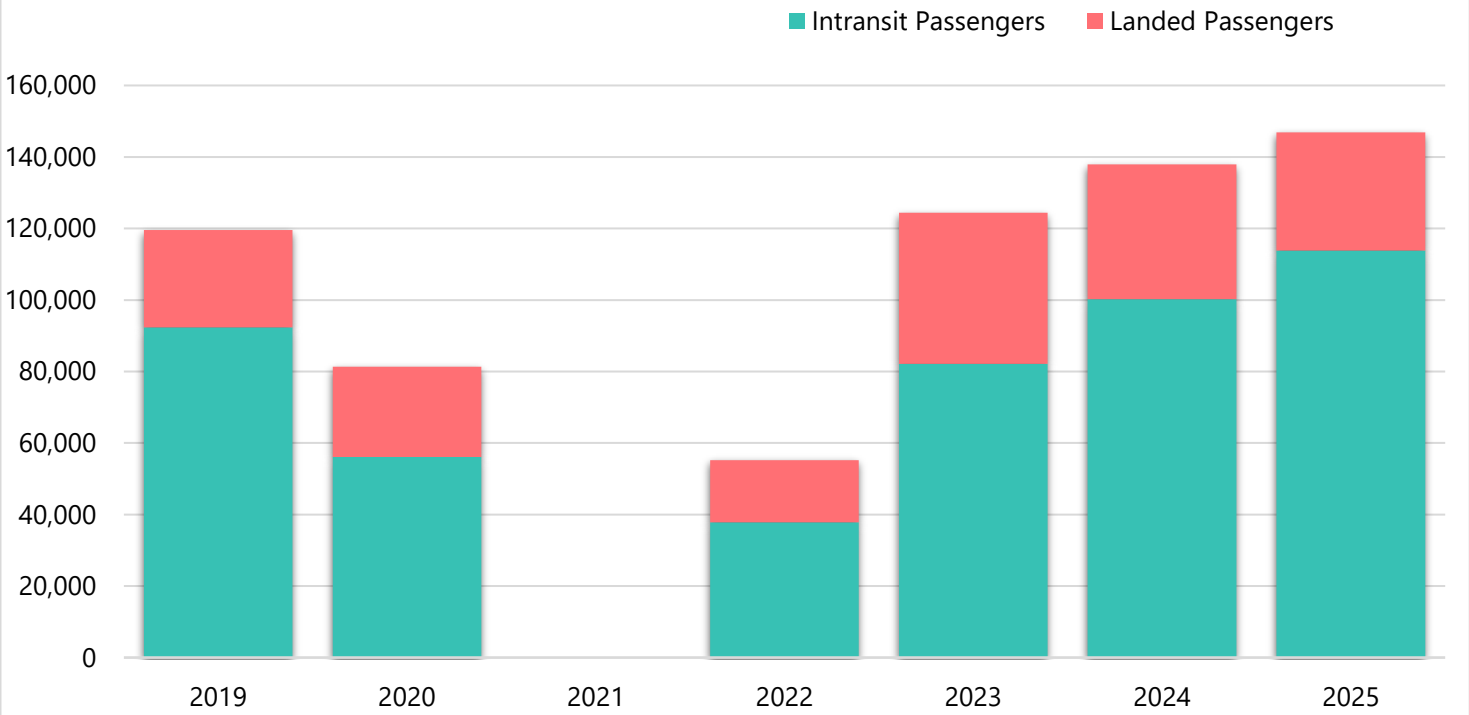

March 2019-2025**

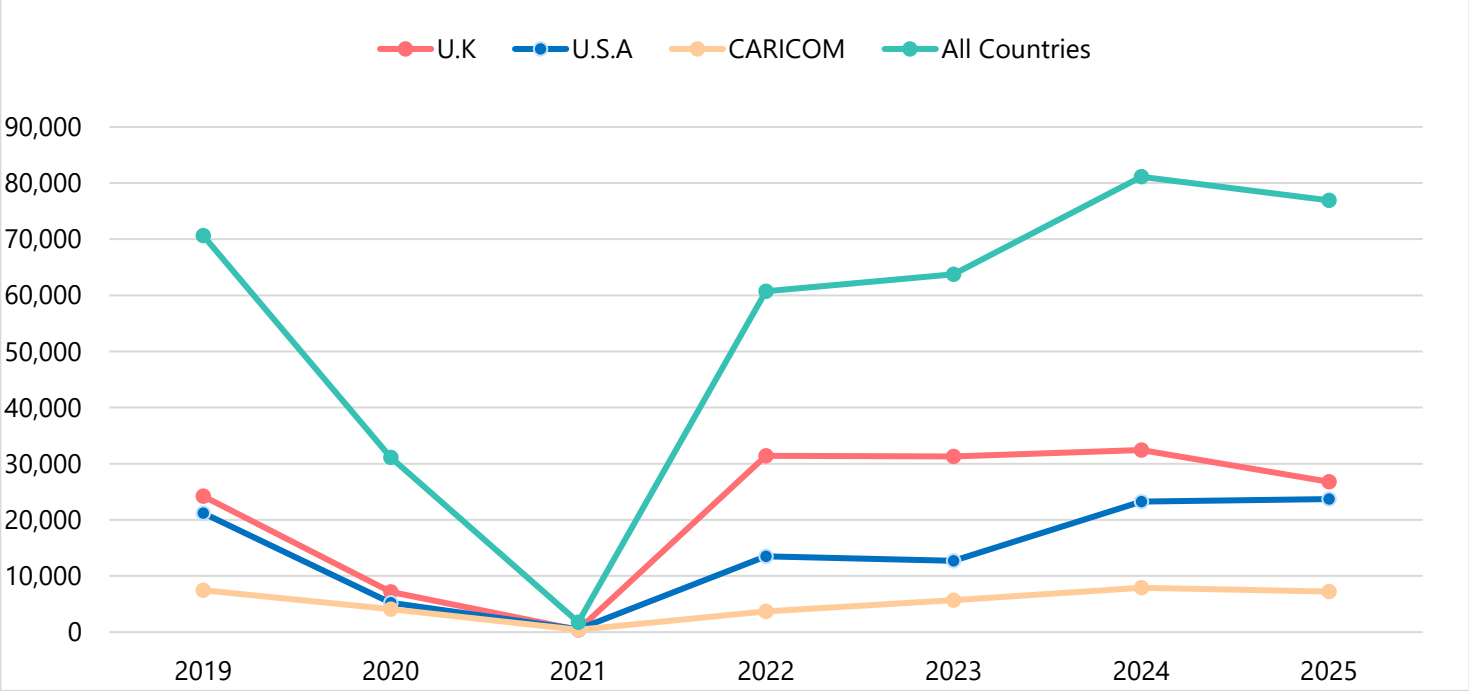

January-March 2019-2025**

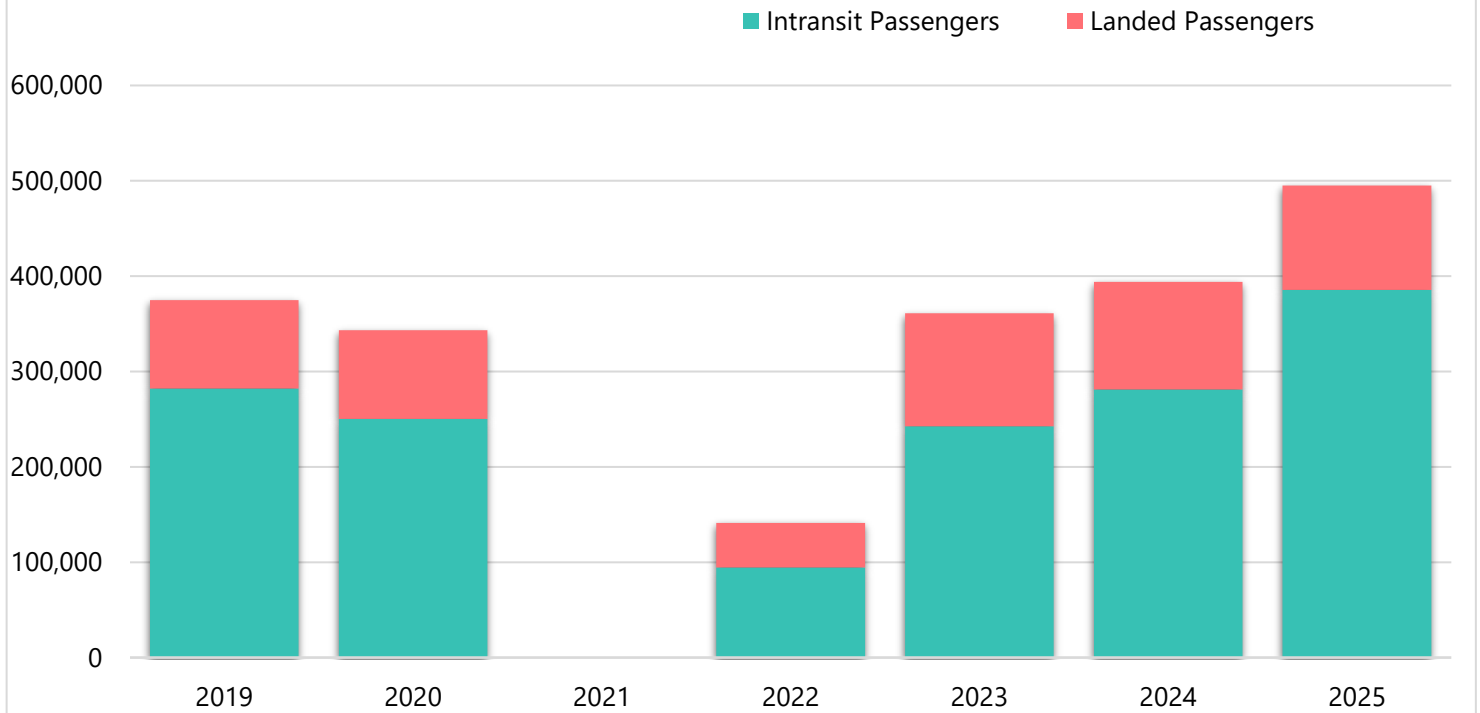

January - March 2019-2025**

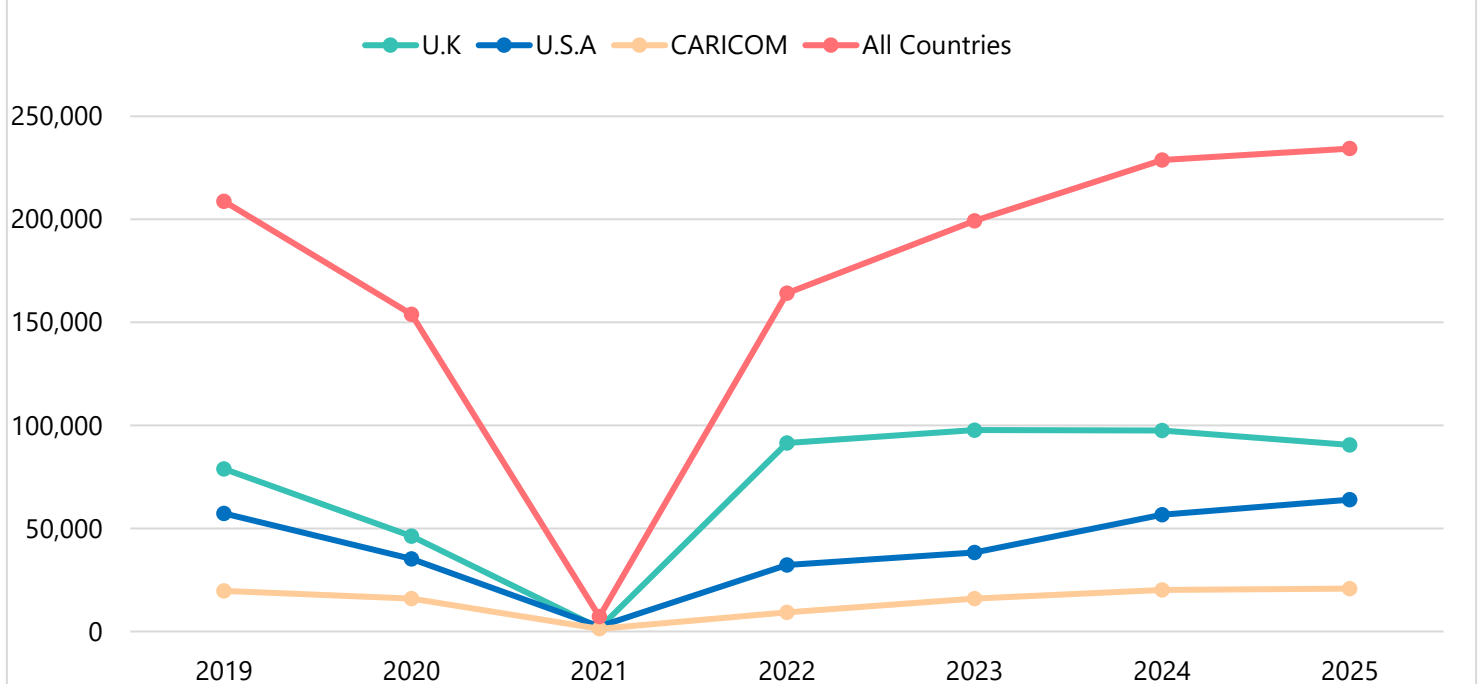
