Stay-Over Arrivals by Country of Residence

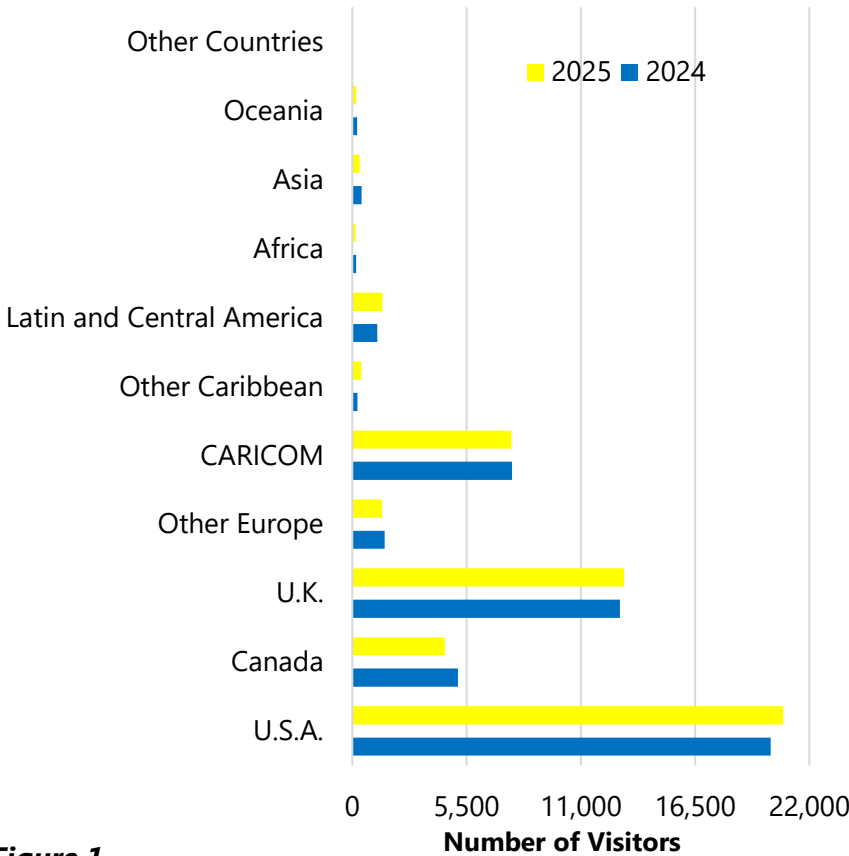

In May 2025, **49,961** stay-over visitors were recorded, this is a slight increase compared to May 2024 when there were **49,682** visitors to our shores. (▲)

The highest number of visitors, **20,736**, arrived from the USA, representing an increase of 593 compared to the same month in the previous year. (▲)

Visitors from United Kingdom were **13,084** (▲), whilst those coming from Caricom countries were **7,663** (▼).

Africa, Asia and Latin and Central America registered **154** (▼), **349** (▼) and **1,443** (▲) respectively.

Arrivals by Cruise Ship

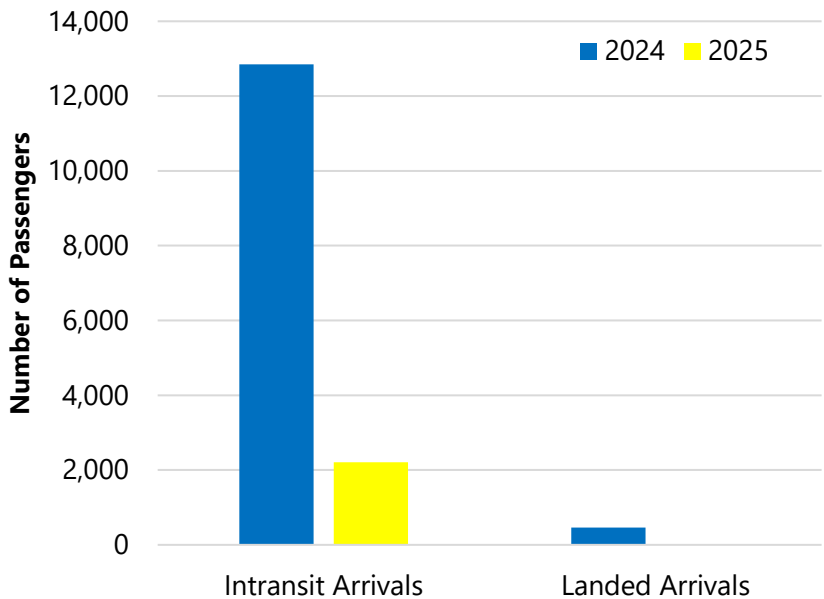

Stay-Over Arrivals by Purpose

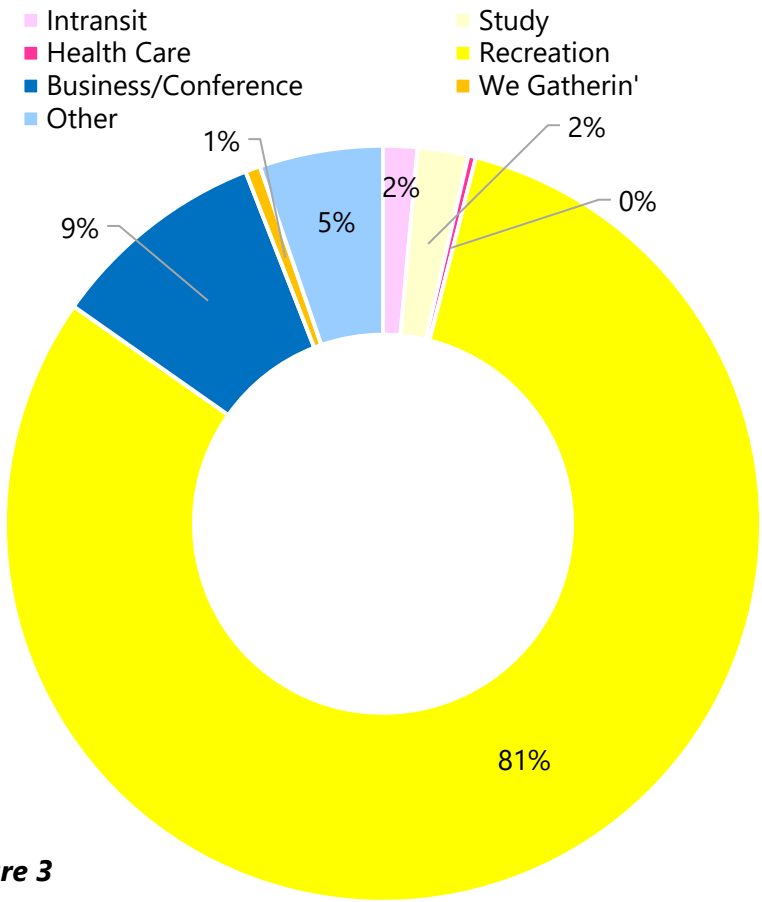

Of the **49,961** stay-over visitors for the period under review, **40,364** (▼) came for recreation, 1,081 (▲) for study, **2,575** (▲) for honeymoon/getting married and **164** (▲) for healthcare.

The number of stay-over visitors who came for holiday was **32,035** (▼), **4,007** (▲) were visiting friends, **4,661** (▼) and **2,638** (▲) arrived for business, conference or convention and other purposes, in that order.

A special highlight is given to the We Gatherin' 2025 activities, registering **321** persons.

Stay-Over Arrivals by Length of Stay

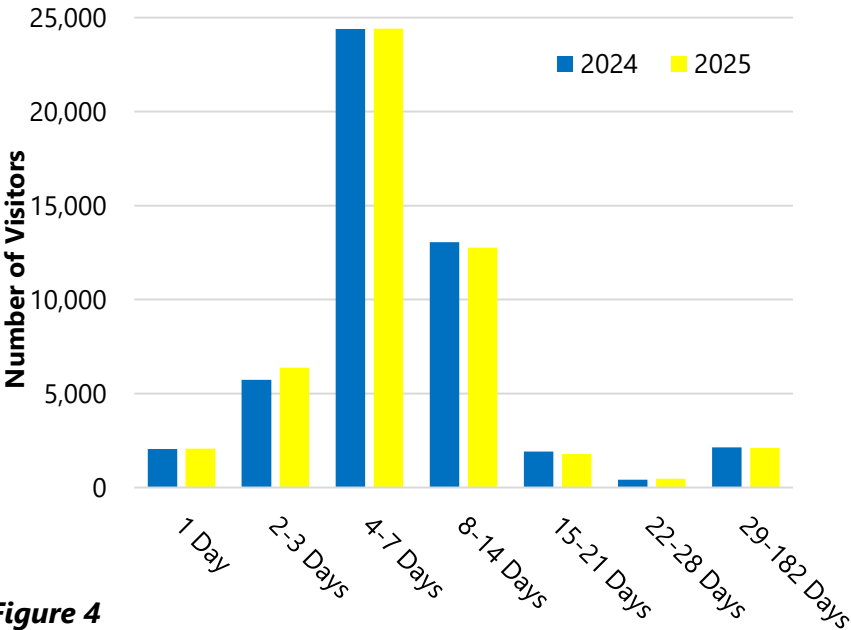

LENGTH OF STAY

The most popular stay-over period was the 4-7 days with **24,408** (▲) visitors. This was followed by the 8-14 days with **12,756** (▼). The least number of arrivals, **467** (▲), was recorded in the 22-28 days category.

Average length of stay was **10.02** (▼) days.

Year to Date Stay-Over Arrivals by Country of Residence

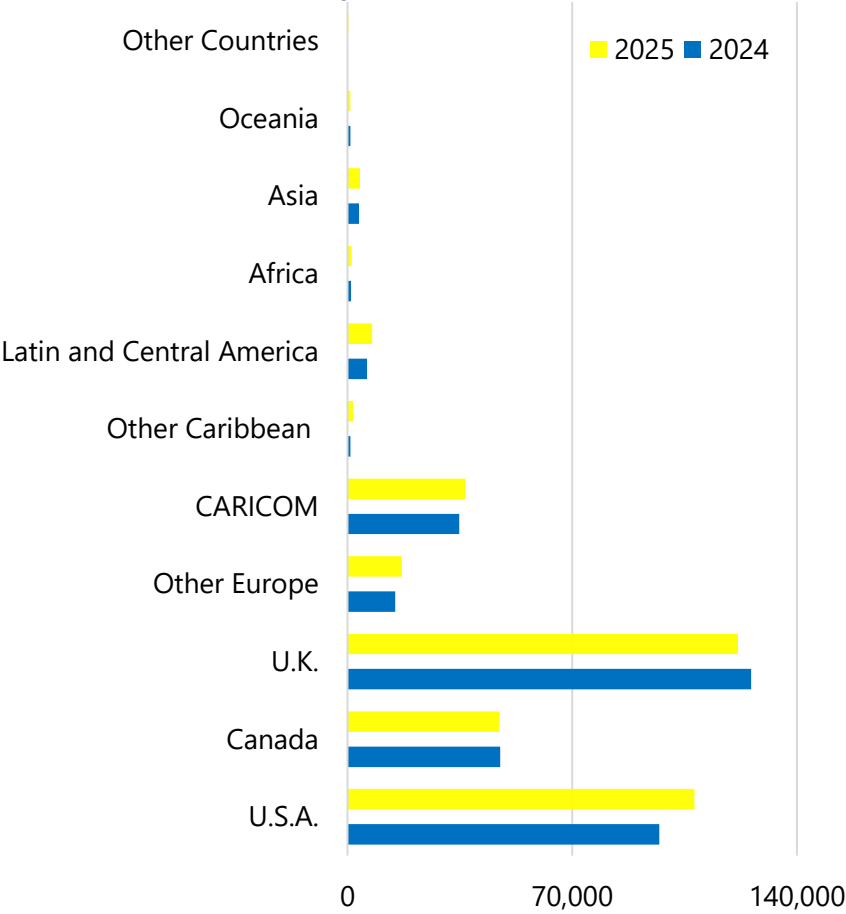

Year to Date Arrivals by Cruise Ship

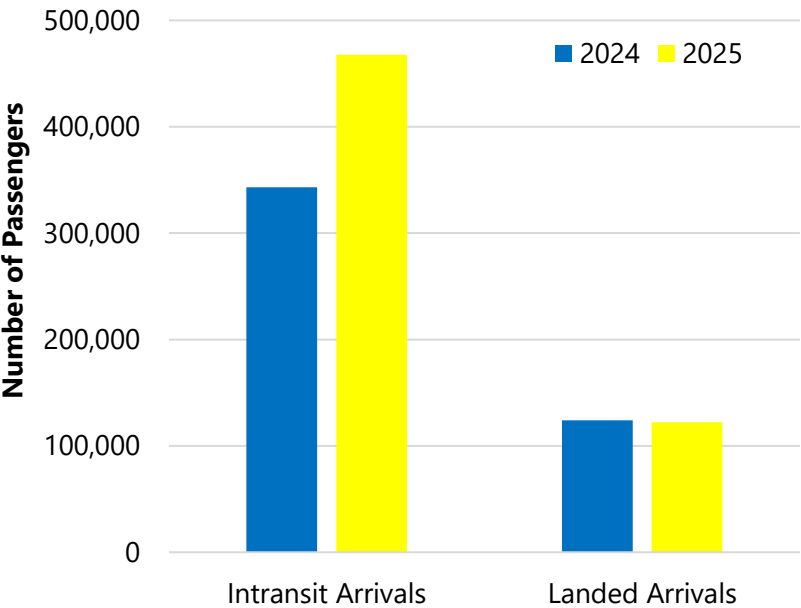

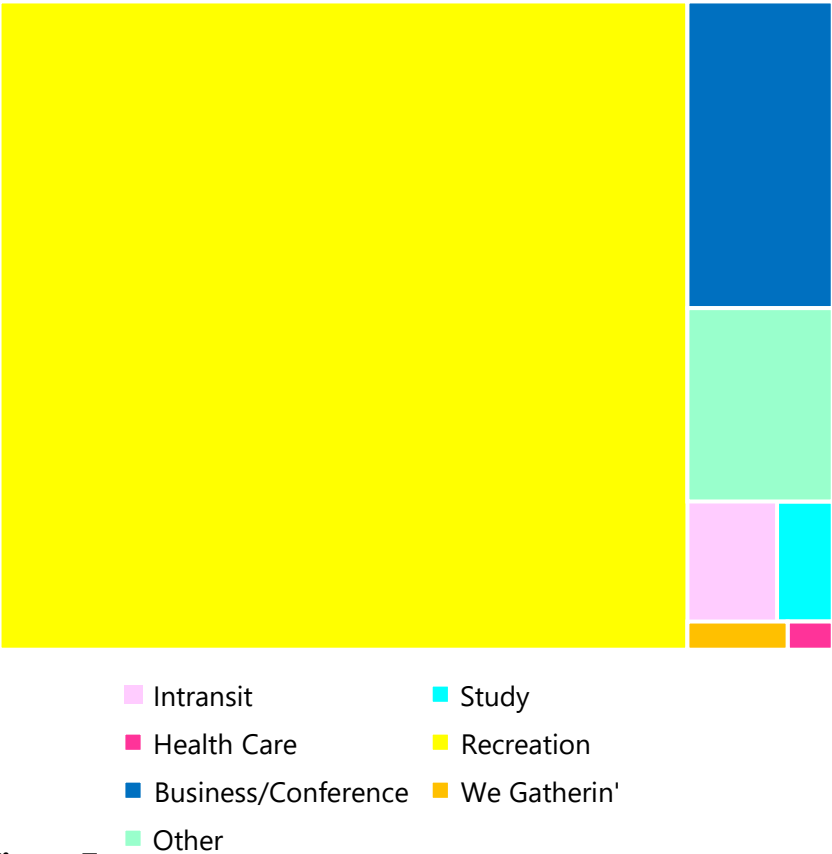
Landed passengers totalled **122,121** (▼).

The average number of days spent in Barbados among stay-over visitor arrivals was approximately **11.46** (▲) days over the review period.

Business/Conference visits numbered **28,600** (▲).

7,628 (▲) persons visited either to honeymoon or get married.

Study visits totalled **4,296** (▲).

We Gatherin' visits were noted at **1,822**.

Year to Date Stay-Over Arrivals by Length of Stay

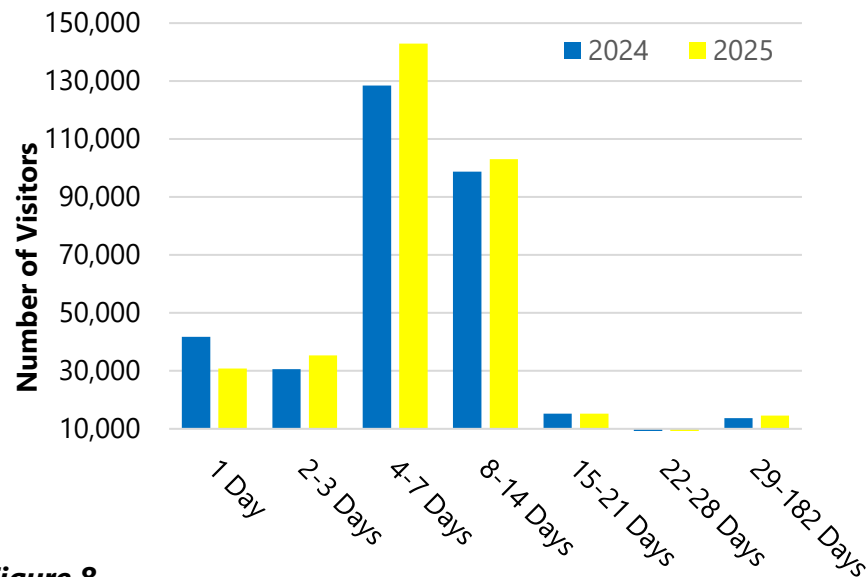

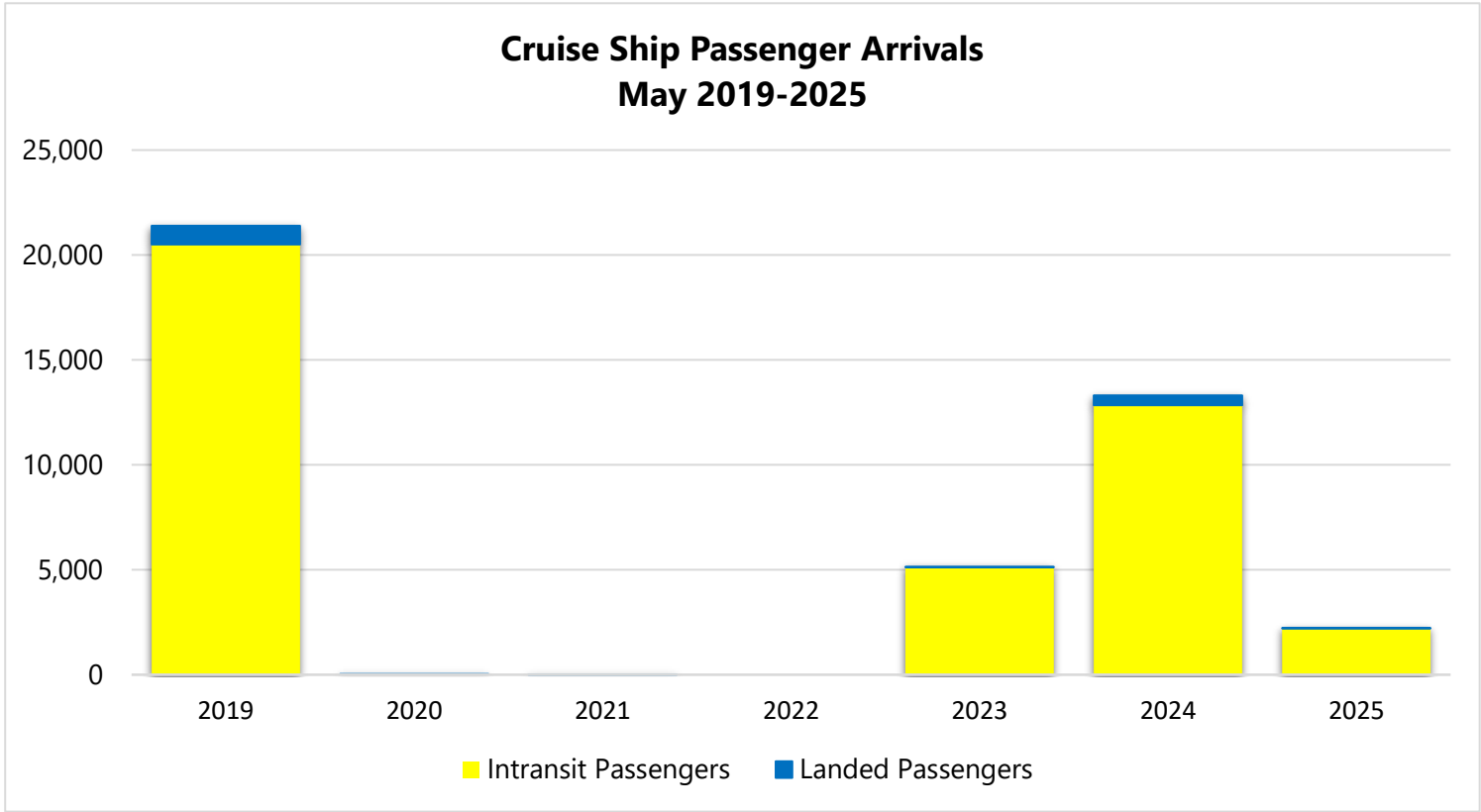

May 2019-2025**

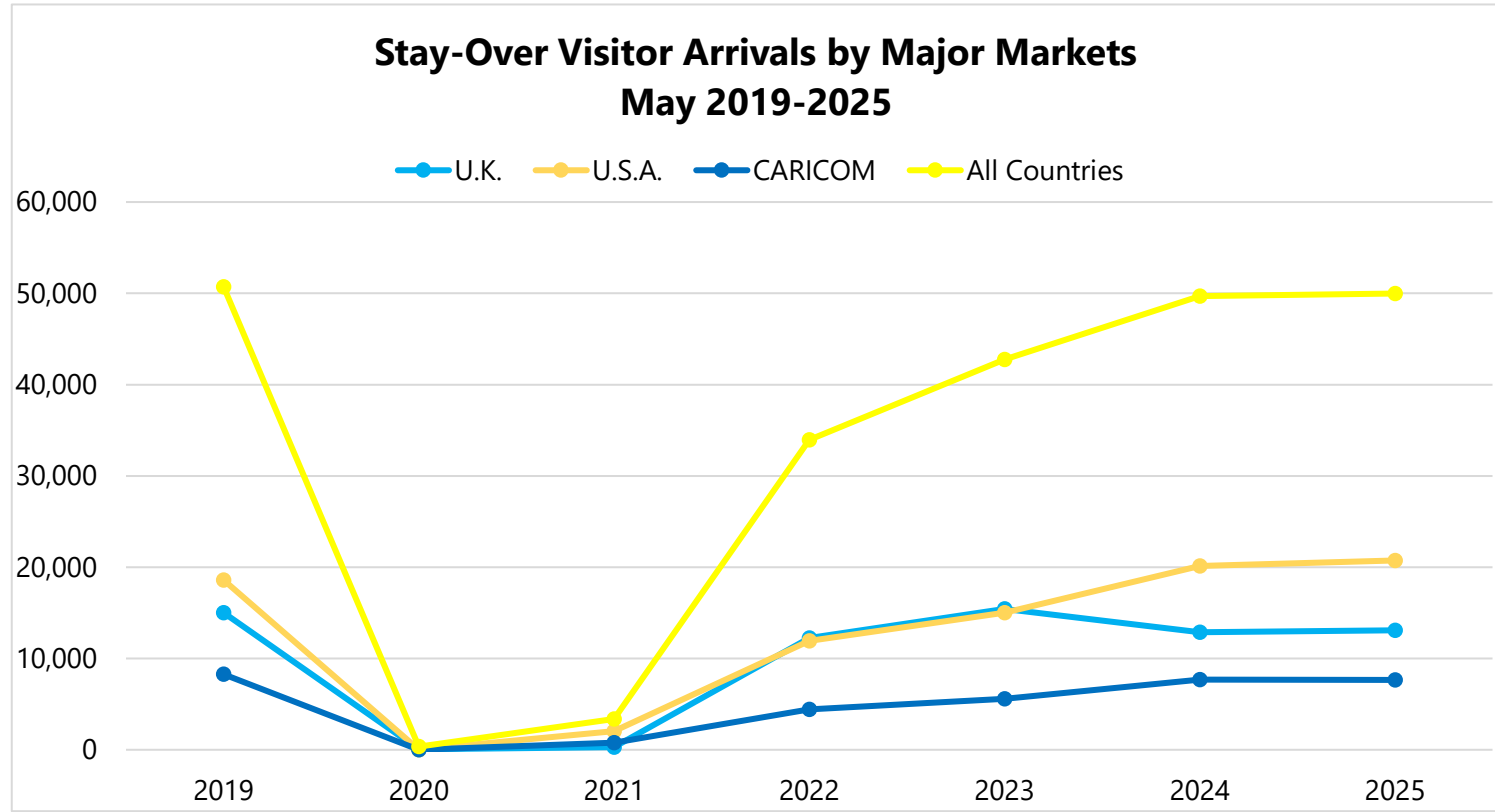

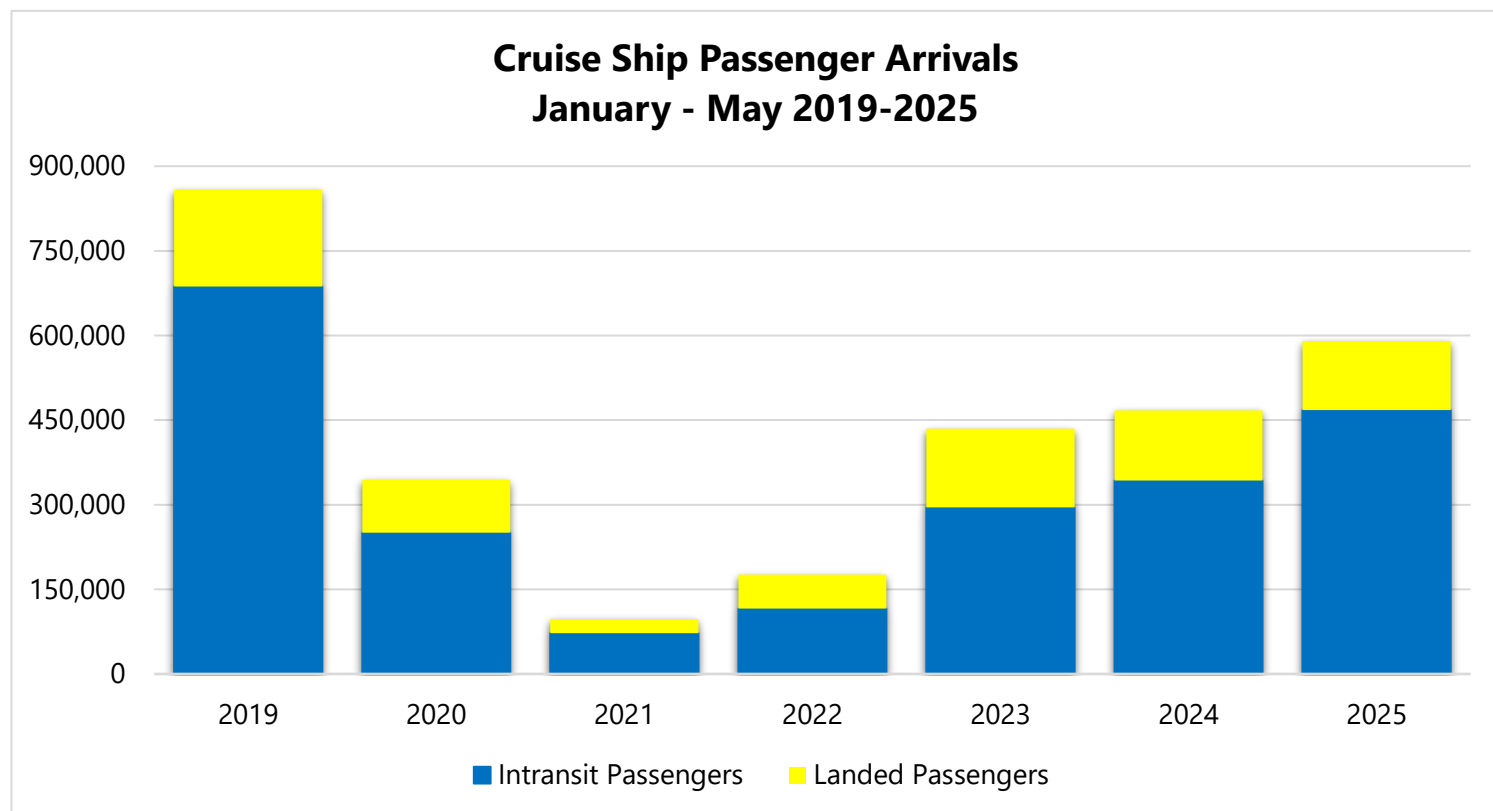

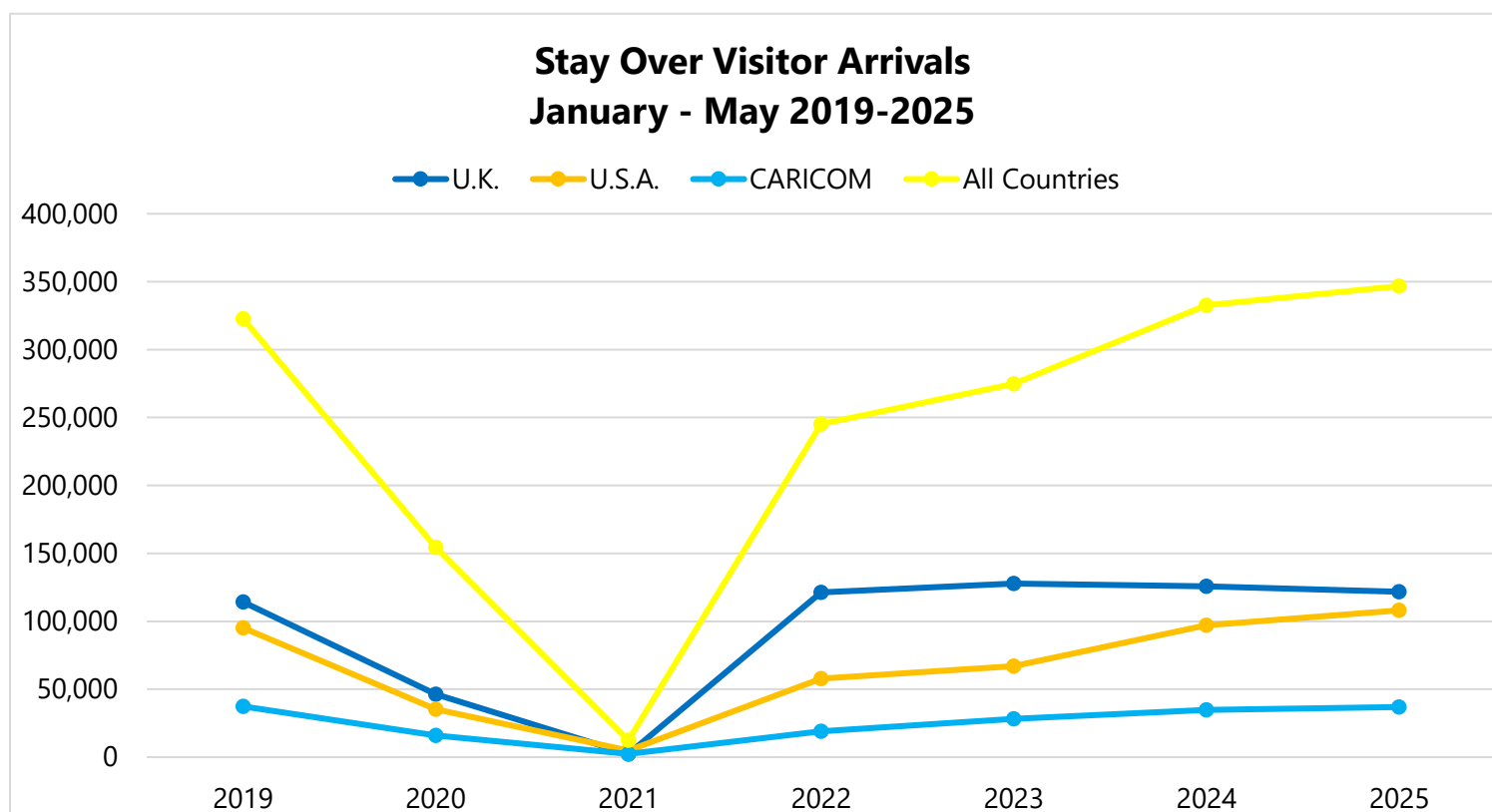
