Stay-Over Arrivals by Country of Residence

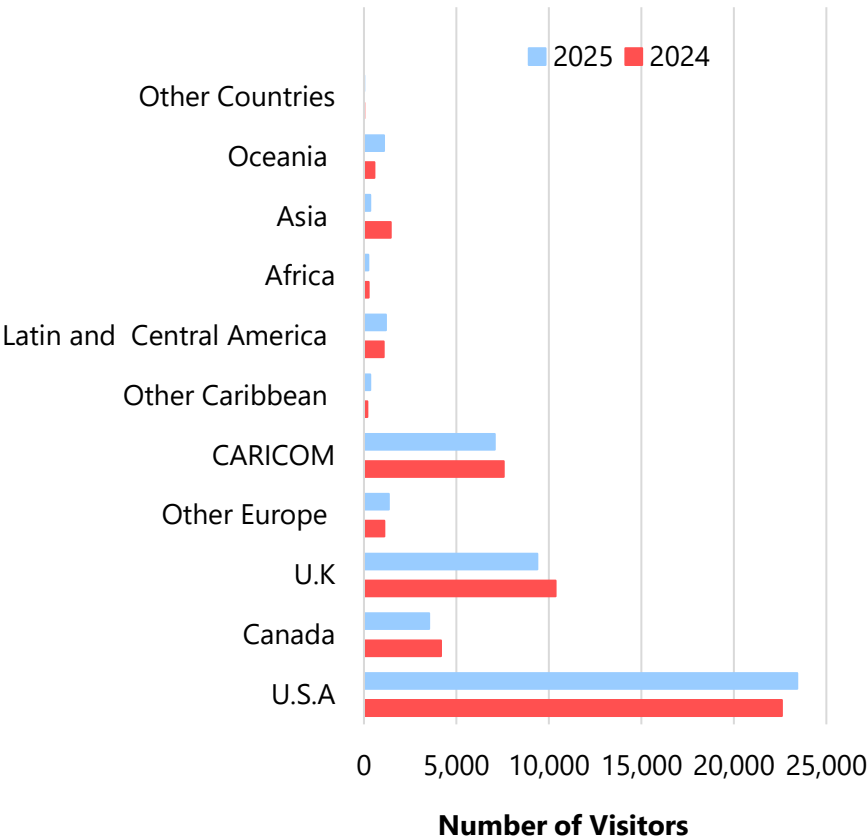

Arrivals By Cruise Ship

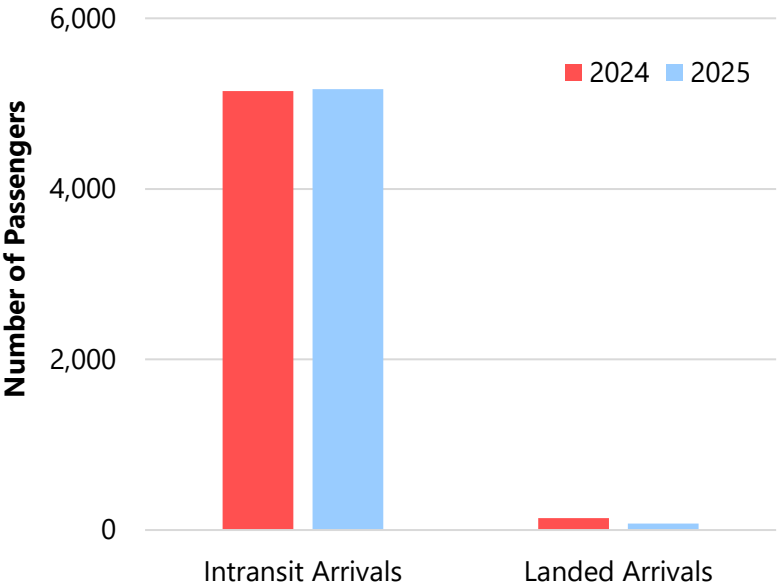

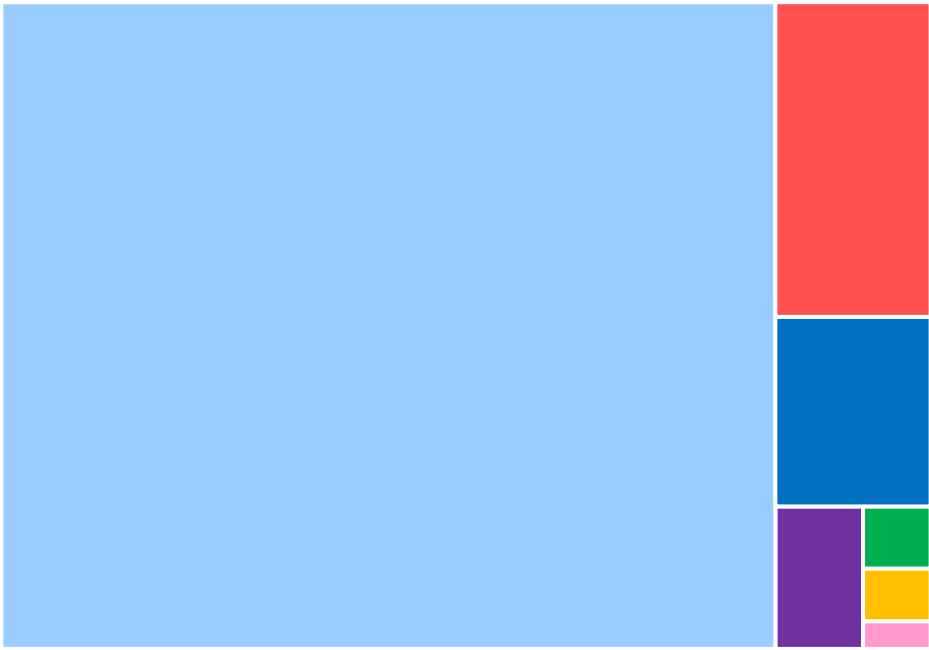

Stay-Over Arrivals By Length Of Stay

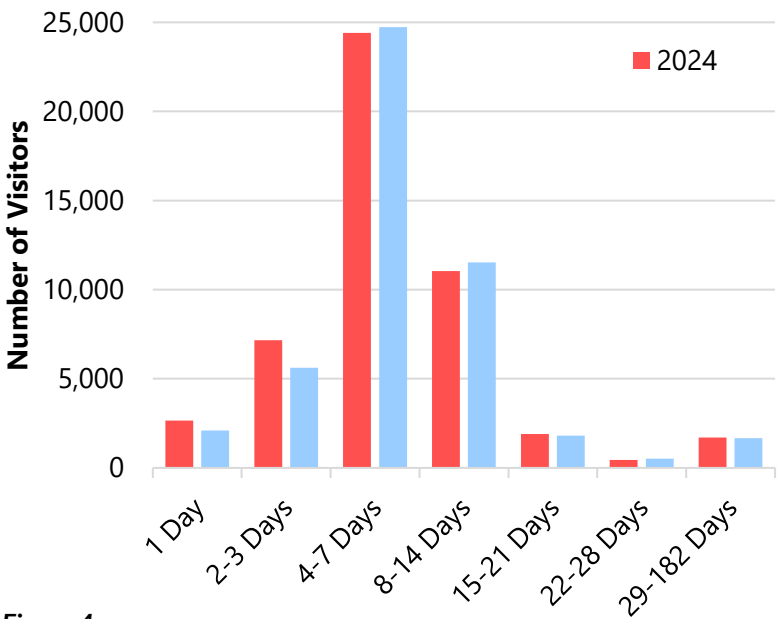

Year To Date Stay-Over Arrivals by Country of Residence

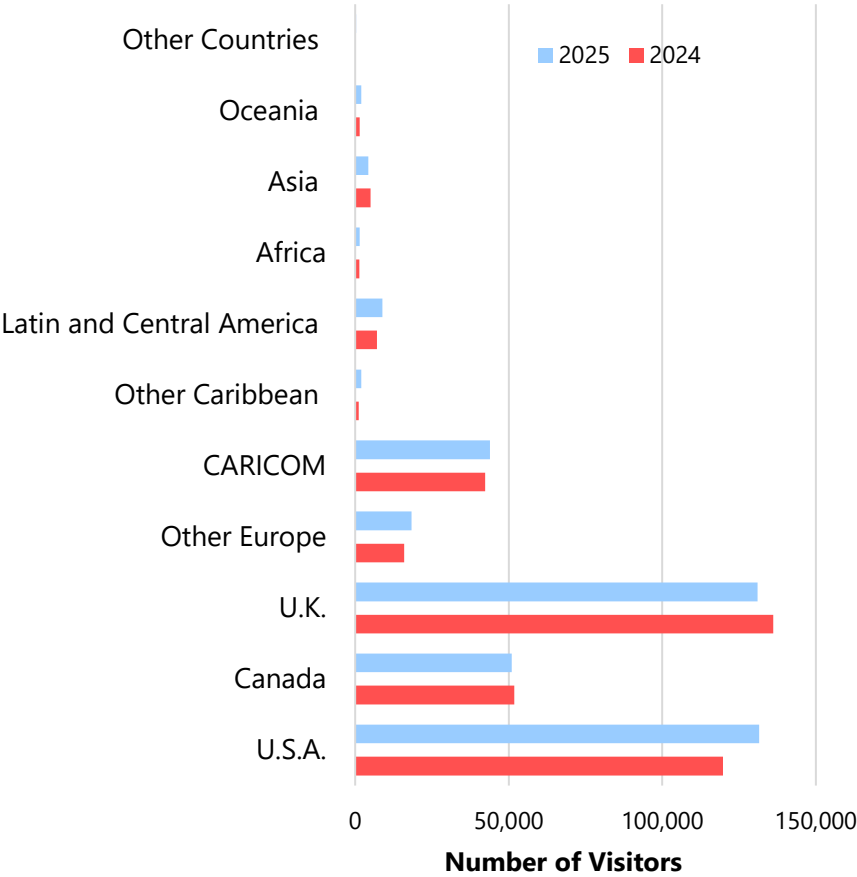

Year to Date Arrivals By Cruise Ship

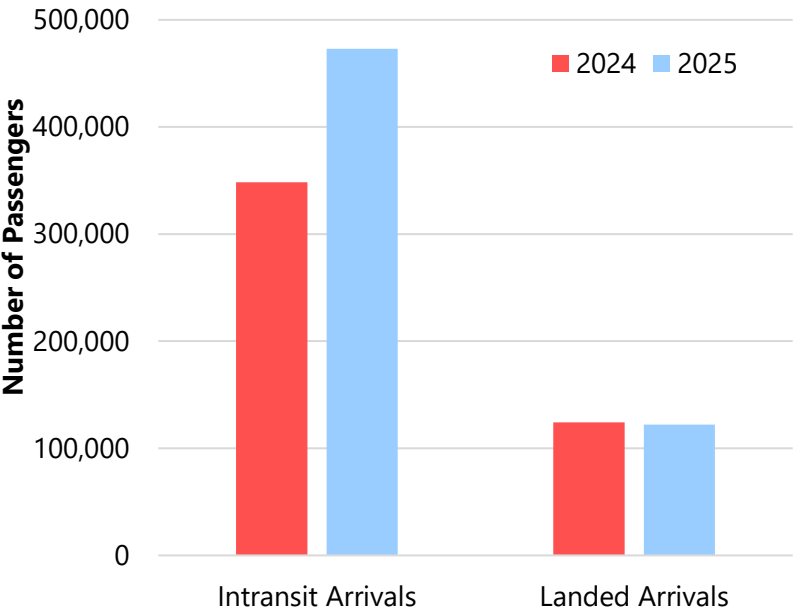

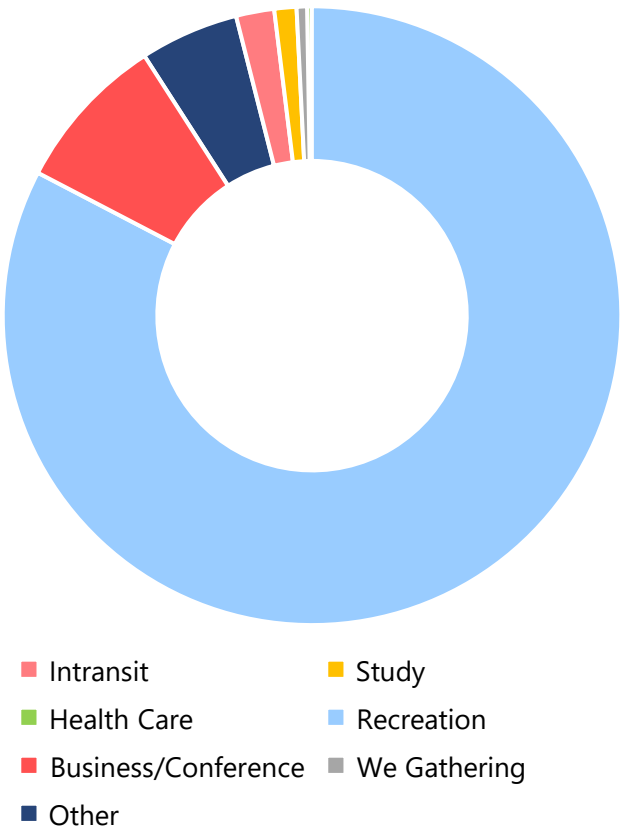
Landed passengers were registered as **122,198**. (▼)

Year To Date Stay-Over Arrivals By Length Of Stay

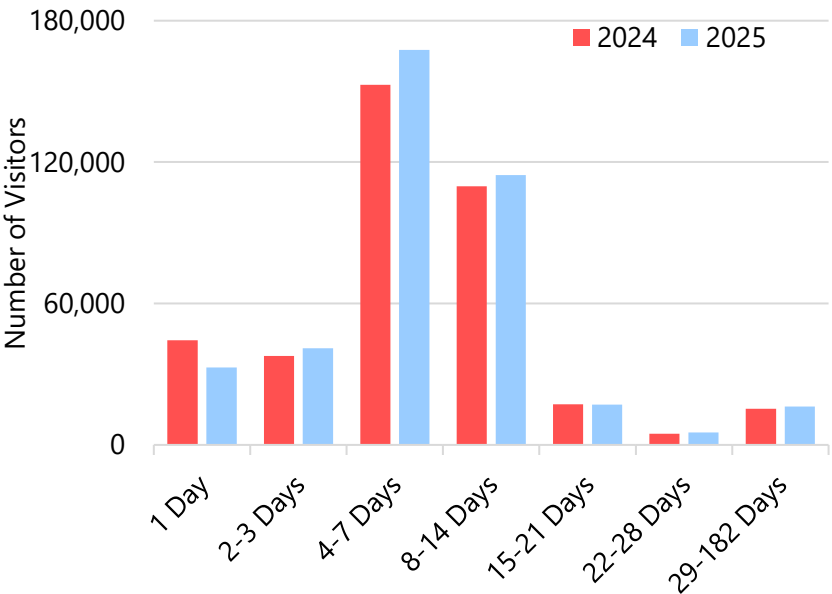

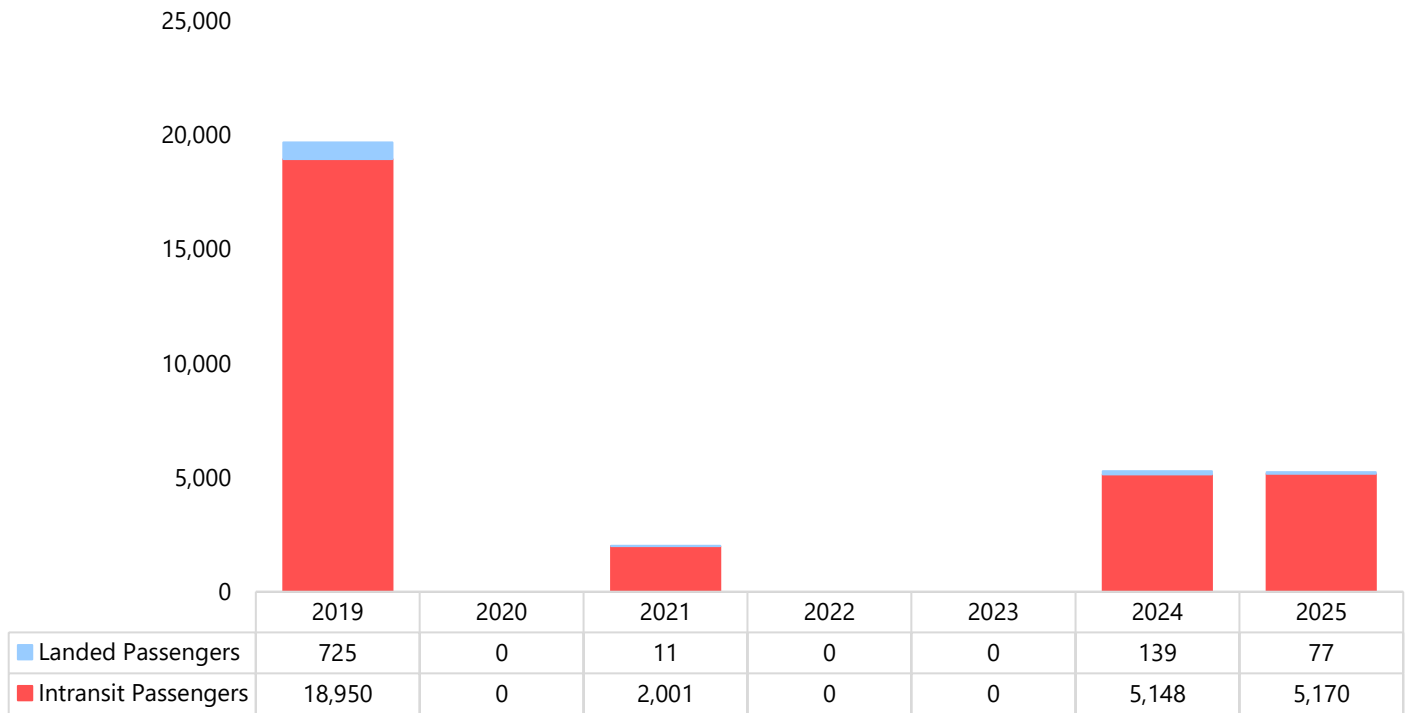

June 2019-2025**

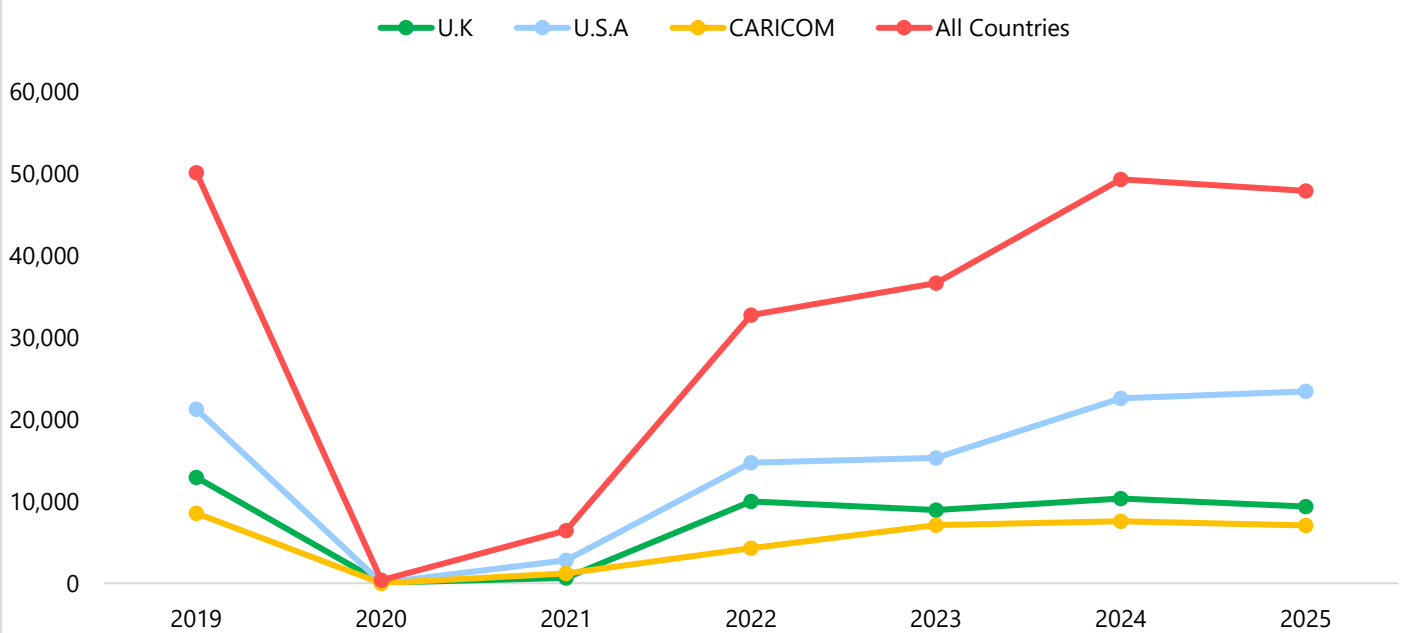

January - June 2019-2025**

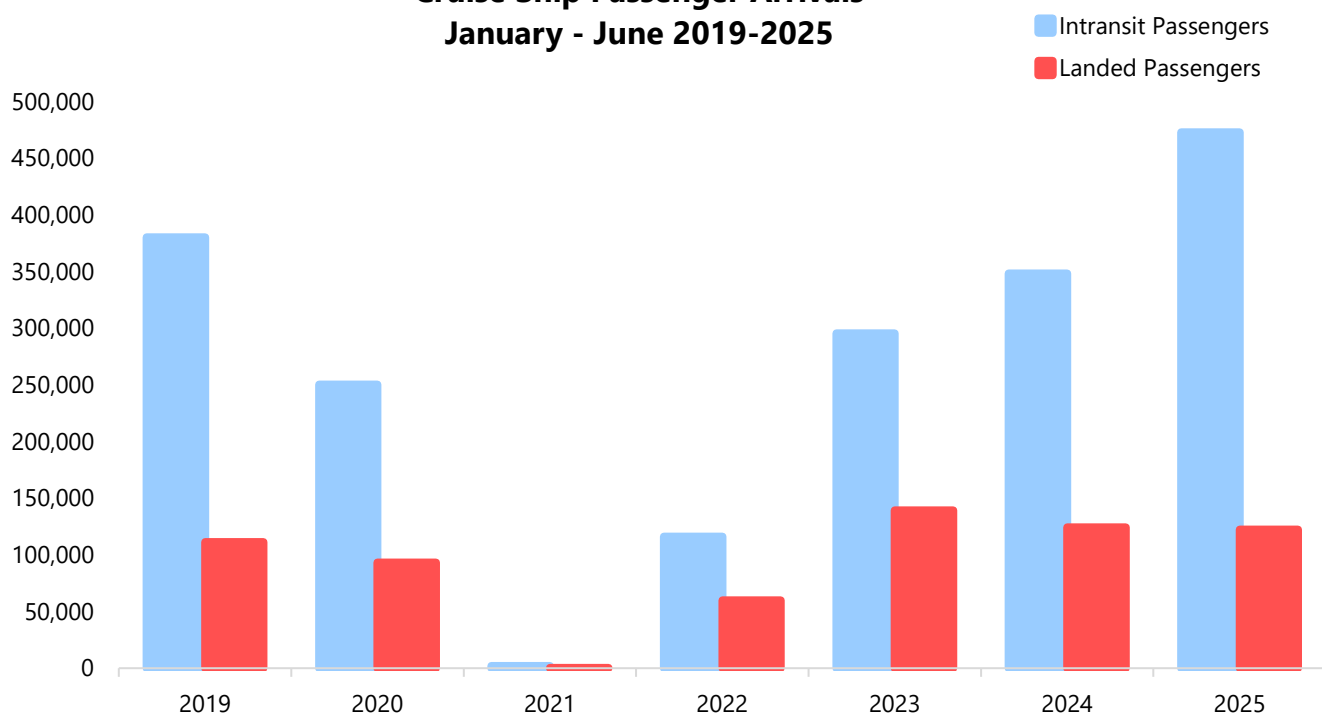

January - June 2019-2025**

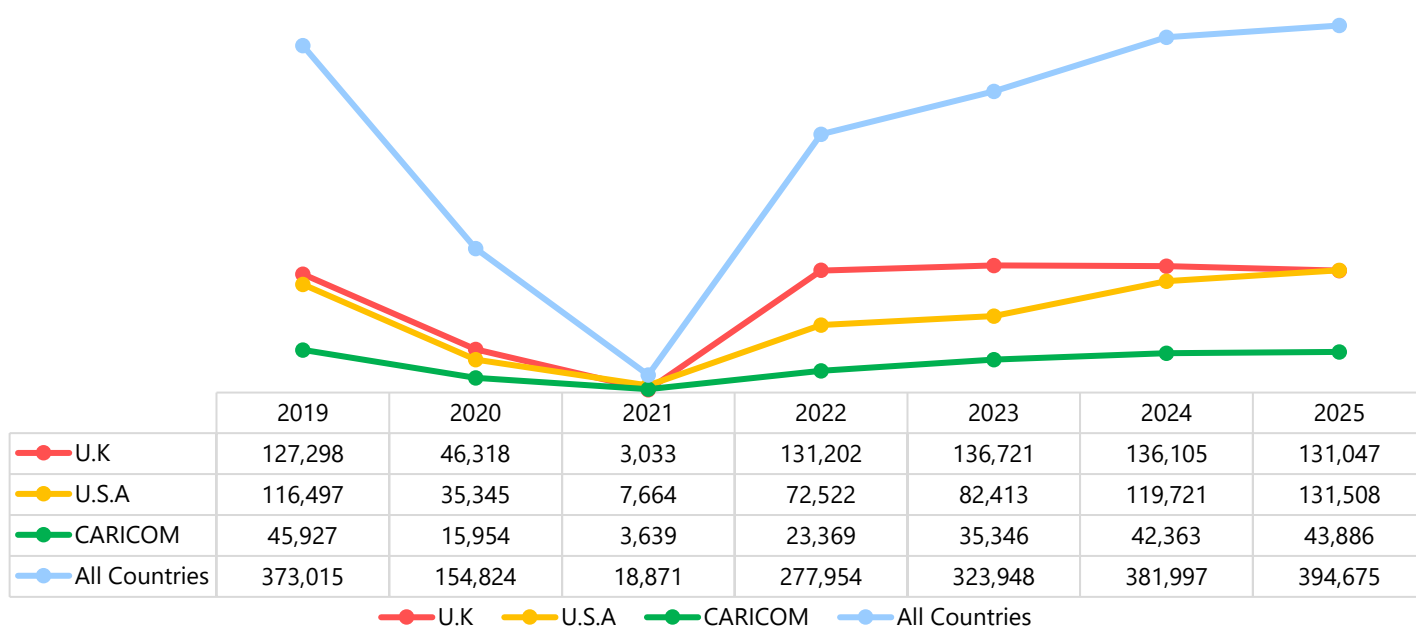
