Stay-Over Arrivals by Country of Residence

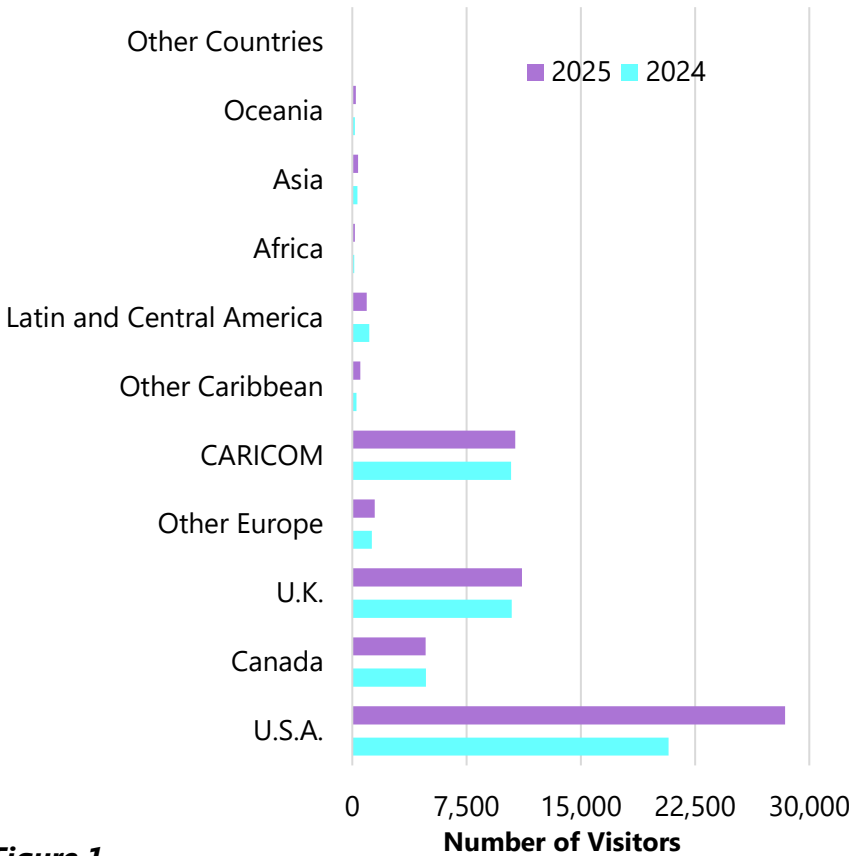

In July 2025, **58,845** stay-over visitors were recorded, this is a slight increase compared to July 2024 when there were **49,801** visitors to our shores. (▲)

The highest number of visitors, **28,415**, arrived from the USA, representing an increase of 7,660 compared to the same month in the previous year. (▲)

Visitors from United Kingdom were **11,147** (▲), whilst those coming from Caricom countries were **10,689** (▲).

Africa, Asia and Latin and Central America registered **173** (▲), **381** (▲) and **956** (▼) respectively.

Arrivals by Cruise Ship

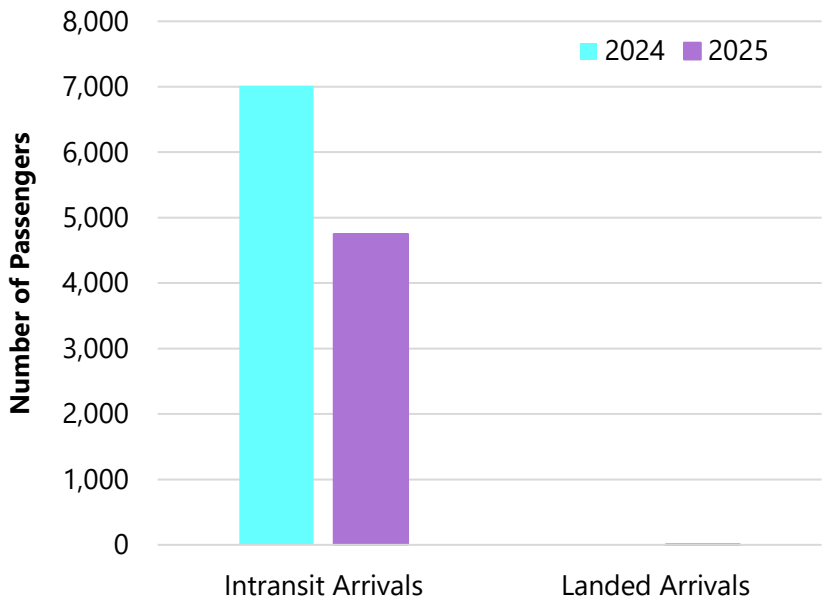

Stay-Over Arrivals by Purpose

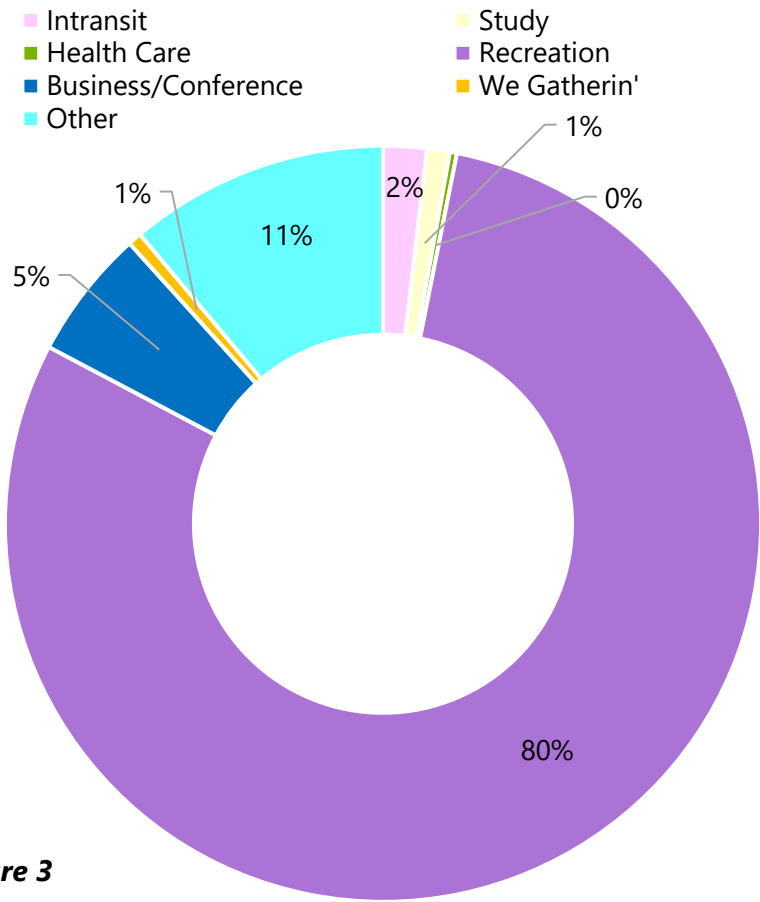

Of the **58,845** stay-over visitors for the period under review, **46,843** (▲) came for recreation, **573** (▲) for study, **1,557** (▼) for honeymoon/getting married and **176** (▲) for healthcare.

The number of stay-over visitors who came for holiday was **36,870** (▲), **7,108** (▲) were visiting friends, **3,270** (▼) and **6,542** (▲) arrived for business, conference or convention and other purposes, in that order.

A special highlight is given to the We Gatherin' 2025 activities, registering **343** persons.

Stay-Over Arrivals by Length of Stay

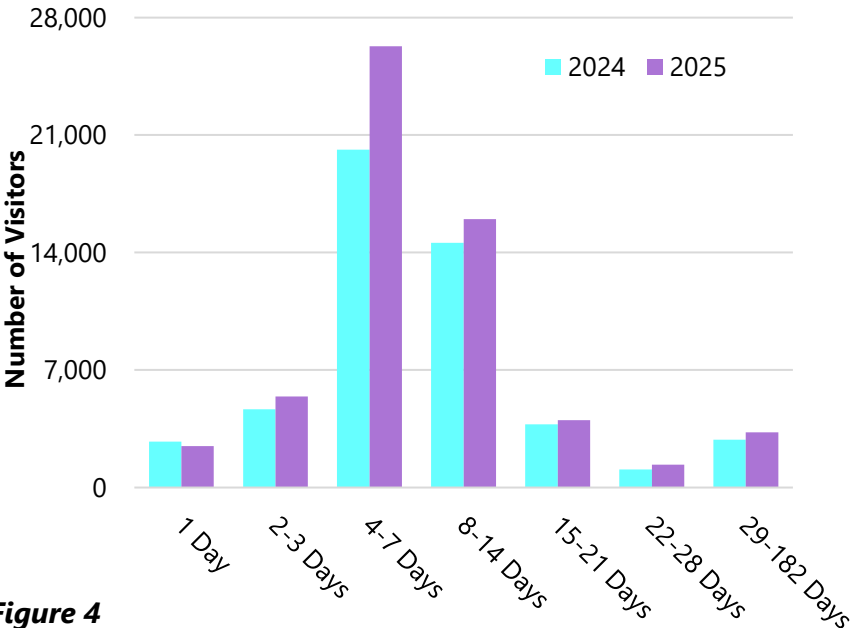

LENGTH OF STAY

The most popular stay-over period was the 4-7 days with **26,286** (▲) visitors. This was followed by the 8-14 days with **15,988** (▲). The least number of arrivals, **1,366** (▲), was recorded in the 22-28 days category.

Average length of stay was **10.31** (▼) days.

Year to Date Stay-Over Arrivals by Country of Residence

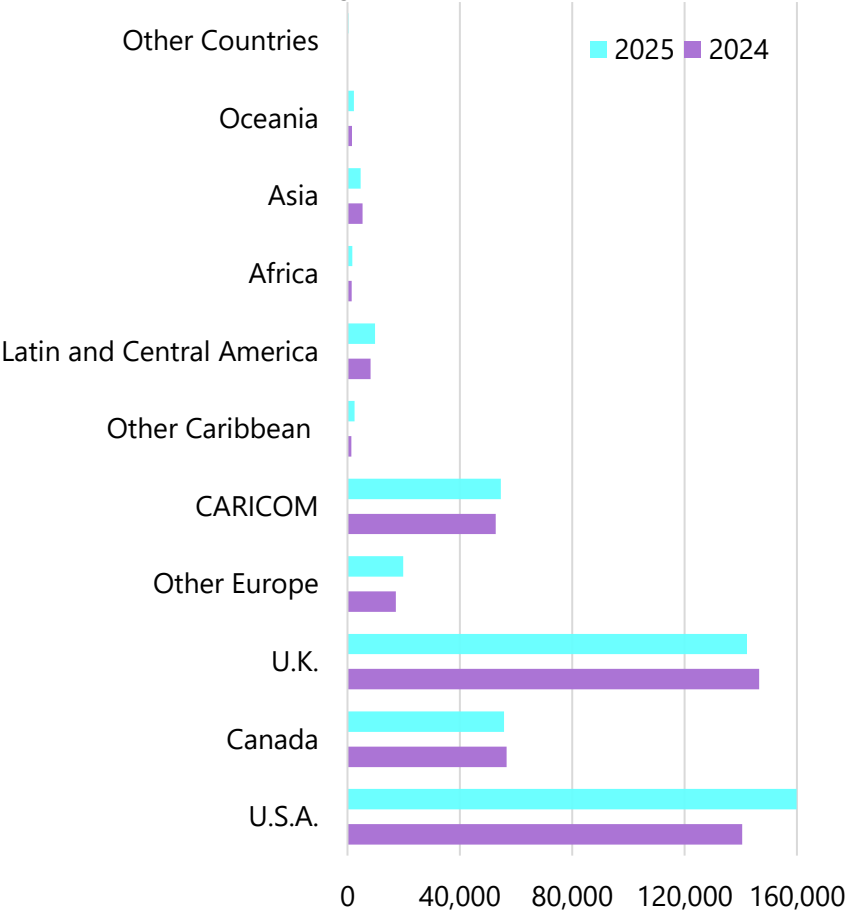

Year to Date Arrivals by Cruise Ship

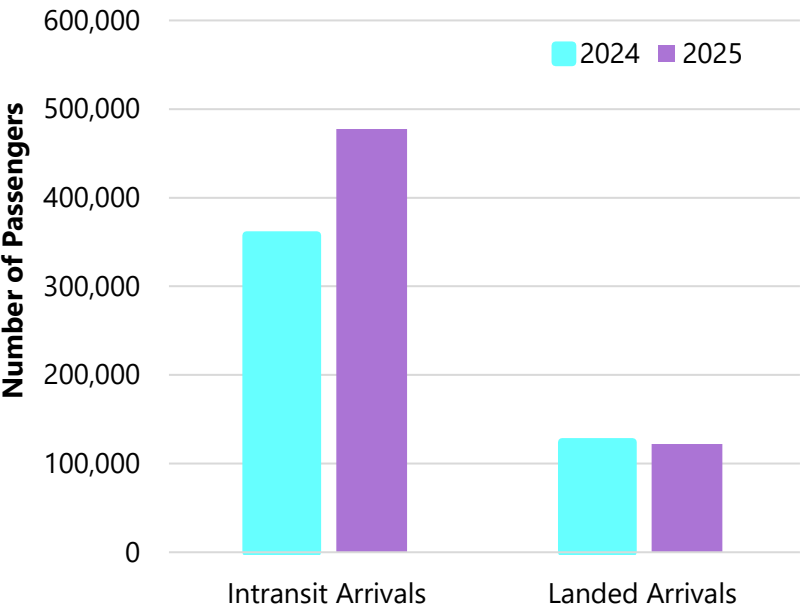

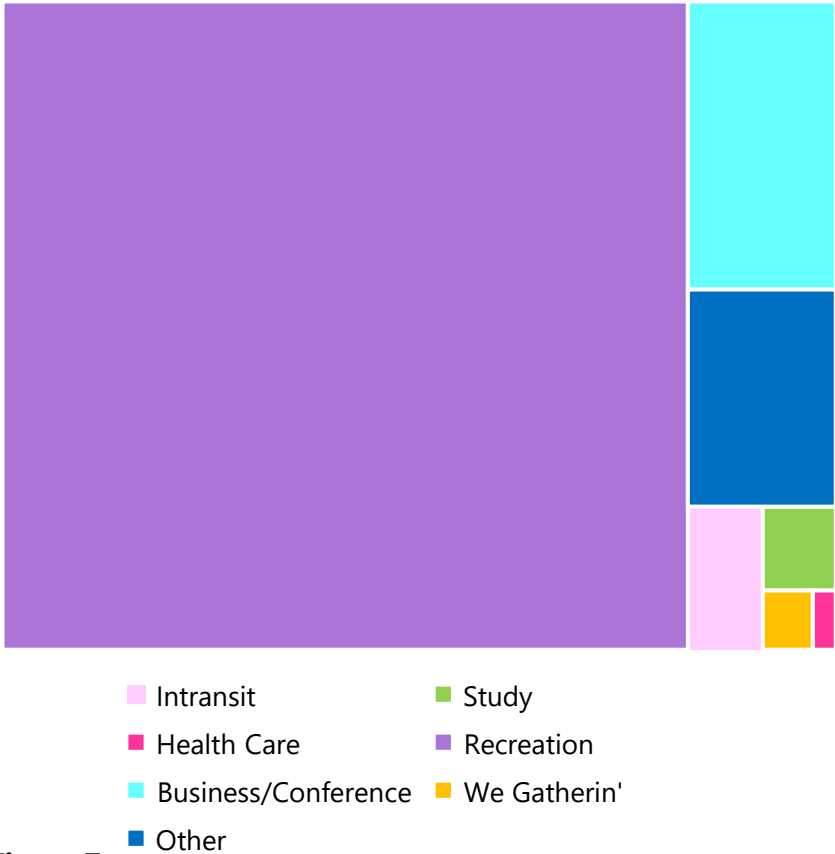
Landed passengers totalled **122,201** (▼).

Business/Conference visits numbered **35,770** (▲).

11,228 (▼) persons visited either to honeymoon or get married.

Study visits totalled **5,155** (▲).

We Gatherin' visits were noted at **2,500**.

Year to Date Stay-Over Arrivals by Length of Stay

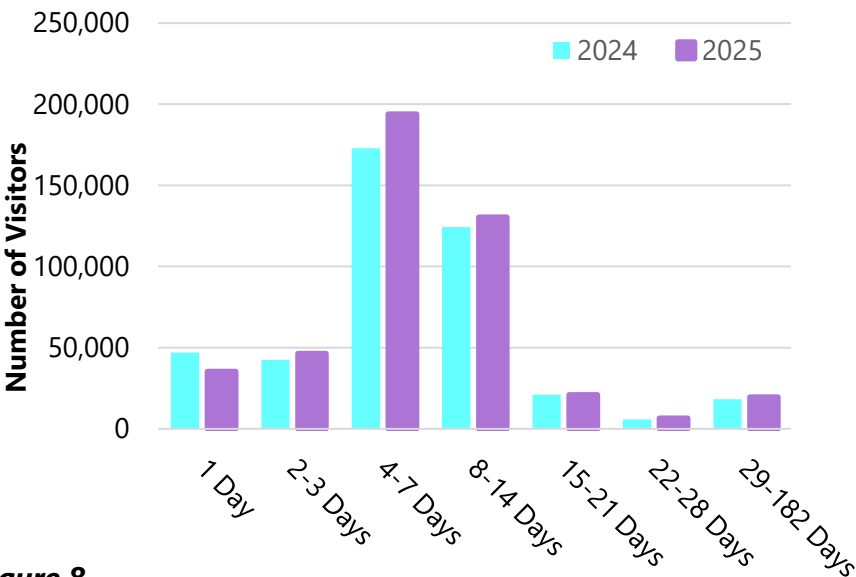

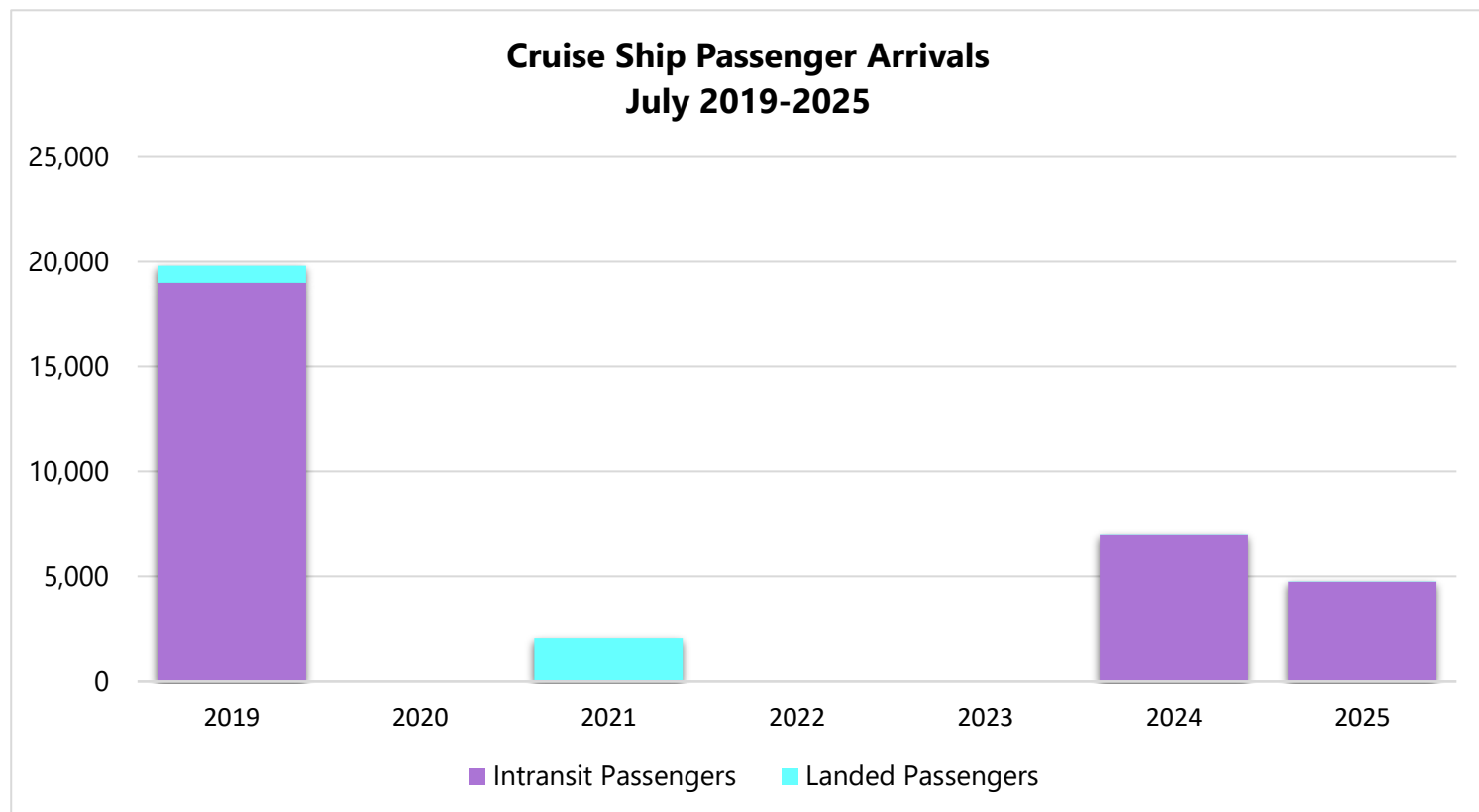

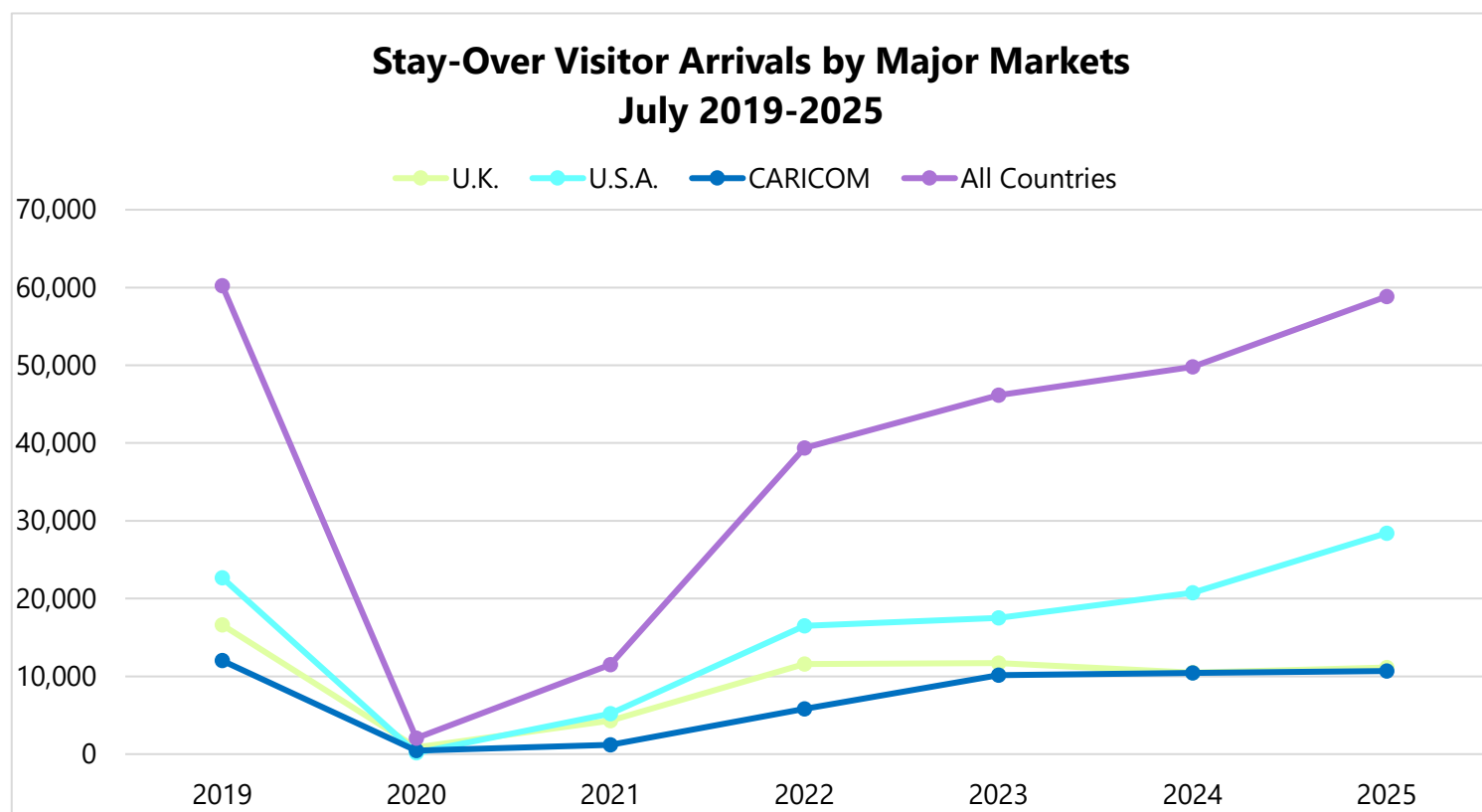

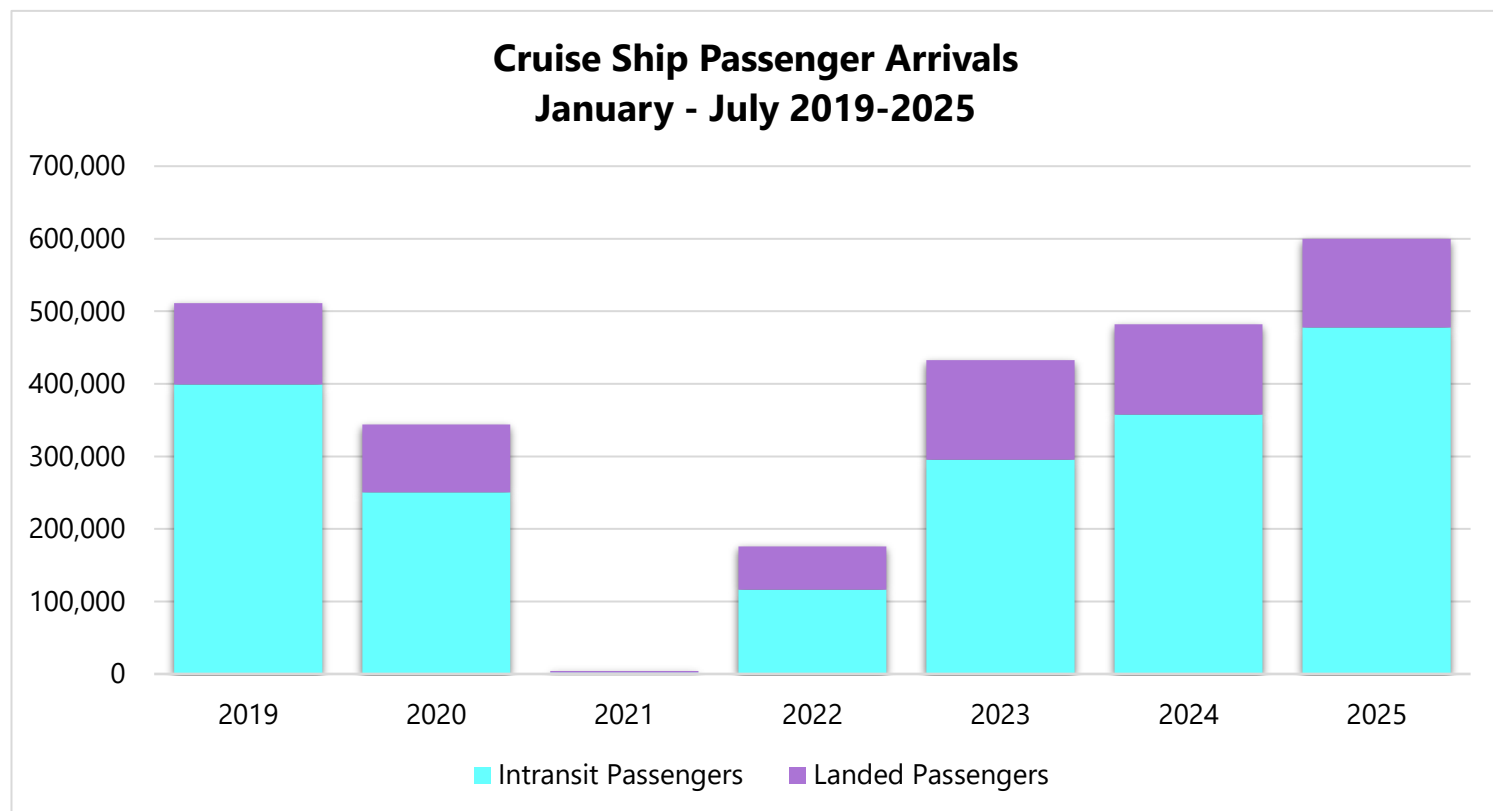

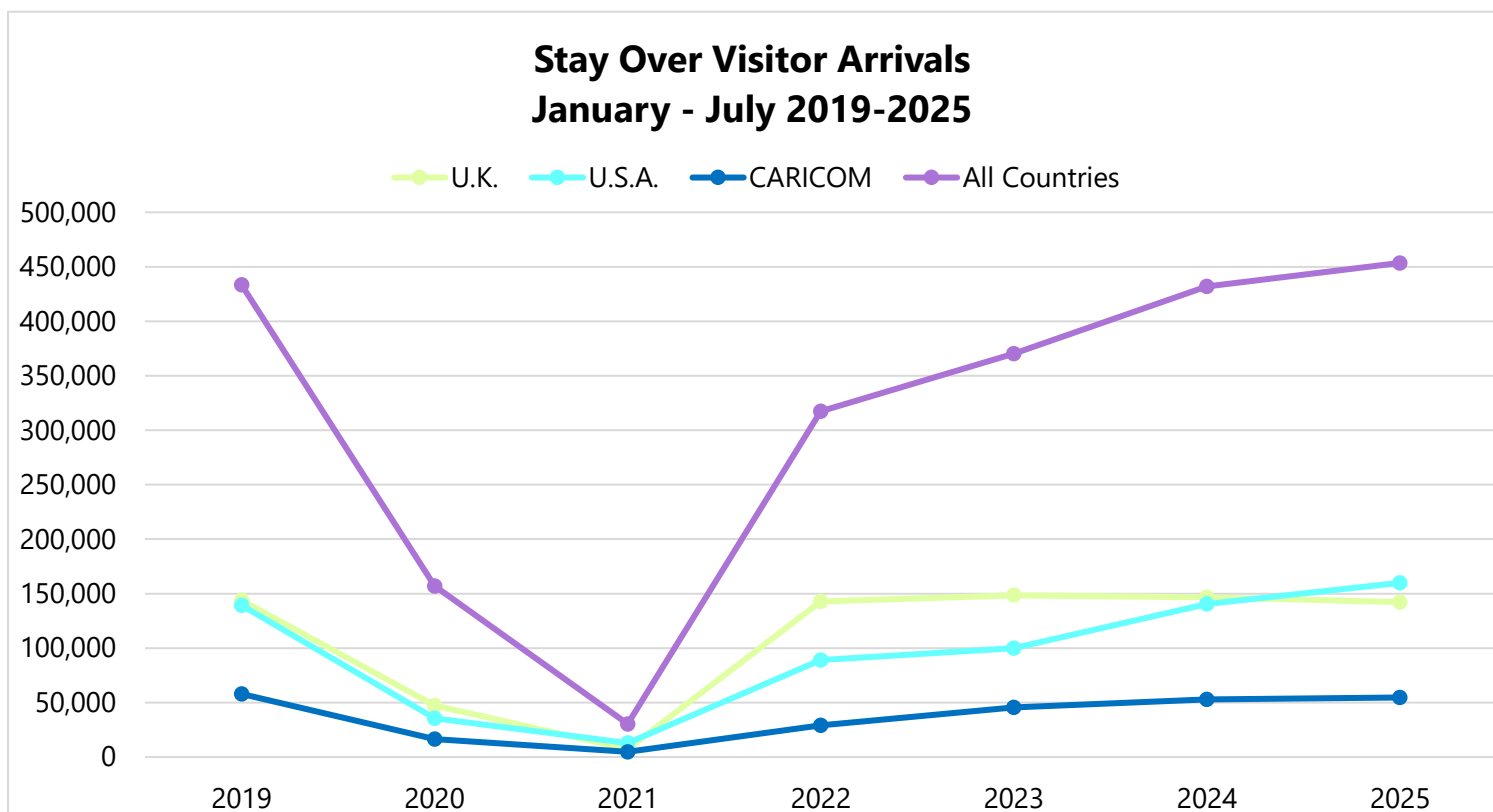
