Stay-Over Arrivals by Country of Residence

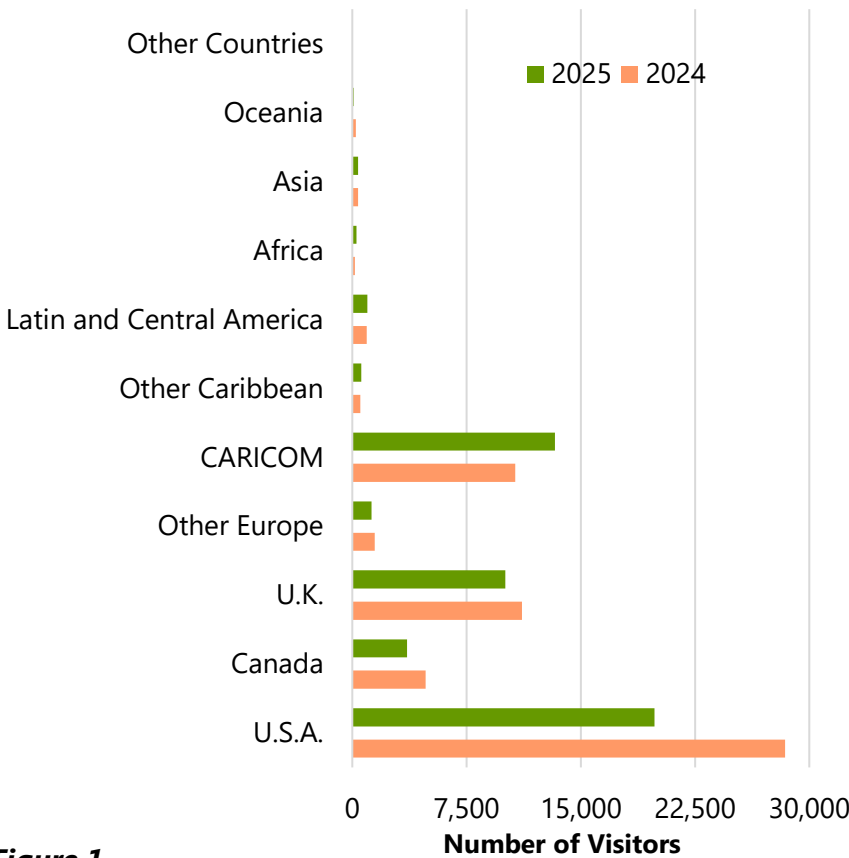

In August 2025, **50,335**(▲) stay-over visitors were recorded, this is a slight increase compared to August 2024 when there were **46,093** visitors to our shores.

Of the stay over visitors who arrived, **19,831**, arrived from the USA, representing an increase of 765 compared to the same month in the previous year. (▲)

Visitors from United Kingdom were **10,035** (▲), whilst those coming from Caricom countries were **13,298** (▲).

Africa, Asia and Latin and Central America registered **283** (▲), **378** (▲) and **980** (▲) respectively.

Arrivals by Cruise Ship

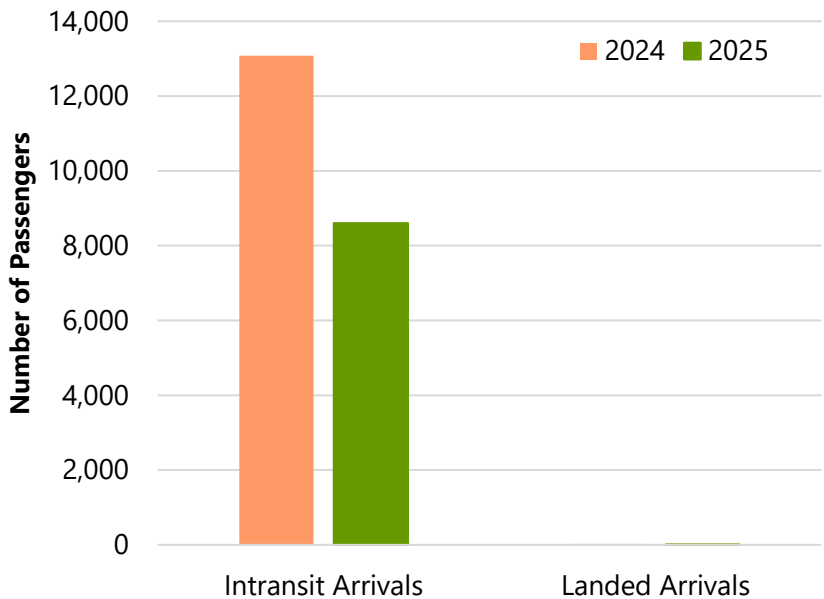

Stay-Over Arrivals by Purpose

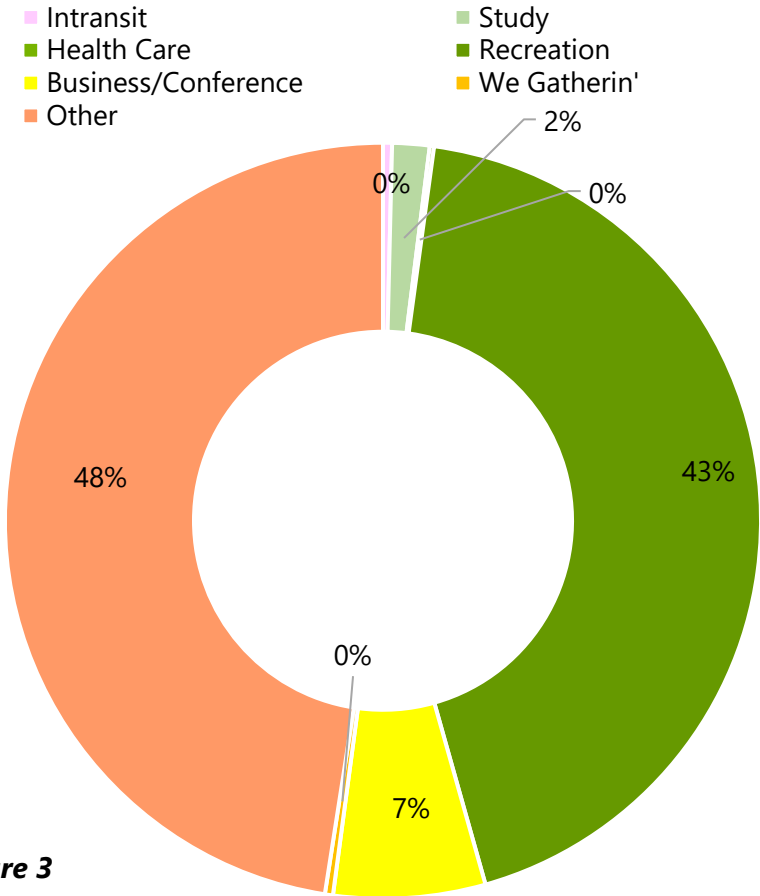

Of the **50,335** stay-over visitors for the period under review, **21,878** (▼) came for recreation, **803** (▲) for study, **838** (▼) for honeymoon/getting married and **92** (▼) for healthcare.

The number of stay-over visitors who came for holiday was **17,496** (▼), **2,153** (▼) were visiting friends, **3,266** (▲) and **23,929** (▲) arrived for business, conference or convention and other purposes, in that order.

A special highlight is given to the We Gatherin' 2025 activities, registering **173** persons.

Stay-Over Arrivals by Length of Stay

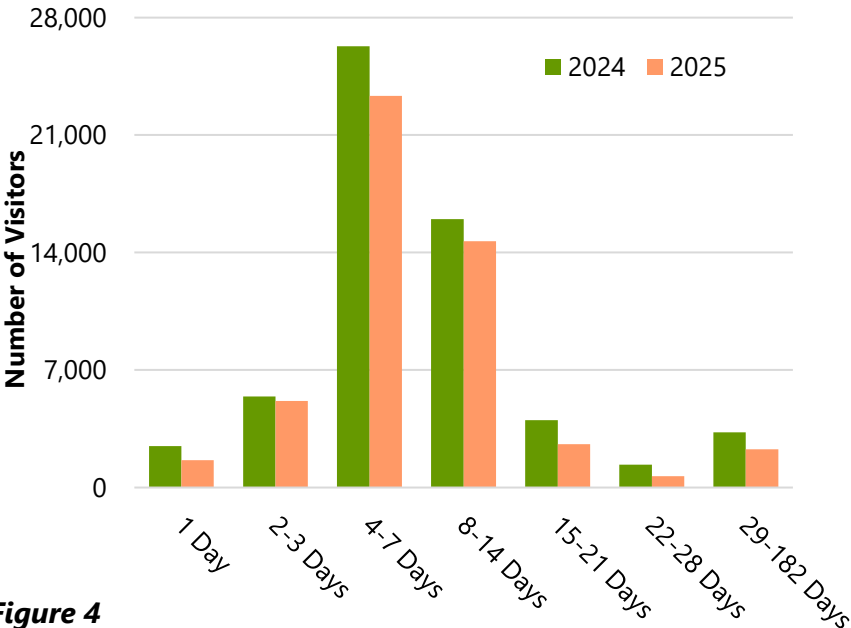

LENGTH OF STAY

The most popular stay-over period was the 4-7 days with **23,343** (▲) visitors. This was followed by the 8-14 days with **14,672** (▲). The least number of arrivals, **668** (▲), was recorded in the 22-28 days category.

Average length of stay was **10.87** (▲) days.

Year to Date Stay-Over Arrivals by Country of Residence

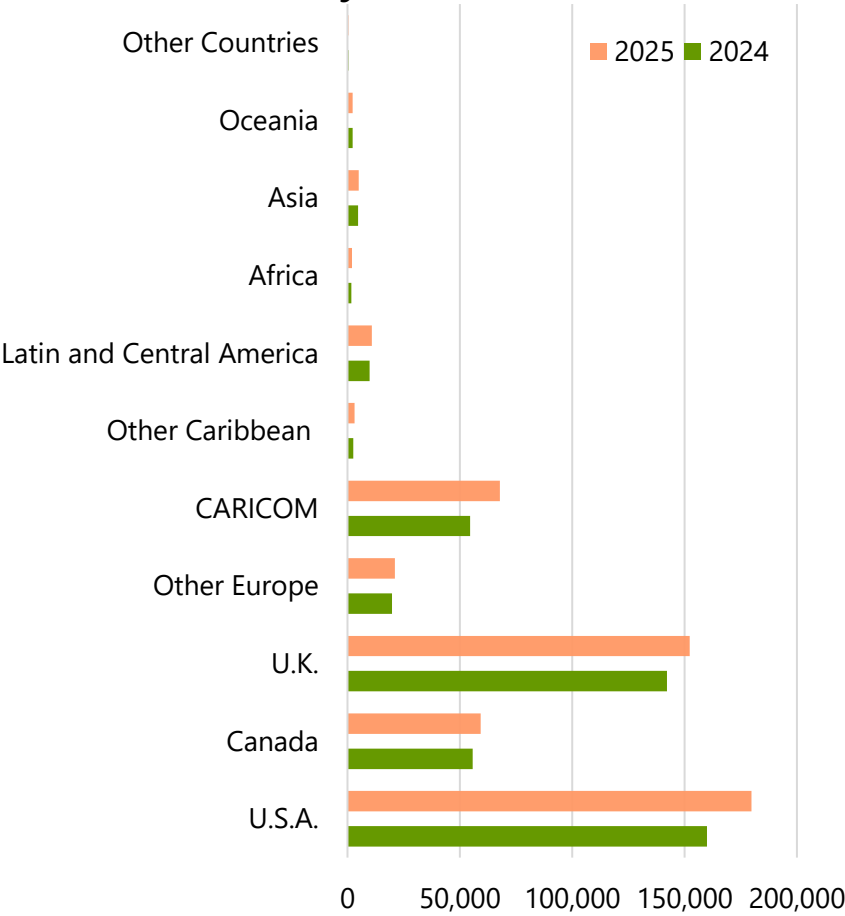

Year to Date Arrivals by Cruise Ship

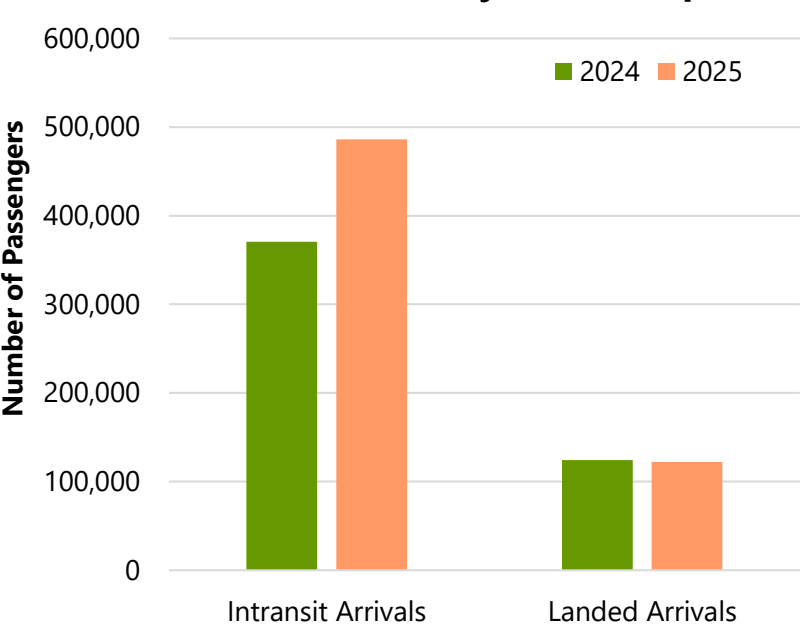

Year to Date Stay-Over Arrivals by Purpose of Visit

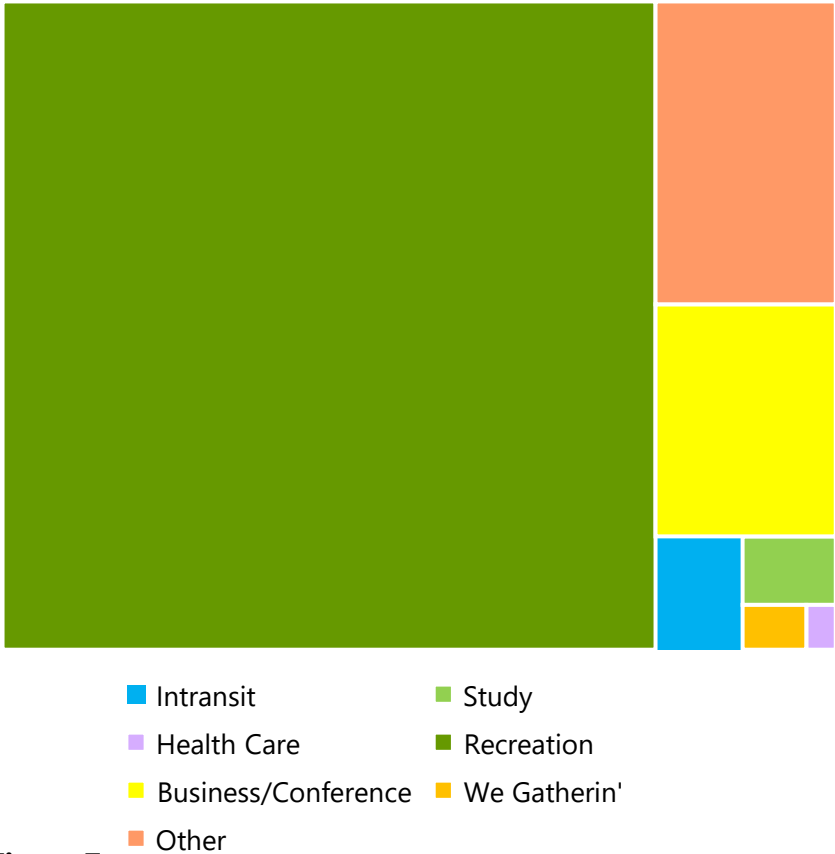

Year to Date Stay-Over Arrivals by Length of Stay

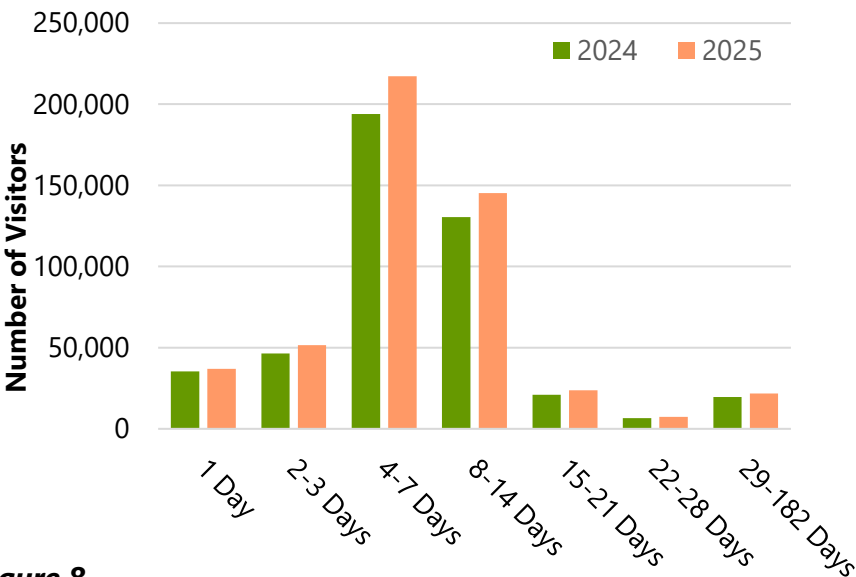

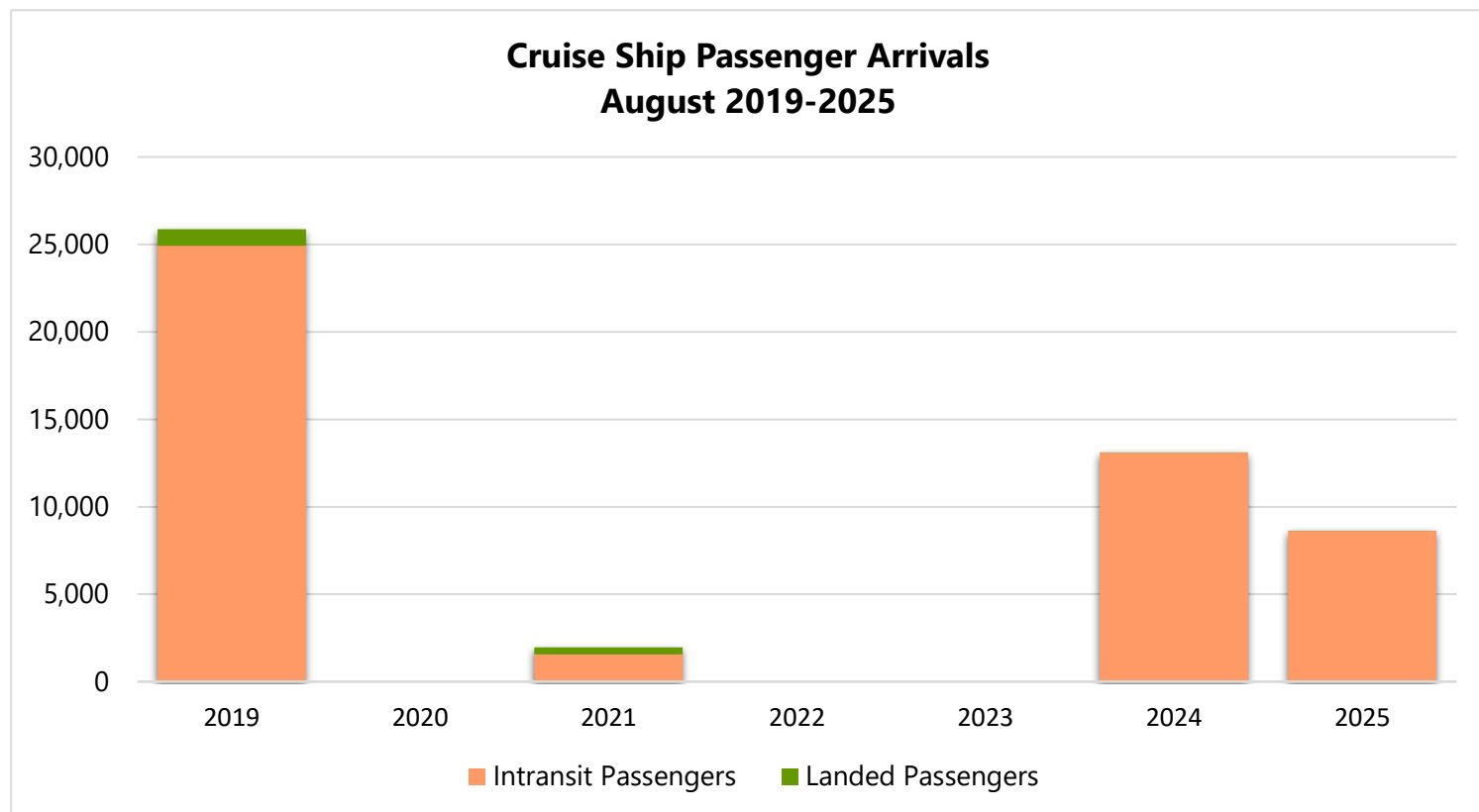

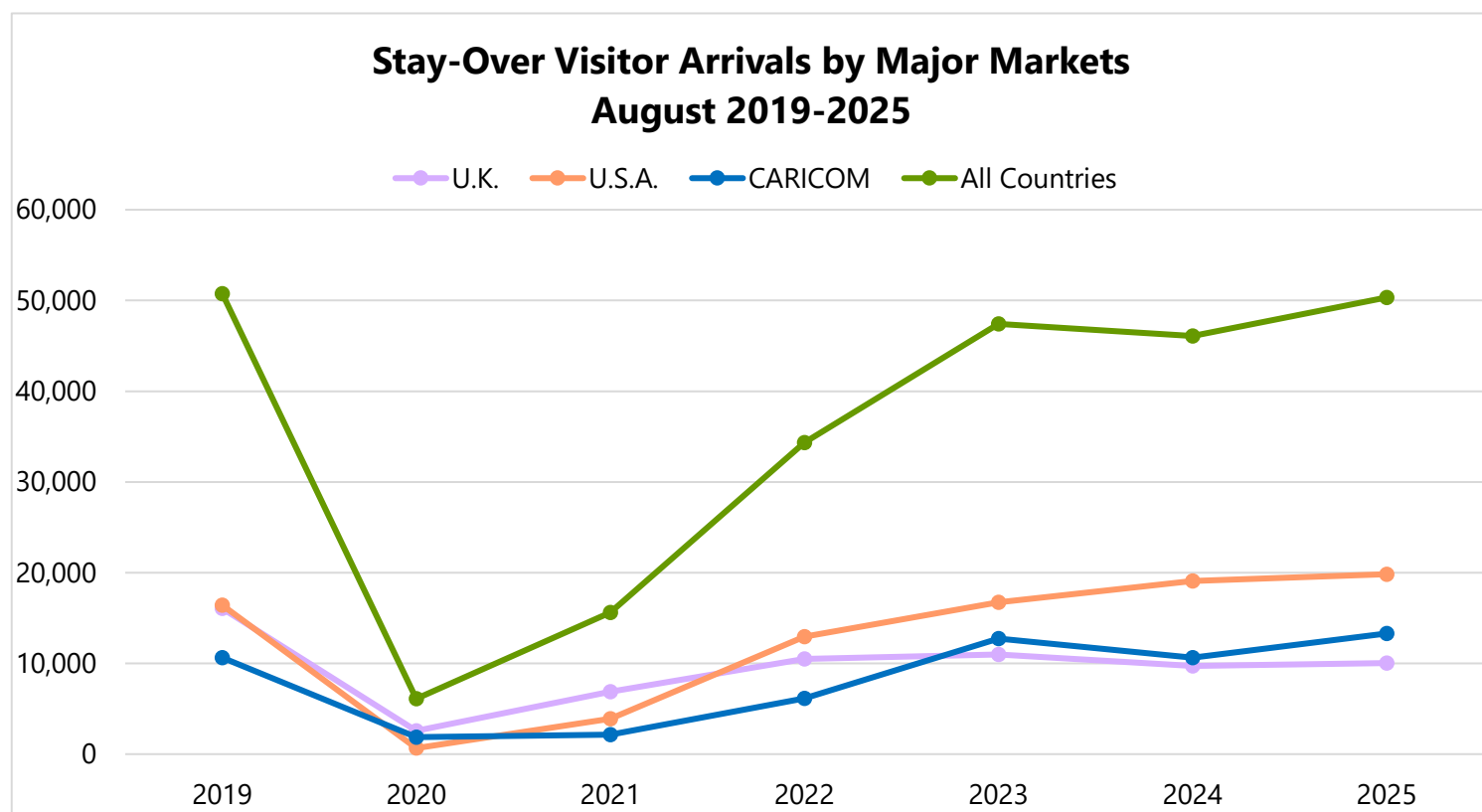

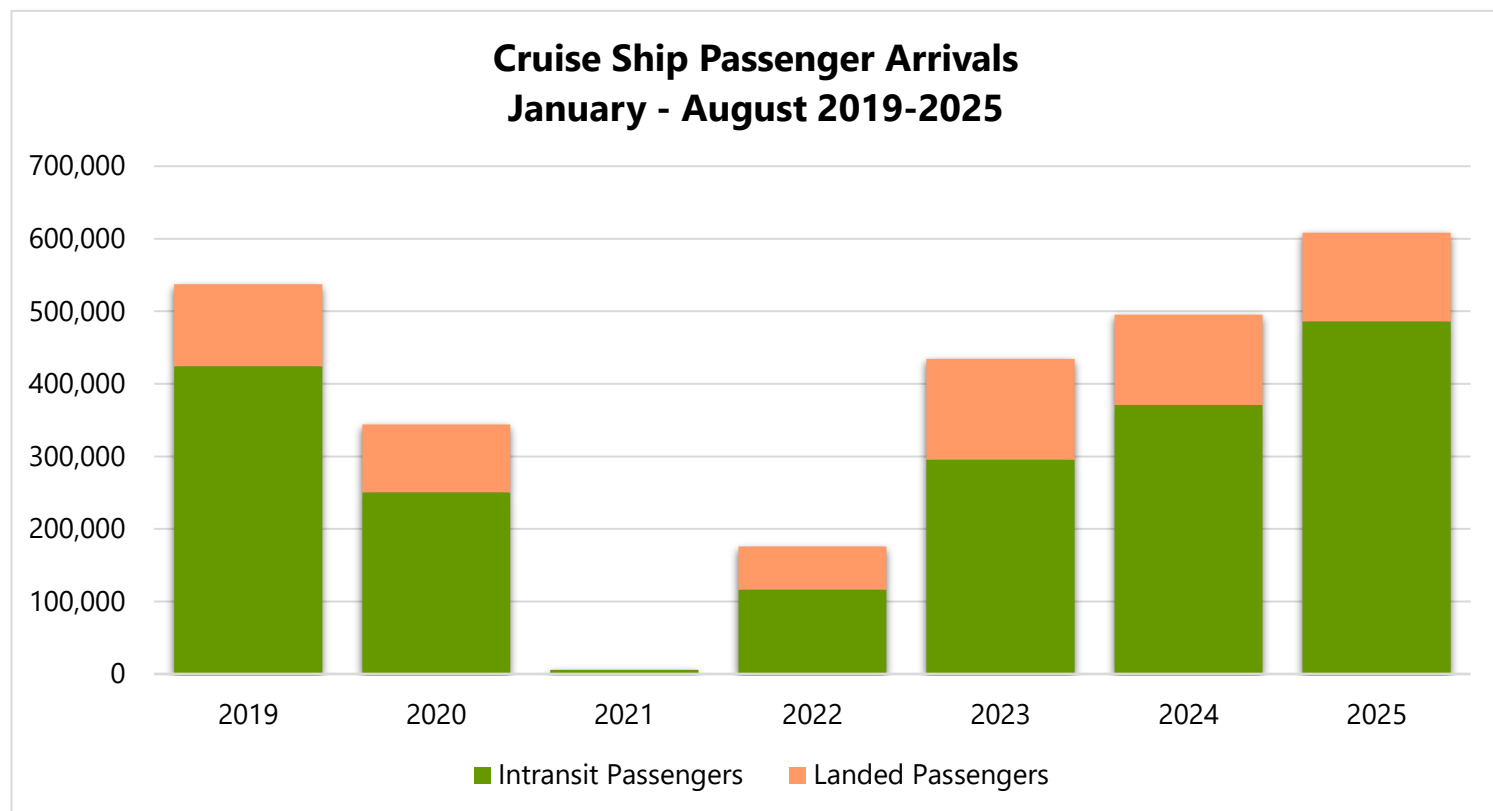

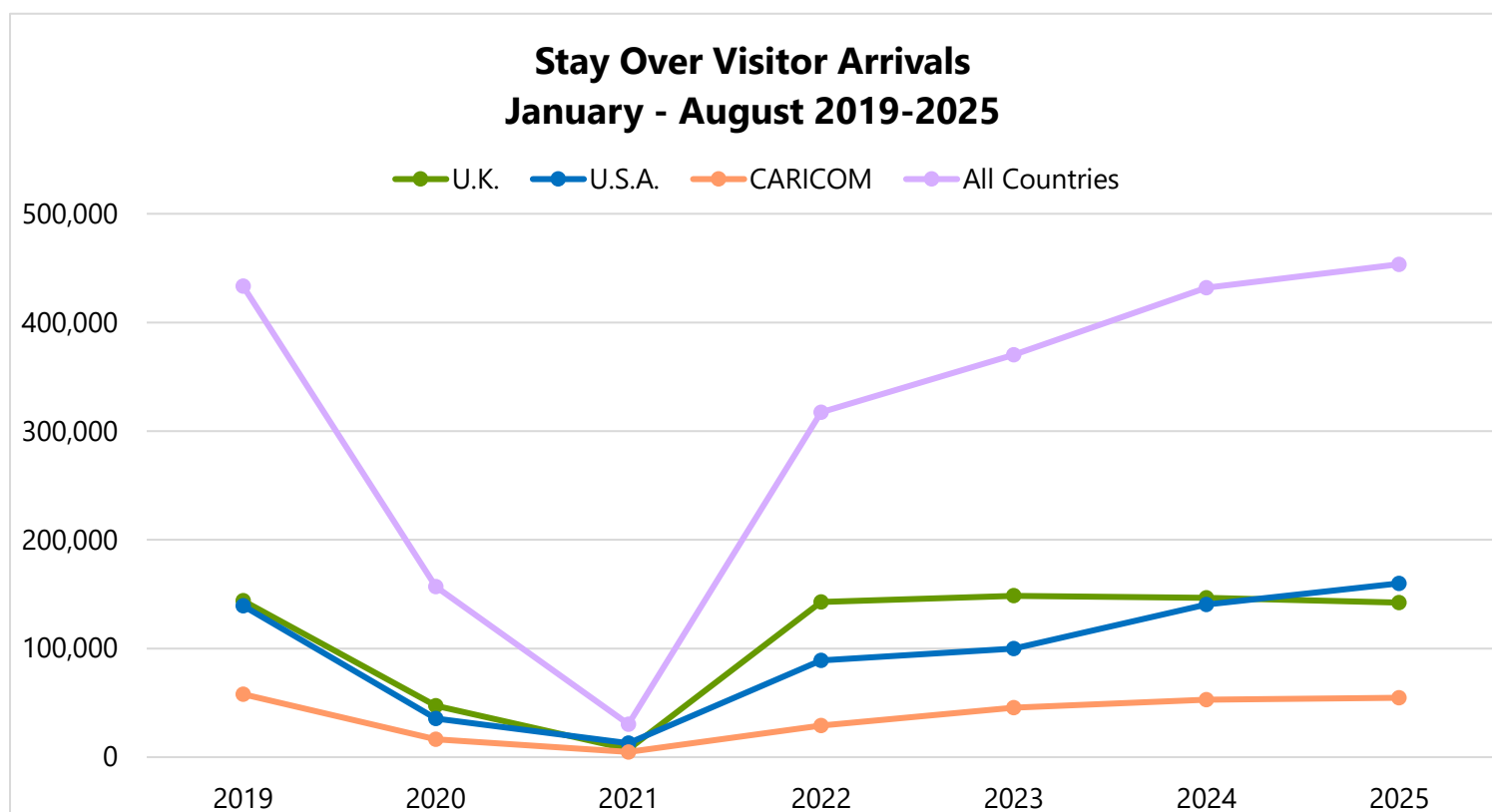
