### **REVIEW OF OVERSEAS TRADE**

During the month of October 2025, total imports to Barbados were valued at \$394.9 million, whilst total exports from Barbados were valued at \$66.7 million. This resulted in a visible trade deficit of \$328.2 million, as compared with a visible trade deficit of \$292.6 million for October 2024.

Imports for October 2025 were \$44.5 million more than imports for October 2024, an increase of 12.7%. Total exports increased by \$8.8 million or 15.2% of the October 2024 figure. Domestic exports increased by \$5.3 million or 15.5% over October 2024, while the value of re-exports increased by \$3.5 million or 14.7% over the corresponding period 2024.

For the period January – October 2025, the value of imports to Barbados was \$3.81 billion, whilst the value of total exports was \$691.2 million representing an accumulated visible trade deficit of \$3.12 billion as compared to a similar deficit of \$2.76 billion for January – October 2024.

Imports for January – October 2025 were \$279.9 million more than imports for the same period 2024, an increase of 7.9%. Total exports showed a decrease of some \$73.1 million or 9.6% over the January - October 2024 figure. Domestic exports decreased by \$33.4 million or 8.3% over January – October 2024. The value of re-exports decreased by \$39.7 million or 11.0% over the corresponding period 2024.

### **CARICOM TRADE**

During the month of October 2025, total imports from CARICOM countries were valued at \$69.2 million, whilst total exports to CARICOM were valued at \$27.0 million, resulting in a trade deficit of \$42.2 million as compared with a visible trade deficit of \$53.9 million for October 2024.

Total CARICOM imports for October 2025 were \$7.3 million less than CARICOM imports for October 2024, a decrease of 9.6%. Total exports to CARICOM for October 2025 were \$4.3 million more than total exports for October 2024, an increase of 18.9%. Domestic exports increased by \$2.7 million or 15.2% over October 2024. The value of re-exports increased by some \$1.5 million, or 33.3%, over the October 2024 figure.

For the period January – October 2025, total imports from CARICOM were valued at \$742.1 million, whilst total exports were \$248.7 million resulting in an accumulated visible trade deficit of \$493.4 million as compared with a deficit of \$611.0 million for the same period of 2024.

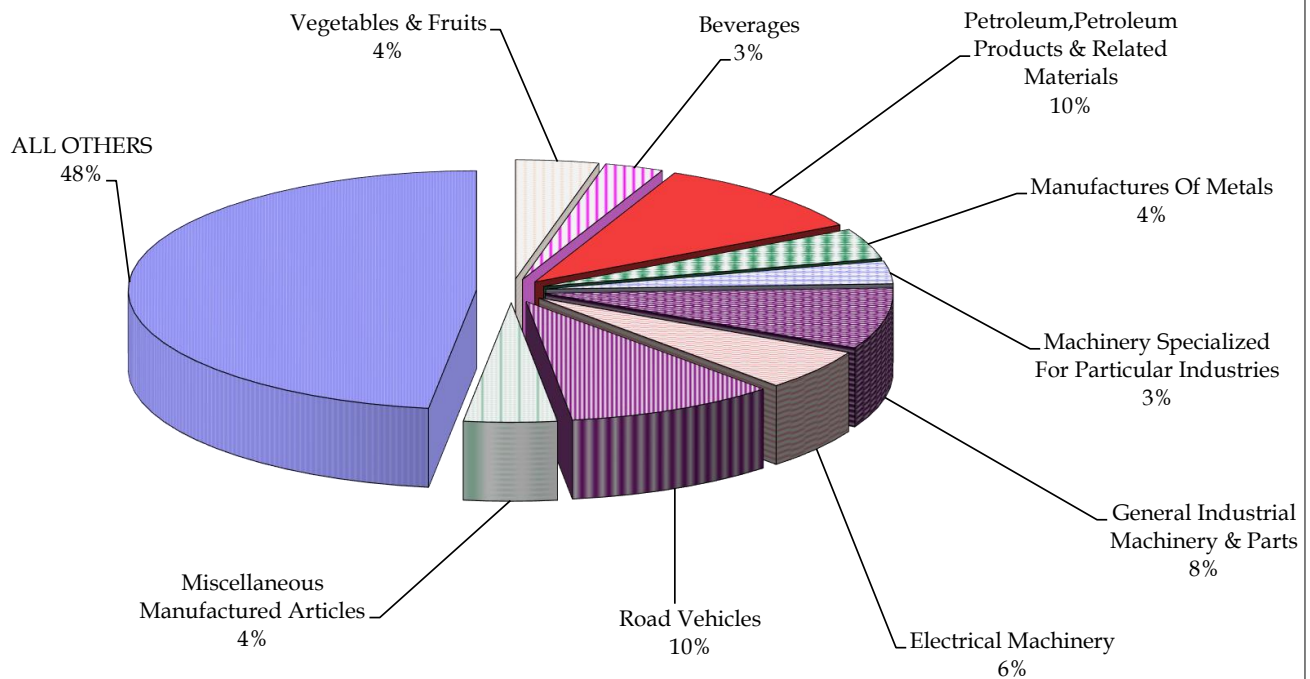
During this period, CARICOM imports were approximately \$137.1 million less than those over the same period in 2024, a decrease of 15.6%. Total exports to CARICOM for January – October 2025 were \$19.5 million less than total exports for the corresponding period 2024, a decrease of 7.3%. Domestic exports decreased by approximately \$23.2 million or 10.4% over the same period 2024. The value of re-exports increased by \$3.7 million or 8.1% over the January – October 2024 figure.

OCTOBER 2025 WITH THE CORRESPONDING MONTH OF 2024

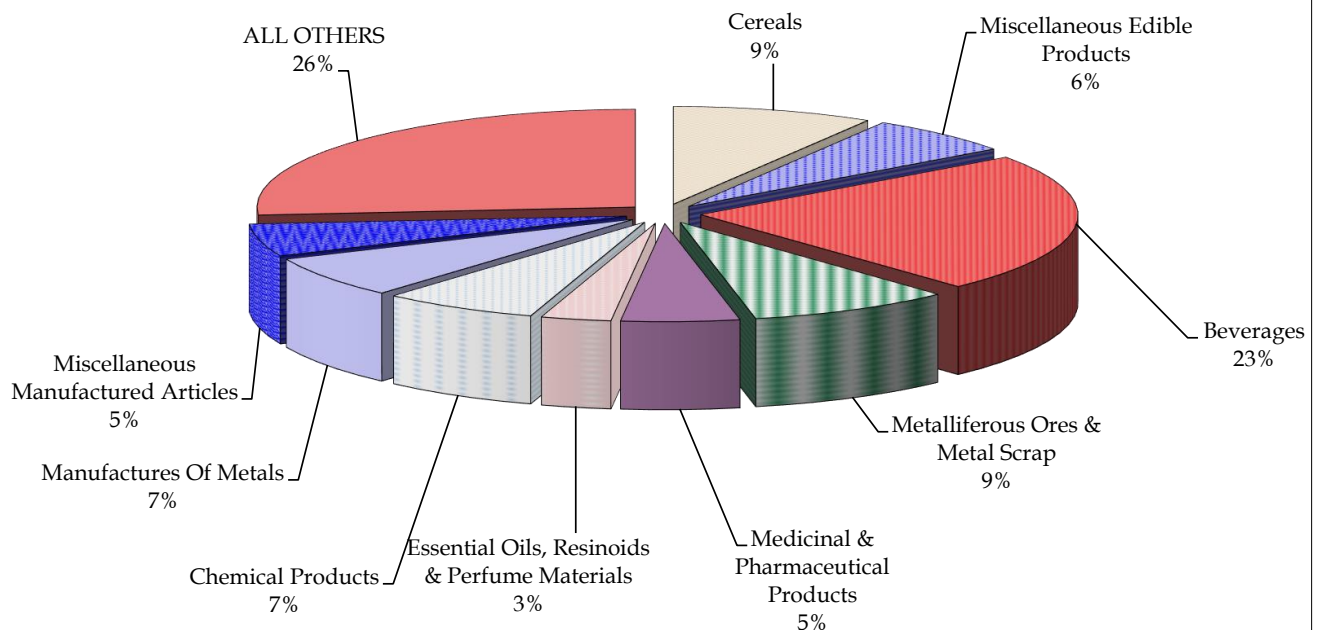

## Principal Domestic Exports - October 2025



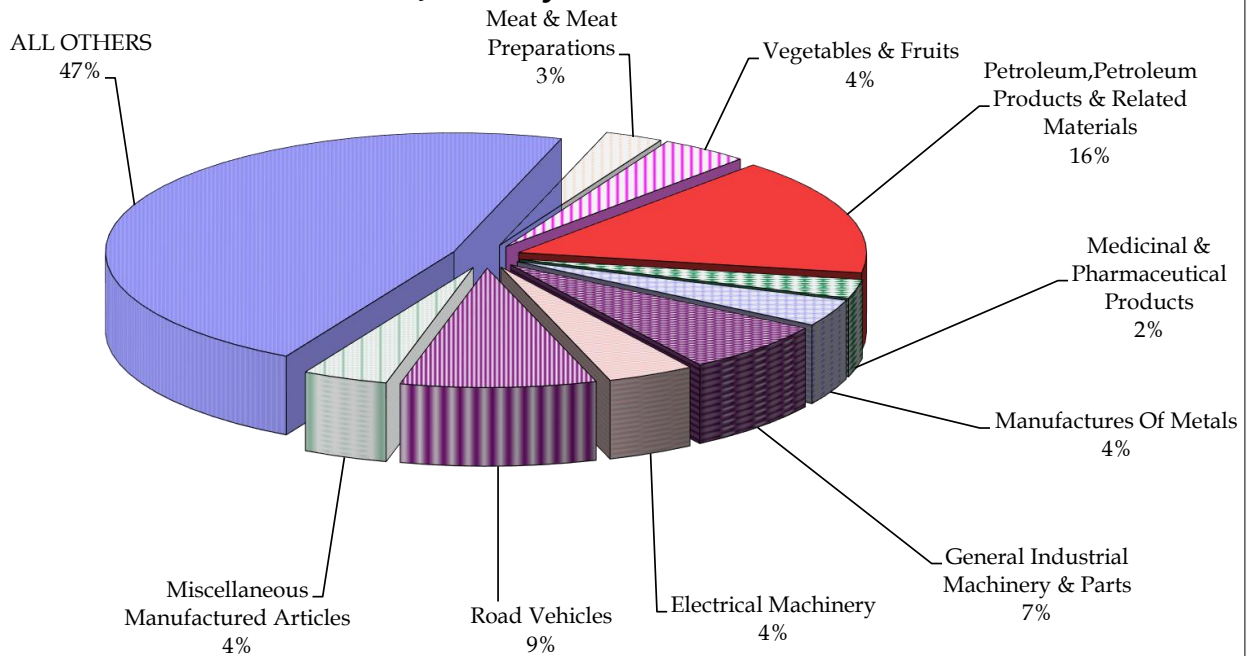

## Principal Domestic Exports January - October 2025

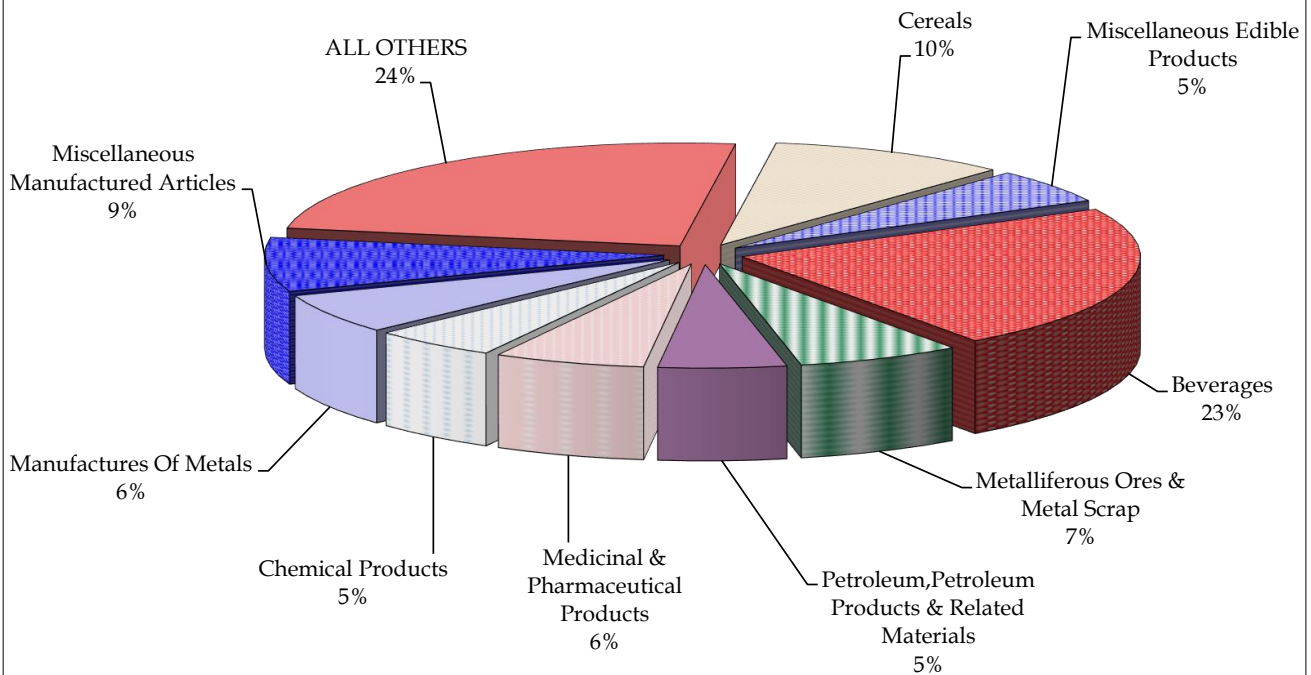

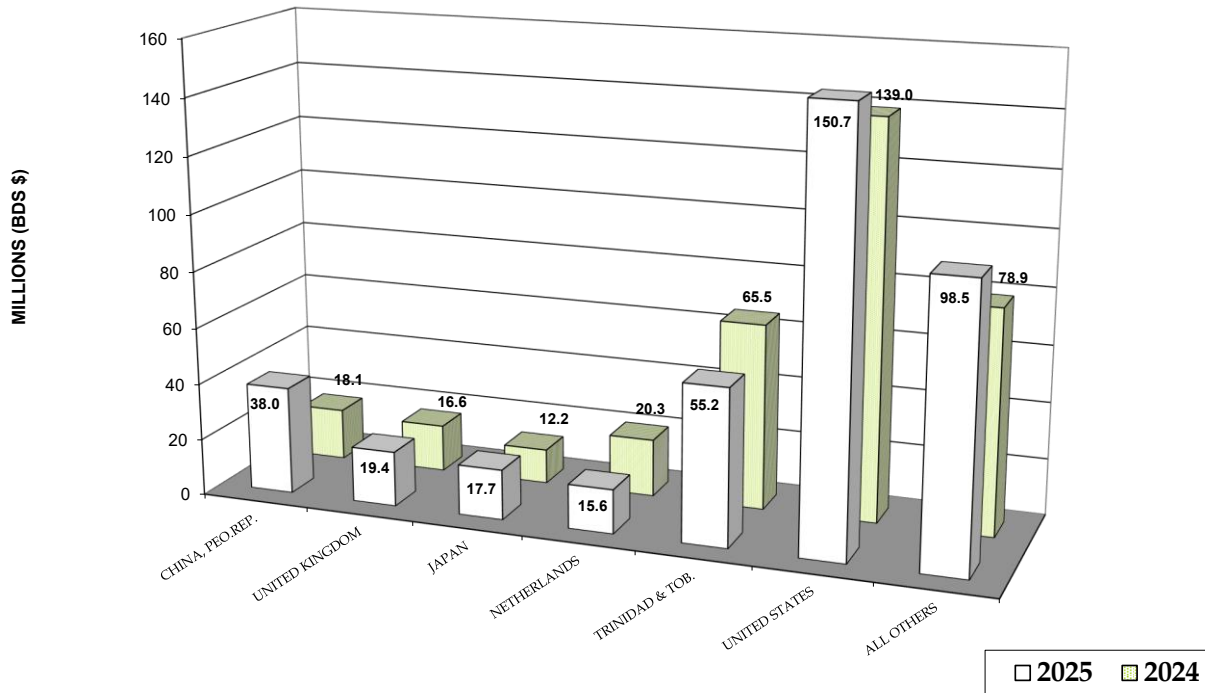

OCTOBER 2025 WITH THE CORRESPONDING MONTH OF 2024

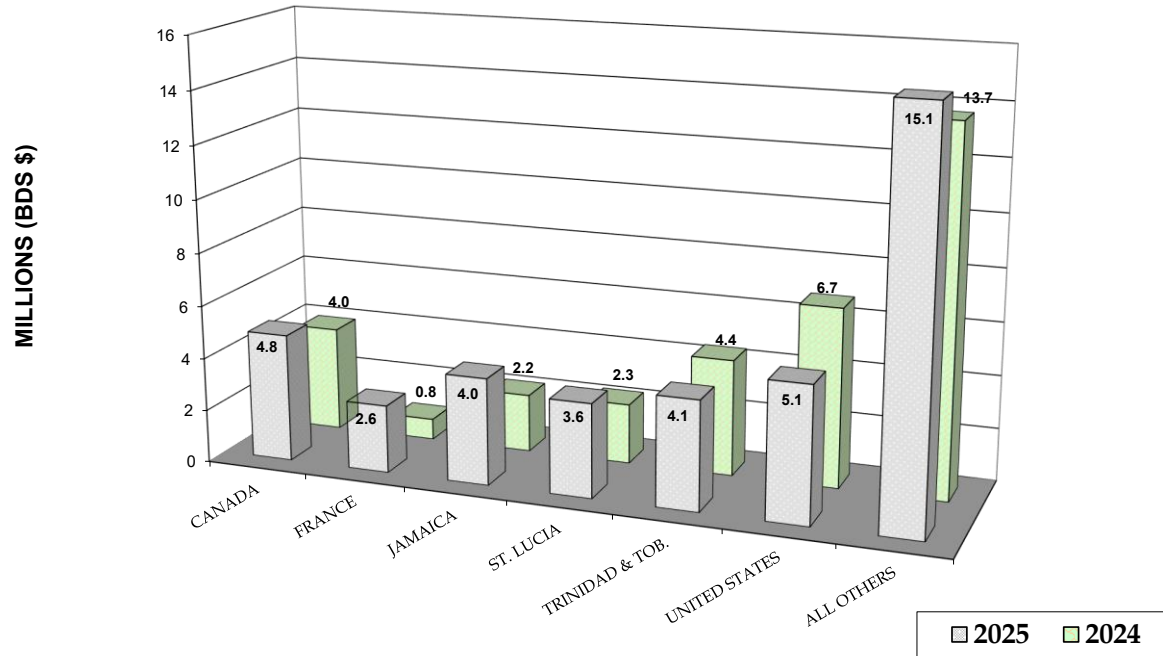


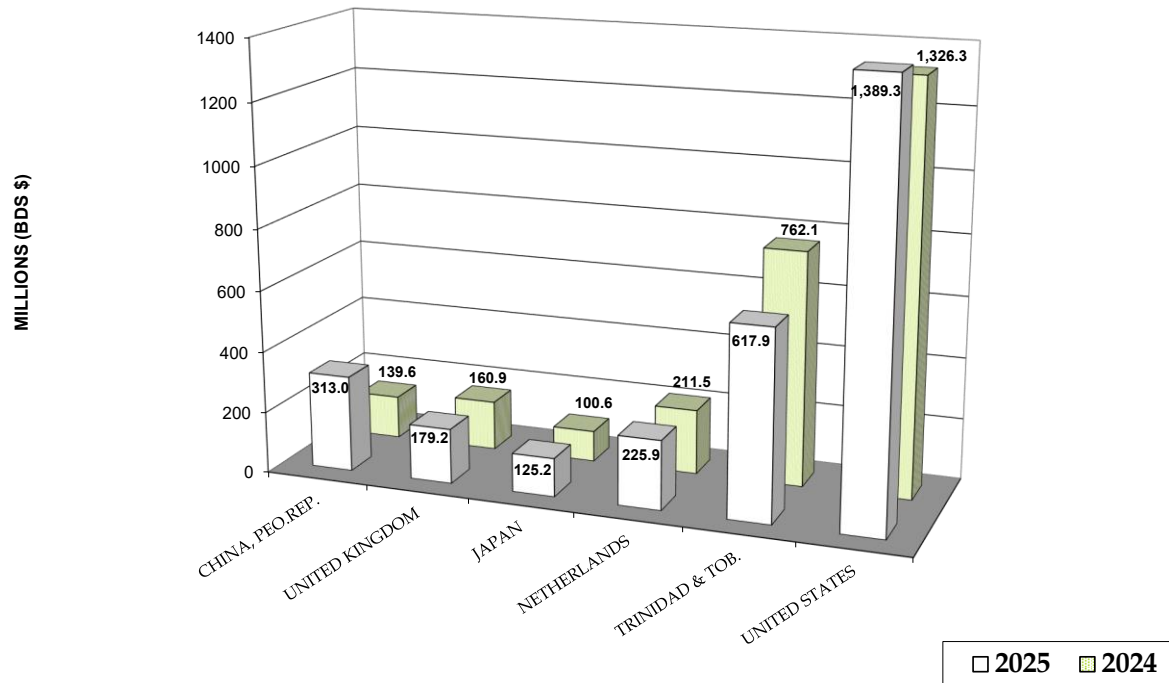

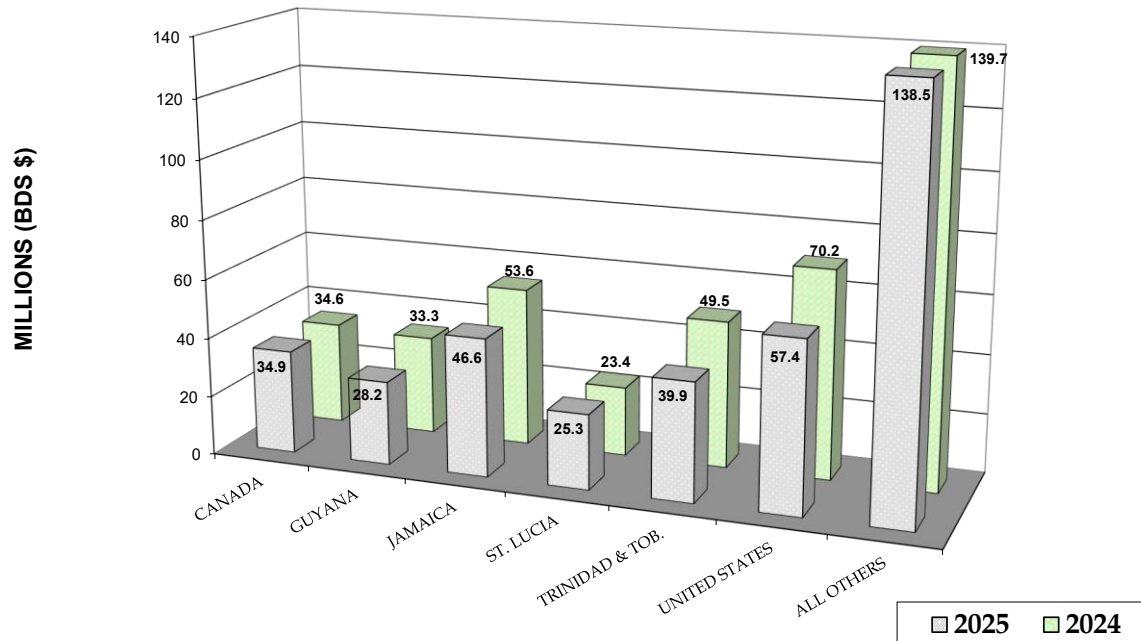

OCTOBER 2025 WITH THE CORRESPONDING MONTH OF 2024

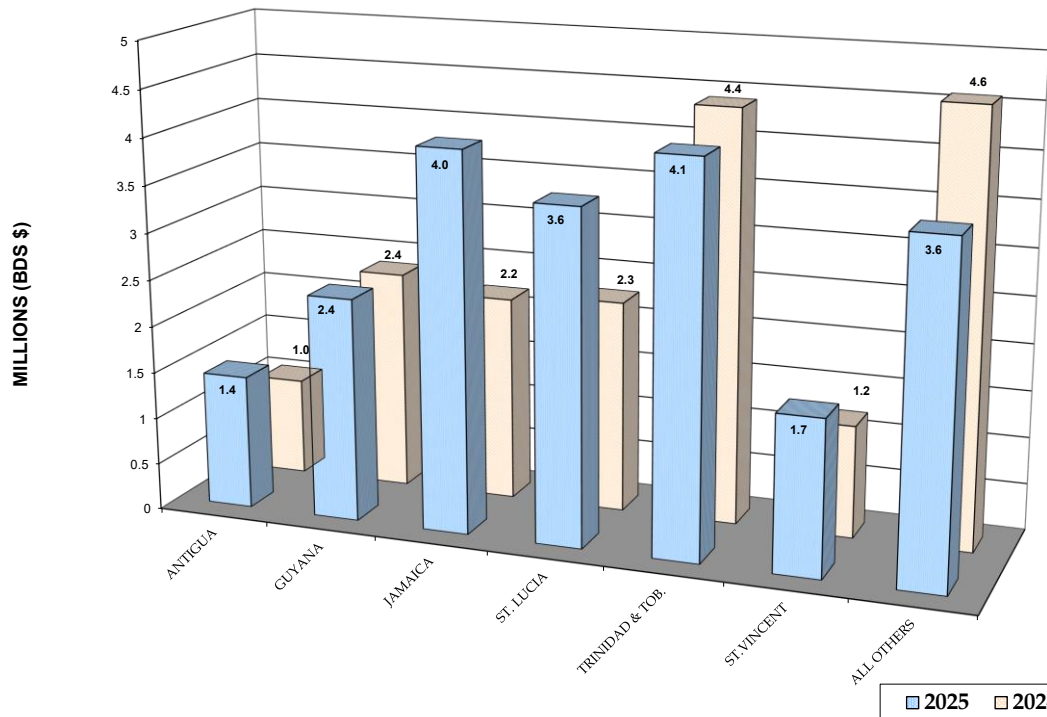
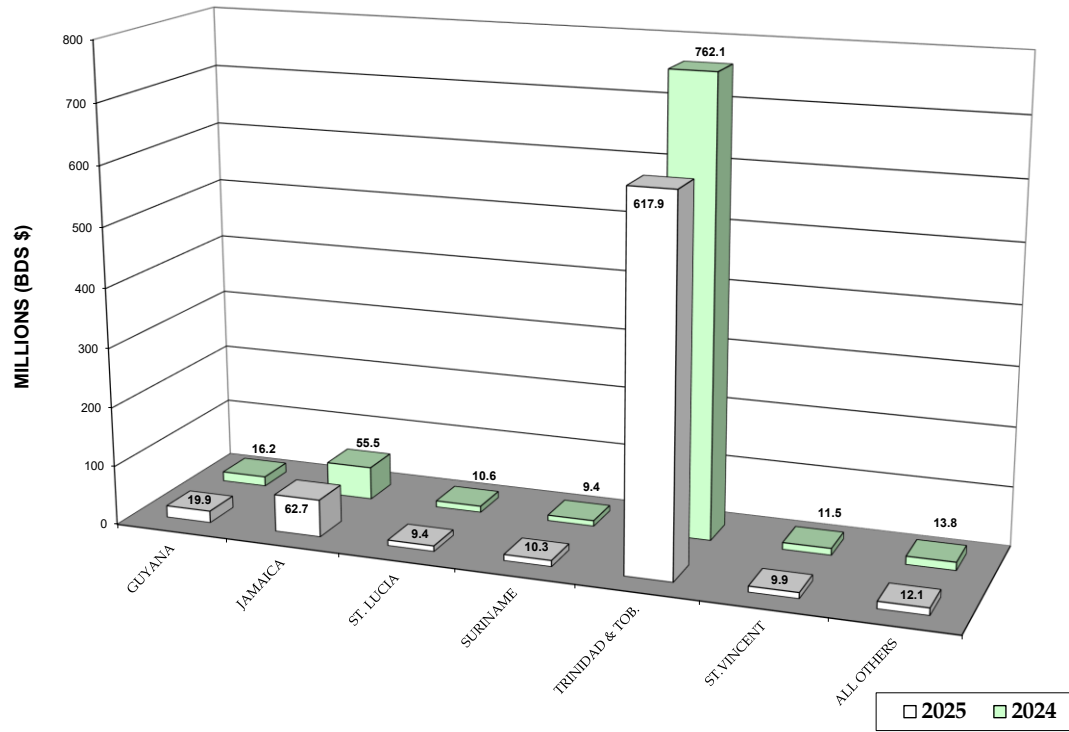

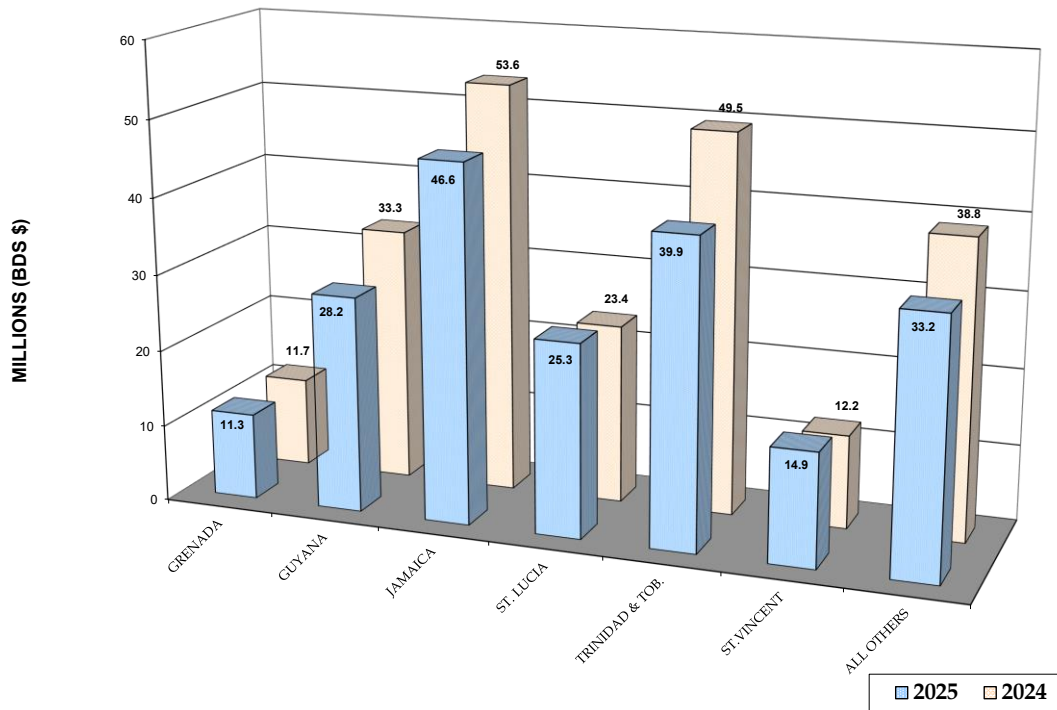
