REVIEW OF OVERSEAS TRADE

During the month of September 2025, total imports to Barbados were valued at \$380.7 million, whilst total exports from Barbados were valued at \$57.2 million. This resulted in a visible trade deficit of \$323.5 million, as compared with a visible trade deficit of \$263.1 million for September 2024.

Imports for September 2025 were \$53.3 million more than imports for September 2024, an increase of 16.3%. Total exports decreased by \$7.2 million or 11.2% of the September 2024 figure. Domestic exports decreased by \$7.0 million or 16.2% over September 2024, while the value of re-exports decreased by \$0.2 million or 1.2% over the corresponding period 2024.

For the period January – September 2025, the value of imports to Barbados was \$3.41 billion, whilst the value of total exports was \$624.5 million representing an accumulated visible trade deficit of \$2.79 billion as compared to a similar deficit of \$2.47 billion for January – September 2024.

Imports for January – September 2025 were \$235.4 million more than imports for the same period 2024, an increase of 7.4%. Total exports showed a decrease of some \$81.9 million or 11.6% over the January - September 2024 figure. Domestic exports decreased by \$38.7 million or 10.4% over January – September 2024. The value of re-exports decreased by \$43.2 million or 12.9% over the corresponding period 2024.

CARICOM TRADE

During the month of September 2025, total imports from CARICOM countries were valued at \$61.7 million, whilst total exports to CARICOM were valued at \$21.5 million, resulting in a trade deficit of \$40.2 million as compared with a visible trade deficit of \$34.6 million for September 2024.

Total CARICOM imports for September 2025 were \$3.2 million less than CARICOM imports for September 2024, a decrease of 4.9%. Total exports to CARICOM for September 2025 were \$8.9 million less than total exports for September 2024, a decrease of 29.3%. Domestic exports decreased by \$8.8 million or 34.1% over September 2024. The value of re-exports decreased by some \$0.1 million, or 1.7%, over the September 2024 figure.



For the period January – September 2025, total imports from CARICOM were valued at \$672.9 million, whilst total exports were \$221.7 million resulting in an accumulated visible trade deficit of \$451.2 million as compared with a deficit of \$557.2 million for the same period of 2024.

During this period, CARICOM imports were approximately \$129.7 million less than those over the same period in 2024, a decrease of 16.2%. Total exports to CARICOM for January – September 2025 were \$23.8 million less than total exports for the corresponding period 2024, a decrease of 9.7%. Domestic exports decreased by approximately \$25.9 million or 12.7% over the same period 2024. The value of re-exports increased by \$2.1 million or 5.2% over the January – September 2024 figure.






SEPTEMBER 2025 WITH THE CORRESPONDING MONTH OF 2024








SEPTEMBER 2025 WITH THE CORRESPONDING MONTH OF 2024



