## **REVIEW OF OVERSEAS TRADE**

During the month of December 2025, total imports to Barbados were valued at \$410.7 million, whilst total exports from Barbados were valued at \$72.5 million. This resulted in a visible trade deficit of \$338.2 million, as compared with a visible trade deficit of \$326.2 million for December 2024.

Imports for December 2025 were \$2.3 million more than imports for December 2024, an increase of 0.6%. Total exports decreased by \$9.6 million or 11.7% of the December 2024 figure. Domestic exports decreased by \$4.4 million or 12.2% over December 2024, while the value of re-exports decreased by \$5.2 million or 11.4% over the corresponding period 2024.

For the period January – December 2025, the value of imports to Barbados was \$4.59 billion, whilst the value of total exports was \$842.2 million representing an accumulated visible trade deficit of \$3.75 billion as compared to a similar deficit of \$3.38 billion for January – December 2024.

Imports for January – December 2025 were \$281.6 million more than imports for the same period 2024, an increase of 6.5%. Total exports showed a decrease of some \$80.3 million or 8.7% over the January - December 2024 figure. Domestic exports decreased by \$31.0 million or 6.5% over January – December 2024. The value of re-exports decreased by \$49.3 million or 11.0% over the corresponding period 2024.

## **CARICOM TRADE**

During the month of December 2025, total imports from CARICOM countries were valued at \$61.2 million, whilst total exports to CARICOM were valued at \$20.8 million, resulting in a trade deficit of \$40.4 million as compared with a visible trade deficit of \$77.6 million for December 2024.

Total CARICOM imports for December 2025 were \$43.5 million less than CARICOM imports for December 2024, a decrease of 41.6%. Total exports to CARICOM for December 2025 were \$6.3 million less than total exports for December 2024, a decrease of 23.1%. Domestic exports decreased by \$6.1 million or 26.9% over December 2024. The value of re-exports decreased by some \$0.2 million, or 4.1%, over the December 2024 figure.

For the period January – December 2025, total imports from CARICOM were valued at \$859.0 million, whilst total exports were \$300.4 million resulting in an accumulated visible trade deficit of \$558.6 million as compared with a deficit of \$737.1 million for the same period of 2024.

During this period, CARICOM imports were approximately \$200.0 million less than those over the same period in 2024, a decrease of 18.9%. Total exports to CARICOM for January – December 2025 were \$21.5 million less than total exports for the corresponding period 2024, a decrease of 6.7%. Domestic exports decreased by approximately \$22.3 million or 8.4% over the same period 2024. The value of re-exports increased by \$0.8 million or 1.4% over the January – December 2024 figure.

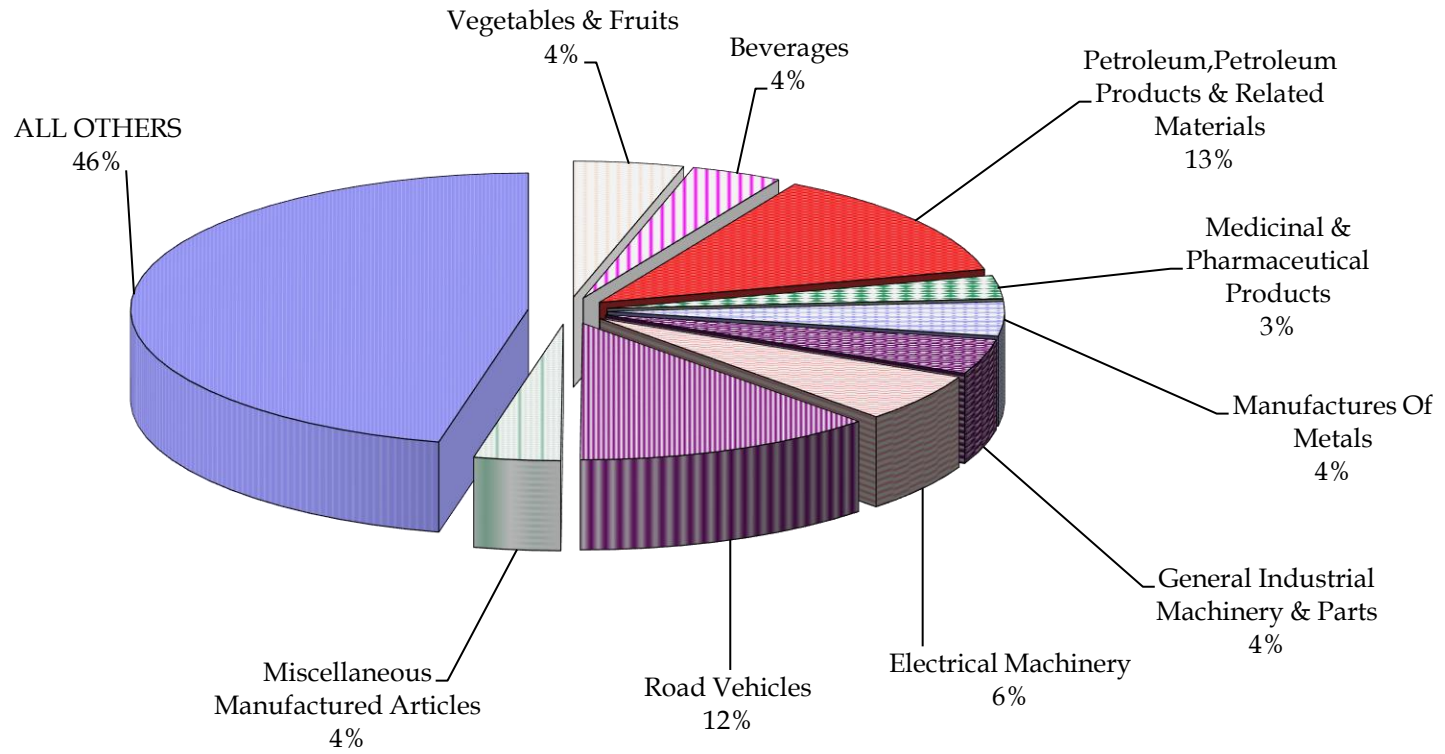

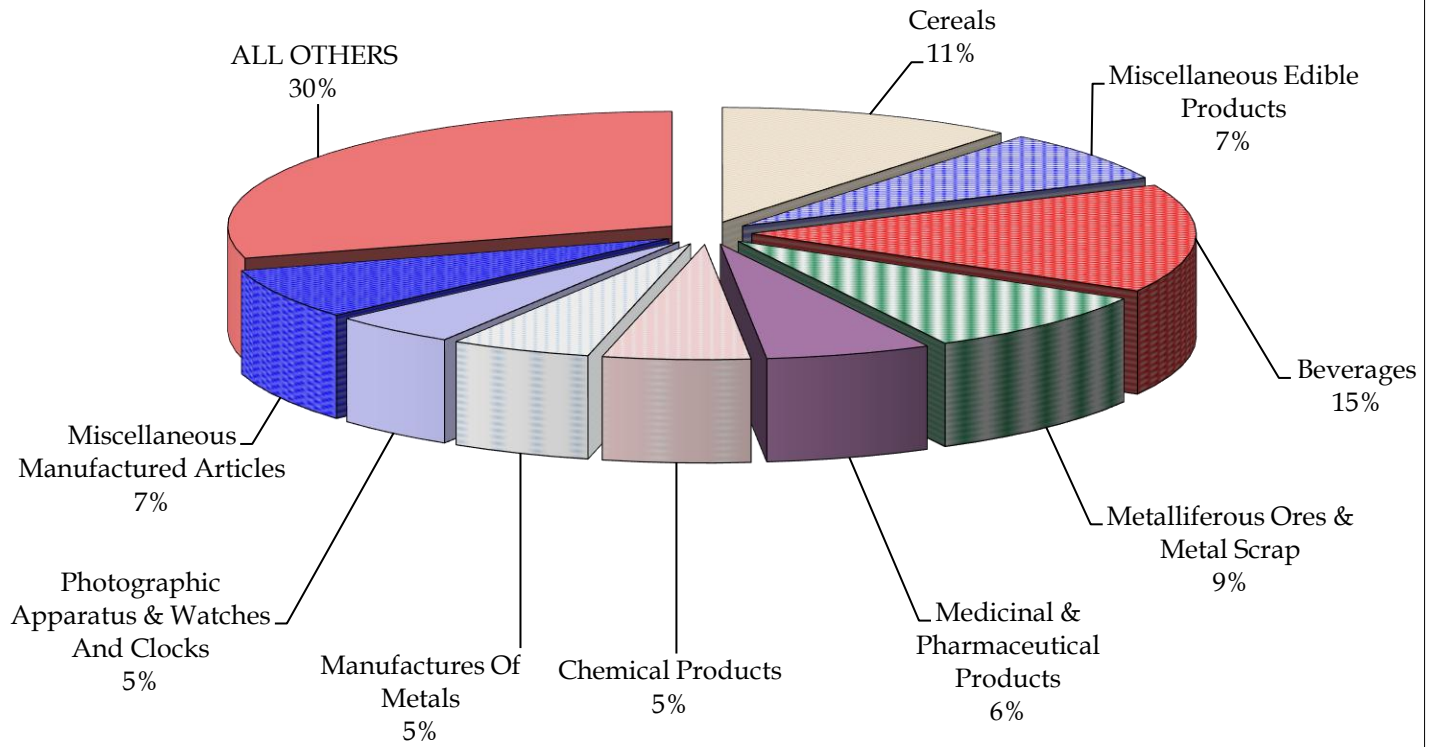

### Principal Domestic Exports - December 2025



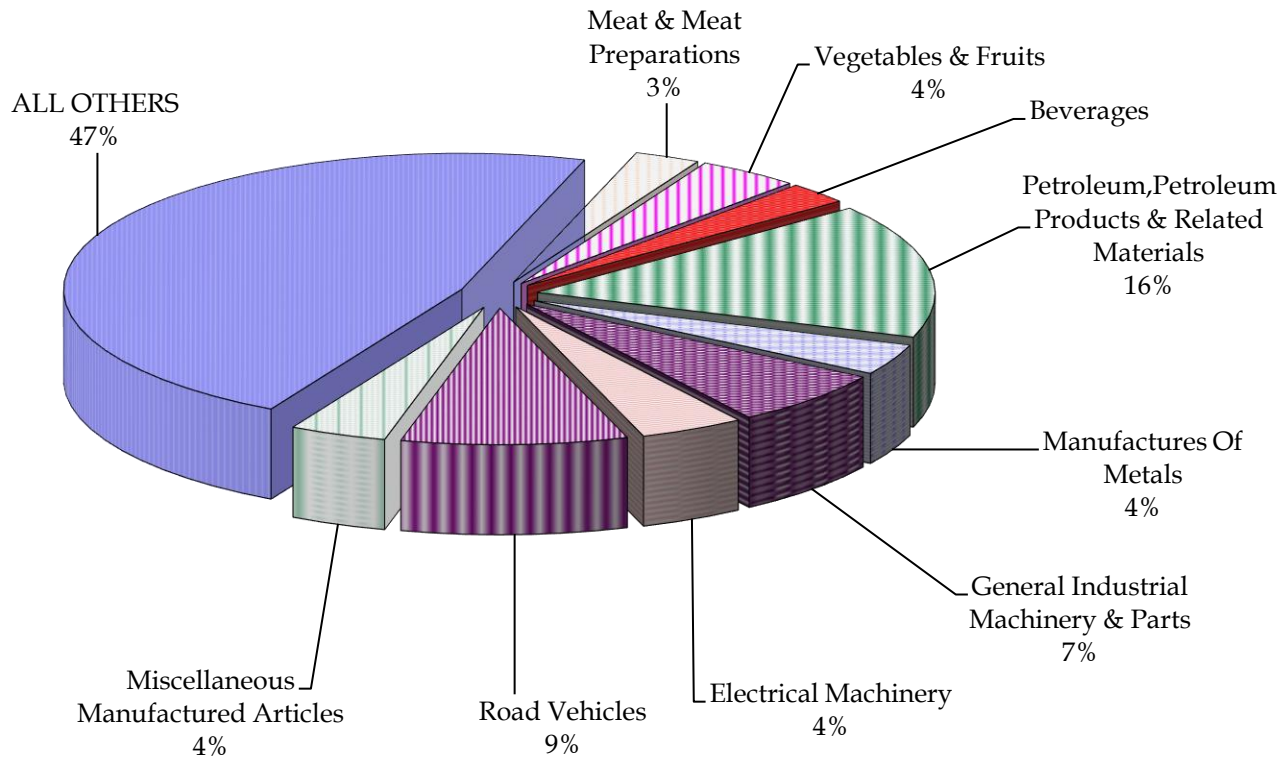

### Principal Domestic Exports January - December 2025

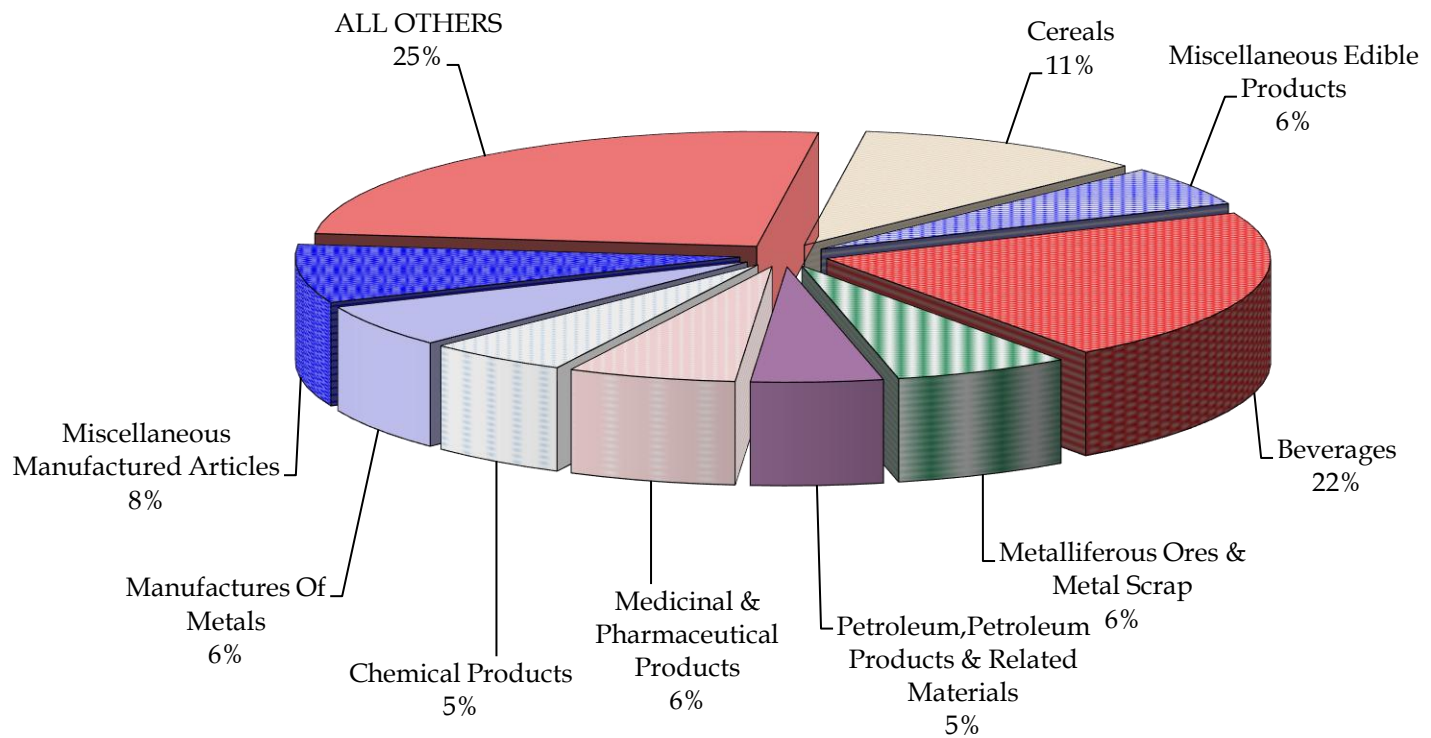

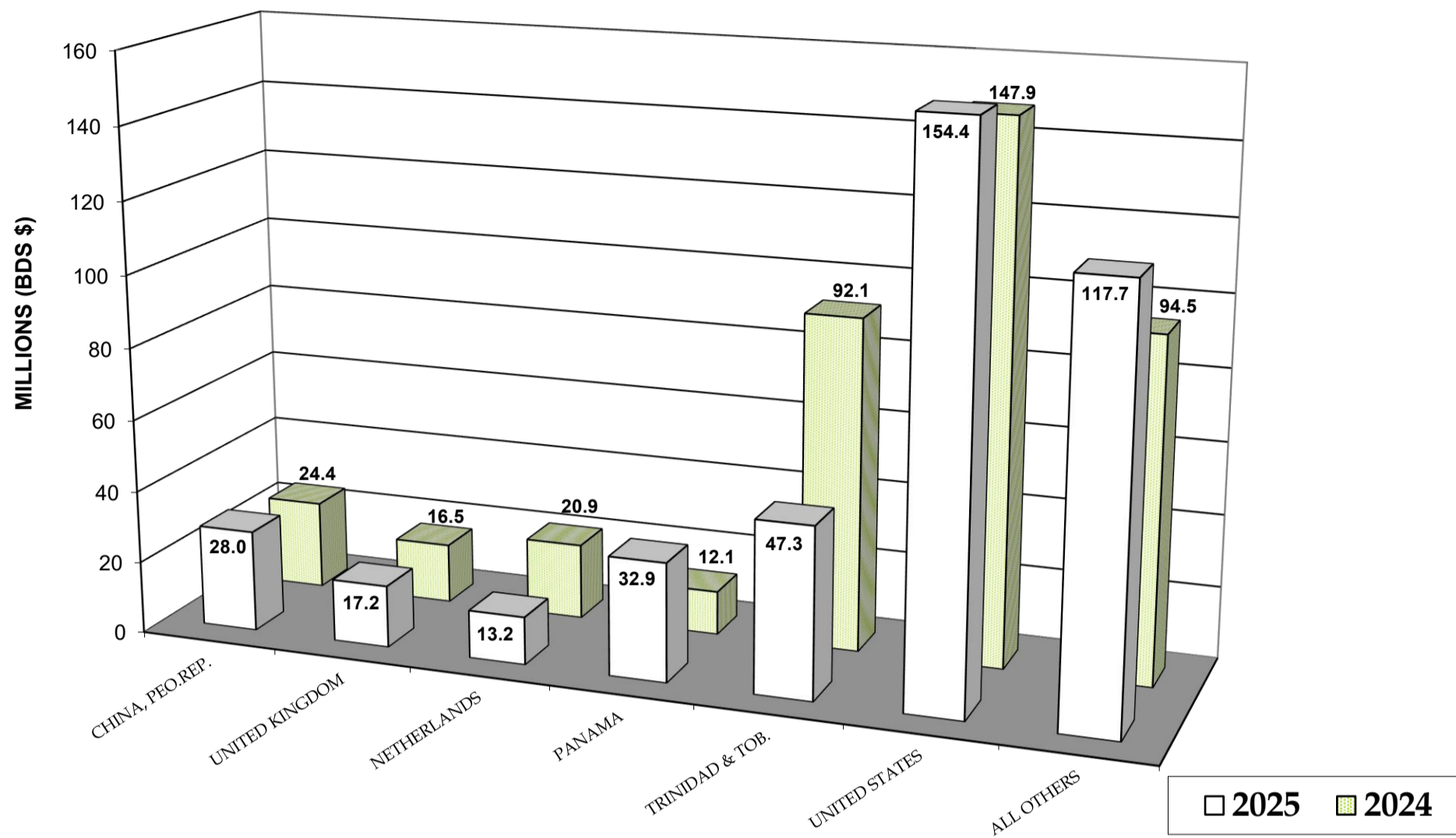

DECEMBER 2025 WITH THE CORRESPONDING MONTH OF 2024

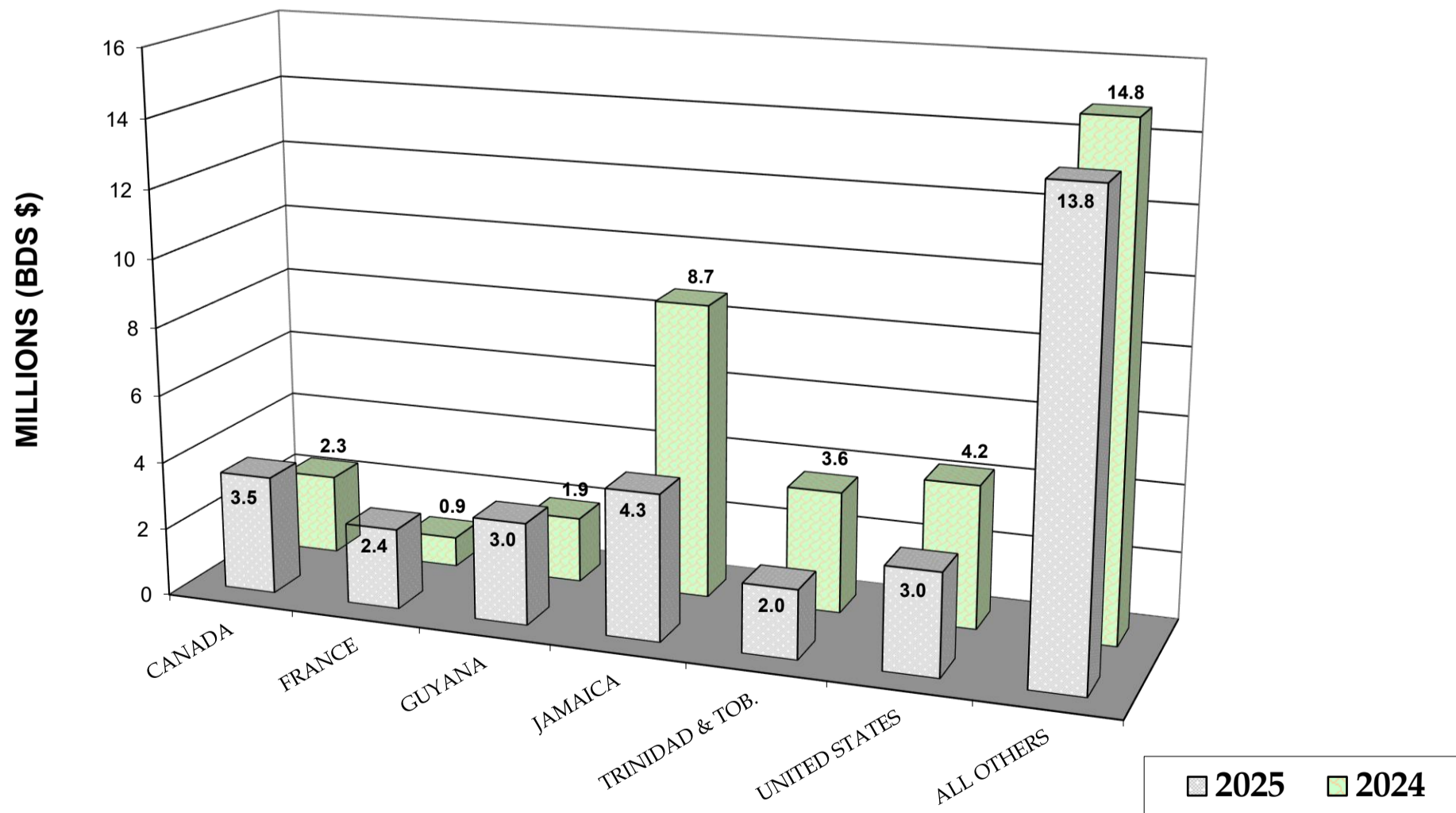


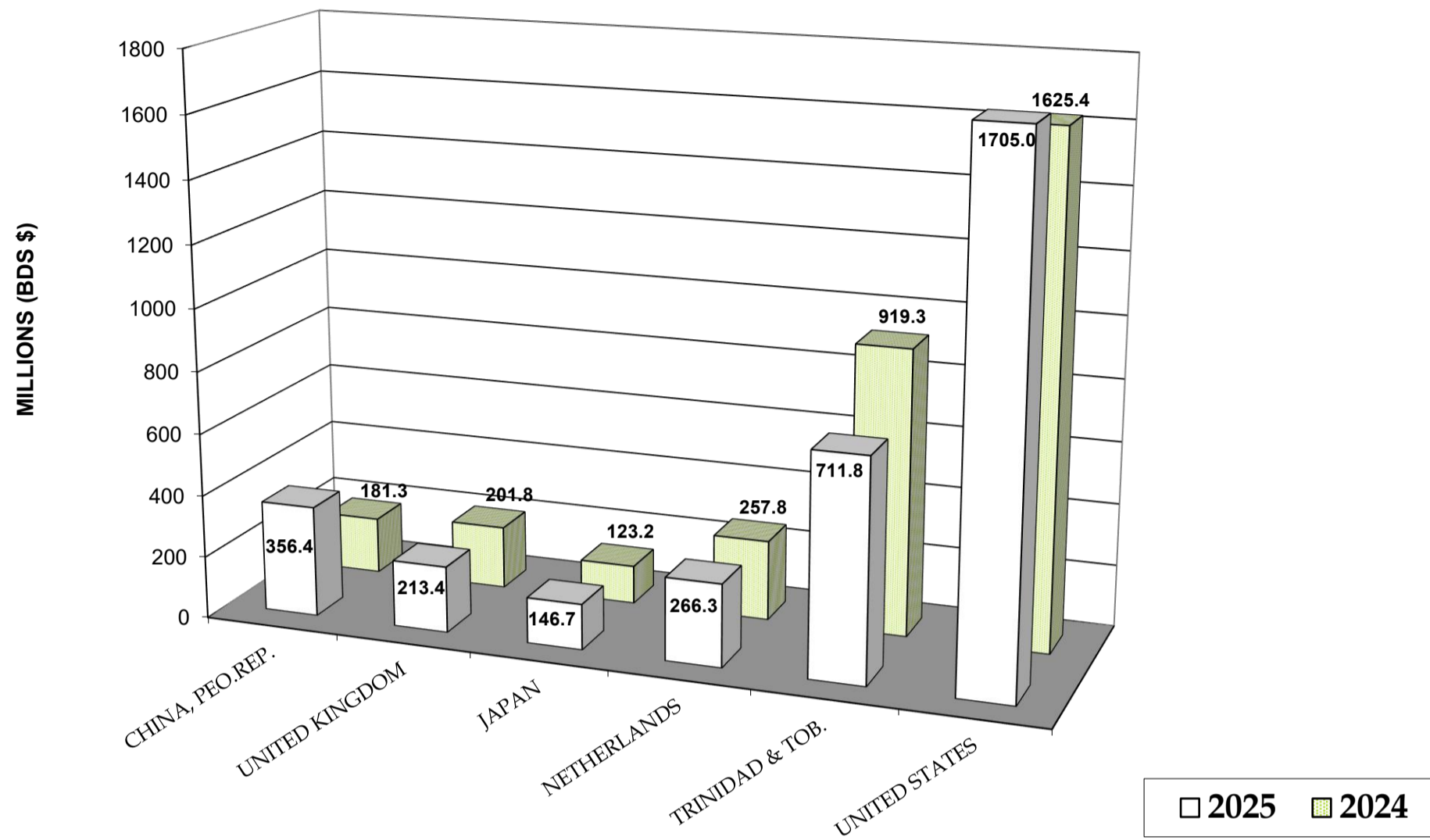

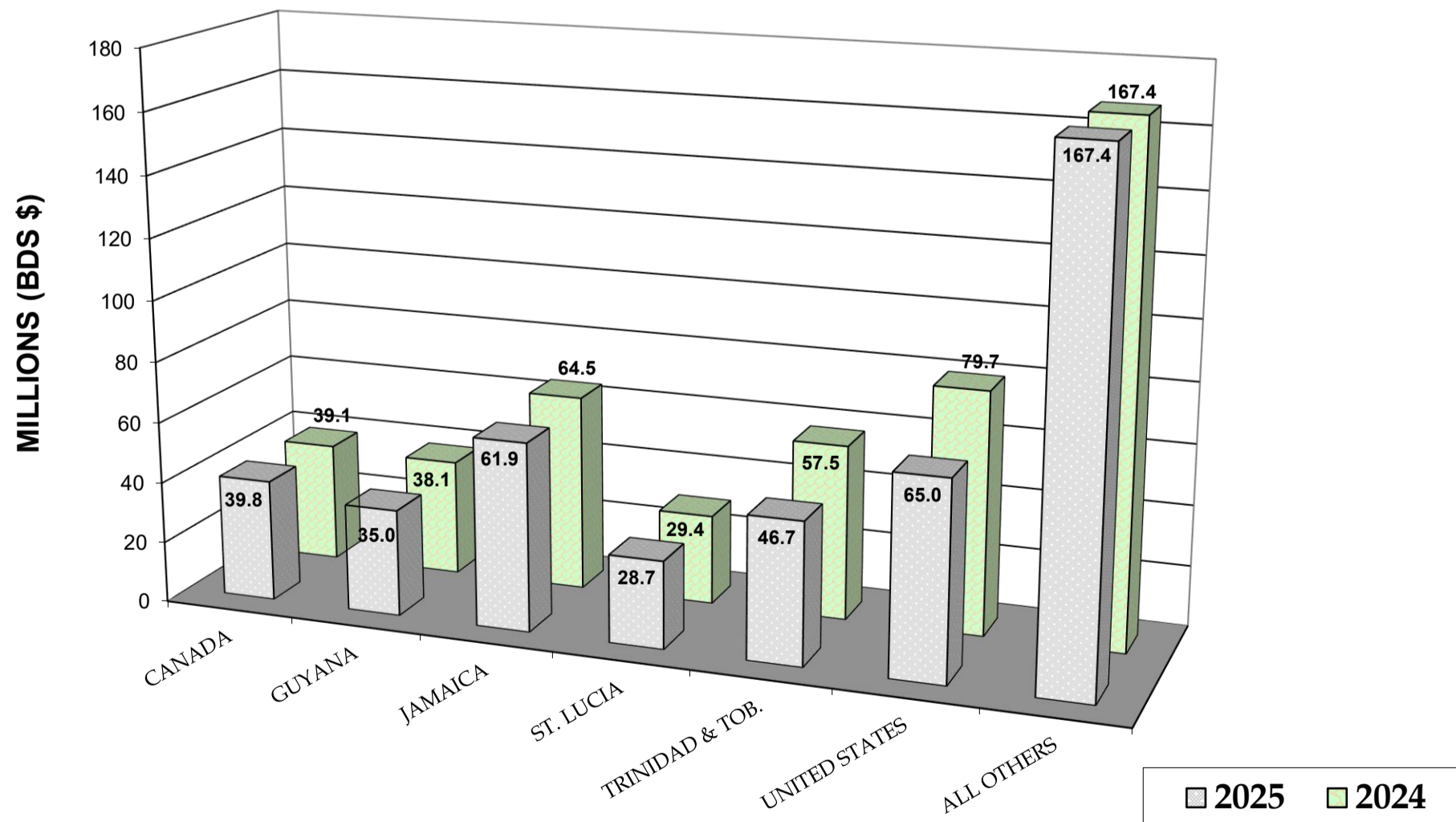

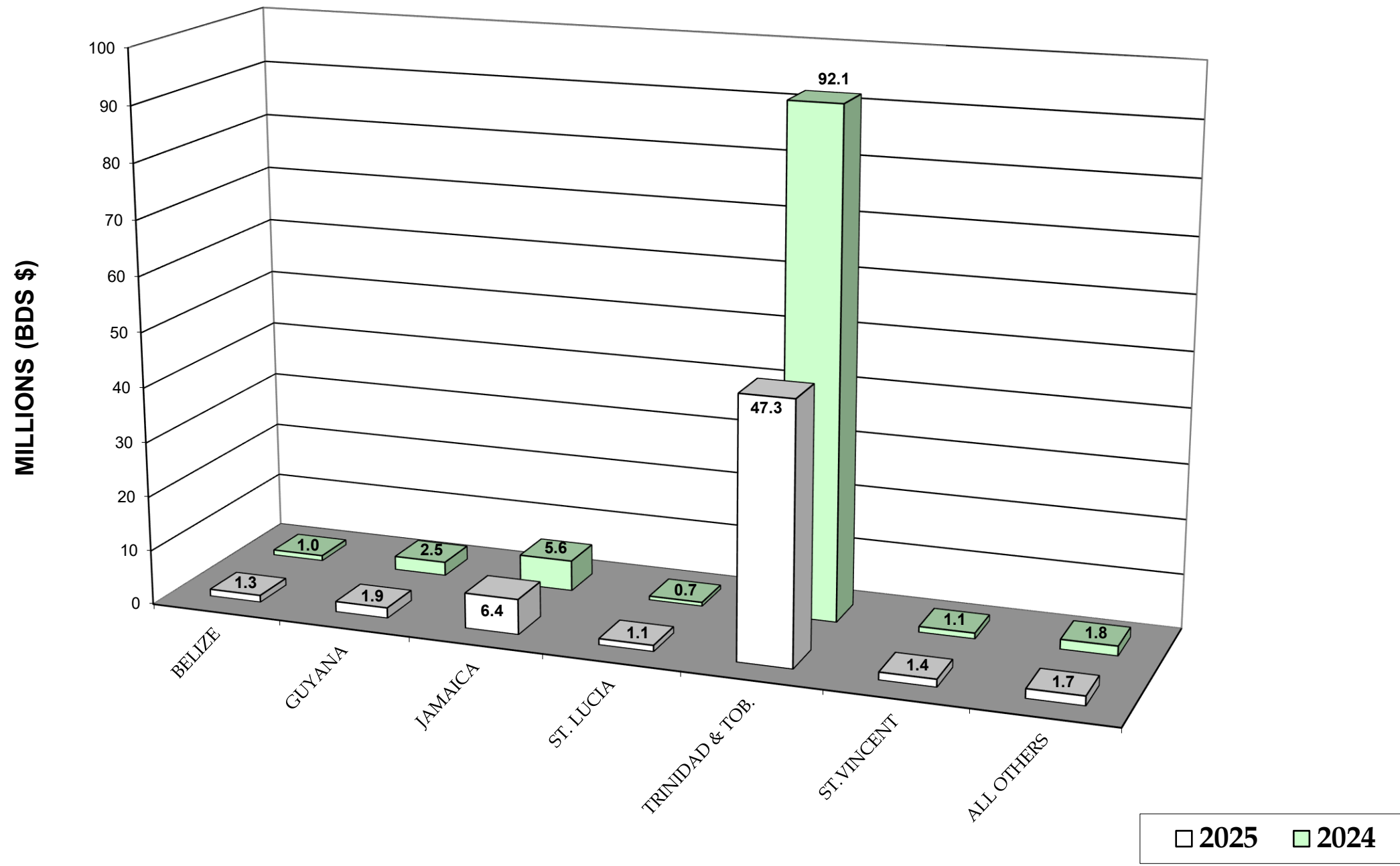

DECEMBER 2025 WITH THE CORRESPONDING MONTH OF 2024

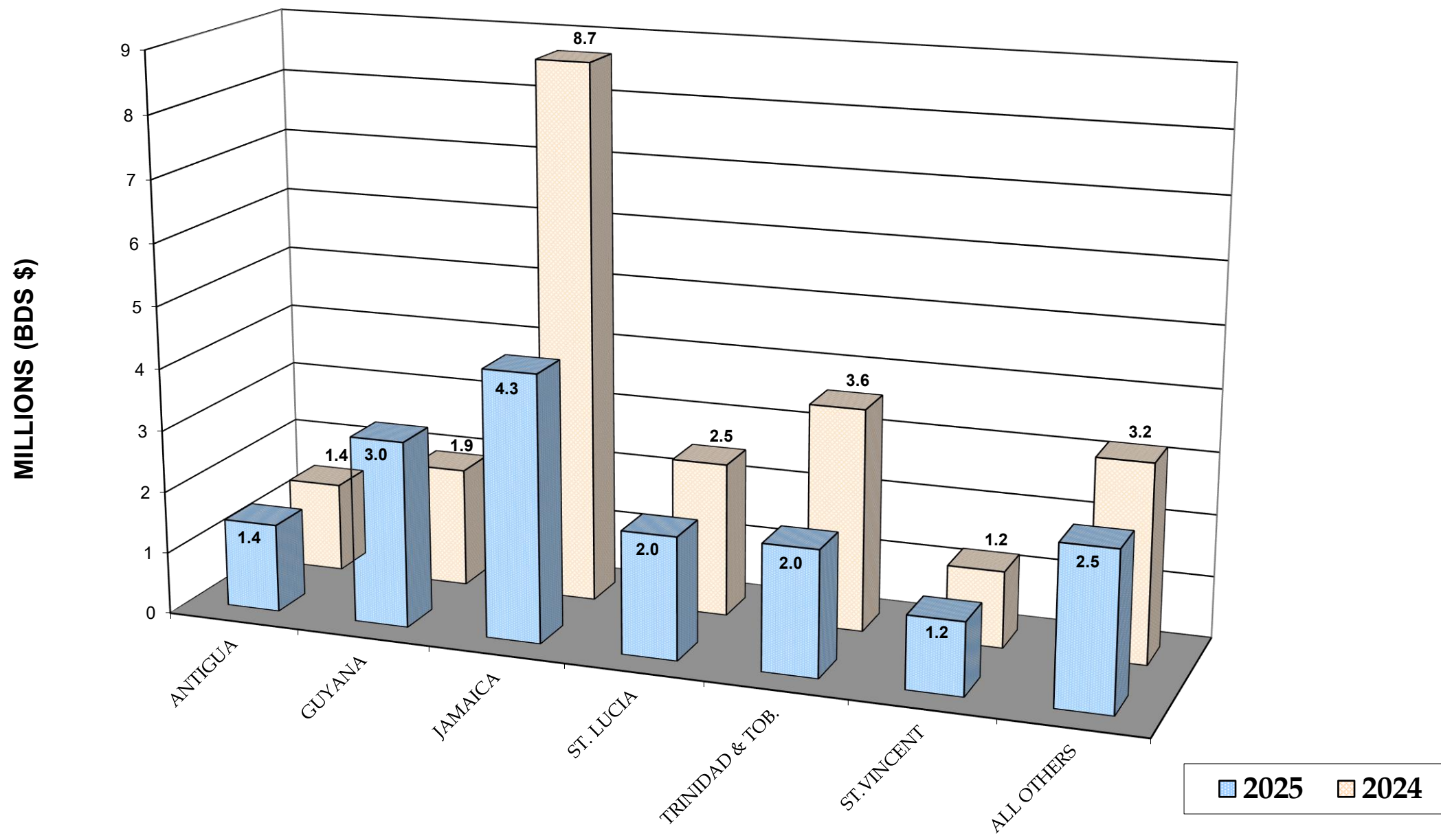


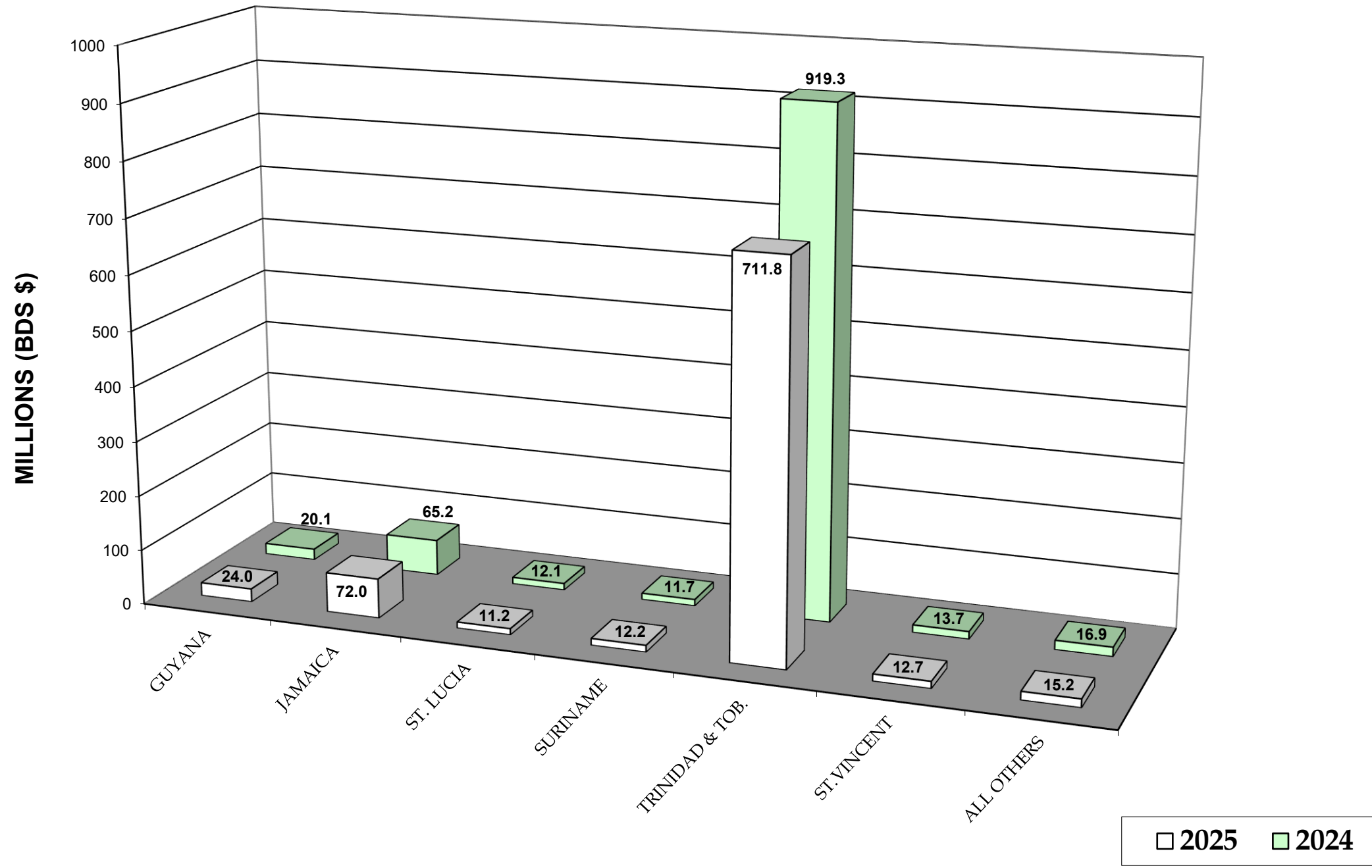

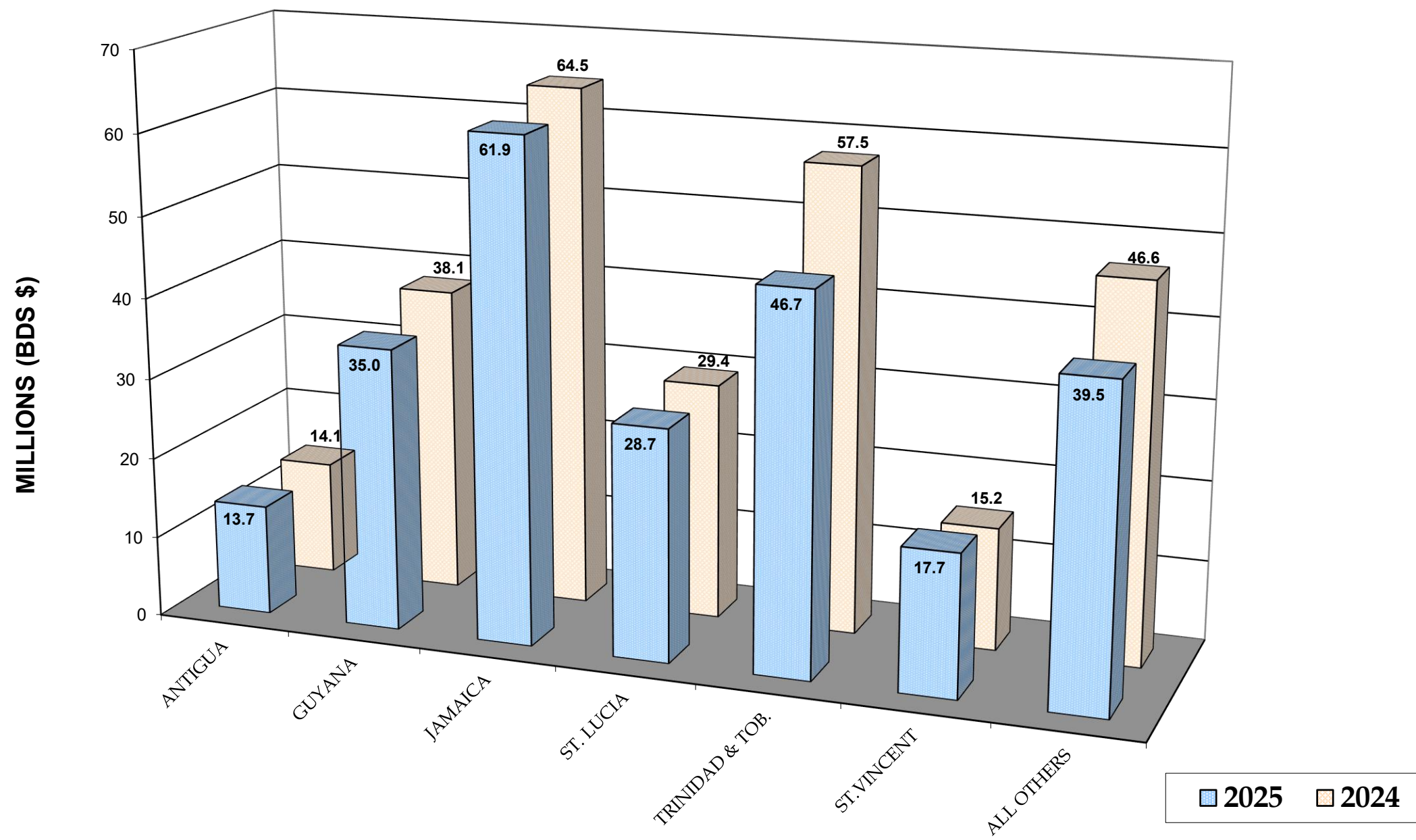
